
What arrangements have been made to clean up debris as a result of the race?

Plan for Signage During the Race

- We will have student council members holding up clearly visible, directional signs to guide the runners in the right direction along the course.
- At the 3 mile check points along the course, members of the Student Council will be holding up mileage signs (Miles 1 and 2 will have water stations).
- The finish line will have people, signs, and a balloon arch to guide runners to the end of the route.
- Student Council will make all of the signs
