3. Discussion with Select Board Member Laura Hebb on issues she feels need to be addressed:
- Overall seems to be working well
 - Some day-to-day activities seem are not being communicated to the Select Board
 - Select Board wasn't informed about hiring consultant to write contract for a cleaning contract for Town buildings
 - Laura would support changing the reporting structure to have ALL employees report to Town Manager since board members likely are not aware of their oversight responsibility and may lack HR skills
 - Would support keeping signing limit at \$25k
