

## TOWN CLERK'S REPORT.

### Town Records 1915.

#### TOWN WARRANT.

*Worcester, ss.*

To the Constable of the Town of Upton, in the County of Worcester,  
Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall in said Upton, on Monday the first day of March, punctually, at six o'clock forenoon, then and there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, three Selectmen, three Overseers of the poor, town treasurer, collector of taxes, auditor, five constables, three fence viewers, and a tree warden, all for one year; one cemetery commissioner (to fill vacancy caused by the resignation of George E Childs) for one year; one cemetery commissioner, one assessor of taxes, one school committee, and three trustees for the public library, all for three years; also for said voters to give in their votes, Yes or No, in answer to the question,

"Shall license be granted to sell intoxicating liquors in this town the ensuing year?" all on one ballot.

The polls may be closed at three o'clock in the afternoon on said day of meeting.

In accordance with a vote passed at the annual meeting of the town, held March 7, 1910, the remaining articles of this warrant will be acted upon at an adjourned meeting of the town held on some evening within ten days of the above date.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, make appropriations of the same, and act thereon.

Article 4. To determine the manner of repairing the highways and bridges the ensuing year, and act thereon.

Article 5. To see if the Town will vote to authorize the Town Treasurer with the approval of the Selectmen, to borrow money in anticipation of revenue of the present municipal year.

Article 6. To see if the Town will vote to authorize their Assessors to have their valuation of the Town for the year 1915 printed, and appropriate money for the same.

Article 7. To see if the Town will vote to accept and adopt the Code of By-Laws as presented by the committee appointed (at a special meeting of the Town held Dec. 15, 1913,) to revise the Code of By-Laws now in use, or act in any manner pertaining thereto.

Article 8. To see if the Town will vote to install (30) thirty additional electric lights, to be located where the Selectmen think they are needed, raise and appropriate money for the same, or act in any manner pertaining thereto.

Article 9. To see if the Town will vote to change the day of the annual Town Meeting from the first Monday in March to the first Monday in February of each year.

Article 10. To see if the Town will vote to give the Farmers' Rural Exchange of East Upton the free use of the school building in that part of the Town for one year, providing they keep it in repair.

Article 11. To see if the Town will vote to elect its Board of Overseers of the Poor, to serve as follows: One member to serve one year, one member to serve two years, one member to serve

three years, and thereafter a member to be elected to serve three years, as provided in Section 406, Chapter 835, Acts of 1913, to take effect at the next annual meeting of the town.

Article 12. To see if the town will vote to appropriate the sum of Three Hundred (\$300.00) Dollars to paint the three school buildings and act thereon.

And you are directed to serve this Warrant, by posting up attested copies thereof at each of the following places in said Town seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE ANNUAL TOWN MEETING,  
MARCH 1, 1915.

Commonwealth of Massachusetts.

*Worcester, ss.*

Pursuant to the foregoing warrant, the legal voters of the town of Upton, met in small hall, town building in said Upton, on Monday, the first day of March A. D. 1915.

The meeting was called to order at six o'clock a. m. by the town clerk, who then read the warrant and the officer's return thereon.

TOWN OFFICERS.

Article 1. The selectmen having appointed Roger Shaughnessy, Owen Donnelly, Jefferson H. Lyford and Leslie W. Gould election officers, they were sworn to faithfully perform the duties of their office by the town clerk.

The cards of instructions and specimen ballots having been posted, a package containing the official ballots were delivered to the proper officers and their receipt given to the town clerk.

The ballot-box having been publicly examined, the index being set on 0000 it was locked and the keys thereof were delivered to William F. Parshley constable in attendance at said meeting.

The ballot-box was in charge of Roger Shaughnessy and the the check-list at the ballot-box in charge of Jefferson H. Lyford.

The polls were declared open for the reception of ballots for town officers at 6.05 o'clock a. m.

The meeting was in charge of moderator Appleton P. Williams.

Voted: To close the polls at four o'clock P. M.

Voted: That when we adjourn, that it will be to Monday evening, March 8, at 7.45 o'clock.

During the voting by the unanimous consent of the election officers, the ballot-box was opened and ballots were taken out for the purpose of counting.

The following named persons having been appointed by the selectmen to canvass the vote Frank O. Ogden, Frank D. Aldrich, J. Edward Murphy and John Carmody, they were duly sworn by the moderator.

At the close of the polls the register on the ballot-box stood at 357 showing that 357 ballots had been cast therein, the check-lists were compared and showed that 331 males and 26 females had voted, the remaining ballots were taken out making 357.

#### REPAIRS OF HIGHWAYS AND BRIDGES.

Article 4 Voted: That the repairs of the highways and bridges be left in the hands of the Board of Selectmen.

#### BORROWING MONEY.

Article 5. Voted: That the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year, beginning January 1, 1915, to an amount not exceeding in the aggregate \$12,000,00, and to issue a note or notes therefor payable within one year, any debt or debts incurred under this vote to be paid from the taxes of said municipal year.

#### PRINTING VALUATION REPORTS.

Article 6 Voted: To instruct the assessors to have their valuation of the town for 1915 printed, and Seventy-five (\$75.00) Dollars was appropriated to pay for the same.

#### BY-LAWS.

Article 7. Voted: To accept and adopt the code of by-laws as presented by the committee appointed at a special meeting of the inhabitants of the town held Dec. 15, 1913.

## ELECTRIC STREET LIGHTS.

Article 8. A motion to install 30 electric lights to be located where the selectmen think they are needed.

A motion to pass over this article was lost.

As the original motion if carried, would require an appropriation larger than the by-laws would allow unless recommended by some town officer or committee, it was voted; to refer the matter to the Board of Selectmen, they to investigate and report at the next meeting.

## DATE OF ANNUAL MEETING.

Article 9. Voted: To pass over this article. See by-laws.

## EAST UPTON SCHOOL HOUSE.

Article 10. Voted: To grant the Farmers' Rural Exchange of East Upton, the free use of the school building in that part of the town for one year, provided they keep it in repair.

## ELECTION OF THE OVERSEERS OF THE POOR.

Article 11. Voted: To elect its Board of Overseers of the Poor, to serve as follows: one member to serve one year, one member to serve two years, one member to serve three years, and thereafter a member to be elected to serve three years, as provided in section 406, chapter 835, Acts of 1913, to take effect at the next annual election of town officers.

## PAINTING SCHOOL HOUSES.

Article 12. Voted: To appropriate the sum of Three Hundred (\$300.00) Dollars to paint the three school buildings.

Article 4. Voted: To raise the sum of (\$24,640.00) by taxation.

Voted: To dissolve the warrant.

Pursuant to the foregoing warrant, the inhabitants of the town of Upton, qualified to vote in elections and town affairs, met in Caucus Hall in said Upton, on Monday, the fifth day of April A. D. 1915, and proceeded as follows:—

The meeting was called to order by the moderator Appleton P. Williams at 4 o'clock P. M.; the warrant and officer's return was read by the town clerk.

The Selectmen having appointed Roger Shaughnessy, Owen Donnelly, George E. Ambler and Frank D. Aldrich, they were duly sworn by the town clerk.

The specimen ballots and cards of instruction having been posted as the law directs, the ballot-box was shown to the voters present to be empty; it was locked and the keys thereof were given to William F. Parshley, constable in attendance at said meeting.

A package of official ballots were delivered to the ballot-clerks and their receipt thereof given to the town clerk.

The ballot-box was in charge of Roger Shaughnessy and the check-list in charge of Frank D. Aldrich.

Due notice having been given the polls at eight o'clock P. M. were declared closed.

The names of those on the list of voters, both at the polls and at the table of the ballot clerks, that had been checked as voted were compared and were as follows:—

Article 2. The Board of Selectmen who comprised the said committee asked for further time which was granted.

#### ADDITIONAL APPROPRIATION FOR GYPSY MOTH.

Article 3. Voted: To pass over this article.

#### PAINT AND REPAIR G. A. R. BUILDING.

Article 4. Voted: To raise and appropriate the sum of Two Hundred (\$200.00) Dollars to paint and repair G. A. R. Hall Building.

Alfred Young Chairman of the Board of Selectmen stated that Deputy State Forest Warden John P. Crowe of Westboro was present and wished the consent of the voters to speak to them for a few minutes.

It was voted unanimously to grant his request.

He said in part that he knew he was late in asking for an appropriation at this meeting but thought he would state his case and get the sentiment of the town in regard to an appropriation at some future meeting.

The observation tower at Westboro is 30 feet high, but there are so many high hills heavily wooded between the tower and some parts of Upton that it is impossible to accurately locate small fires; the same conditions exist between the tower and Grafton and Northboro, places that the man at the tower is supposed to cover.

It is the plan for the State Commission to ask Upton to appropriate \$75.00, Grafton \$75.00, Northboro \$50.00, and Westboro \$100.00 towards the expense of building the tower thirty feet higher.

An informal vote was called for by the Moderator and it was a unanimous vote that the town appropriate \$75.00 towards the expense of raising the tower, at some future meeting.

The votes having been counted, declaration thereof was made in open meeting and recorded as follows:—

## BY-LAWS OF THE TOWN OF UPTON.

MAY 7, 1915.

In compliance with Chapter 344, Acts of 1904, I hereby Certify that, the following is a true copy of the By-Laws adopted by the town of Upton, at a legal meeting held March 8, 1915, and that they have been approved by the Attorney General.

I also Certify that, I have caused the said By-Laws and approval of the Attorney General to be published in three issues of the Milford Daily Journal, as the law directs, on May 5th, 6th, and 7th, 1915.

## ARTICLE 1.

## TOWN MEETINGS AND THE PROCEDURE THEREAT.

Section 1. The annual meeting for the election of town officers, shall be held on the first Monday in February in each year. The polls shall be open at six o'clock in the forenoon and shall remain open until four o'clock in the afternoon, when they shall be closed, and it shall be so stated in the warrant calling said meeting.

All business of the annual meeting (except the election of such officers and the determination of such matters as by law are required to be elected or determined at such meeting), and the raising and appropriating of money in anticipation of the payment of taxes, shall be considered at an adjournment thereof, which adjournment shall be held on the second Monday of February at seven forty-five o'clock P. M.

Section 2. Warrants for all town meetings shall be directed to either of the constables of the town, and the meeting shall be notified by posting attested copies of the warrant in each of the post-offices of the town and on the town hall building, seven days at least, before the day of such meeting.

Section 3. No grant of a sum of money exceeding Two Hundred Dollars shall be made until the subject matter thereof has been considered and estimates reported to the town either by the selectmen, school committee, engineers of the fire department, or other town officers, or by some committee chosen for that purpose in pursuance of a vote of the town.

Section 4. When a question is under debate, no motion shall be received, except a motion to adjourn, to lie on the table, to commit or amend, to refer or to postpone to a day certain, or to postpone indefinitely, which several motions shall have precedence, in the order in which they are arranged.

Section 5. Upon taking a vote upon any question, if the decision of the moderator is doubted, or a division of the house called for, the moderator shall request the house to be seated, and shall appoint tellers. The question shall then be distinctly stated and those in the affirmative and negative respectively shall be requested to rise and stand in their places until they are counted by the tellers, who shall count each side and make report thereof to the moderator.

Section 6. No vote shall be reconsidered at the same meeting, or any adjournment thereof, except upon a motion made within one hour of the adoption of such vote, or unless ordered by two-thirds of the voters present and voting.

Section 7. The duties of the moderator not prescribed by the statutes, or these by-laws, shall be determined by the general rules of parliamentary law so far as they may be adapted to town meetings.

## ARTICLE 2.

### DUTIES OF TOWN OFFICERS.

Section 1. The Selectmen shall have full authority, as agents of the town, to institute and prosecute suits in the name of the town, and may appear either personally or by counsel before any court,

committee of the legislature, or any state or county board or commission, to protect the interest of the town, but are not authorized by these by-laws to commit the Town to any course of action.

Section 2. Whenever it shall be necessary to execute any deed conveying land, or any other instrument required to carry into effect any vote of the town, the same shall be executed by the selectmen or a majority thereof, in the name of the town, unless otherwise provided by law or by vote of the town, and shall be sealed with the town seal.

Section 3. The selectmen shall furnish for the use of the voters at the annual town meeting and adjournment thereof, copies of the town warrant for that meeting.

Section 4. The selectmen shall cause an annual report to be printed and ready for distribution among the voters of the town at the annual town meeting.

Section 5. All town officers required by law or requested by the selectmen to submit a written annual report, shall prepare and submit the same to the board of selectmen before the fifth of January in each year.

#### TOWN CLERK.

Section 6. It shall be the duty of the town clerk to see that every conveyance to the town of any interest in land is properly recorded in the Registry of Deeds.

Section 7. The town clerk shall furnish all boards, committees and officers with a copy of all votes affecting them.

Section 8. The town clerk shall furnish the selectmen for publication in the annual printed report of the town, a copy of his record of all town meetings that have been held during the preceding year also the vital statistics recorded during the preceding year.

## TOWN TREASURER.

Section 9. The town treasurer shall have the custody of all insurance policies, and he shall publish the same in the annual report, which report shall include a statement of the property covered, the names of the companies, the date of expiration of each, and the amount of each policy.

## COLLECTOR OF TAXES.

Section 10. The collector of taxes shall have all the powers conferred by law on a town treasurer when acting as collector.

## ARTICLE 3.

## FINANCIAL.

Section 1. The financial year shall begin with the first day of January in each year, and end with the last day of December.

Section 2. Funds given to the town in trust or otherwise for specific purposes, shall not be mingled with other funds of the town but shall be kept and invested separately, and used only in accordance with the terms of the gift.

Section 3. The money received each year from dog licenses, shall be used for the support of the schools.

## ARTICLE 4.

RELATING TO JUNK DEALERS AND DEALERS IN  
SECOND-HAND ARTICLES.

Section 1. The Selectmen may license suitable persons to be dealers in and keepers of shops for the purchase, sale or barter of junk, old metals, or second-hand articles, subject to the provisions of sections 186 to 189 inclusive of chapter 102 of the Revised Laws of Massachusetts; and may revoke such license at pleasure.

Section 2. Every shop keeper shall keep a book in which shall be written, at the time of every purchase of any such article, a de-

scription thereof, the name, age and residence of the person from whom, and the day and hour when such purchase is made; that such book shall, at all times, be open to the inspection of the selectmen, constables and police officers of the town; that every keeper of such shop shall put, in some suitable and conspicuous place on his shop, a sign having his name and occupation legibly inscribed thereon in large letters; that such shop and all articles of merchandise therein may be, at all times examined by the selectmen, constables, and police officers of the town; and that no keeper of such shop shall directly or indirectly, either purchase or receive, by the way of barter or exchange, any of the articles aforesaid of a minor or apprentice, knowing or having reason to believe him to be such.

Section 3. Every person owning or having the care, or driving of a cart, wagon, dray, truck, hand-cart, sleigh, sled, hand-sled or other vehicle which shall be used in the town for or in the collection of junk, old metals, rags, paper or second-hand articles shall be licensed by the selectmen; and each of said vehicles shall have placed upon the outside and upon each side of the same the name of the licensee and the number of the license in plain, legible letters and figures of not less than three inches in length, and so that the same may be distinctly seen and read; and any person owning, having the care, or driving of any of the above described vehicles, shall wear a badge on some conspicuous part of his clothing, with the number of his license thereon in plain legible figures of not less than one inch in length.

Section 4. Any person who shall collect junk, old metals, rags, paper, or second-hand articles without a wagon, cart, dray, truck, hand-cart, sleigh, sled, hand-sled or other vehicle, shall be licensed by the board of selectmen, and shall wear a badge on some conspicuous part of his clothing with the number of his license thereon in plain legible figures of not less than one inch in length.

Section 5. For every license so granted there shall be paid to the town treasurer the sum of ten dollars for the use of the town.

## ARTICLE 5.

Section 1. Whosoever shall behave in any indecent or disorderly manner, or use profane, indecent or insulting language in any public place or on any sidewalk or street in the town, to the annoyance or disturbance of any other person there being or passing in a peaceable manner, shall forfeit and pay a sum not less than one dollar, nor more than twenty dollars for each offence.

Section 2. Three or more persons shall not continue to stand, or remain in a group, or near to each other, on any sidewalk, or in any public place, in such a manner as to obstruct a free passage for foot passengers, after having been requested by a constable or police officer to move on; and any person who shall violate the provisions of this by-law, shall forfeit and pay a sum not exceeding five dollars.

Section 3. Whosoever by any means or in any manner shall wilfully frighten any horse, or play at any game in which a ball is used, or shoot with bows and arrows or throw stones or other missiles, in any street, or on any sidewalk, shall forfeit and pay a sum not less than one dollar, nor more than ten dollars, for each offence.

Section 4. Whosoever shall drive any horse, cattle or swine or permit any horse, cattle or swine under his care to go upon and over any sidewalk, or suffer any horse to remain hitched across any sidewalk, or hitch his horse to any ornamental tree standing or growing upon any sidewalk, or draw or propel any hand-cart over any sidewalk so as thereby to cause any injury, either to person or property of others, or to obstruct the safe and convenient passing of persons lawfully using the same, shall forfeit and pay a sum not less than one dollar nor more than ten dollars, for each offence.

## ARTICLE 6.

Section 1. These by-laws may be amended at any annual town meeting, an article or articles for that purpose having been inserted in the warrant for such meeting.

Section 2. All town by-laws heretofore existing are repealed upon the taking effect of these by-laws.

Section 3. These by-laws shall remain in full force and effect until duly repealed by vote of the town, or until amendments or alterations therein, or until other by-laws in substitution therefor shall take effect.

## PROCEEDINGS OF THE STATE ELECTION NOVEMBER 2, 1915.

## COMMONWEALTH OF MASSACHUSETTS.

*Worcester, ss.*

Pursuant to the foregoing warrant, the legal voters of the town of Upton, met in their town hall in said Upton, on Tuesday the second day of November A. D. 1915, it being the first Tuesday after the first Monday, punctually at six o'clock forenoon.

The meeting was called to order by the Town Clerk, who then read the warrant and the officer's return thereon.

In accordance with the provisions of Chapter 835, Acts of 1913, a sealed package said to contain 600 official ballots was delivered to the proper officers and a receipt therefor given to the town clerk.

The cards of instruction, amendments of the constitution to be voted for, and specimen ballots all having been posted as the law directs. The ballot-box required by law to be used in elections was then publicly opened and shown to be empty, the register of the box was set at 0000, the box was locked and the keys delivered to William F. Parshley, constable in attendance at said meeting.

Thomas J. Gorman, Stedman C. Brown, Jefferson H. Lyford and Roger Shaughnessy having been appointed election officers by the selectmen for this meeting, were duly sworn to perform the duties of their office by the town Clerk.

The package of ballots was delivered to Thomas J. Gorman and Stedman C. Brown, ballot clerks, who then publicly broke the seals of said package.

Roger Shaughnessy had charge of the ballot-box.

Jefferson H. Lyford had charge of the voting list at the ballot-box.

The polls were declared open at 6.05 o'clock A. M. for the reception of ballots for State and County Officers.

Frank O. Ogden, Charles W. Childs, William J. Gorman and James F. Shechan having been appointed by the selectmen, Tellers to canvass the vote, they were duly sworn to perform the duties of their office by the town clerk.

At 9.05 A. M., the ballot-box, by unanimous consent of the election officers was opened, the register standing at 208 and two hundred ballots were taken therefrom for the purpose of counting the same, again at 1.30 P. M., when the register stood at 315 and one hundred were taken therefrom, also at 3 P. M. when the index registered 351 and fifty were taken out.

Voted: To close the polls at four o'clock P. M.

Due notice having been given, the polls at 4 P. M. were declared closed.

#### ARTICLE of AMENDMENT.

(Full power and authority are hereby given and granted to the general court to impose and levy a tax on income in the manner hereinafter provided. Such tax may be at different rates upon income derived from different classes of property, but shall be levied at a uniform rate throughout the commonwealth upon incomes derived from the same class of property. The general court may tax income not derived from property at a lower rate than income de-

rived from property, and may grant reasonable exemptions and abatements. Any class of property, the income from which is taxed under the provisions of this article may be exempted from the imposition and levying proportional and reasonable assessments, rates and taxes as at present authorized by the constitution. This article shall not be construed to limit the power of the general court to impose and levy reasonable duties and excises.)

Adjourned to 7.45 o'clock in the evening.

#### SPECIAL TOWN MEETING.

At 7.45 o'clock in the evening of the above mentioned second day of November, at the same place the above described legal voters acted upon the following articles in the warrant.

The moderator Appleton P. Williams, called the meeting to order; the town clerk read that part of the warrant that related to town affairs.

## SUPPORT OF POOR.

Article 1. Mr. E. B. Newton clerk of the Overseers said in part, that the appropriation made in the spring had been used up and he thought the appropriation asked for would carry them through to the annual meeting.

Voted: To appropriate the sum of Nine Hundred (\$900.00) Dollars additional, for the support of the poor.

## FIRE TOWER AT WESTBORO.

Article 2. As an informal vote was passed at a special town meeting on April 5, 1915 in favor of this article, it was voted: To appropriate the sum of Seventy-five (\$75.00) Dollars to pay Upton's share in raising the fire tower in Wesboro, thirty feet higher.

## REPORT OF COMMITTEE ON 30 ADDITIONAL STREET LIGHTS.

Article 3. Mr. Alfred Young chairman of the committee said in part, that they had looked over the ground relative to adding thirty more electric street lights to the present system, they would recommend the addition and would suggest they be placed as follows:

Grove Street	3600 feet	9 lights.
Christian Hill	1645 feet	4 lights.
Hartford Avenue	3535 feet	8 lights.
Mechanic Street	2935 feet	7 lights.
Grafton Road near P. Dwyer		1 light.
William Street		1 light.

The cost of 130, 60 candle power lights at \$16.50 would be \$2145.00, also the committee recommended that if the town would make it up to 160 lights that they thought it would forever

settle the lighting question in the town, as it would cover all streets where lights might ever be expected to be asked for.

Voted: To add thirty (60 candle power) electric street lights to the present system.

#### CONTRACT FOR STREET LIGHTING.

Article 4. Voted: on motion of Mr. Eben T. Hall that the selectmen be, and that they hereby are, authorized to sign, on the part of the town, a contract with the Worcester Suburban Electric Company for lighting the streets of the town for one year, said contract to contain the furnishing of 100 (32 candle power) electric lights at \$13.50 each per year, and 30 (60 candle power) electric lights at \$16.50 each per year; and that said selectmen shall have the power to locate said lights where in their judgment it will be for the best interest of the town.

Voted: To dissolve the warrant.

The Librarian herewith submits the following report for the library year ending July 1, 1915:—

Number of volumes in library July 1, 1915, 6,763.





## REPORT OF THE SUPERINTENDENT OF SCHOOLS

---

TO THE SCHOOL COMMITTEE OF UPTON:—

GENTLEMEN.

Herewith is presented my fourth annual report as superintendent of your schools it being the twenty-fifth since the formation of the union with Grafton.

The work has been along the same general lines as last year, with a healthy progress in all departments.

The new course of study in the high school is now in full operation; the pupils have adjusted themselves to it, and the teachers are enabled to do better work since their energies are not scattered over so wide a field and they have more time for preparation. By the law of the state we are compelled to "fit for college" and for a small country school Upton sends an unusually large proportion of its graduates to higher institutions. It is said that a school is judged not by its teachers, buildings or course of study but by the record made by its graduates after they leave the school.

If that is so, then Upton has reason to have faith in its high school since the reports from colleges and other schools, attended by our graduates, are such that we can not but take pride in the work that they are doing in such institutions.

But a large majority of the graduates remain in Upton and in justice to the taxpayers who provide the school, there should be given some training in subjects that they can make direct use of in the town. As far as possible the material in the different subjects is adapted to use in Upton but either more time or more teachers must be provided if we do work that will have an immediate value to the graduate as he leaves the school to take up his life in this, his own community. If it were possible I would like to see established a course in elementary agriculture for the boys and one in

domestic science for the girls. Our girls and boys have made good use of the opportunities afforded them by the Home Literary Club and I regret that we can not follow up the course further.

Last year there was given in the high school a very valuable course in community civics which has done much to arouse in the minds of the pupils a more accurate conception of their rights and duties in the political life of the town, state and nation. We need however, a higher appreciation of the importance of little things as showing the degree of citizenship to which the boys and girls have attained.

For instance:—By looking at the attendance table given elsewhere in this report one will see that there were three hundred and eight cases of absence from the high school. In other words each pupil, on an average, was absent five whole days or one week during the year. In the year 1913-14 the number was thirteen and this year Mr. Swain tells me it will be below five. Each pupil in 1914-15 was tardy five and six-tenths times; in 1913-14 eight and two-tenths and that also will be less this year if the present rate is kept through the session. In 1914-15 there were 46 dismissals; in 1913-14 ninety five. This improvement is gratifying but the school is a long way from where it might and ought to be. In 1913-14 every child was absent some part of twenty three and three-tenths sessions out of one hundred eighty four; in 1914-15 eleven and seven-tenths out of one hundred and ninety six.

This all means extra work for the teachers, less thorough work on the part of the pupils and a resulting lower standard for the whole school. Can not the parents see that their children attend with a greater degree of regularity and assist the teachers in their efforts to raise the rank of the school? It is difficult work at best and especially so when a parent says "Your stand is right and I think you are right but I won't back you up in it to my child", or when a parent comes to the office of the superintendent, makes a complaint that is just, and then before leaving withdraws the complaint and asks that nothing be done about it.

Just criticism of our schools is welcome by all officially connected with their administration. Our great regret is that the townspeople do not visit them oftener. In the year ending June

1915 exclusive of attendance at the time of "exercises" there were one hundred and ninety-seven visits paid to the schools by one hundred and eleven different people. The schools are one of the great industries of the towns and why should not the citizens or stockholders see how the money is spent and the class of employees at work. The more a school is visited the better school will it be. If the pupils know a visitor may be expected at any time they will always be on the alert to do a higher grade of work. On account of the seasonable work of the straw shop the fathers in one way are to be envied for they have more time and opportunity than most fathers to see what the children are doing in the schools. The fact is though that only four did so during the last school year. If they were having a colt or hunting dog trained they would visit the trainer, inquire into his methods and examine the result. Are not the children worthy of as much attention? It is sometimes said and without justice too I believe, "That the schools have drawn away from the people and are not close enough to the citizens." If it is so the fault is not with the teachers or school authorities who will be only too glad to welcome any interested in the welfare of the children, and only too willing to receive and act upon any criticism that is offered in the true spirit of helpfulness to the schools.

If parents and teachers could only meet upon some common ground of interest and talk over Johnny and Mary, then when trouble did come the matter could be settled without resentment on either side. The strong probability is though that trouble would not arise at all if parents and teachers understood each other at the beginning. The pupil is proud to have the teacher call at his home on a purely social errand. Do townspeople in general find themselves as ready to call upon the new teachers as upon other newcomers of equal social rank?

In October the grange gave a reception to teachers and strangers in town which was an enjoyable occasion and I believe it will react in the form of better and more interested work on the part of those in whose honor it was given. It means much to have your labors recognized by those in authority. Any thing which tends to bind a teacher to a town by interest tends to make the schools so much better because the teacher is ready and willing to

stay with her pupils more than one year and thus secure a better understanding of their capabilities. It is a pleasure to report that five of our eight grade teachers are in either their second or third year of service in Upton. It has been many years since the work started forward in September with so little lost time because of the necessity of the teacher becoming acquainted with local conditions.

I give below some statistics from the last report of the State Board of Education for the year ending June 30, 1914.

There are in the state 353 towns and cities. In 1912-13 261 raised more by taxation per pupil for school expense. In 1913-14 278 did so.

In amount of tax appropriated for school purposes 97 paid more in 1912-13 and 136 in 1913-14.

The returns for 1914-15 are not available now but the fact is the town has probably not improved its standing in the commonwealth in the past year.

Below is given an analysis of expenses for school year ending June 30, 1915.

From the above one can see that only a little over one half of the amount appropriated for schools is available for the primary purpose of instructing the children. And there seems to be no way in which the large proportion of overhead expense can be reduced. As the pay of plumbers, painters and carpenters raises, repairs must cost more. Wood is no lower in price and coal has a gradual advance and will probably take a sharp one this year. Hay and grain are high and barge drivers can not afford to take a contract at loss.

The same problem is present in every town and if Upton wishes to retain the rank she has held in the past a larger amount

must be placed at the disposal of the school committee. For the actual money spent I believe the town can show results that compare favorably with others in the vicinity and we know that there is a demand for teachers who have had experience in Upton.

If the town does see fit to give a larger amount I am sure that the school committee will spend it with that careful and conservative judgment which it has shown in the past and that the better results produced will be observed with pleasure by the citizens.

## REPORT OF PRINCIPAL OF HIGH SCHOOL

---

MR. T. H. DECOUDRES, SUPERINTENDENT OF SCHOOLS:—

Dear Sir:—I have the honor of submitting my second report as Principal of the Upton High School.

The total registration for the year ending June 25, 1915 was sixty-seven. The registration of the first year has reached seventy-three. This slight increase is due largely to the small graduating class of last June.

The following is the enrollment of the present year by classes:

Three pupils have left since the opening of school in September. One is attending school elsewhere and the other two are working.

The plan adopted last year of exempting from final examinations all pupils who maintained an average of 90 per cent. in any

study has encouraged many to do their best. In the mid-year examinations four pupils were exempted from every subject while several others were exempted from one or two subjects. In the June examinations eight pupils were exempted from every subject and there was a small increase in the number who are exempted from one or two subjects. The results show that the plan was well worth trying.

The percentage of attendance thus far this year has been somewhat larger than last year. The percentage of tardiness has decreased. I wish to urge the parents to co-operate with the school in making the attendance as nearly perfect as possible.

The magazine club which was formed last year has been a benefit to all of the pupils. We have seven periodicals, two weeklies, and five monthlies. From these, the English classes obtain current events and topics for oral compositions and discussions.

The social gatherings of the school have not been frequent enough to distract the interest of the pupils from their school work. A play was given the latter part of last year which was beneficial socially as well as educationally. The proceeds were used to purchase books for our school library.

Through the generosity of Mr. A. P. Williams of Upton, we received sixty-two volumes. Mr. Walter F. Partridge of Framingham presented the school library with a volume of *The Noted Men of Worcester County*. This gives our library a total increase during the past year of one hundred and five volumes.

There have been several changes in the text books which have proved satisfactory. There is need of a few more changes before another year. I think the new song book has aroused a great interest in the music department.

During the summer the outside woodwork was painted. A few repairs were made inside and more are needed for the preservation and appearance of the building.

I wish to express my appreciation of the interest the parents and towns people have shown in the school. I wish to thank the school committee for their interest and support, and you, Mr. DeCoudres for your ever ready suggestion and encouragement.

## REPORT OF SUPERVISOR OF MUSIC AND DRAWING

---

MR. THOMAS H. DE COUDRES, SUPERINTENDENT OF SCHOOLS:—

Dear Sir:—I am pleased to report that the work in both departments under my supervision is making more satisfactory progress than for several years. It is largely due to the fact that a greater per cent. of the teachers returned in September, equipped with the knowledge and experience of the previous year's work. This has enabled them to teach with greater confidence and skill, and the work has gone forward accordingly.

The aim in drawing and handwork has been to develop self-activity in the pupils and a keener appreciation of the world of industry and art in which they live, so that they may be helped, on leaving school, to find that life occupation for which they are best fitted. To this end the work throughout the grades has been planned to show an increased facility in the use of simple tools, and a development of good taste in working out original ideas in line, form and color, as applied to the arts and industries.

The exhibition of school craft at the annual fair held in the Town Hall in September spoke for itself. Not all of the projects could be obtained, for some had been appropriated for school purposes and others spoiled by home use.

In the shop drawings for the eighth grade boys we have been unable to produce finished working drawings ahead of the constructed objects in the manual training room, owing to the great variety of objects selected. Rough sketches have been made and dimensioned, which are being used until time can be given to a careful study of each object, which, with the other necessary work will occupy the remainder of the year. While this will not be

as helpful in the construction of the different models as we desire, on the other hand a knowledge of the construction will gain a much clearer understanding of the drawings to be made.

In music especial emphasis has been placed upon the necessity of securing light head tones, and singing with a free voice and distinct enunciation. In the rooms where this has been accomplished the results are delightful. It is of the utmost importance that the work of the first three of four years is carefully accomplished as outlined, for, with the very limited time at our disposal any failure to produce the desired results at this formative period often means defeat for a pupil later on.

The "High School Song Book", which was placed in the High School last year still continues in popularity with the pupils, and has furnished us so far with an inexhaustible supply of music. The condition of the boys' voices is not much improved, consequently unison singing has proved the most beneficial for them.

I desire, through the medium of this report, to thank all with whom I am associated, for the generous assistance given me at all times.

## REPORT OF SUPERVISOR MANUAL TRAINING

MR. THOMAS H. DE COUDRES, SUPERINTENDENT OF SCHOOLS:—

Dear Sir:—This is my fifth report concerning the work accomplished by the boys in the Manual Training department of the Upton public schools.

The special kind of Manual Training work carried on in your schools has been fully explained in my reports of previous years. Therefore it does not seem advisable for me to take the space in this report to enlarge upon it. The new class, or seventh grade, are, at present, making separable book racks for use in the schools. The old class, or eighth grade, are making a pedestal, three book cases, a book case and desk combined, a large foot stool and a medicine chest. This, of course, takes the entire time given during the year, but I find that the interest in the work and the results obtained more than compensate for the giving of so much time to one large project.

We have 19 boys in the seventh grade and our room only accommodates 8 boys. We have to crowd 10 into some classes. Of course 10 is a small number with proper equipment and floor space, but a large class if crowded.

We are sorely in need of more time, three fourths of an hour a week is not enough for good results. I would suggest, as in my report of a year ago, that we either give one and one half hours per week to each class, or extend the work into the freshman class of high school and give three hours per week there, where we could carry on the work along more advanced lines.

We have much to encourage us as the boys are interested in the work and strive to do their best.

I wish to take this opportunity to thank Miss Randall and the teachers for their hearty co-operation and assistance with the drawing.

## REPORT OF SEWING TEACHER

MR. THOMAS H. DE COUDRES, SUPERINTENDENT OF SCHOOLS:—

Dear Sir:—I herewith present my first report of sewing in the public schools of Upton.

More time is needed for the lesson, no class should have less than an hour.

I find the pupils much interested in their work.

Elements of sewing:—

Grades five and six: Canvas sampler with stitches of even and uneven basting, running stitch, back-stitching, half back-stitching, overcasting, overhanding, catch stitching, button hole stitch and blanket stitch.

Articles: Pin holder, sewing bag, dust bag, dish towel, apron.  
Sewing on lace:—

Grades seven and eight: Hemstitching, crocheting, French seam, bias facing, sewing on buttons, placket, bands and tucks.

Articles: Crocheted insertion and edge, middy blouse, kimono, skirt, towels and pillow case.

As good results depend upon the pupils having their materials at the time needed I wish to express my appreciation to the parents for their assistance and co-operation in providing the materials asked for.
