UPTON RECORDS, 1926.

WARRANT FOR ANNUAL TOWN MEETING, FEBRUARY 1, 1926.

Worcester, SS.

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you
are directed to notify the inhabitants of the Town of Upton,
qualified to vote in Elections and in Town Affairs, to meet at
the Town Hall, in said Upton, on Monday, the first day of
February, 1926, punctually, at six o'clock forenoon, then and
there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the en-
suing year: Moderator, three Selectmen, Town Treasurer, Col-
lector of Taxes, Auditor, five Constables, Tree Warden and one
Assessor of Taxes (to fill a vacancy caused by the resignation of
George F. Briggs), all for one year; one Cemetery Commissioner
(to fill a vacancy caused by the resignation of the late George R.
Pierce) for two years; Town Clerk, one Assessor of Taxes, one
Overseer of the Poor, one Cemetery Commissioner, one School
Committee, and three Trustees for the Public Library, all for
three years; all on one ballot.

The polls shall be closed at four o'clock in the afternoon on
said day of meeting.

In accordance with Section I, Article 1, of the By-laws of the Town of Upton as amended February 12, 1923, the remaining articles of this warrant will be acted upon at an adjourned meeting of the Town held Saturday afternoon February 6th at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and act thereon.

Article 4. To determine the manner of repairing the highways and bridges the ensuing year, and act thereon.

Article 5. To see if the town will vote to authorize the town treasurer, with the approval of the selectmen, to borrow money in anticipation of revenue of the present municipal year.

Article 6. To see if the town will vote to appropriate twenty-three hundred (\$2,300.00) dollars for street lights, this sum to be taken from free and unappropriated money in town treasury, or act thereon.

Article 7. To see if the town will vote to appropriate the sum of five hundred (\$500.00) dollars for concrete sidewalks on Main Street, this sum to be taken from free and unappropriated money in town treasury, or act thereon.

Article 8. To see if the town will vote to appropriate five hundred (\$500.00) dollars for the police department, this sum to be taken from free and unappropriated money, or act thereon.

Article 9. To see if the town will vote to appropriate one thousand (\$1,000.00) dollars to improve the Westboro road, this sum to be taken from free and unappropriated money, provided the County and State will each give a like amount or more, or act in any manner pertaining thereto.

Article 10. To see if the town will vote to appropriate five

thousand five hundred (\$5,500.00) dollars for a combination fire truck and necessary equipment and appoint a committee to purchase the same, or act in any manner pertaining thereto.

Article 11. To see if the town will vote to appropriate one thousand (\$1,000.00) dollars for painting and repairing the buildings at the Town Farm, or act in any manner pertaining thereto.

Article 12. To see if the town will vote to appropriate one hundred (\$100.00) dollars for beautifying the grounds at the George S. Ball School, or act thereon.

Article 13. To see if the town will vote to place six street lights on Hopkinton Road and appropriate one hundred (\$100.00) dollars for the same, as petitioned for by Wilbur G. Taft and others.

Article 14. To see if the town will vote to place eight street lights on Mechanic Street and appropriate one hundred thirty (\$130.00) dollars for the same, as petitioned for by Ida M. Gorton and others.

Article 15. To see if the town will vote to change the salary of the Treasurer from \$175.00 to \$250 per year, or act thereon.

Article 16. To see if the town will vote to add to the "Library Building Fund" the sum of six hundred and seventy-five (\$675.00) dollars received from the sale of the Old Center School property, or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at each of the following places in said town, seven days at least before the time of holding said meeting:—At each of the Post offices and on the Town House in said town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

Pursuant to the foregoing warrant, the legal voters of the Town of Upton met in the Town Hall in said Upton, on Monday, the first day of February, 1926. The meeting was called

to order at six o'clock A. M. by the town clerk, who then read the warrant and the officer's return thereon.

PROCEEDINGS OF THE ADJOURNED TOWN
MEETING, FEBRUARY 6, 1926.

The meeting was called to order by Malcolm C. Temple, moderator. The warrant was read by the town clerk.

REPORTS OF TOWN OFFICERS.

Article 2. Voted: To accept the reports of town officers as printed. Fred W. Wood, town treasurer, announced a legacy of \$5,000.00 received too late to be published in the annual town report. He read from the will of the late George W. Knowlton, as follows:

"I give to the Town of Upton Five Thousand (\$5,000.00) Dollars to be known as the "George W. Knowlton Fund" the income to be used to render assistance and help to worthy people of the town. It being the intent of this clause that the money may be used in any way which would be helpful to townspeople who are in distress."

This \$5,000.00 is deposited in the Savings Department of the Home National Bank at Milford under the title of "George W. Knowlton Fund," subject to withdrawal by the Town Treasurer, income only to be used.

HIGHWAYS.

Article 4. Voted: That the care and repairs of the highways and bridges be left in the hands of the selectmen.

BORROWING MONEY.

Article 5. Voted: That the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year, beginning January 1, 1926, to an amount not exceeding in the aggregate \$20,000.00 and to issue a note or notes therefor, payable within one year, and debt or debts incurred under this vote to be paid from the taxes of said municipal year.

STREET LIGHTS.

Article 6. Voted: To appropriate twenty-three hundred

(\$2,300.00) dollars for street lights, this sum to be taken from free and unappropriated money in the town treasury.

CONCRETE SIDEWALKS.

Article 7. Voted: To appropriate five hundred (\$500.00) dollars for concrete sidewalks on Main Street, this sum to be taken from free and unappropriated money in the town treasury.

POLICE DEPARTMENT.

Article 8. Voted: To appropriate five hundred (\$500.00) dollars for the police department, this sum to be taken from free and unappropriated money in town treasury.

WESTBORO ROAD.

Article 9. Voted: To appropriate one thousand (\$1,000.00) dollars to improve the Westboro Road, this sum to be taken from free and unappropriated money, provided the County and State will each give a like amount or more.

FIRE TRUCK.

Article 10. Voted: On motion of Alvrado Henry, to appropriate five thousand five hundred (\$5,500.00) dollars for a combination fire truck and necessary equipment.

REPAIRS AT TOWN FARM.

Article 11. Voted: On motion of Henry D. Aldrich, to appropriate one thousand (\$1,000.00) dollars for painting and repairing the buildings at the town farm.

Following Article 11, Edward Moroney reminded the Moderator that the committee to purchase the fire truck had not been appointed. The Moderator ruled that the Selectmen would be that committee. Edward Moroney made a motion that a committee of ten be appointed from the floor. John E. Dearth, with the consent of Moroney who withdrew his motion, moved to take up Article 10 again. This motion was lost.

Article 12. Voted: On motion of Henry A. Tuttle, to appropriate one hundred (\$100.00) dollars for beautifying the grounds at the George S. Ball School.

STREET LIGHTS ON HOPKINTON ROAD.

Article 13. Voted: On motion of Edwin Chamberlain, to place six street lights on Hopkinton Road and appropriate one hundred (\$100.00) dollars for the same.

STREET LIGHTS ON MECHANIC STREET.

Article 14. Voted: On motion of Daniel Bates, to place eight street lights on Mechanic Street and appropriate one hundred and thirty (\$130.00) dollars for the same.

SALARY OF TREASURER.

Article 15. Voted: On motion of Henry A. Tuttle to change the salary of the Treasurer from \$175.00 to \$250.00 per year.

LIBRARY BUILDING FUND.

Article 16. Voted: On motion of Dr. Samuel R. Capen, to add to the "Library Building Fund" the sum of six hundred and seventy-five (\$675.00) dollars received from the sale of the Old Center School property.

Voted: To raise the sum of \$51,280.00 by taxation.

Voted: To dissolve the warrant.

TOWN TREASURER'S STATEMENTS.

There is deposited in the Milford Savings Bank, known as the Knowlton School Fund, in trust with the Town Treasurer as trustee \$21.99 to be used by the School Committee to defray the extraordinary expenses of the Knowlton School Building.

There is deposited in the Worcester County Institution for Savings known as the Charlotte A. Batchelor School Fund in trust with Town Treasurer as trustee, Five thousand (\$5,000.00) dollars, the income to be used for the Public Schools. Two Hundred Twenty Five Dollars of this income was used this year.

There is deposited in the Milford Savings Bank, known as

Charlotte A. Batchelor Library Fund, in trust with the Town Treasurer as trustee, Five Thousand Dollars (\$5,000.00) the income to be used for the Public Library. Two Hundred Twenty-five Dollars of this income was used this year.

The Town received from the State Department, as per Chapter 480, Acts of 1924, the sum of \$950.48 as the surplus War bonus fund due the Town. This sum was deposited in the Milford Savings Bank as a nucleus of a fund for a library building, as voted by the Town February 7, 1925.

The old Center School building was sold this last year to the Upton Grange for \$675.00 and by vote of the Town this was to go to this fund. This was deposited in the Milford Savings Bank, thereby making this fund total \$1,661.42.

A legacy of \$5,000.00, to be known as the "George W. Knowlton Fund," was left to the Town this year by will of the late George W. Knowlton, Sr. Clause XI of the will reading as follows: "I give to the Town of Upton Five Thousand Dollars (\$5,000.00), to be known as the George W. Knowlton Fund, the income to be used to render assistance and help to worthy people of the Town, it being the intent of this clause that the money may be used in any way which would be helpful to Townspeople who are in distress."

This \$5,000.00 is deposited in the Milford Home National Bank, Milford, Mass. Subject to withdrawal by the Town Treasurer. The income only to be used.

REPORT OF AN AUDIT

CHAPTER 44, GENERAL LAWS.

Sir:—

In accordance with your instructions, I have made an audit of the accounts of the town of Upton for the period from January 1, 1925 to October 30, 1926, and report thereon as follows:—

The financial transactions of the town as recorded on the books of the several departments receiving or disbursing money for the town were examined, checked, and verified.

The books and accounts of the town treasurer were examined and checked. The receipts, as recorded on the cash book, were checked with the records of the several departments making payments to the treasurer and with other sources from which money was paid into the town treasury. The payments were checked

with the selectmen's warrants and with vouchers and pay-rolls on file.

It was noted that some payments are being made by the cemetery commissioners as well as on account of state aid and mothers' aid without the approval of the selectmen, which is contrary to Section 52, Chapter 41, General Laws, which reads in part as follows:—

.....the selectmen in towns, shall approve the payment of all bills or pay rolls of all departments before they are paid by the treasurer.

The treasurer's cash balance was proved and reconciled with statements furnished by the bank in which the town funds are deposited, and by an actual count of the cash in the office.

The savings bank books, representing the investments of the trust funds in the custody of the treasurer, were examined and the income was verified and found to be as recorded on the treasurer's books. Schedules of the trust fund transactions are appended to this report.

The books and accounts of the tax collector for the years 1922 to 1926, inclusive, were examined. The commitments were added, the abatements were checked with the assessors' records of abatements granted, and the payments to the treasurer were compared with the treasurer's cash receipts. The outstanding accounts were listed and proved by mailing notices to a number of persons whose names appeared on the books as owing money to the town, and from the replies received it appears that the accounts as listed are correct.

The appropriations and transfers voted by the town at the regular and special meetings were checked and verified by a comparison with the town clerk's records.

In connection with the appropriations it was noted that it has been the custom to add receipts to the amounts appropriated by the town for certain purposes. It is apparent that in many cases appropriations have been made in amounts smaller than is necessary to carry on the activities of the department, allowing

the receipts to take care of the additional sums needed. This practice is contrary to Section 53, Chapter 44, General Laws, which reads as follows:

All moneys received by any town officer or department, except as otherwise provided by special acts and except fees provided for by statute, shall be paid by such officer or department upon their receipt into the town treasury. Any sums so paid into the town treasury shall not later be used by such officer or department without a specific appropriation thereof, except that sums allotted to towns for highway purposes by the commonwealth or a county, which shall be used only for the purposes specified by the officials making the allotment or to meet temporary loans issued in anticipation of such allotment as provided in Section 6 or 6A, shall be available therefor without any appropriation.

Appropriations should be made on a flat basis, allowing the receipts to be paid into the town treasury for the use of the assessors in fixing the tax rate, as is provided in Section 23, Chapter 59, General Laws, which reads as follows:

The assessors shall annually assess taxes to an amount not less than the aggregate of all amounts appropriated, granted or lawfully expended by their respective towns since the last preceding annual assessment and not provided for therein, of all amounts required by law to be raised by taxation by said towns during said year, of all amounts necessary to satisfy final judgments against said towns and of all abatements granted on account of the tax assessment of any year in excess of the overlay of that year, and not otherwise provided for; but such assessments shall not include liabilities for the payment of which towns have lawfully voted to contract debts. The assessors may deduct the amount of all the estimated receipts of their respective towns, except from loans or taxes, lawfully

applicable to the payment of the expenditures of the year from the amount required to be assessed; but such deduction shall not exceed the amount of the corporation tax received from the commonwealth on or before May first of the current year on account of the assessments of the previous year and of such other receipts as have been received during the preceding financial year.

The surety bonds of the treasurer and the collector were examined and found to be in proper form. In the case of the town clerk it was found that a personal bond had been filed, which is contrary to the provisions of Section 9, Chapter 404 of the Acts of 1924.

The accounts of the town clerk for dog, sporting and town licenses, for the period of the audit, were examined. The payments to the county, state and town, respectively, and the cash on hand were verified.

Appended to this report is a balance sheet showing the financial conditions of the town on October 30, 1926.

While engaged in making the audit, I received the hearty co-operation of all the town officials, and on behalf of my assistants and for myself, I wish to express appreciation for the courtesies extended and the assistance rendered.

LIBRARIAN'S REPORT.

TO THE TRUSTEES OF THE UPTON LIBRARY:—

The librarian herewith submits her ninth annual report following which are library statistics and the catalog of new books.

During the year books have been purchased and added to the "Dr. Carpenter Alcove" as required.

The Woman's Education Association loaned two sets of pictures to the library during 1926; in May, pictures of Fairy Tales by the English painter, Sir Walter Crane; in September, photographs of a pageant held at Lancaster illustrating episodes in the history of that town. Each set remained here for one month.

Children's Book Week was observed with an exhibit of new books for children and with a play "A Feast of Adventure" given on Saturday afternoon.

It is pleasing to note the growth in the use of the branch at West Upton. Though it was open 22 less days than in 1925, 447 more books were circulated.

Tables prepared recently by the Division of Public Libraries say that a Model Town Library has an income of \$1.00 per capita (minimum) and a circulation of 5 books per capita. The circulation of the Upton Library last year was 6 books per capita, the income less than fifty cents per capita.



REPORT OF THE SUPERINTENDENT OF SCHOOLS.

TO THE SCHOOL COMMITTEE OF UPTON:—

I take pleasure in presenting this, my sixth annual report, and with it reports of the Principal of the High School, Supervisors and Nurse

ATTENDANCE.

During 1925-26 there was a still further increase in regularity of attendance and a slight decrease in tardiness. The per cent of attendance, 93.6 is the highest for some years, and is an excellent record when we consider the fact that our schools are open on many stormy days when schools in many other towns are closed.

BUILDINGS.

This year the high school building has been tinted inside. Next year and thereafter, as soon as possible, the following repairs and replacements should be attended to:

Outside painting, Ball School.

Knowlton School:

Desks refinished.

Walls tinted and finish varnished.

New toilets. (The present ones are obsolete and located in an open basement without proper regard to privacy or cleanliness.)

High School:

Desks refinished.

Inside finish varnished.

TRANSPORTATION.

A further increase in the cost of transportation is made necessary by the compulsory liability insurance law just going into effect. This entails an added expense to the barge drivers of about \$260.00 for which it seems only fair to reimburse them.

CARE OF THE SCHOOLHOUSES.

The condition of our schoolhouses as to general cleanliness and minor repairs is far from satisfactory. This is not said in a spirit of criticism of the present janitor, but that the causes of the difficulty may be found and remedies sought.

In the first place, the pay is not sufficient to secure a man's whole time. In order to do the work in three schools, the extremes being a mile apart, an automobile is necessary at an annual expense of at least \$300. Of the \$1200 actually paid the janitor, this gives him a net sum of only \$900, which is at the rate of 41 cents an hour for 44 hours a week for 50 weeks a year. If you reckon it at the rate of 50 cents an hour, the price of unskilled labor, the \$900.00 pays for 36 hours a week for 50 weeks in the year.

A janitor's work is a seven-day-a-week proposition and in winter the time consumed in care of fires including the time consumed in getting from school to school would consume all of the 36 hours per week for which he is being paid at the rate of 50 cents an hour. No time is left for cleaning, for setting a pane of glass, for adjusting a door knob, for packing a leaky steam valve or for doing the numerous odd jobs which, together with proper warmth and cleanliness, go to make up the well-kept schoolhouse.

Nor do we get the full time of the janitor—no able-bodied man could be expected to put in full time for \$900, and a multiplicity of other duties engage the time and attention of the janitor in order that he may earn a living wage.

Two methods might be proposed to remedy the difficulty:

1. Materially increase the pay of the janitor—make it suf-

ficient to pay him a living wage and enough in addition to pay the cost of his automobile—and then require his full time. In addition to this there should be paid during the winter months something for cleaning in addition to what the janitor has time to do.

2. If it is possible to find someone near enough to the Ball School so situated that he would be willing to care for it on the part-time basis and yet able to go in frequently to attend to the fires, it would be entirely feasible to run this building on soft coal at an annual saving of probably \$250. It might be possible to combine the care of this building with that of the Town Hall and Library. It might then be possible for one man to care for the High and Knowlton Schools by putting in the same amount of time as he is now giving to the three schools and for the same salary as he is now getting—as it would still be necessary for him to have an auto to make the trip from school to school.

Whatever the method, a way should be sought to have our schoolhouses adequately cared for, remembering that it is a full-time job, requiring means of transportation and should be paid for on that basis.

SPELLING.

Last Spring a spelling contest was conducted in Worcester County by the Telegram-Gazette to pick a county champion to be sent to Washington to compete in a national contest. Ernest Bartlett of the seventh grade in our schools won the championship of the Towns of Hopedale, Grafton and Upton, and represented these three towns in the contest held in Worcester. While he did not win the County championship, he stood well with the others and gave a good account of himself.

During the last five years, annual tests in the supposedly forgotten art of spelling have been given. In 1922 the Upton schools averaged 29 points lower than other schools taking tests on the same words. Last May the grade medians of the Upton schools averaged 2.7 points above standard, as shown below:

SCHOOL SAVINGS.

Last Spring after permission of the Committee, a School Savings System was started under the direction of the Savings Bank Association of Massachusetts, being financed by the Grafton Savings Bank where the deposits are made. The first deposits were taken April 8, and have been taken each school week since. Below is given a summary of the results:

MANUAL TRAINING.

MR. STANLEY REPORTS:

"Manual Training in this town is carried on much the same as in previous years. In fact not much change is possible when one considers the amount of time given—one day every two weeks. At least one day each week should be given to this work in order that the boys receive even the minimum time other schools allow for Manual Training.

"We have large classes this year. At present the seventh grade is working on a new project, a tool rack. The eighth grade boys are making various projects according to their different abilities.

"We have a fine Manual Training room in this town and it would mean only the additional expense of teaching instruction to give this branch of study the right amount of time."

MUSIC.

MISS BLANCHARD REPORTS:

"We are working to develop in the child:

1. A pleasing voice.
2. A love for good music.
3. The ability to read music at sight.
4. The power to interpret and appreciate good music.

This last item is being stressed in the High School as well as in the graded schools.

"In the Grammar Grades the first steps in music writing are being taught, endeavoring to develop new phases along musical lines. Music note books are being kept by the seventh grade.

"Under the new arrangement for the chorus the work is progressing more satisfactorily.

"Although the High School orchestra is small and we are somewhat handicapped by the lack of a bass instrument and drums, it promises to be of a great help in furnishing music for different school functions."

DRAWING.

MISS BALL REPORTS:

"Emerson says: 'Though we travel the world over to find the beautiful, we must carry it with us or we find it not.'

"Drawing in its many phases is constantly undergoing changes and so it is quite a problem for the towns to keep up with the work done in larger places.

"In November I attended a meeting for Drawing Teachers held at the Framingham Normal School. Each teacher was asked to bring some work done by her pupils. I felt the work in our schools compared quite favorably.

"The work does not change a great deal from year to year. I can see that the pupils are gaining in ability, and in a few cases a decided talent has been discovered. This is always encouraged in every way possible.

"This year the sewing in the seventh grade has started out with much interest and we have already accomplished quite a bit of work. This is due to the fact that the girls are anxious to know how to sew, and then more time can be given by the regular teachers."

REPORT OF THE HIGH SCHOOL PRINCIPAL.

MR. SUPERINTENDENT AND MEMBERS OF THE

SCHOOL COMMITTEE:—

I herewith submit my third annual report as Principal of the Upton High School.

School opened September 8th with an enrollment of 26 seventh grade pupils, 27 eighth grade pupils, 30 freshmen, 15 sophomores, 18 juniors and 7 seniors. The attendance for the fall term has been very good, and the tardiness record shows a big improvement over that of the previous two years.

There is one matter which I should like to call to the attention of the citizens of Upton at this time. It concerns the new system of supervision of the finances of school organizations by a faculty member. This is based on the idea that as these pupil organizations get their money from the townsfolk because they are members of the school, they should not feel free to spend it without supervision by a representative of the faculty. The accounts of the various organizations are kept strictly separated, and the only difference between the new method and the old lies in the fact that by the new method every expenditure on the part of a school organization must be approved by the faculty supervisor.

A school orchestra has been organized, under the direction of Miss Blanchard, our music teacher. The members of this orchestra are practising faithfully and much credit is due them and Miss Blanchard for their progress.

Another innovation is the changed form of the school paper. In its new form, mimeographed, it is the result of more pupil activity, as the whole process of writing and publishing the paper is carried on by the pupils. An additional advantage of this mimeographed paper is that it can be financed by means of the

sales alone, and it is therefore unnecessary to ask donations, in the form of advertisements, from local citizens.

At this time I should like to voice my appreciation of the interest and energy which the entire teaching force are putting into their work.
