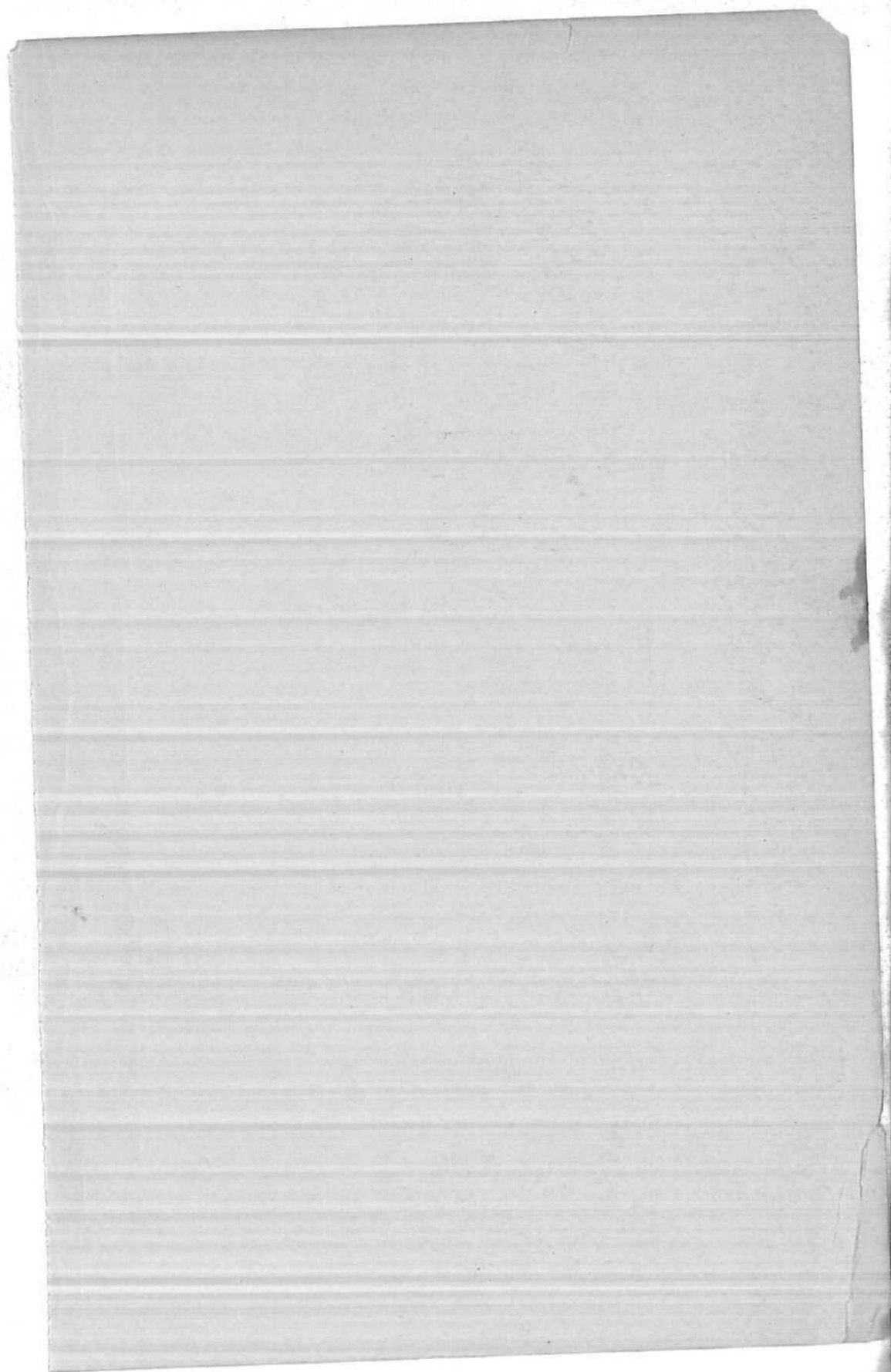

WARRANT FOR ANNUAL TOWN MEETING, FEBRUARY 6, 1928.

Worcester, SS.

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday the sixth day of February, 1928, punctually, at six o'clock forenoon, then and there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, three Selectmen. Town Treasurer, Collector of Taxes, Auditor, five Constables, Tree Warden and one Trustee for the Public Library (to fill a vacancy caused by the resignation of Carrie Q. Whiting), all for one year; one Assessor of Taxes, one Member of the Board of Public Welfare, one Cemetery Commissioner, one School Committee and three Trustees for the Public Library, all for three years: all on one ballot.

The polls shall be closed at four o'clock in the afternoon on said day of meeting.

In accordance with Section 1, Article 1, of the By-laws of the Town of Upton as amended February 12, 1923, the remaining articles of this warrant will be acted upon at an adjourned meeting of the Town held Saturday afternoon, February 11th at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and act thereon.

Article 4. To see if the town will vote to authorize the town treasurer, with the approval of the selectmen, to borrow money in anticipation of revenue of the present municipal year.

Article 5. To hear the report of the Committee appointed at the annual meeting, February 12th, 1927, to investigate and report concerning the tomb at Lakeview Cemetery.

Article 6. To see if the town will vote to consider the article and motion concerning the Westboro road, laid on the table until this annual meeting, by vote April 18th, 1927. The motion was as follows: Moved: That the town appropriate \$1,500.00 to continue improvements on the Westboro road, provided the County and State will each give a like amount or more.

Article 7. To see if the town will vote to authorize the selectmen to sign a five year contract with the Worcester Suburban Electric Company for lighting the streets of the town by electricity, on most favorable terms obtainable, or act in any manner pertaining thereto.

Article 8. To see if the town will vote to appropriate seven hundred and fifty (\$750.00) dollars to finish the sidewalk on Main Street between the Town Hall and the Drug Store at West Upton, or take any action thereon.

Article 9. To see if the town will vote to place one street light on the West side of Nelson Street, between the residences

Article 10. To see if the town will vote to place three street lights on School Street as follows: one near the residence of Fred W. Fiske and two between Charles Barton's and Warren Street, and appropriate forty-eight (\$48.00) dollars for the same, as petitioned for by Lewis Bates and others.

Article 11. To see if the town will vote to close the part of the Christian Hill road that runs easterly from Glen View Street to Fiske Street, as petitioned for by Malcolm C. Temple and others, or take any action pertaining thereto.

Article 12. To see if the town will vote to amend the Town By-laws to authorize the appointment of a finance committee, as petitioned for by Malcolm C. Temple and others, or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting: At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

TOWN OFFICERS.

Article 1. The selectmen having appointed Ross B. Nessy, William F. Parshley, Jr., Michael Murphy and Chamberlain election officers, they were duly sworn to perform the duties of the office by the town clerk.

PROCEEDINGS OF THE ADJOURNED TOWN
MEETING, FEBRUARY 11, 1928.

The meeting was called to order by Malcolm C. Temple, moderator. The warrant was read by the town clerk.

REPORTS OF TOWN OFFICERS.

Article 2. Voted, on motion of John Dearth, to take up the Town Report by departments. Voted: to accept the report of the Town Clerk as printed. Voted: to accept the Assessors' report as printed. Voted: to accept the Collector's reports as printed. Voted: to accept the Treasurer's report as printed. A

motion by John Dearth that the Selectmen's report be not accepted and that the chair appoint a committee to investigate the discrepancies caused much discussion. Attention was called to the differences between the figures of Mr. Vesper's report and the report of the Selectmen. Alvrado Henry offered an amendment that the Town Report be submitted to the State Auditors. Mr. Dearth withdrew his motion in favor of Mr. Henry's. A rising vote was taken, Yes—105, No—40. Voted: that no other reports be considered until after the State Audit.

The following votes were taken: Highways: Voted, on motion of Arthur Cobbett, to appropriate said sum and leave in the hands of the selectmen to appoint a superintendent of streets. Board of Public Welfare: a motion to appropriate \$6,000.00 was amended to appropriate \$3,500.00. The amendment was lost. Original motion carried. Signboards: motion to pass over was lost. Motion to appropriate \$25.00 was amended to appropriate \$50.00. Amendment lost, \$25.00 appropriated. Tree Warden: motion to appropriate \$100.00 was amended to appropriate \$200.00. Amendment carried.

BORROWING MONEY.

Article 4. Voted: That the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year, beginning January 1, 1928, to an amount not exceeding in the aggregate \$30,000.00 and to issue a note or notes therefor, payable within one year, and debt or debts incurred under this vote to be paid from the taxes of said municipal year.

REPAIRS ON TOMB AT LAKEVIEW CEMETERY.

Article 5. Fred W. Wood, chairman of the Committee appointed to investigate the condition of the tomb at Lakeview Cemetery, reported that conditions were not as bad as anticipated and recommended that the present tomb be repaired and that the

sum of \$200.00 be appropriated for that purpose. Voted: to accept the report of the committee and to appropriate \$200.00 to repair the tomb at Lakeview Cemetery. Voted: to leave the repairs in the hands of the Cemetery Commissioners.

WESTBORO ROAD.

Article 6. Voted: to pass over the article.

CONTRACT FOR STREET LIGHTING.

Article 7. Voted: that the matter be left in the hands of the Selectmen.

SIDEWALK ON MAIN STREET.

Article 8. Voted: to appropriate seven hundred and fifty (\$750.00) dollars to finish the sidewalk on Main Street between the Town Hall, Upton, and the Drug Store at West Upton.

LIGHT ON NELSON STREET.

Article 9. Voted: on motion of Lizzie H. Ball, to place one street light on the West side of Nelson Street, between the residences of G. Jenner Aldrich and the Misses Ball, and to appropriate sixteen (\$16.00) dollars for the same.

LIGHTS ON SCHOOL STREET.

Article 10. A motion to pass over the article was lost. Voted: to place three street lights on School Street, one near the residence of Fred W. Fiske and two between Charles Barton's and Warren Street and to appropriate forty-eight (\$48.00) dollars for the same.

Article 11. A motion to pass over the article was lost. The moderator, Malcolm Temple called John Dearth to the chair. Mr. Temple then explained that the piece of road in question was used by very few people. It was badly washed by

the November storm and he estimated that it would cost nearly \$900.00 to repair it. It would seem better to spend that amount of money where more would be benefited. He made a motion that the Selectmen take the proper steps to legally close the road. This caused much discussion. Mr. Colcord said that he wished the road kept open, as he used it to get to his land. Mr. Henry's figures for repairs were between \$700.00 and \$800.00.

Voted: that the Selectmen take the proper steps to legally close the part of the Christian Hill road that runs easterly from Glen View Street to Fiske Street.

FINANCE COMMITTEE.

Article 12. Malcolm Temple read Chapter 388, Acts of 1923. He then offered the following as an amendment to the Town By-laws:

Section 1. There shall be a finance committee consisting of nine citizens of the Town who shall be sworn to a faithful performance of their duties. No town officer elective or appointed shall be eligible to membership on the Finance Committee.

The Board of Selectmen shall appoint, not later than the first day of May, 1928, the said nine citizens, three for one year, three for two years, and three for the term of three years, and annually not later than the first day of May, the said Selectmen shall appoint three members for the term of three years in place of those whose term shall expire in that year.

They shall immediately give public notice of such appointment in a newspaper receiving local distribution.

If any person so appointed does not within fifteen days thereafter take the oath aforesaid, his office shall thereupon become vacant and such vacancy shall forthwith be filled by the Selectmen.

Section 2. The Committee shall meet, choose its own officers, and adopt such rules and regulations affecting its government as may from time to time seem necessary.

Section 3. This Committee shall have power to fill by ballot any vacancies that may occur in its membership by death, resignation, removal from town or other causes.

Section 4. This Committee shall consider matters relating to the appropriation and expenditure of money by the Town, its indebtedness, the administration of its various departments, property valuation and assessments, and other municipal affairs of the Town, and make such report and recommendation to the Town concerning the same, as circumstances and conditions may require.

It shall have authority at any time to investigate the books, accounts and management of any department of the Town; and the books, accounts and records of all departments and officers of the Town shall be open to its inspection.

All officers of the Town shall upon its request, furnish it with facts, figures and other information pertaining to that department.

Section 5. The Finance Committee may furnish a report of any and all matters which have been considered by them, pertaining to the Town, with their recommendations and suggestions, so that the same can be published in the Annual Town Report.

Voted: to adopt the above as an amendment to the Town By-laws.

Voted: To raise the sum of \$56,241.60 by taxation.

Voted: To dissolve the warrant.

ADDITION TO THE BY-LAWS OF THE TOWN OF UPTON

As approved by the Attorney-General, Arthur K. Reading,
April 18, 1928.

FINANCE COMMITTEE.

ARTICLE VII.

Section 1. There shall be a finance committee consisting of nine citizens of the Town who shall be sworn to a faithful performance of their duties. No Town officer elective or appointed shall be eligible to membership on the Finance Committee.

The Board of Selectmen shall appoint, not later than the first day of May, 1928, the said nine citizens, three for one year, three for two years, and three for the term of three years, and annually not later than the first day of May, the said Selectmen shall appoint three members for the term of three years in place of those whose terms shall expire in that year.

They shall immediately give public notice of such appointment in a newspaper receiving local distribution.

Section 2. The committee shall meet, choose its own officers, and adopt such rules and regulations affecting its government as may from time to time seem necessary.

Section 3. This committee shall consider matters relating to the appropriation and expenditure of money by the Town, its indebtedness, the administration of its various departments, property valuation and assessments, and other municipal affairs of the Town, and make such report and recommendation to the Town concerning the same, as circumstances and conditions may require.

It shall have authority at any time to investigate the books, accounts and management of any department of the Town; and the books, accounts and records of all departments and officers of the Town shall be open to its inspection.

Section 4. The Finance Committee may furnish a report of any and all matters which have been considered by them, pertaining to the Town, with their recommendations and suggestions, so that the same can be published in the Annual Town Report.

There is deposited in the Milford Savings Bank, known as the Knowlton School Fund, in trust with the Town Treasurer as trustee, \$23.98 to be used by the School Committee to defray the extraordinary expenses of the Knowlton School Building.

There is deposited in the Worcester County Institution for Savings, known as the Charlotte A. Batchelor School Fund, in trust with the Town Treasurer as trustee, five thousand (\$5,000.00) dollars, the income to be used for the Public Schools. Two hundred thirty seven (\$237.00) dollars and fifty (50c) cents of this income was used this year.

There is deposited in the Milford Savings Bank, known as

the Charlotte A. Batchelor Library Fund, in trust with the Town Treasurer as trustee, five thousand dollars (\$5,000.00) the income to be used for the Public Library. Two hundred twenty-five dollars of this income was used this year.

There is deposited in the Milford Savings Bank as a nucleus of a fund for a library building as voted by the Town February 7, 1925, the sum of \$1,887 32.

There is deposited in the Milford Home National Bank, the sum of five thousand (\$5,000.00) dollars known as the "George W. Knowlton Fund." This Fund is subject to withdrawal by the Town Treasurer. The income only to be used to help the Townspeople who are in distress.

There has been drawn on this fund this year, \$100.00.

Total of this fund as of Jan. 1, 1929 is \$5,486.10.

REPORT OF AN AUDIT OF THE ACCOUNTS OF
THE TOWN OF UPTON.

FOR THE FISCAL YEAR 1927.

Made in Accordance with the Provisions of Chapter 44,
General Laws.

Sir:—

As requested by you, I have made an audit of the accounts of the town of Upton for the fiscal year 1927, and report thereon as follows:

The financial transactions of the town as recorded on the books of the several departments receiving or disbursing money for the town were examined, checked, and verified.

The books and accounts of the town treasurer were examined and checked. The cash book footings were verified; the receipts were checked with the records of the various departments and officials collecting money for the town and with the other sources from which money was paid into the town treas-

ury; and the payments were checked to the selectmen's orders authorizing the disbursement of town funds.

The cash balance on March 3, 1928 was verified by a reconciliation of the bank statement of that date and by an actual count of the cash in the office.

The savings bank books representing the investments of the trust funds, in the custody of the town treasurer, were examined, the income being verified and found to be as recorded on the treasurer's books. Schedules of the trust fund transactions are appended to this report.

The appropriation accounts for highway purposes were examined and checked in detail. It was noted that the total amount expended for highways under Chapter 81, General Laws, was reported by the town treasurer as \$10,499.55, while the amount reported by the state engineer for this purpose was \$10,468.55. The difference, amounting to \$31, represented a payment for demurage on oil not included in the report of the "Chapter 81 Assistant." The "Chapter 81 Assistant" also included a statement relative to the total amount, expended for emergency repairs of highways in 1927, the work thereon not having been done under the supervision of the state engineer. The latter reported as the total expenditures for 1927 for emergency repairs the sum of \$13,457.89, which is \$2,115.94 in excess of the amount paid in 1927 by the town treasurer. The difference is due to the fact that three pay-rolls of January 4, 1928, amounting to \$2,106.44, and an additional variation of \$9.50 were shown by the "Chapter 81 Assistant" as having been paid in 1927.

The books of the collector of taxes for the levies of 1924 to 1926, inclusive, were examined and checked. The abatements were checked to the assessors' records of abatements granted, the payments to the treasurer were verified by a comparison with the treasurer's books, the cash on hand was verified by an actual count, and the outstanding accounts were listed and proved.

The books of the collector of taxes for the levy of 1927 were also examined and checked. The commitment was checked to the assessors' warrants, and the abatements were checked to the

assessors' records of abatements granted. The payments to the treasurer were verified by a comparison with the treasurer's books, the cash on hand was verified by an actual count, and the outstanding accounts were listed and proved.

The outstanding accounts of all levies were further proved by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The town clerk's records for dog licenses issued were examined, and the payments to the county were verified.

The records of the town clerk for appropriations and other financial transactions as voted at the town meetings were examined.

The records of the sealer of weights and measures were examined and the payments to the treasurer were verified.

The records of the treasurer of the Lake View Cemetery Commission were examined and checked. The footings of the cash book were verified and the cash balance on March 3, 1928, was proved.

The surety bonds of the treasurer, the collector, and the town clerk were examined and found to be in proper form.

Appended to this report is a balance sheet showing the financial condition of the town as of December 31, 1927.

While engaged in making the audit, I received the cooperation of the several town officials, and on behalf of my assistants and for myself, I wish to express appreciation.

REPORT OF THE SUPERINTENDENT OF SCHOOLS.

TO THE SCHOOL COMMITTEE OF UPTON:—

I take pleasure in presenting to you my eighth annual report.

BUILDINGS.

For several years the Committee has been trying to put the school buildings in a good condition and with results that are quite apparent. The outside repairs have been practically taken care of and much has been done to the interiors. There remain the following items that should be attended to as fast as funds will allow:

KNOWLTON SCHOOL:

A metal ceiling is needed in the room now occupied by grades four and five.

The woodwork needs varnish throughout the building.

The pupils' desks all need to be refinished after which a coat of varnish each year will keep them in condition.

HIGH SCHOOL:

All the rooms in this building except those on the top floor have recently been retinted. These two rooms—one of them being used as a science laboratory and recitation room, the other, until recently, used for manual training, now being used as the English room—should receive as soon as possible paint for the walls and ceiling and varnish for the woodwork.

All other woodwork in the building except that in the corridors has been recently varnished. The corridors should also receive attention.

Many of the pupils' desks in this building also need refinishing.

The furnishings in the room used as a science laboratory are somewhat dilapidated but probably could be repaired and put in very good condition by being painted and having the tops covered with an acid-resisting asbestos board, all of which could be done at small expense.

RECENT READJUSTMENTS OF CLASSES.

For several years the first and second grades at the Ball School have been too large for one teacher to teach efficiently. The same grades at the Knowlton School have also been at times too large for good work. Since the fall of 1927 these two grades at the Ball school have had a membership varying from 45 to 50 pupils, obviously impossible to handle in a room whose maximum working capacity is 40 pupils. As a temporary expedient the two grades were put on half-time—one attending in the forenoon, the other in the afternoon.

This fall the Committee was urgently requested by the parents of the children involved to find some means of having these children attend full time. After discussing various plans the Committee finally decided on the following:

1st. Transfer the manual training equipment from the High School to the room in the Knowlton School until recently used for a club room and assembly room.

2nd. Using the room in the High School, thus vacated, for the English classes.

3rd. The room formerly used for the English classes became available for the sixth grade which, until that time, had been in the Ball and Knowlton Schools, being grouped with the fifth grades in those schools.

4th. This left five grades in the Ball and Knowlton Schools which were grouped as follows without having any group too large for one teacher:

The above plan necessitated the purchase of about \$200.00 worth of furniture and the employment of an additional teacher.

The highest average membership of all the schools since 1922 has been 318; the lowest, 305. During the school year 1927-'28 the average membership was 312, exactly the same as in 1922-'23.

The average membership of the pupils in the high school

building has fluctuated from a low mark of 107 to a high mark of 125 but is on the average slightly larger than in 1922-'23.

The average membership at the Center—now the Geo. S. Ball—School, has varied from a low mark of 83 in 1925-'26 to a high mark of 101 in 1927-'28, but in 1922-'23 the number was 93, about five per cent less than in 1927-'28. The November, 1928 enrollment for these same grades was 117.

The average membership at the Knowlton school was 105 in 1922-'23, 100 in 1926-'27, 90 in 1927-'28 and the same grades totaled 99 in November, 1928.

The above figures are affected somewhat by enforced absence due to epidemics of children's diseases and also by the moving in and out of town of some families, but do not indicate any general tendency to an increase of the school population.

The estimated enrollment for the fall of 1929 shows the advisability of planning to continue to house the sixth grade at the High School during the coming school year of 1929-'30.

FIRST GRADE ENTRANCE AGE.

The following table shows the number in Grade 1 in June and the corresponding number of these pupils in Grade 2 the following September:

These show that on the average about 20% of the pupils of Grade 1 are not promoted but spend two years in that grade. In a majority of cases this inability to accomplish the work of Grade 1 is due to immaturity as many of these pupils do fair work in later grades after having been two years in Grade 1. In other words, many pupils at five and one-half years, the age at which we allow them to enter, are too immature to do first grade work and would be better off—since we have no kindergartens in which to place them—to remain out of school a year, when the added maturity would greatly increase their chances of doing satisfactory school work.

It would seem to me advisable to increase the entrance age to five years, nine months and perhaps—eventually—to six years. This might be done with the proviso that children five and a half years old but less than five years, nine months, might be admitted by taking a test indicating they have reached a sufficient maturity to do first grade work, as many children of that age are able to do. The latter plan is now followed in several places in Massachusetts with satisfactory results.

SAFETY.

The teachers of Knowlton School under the direction of Mrs. Durgin have organized their pupils into squads under the direction of pupil leaders to insure greater care when crossing streets and to keep pupils on the side-walks on their way from school. The plan seems to be working out well and seems to be particularly needed at this school as a large proportion of its pupils have to cross the main highway on their way home.

TESTS.

Tests have recently been given in reading, arithmetic, language and spelling: the results being tabulated below. On the average, our pupils tested about the same as pupils in similar grades in other communities where the same tests have been given.

SCHOOL COSTS.

The people generally have an erroneous impression that the schools cost the Town \$24,000 a year since that is the amount last appropriated for this purpose. The actual cost to the Town is, however, considerably less than that amount since the state has various funds intended expressly to help small towns and to which the wealthier portions of the State contribute more heavily than the less wealthy. REPORT OF THE HIGH SCHOOL PRINCIPAL.

Upton, Mass., Dec. 19, 1928.

MR. SUPERINTENDENT AND MEMBERS OF THE
SCHOOL COMMITTEE:—

My report to you this year is to be very brief. Since the last report was submitted the course of the school has gone along very much as in past years with the usual classes and athletic, dramatic, social and literary activities. We have tried both in the classroom and in the allied activities to enable as many children as possible to take part in purposeful activity leading to the achievement, as far as they were concerned, of the two main objectives of education: Good citizenship, and a rich and full life for each individual pupil.

During the last month we welcomed to the building the sixth grade, with Miss Nelson. This class is occupying the room on the first floor. The classes formerly held there meet in what was recently the manual training room, on the north side of the third floor. This is a bright, airy room, and is entirely satisfactory. As far as can be judged at present, the arrangement by which the sixth grade is housed in this building is quite successful. There is practically no inconvenience to the high school classes and there is given a certain balance to the school which has been lacking hitherto. By this I mean that there exists a close relationship between the pupils of the sixth and seventh grade which makes possible a unification of the two groups of children of the same age which I believe is of mutual benefit. This works itself out in recess periods together, special programs, competition on the playgrounds, etc.

We were fortunate to retain the excellent teaching staff of last year and each teacher has continued to give service of the very highest order.

In closing, let me express to you the appreciation of the entire teaching force for the assurance of your support in all our undertakings.

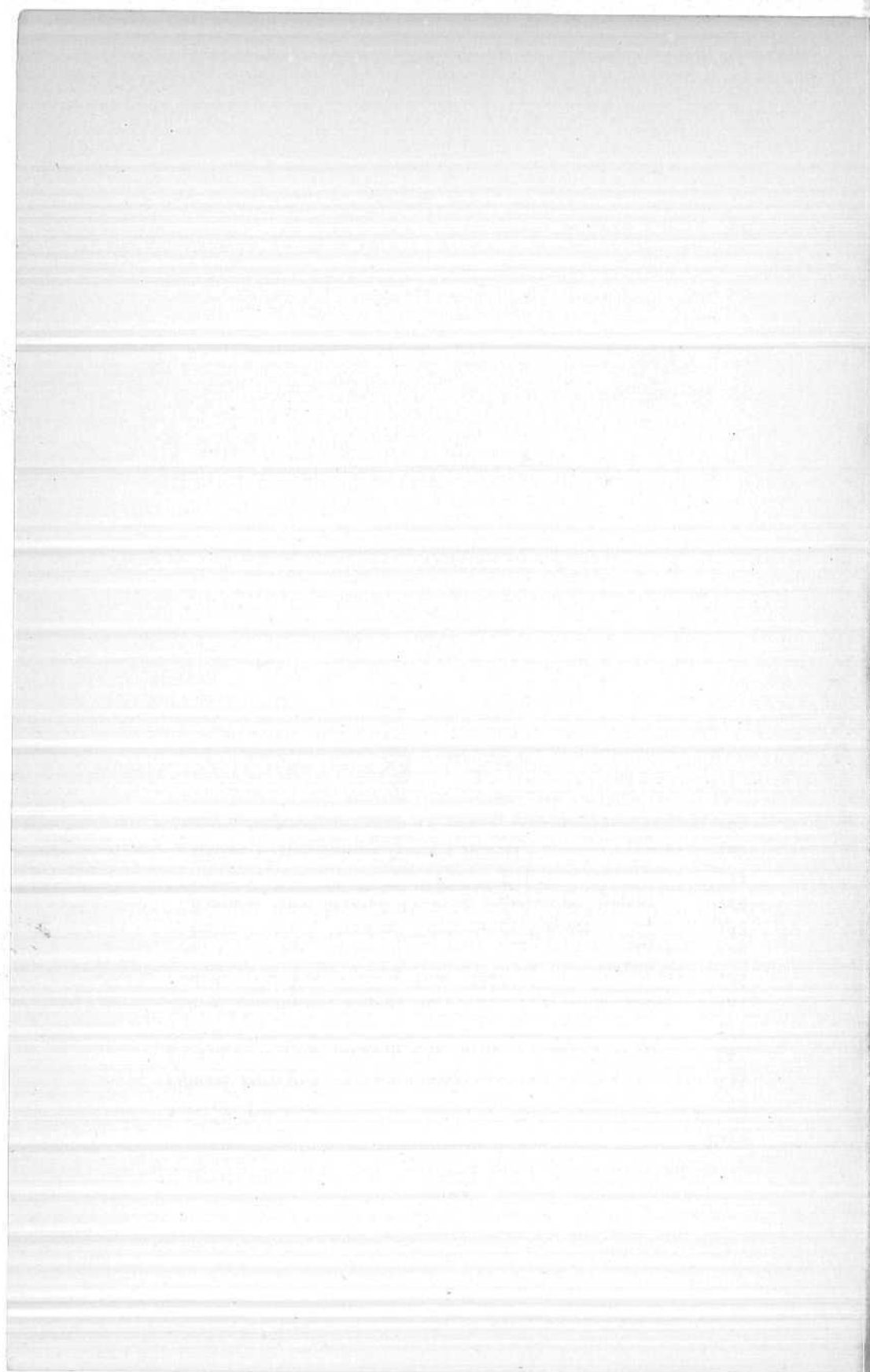
