

UPTON RECORDS, 1932.

WARRANT FOR ANNUAL TOWN MEETING,
FEBRUARY 1, 1932.*Worcester, SS.*

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you
are directed to notify the inhabitants of the town of Upton,
qualified to vote in Elections and in Town Affairs, to meet at
the Town Hall, in said Upton, on Monday, the first day of
February, 1932, punctually, at six o'clock A. M., then and
there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the
ensuing year: Moderator, three Selectmen, Town Treasurer,
Collector of Taxes, Auditor, five Constables, Tree Warden and
one Cemetery Commissioner (to fill a vacancy caused by the
death of Charles E. Barbour), all for one year; Town Clerk,
one Assessor of Taxes, one member of the Board of Public
Welfare, one Cemetery Commissioner, one School Committee
and three Trustees for the Public Library, all for three years;
all on one ballot.

The polls shall be closed at four o'clock in the afternoon
on said day of meeting.

In accordance with Section 1, Article 1 of the By-Laws of the Town of Upton as amended February 12, 1923, the remaining articles of this warrant will be acted upon at an adjourned meeting of the Town held Saturday afternoon, February sixth, at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and act thereon.

Article 4. To see if the town will vote to authorize the town treasurer, with the approval of the selectmen, to borrow money in anticipation of revenue of the present municipal year.

Article 5. To hear the report of the committee appointed to revise the Town By-Laws and take any action pertaining thereto.

Article 6. To see if the town will vote to appropriate the sum of two thousand (\$2,000.00) dollars for further extension of the Westboro Road, provided the State and County will appropriate \$4,000.00 each, as recommended by the Finance Committee, or act in any manner pertaining thereto.

Article 7. To see if the town will vote to establish a Road Machinery Account, to which shall be credited all receipts received for the use or rental of road machinery, the proceeds to be appropriated as voted by the town for road machinery purposes, or take any action in relation thereto.

Article 8. To see if the town will vote to appropriate the sum of \$1,000.00 to establish a Road Machinery Fund for the purpose of purchasing, repairing and operating road machinery.

Article 9. To see if the town will vote to accept the provisions of Chapter 458, Acts of 1931, regarding insurance for town trucks, as recommended by the Finance Committee, or act in any manner relating thereto.

Article 10. To see if the town will vote to increase the salaries of the Board of Public Welfare as follows: the clerk from \$65.00 to \$90.00 per annum, the other members from \$40.00 to \$50.00 per annum, as recommended by the Finance Committee, or act in any manner pertaining thereto.

Article 11. To see if the town will vote to dispose of the Town Farm, as advised by the Finance Committee, or take any action relating thereto.

Article 12. To see if the town will vote to appropriate the sum of one hundred (\$100.00) dollars to improve the condition of the "Parson Wood" elm tree, so-called, in Upton Square, as recommended by the Finance Committee, or act in any manner pertaining thereto.

Article 13. To see if the town will vote to appropriate the sum of fifty (\$50.00) dollars for the care of the Town Dump, so-called, as recommended by the Finance Committee, or take any action thereon.

Article 14. To see if the town will vote to remove the three street lights on Depot Street in Upton, as recommended by the Finance Committee, or act in any manner pertaining thereto.

Article 15. To see if the town will vote to place three street lights on Eames Road, and appropriate \$50.00 for the same, as petitioned for by Charles H. James and others.

And you are directed to serve this Warrant by posting up attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

FEBRUARY 1, 1932.

COMMONWEALTH OF MASSACHUSETTS.

Worcester, SS.

Pursuant to the foregoing warrant, the legal voters of the Town of Upton met in the Town Hall in said Upton, on Monday, the first day of February, 1932. The meeting was called to order at six o'clock A. M. by the town clerk, who then read the warrant and the officer's return thereon.

TOWN OFFICERS.

Article 1. The selectmen having appointed Henry E. Allard, Kenneth W. Wood, Joseph W. Gorman and Henry A. Stearns, election officers, they were duly sworn to faithfully perform the duties of the office by the town clerk.

Cards of instruction and specimen ballots having been posted as the law directs, a package said to contain 1100 official ballots, to be used at this election, was delivered to the ballot clerks.

The ballot box was then shown to the voters present to be empty, the index being set on 0000, it was locked and the keys thereof were given to Herbert A. Bagley, constable in attendance at said meeting.

The polls were declared open at six o'clock A. M.

The following persons having been appointed by the selectmen to canvass the vote, Eleanor B. Adair, Grace M. Murphy, George G. Newton and Edwin W. Sadler, they were duly sworn by the town clerk.

At the close of the polls, the register on the ballot box stood at 788. The check-lists were compared and showed that 788 had voted.

REPORT OF
FINANCE COMMITTEE
UPTON, MASSACHUSETTS

FEBRUARY, 1932.

To the Voters of Upton:—The Finance Committee recommends the following appropriations. The totals deal with appropriations only and will not balance with Town Reports. For the second consecutive year no department overdraw its account.

The taxpayers of Upton are faced with an increase of taxes this year largely due to the provisions of the "Old Age Assistance" law. The appropriations for town aid this year total \$19,400 with a very definite possibility that this amount will have to be increased later. In as much as the Town Farm has been no aid to the Town, even in this depression, the Finance Committee still affirm that its disposal or elimination would be advisable.

REPORTS OF TOWN OFFICERS.

Article 2. Voted: to accept the reports of town officers as printed.

APPROPRIATIONS.

Article 3. The appropriations as recommended in the Report of the Finance Committee were taken up and acted upon separately.

Voted: on motion of the Malcolm Temple to pass over the appropriation for Public Welfare until after acting on Article 11.

In connection with Old Age Assistance, William Teachout had prepared a chart listing nearby towns, their population and their appropriation for Old Age Assistance and showing graphically that Upton, in proportion to its population was asking for a much larger appropriation than any other town and that some towns of the same size were not using even one-quarter of the sum asked for here.

Voted: on motion of Malcolm Temple, to appropriate \$5,000.00 for Old Age Assistance and refer to the Finance Committee for further information in regard to our policy of extending aid. A rising vote was taken: Yes—74, No—50.

BORROWING MONEY.

Article 4. Voted: that the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year, beginning January 1, 1932, to an amount not exceeding in the aggregate \$30,000.00 and to issue a note or notes therefor, payable within one year, and debt or debts incurred under this vote to be paid from taxes of said municipal year.

REPORT OF BY-LAWS COMMITTEE.

Article 5. Eben T. Hall reporting for the committee appointed to revise the Town By-Laws said that the committee had made some progress but needed more time and asked for an appropriation of \$50.00.

Voted: To accept the report and to appropriate \$50.00 for the use of the committee.

WESTBORO ROAD.

Article 6. Voted: on motion of John E. Dearth, to appropriate the sum of two thousand (\$2,000.00) dollars for further extension of Westboro Road, provided the State and County will appropriate \$4,000.00 each for the same.

ROAD MACHINERY ACCOUNT.

Article 7. Voted: to establish a Road Machinery Account, to which shall be credited all receipts received for the use or rental of road machinery, the proceeds to be appropriated as voted by the town for road machinery purposes.

ROAD MACHINERY FUND.

Article 8. Voted: to appropriate the sum of \$1,000.00 to establish a Road Machinery Fund for the purpose of purchasing, repairing and operating road machinery.

Article 9. The moderator read Chapter 458, Acts of 1931. Voted: to accept the provisions of Chapter 458, Acts of 1931, regarding insurance for town trucks.

SALARIES OF BOARD OF PUBLIC WELFARE.

Article 10. Voted: to pay the Board of Public Welfare as follows: the clerk \$90.00 per annum, the other two members \$50.00 per annum.

TOWN FARM.

Article 11. Voted: as moved by Malcolm Temple and amended by Eben Hall, to appoint a committee of seven to bring in all information in regard to selling the Town Farm and caring for the inmates. A rising vote was taken: Yes—97, No—17. The following committee was appointed from the floor: Malcolm C. Temple, Charles W. Childs, Edward B. Newton, William T. Teachout, Eben T. Hall, Albert B. Stearns, John E. Dearth.

Voted: to appropriate \$7,000.00 for Public Welfare.

"PARSON WOOD" ELM TREE.

Article 12. Henry R. Hoyle read a list of companies who had given estimates of cost of improving condition of the tree, all bids were for amounts not to exceed \$100.00.

Walter H. Cambo of Whitinsville spoke from the floor. He advised taking out all dead wood, cabling limbs that hang over the street, putting tree in safe condition, but not touching large cavity at present. Voted: to appropriate \$100.00 to improve the condition of the "Parson Wood" elm tree, so-called, in Upton Square.

TOWN DUMP.

Article 13. Voted: on motion of George Poirier, to appropriate the sum of fifty (\$50.00) dollars for the care of the Town Dump.

LIGHTS ON DEPOT STREET.

Article 14. Voted: to remove the three street lights on Depot Street in Upton.

Article 15. Voted: to pass over the article.

Voted to raise the sum of \$67,896.73 by taxation.

Voted: to dissolve the warrant.

Parents and others are requested to carefully examine the above lists and if any errors or omissions are discovered report them at once to the town clerk, that the record may be corrected, as it is of importance that the records of Vital Statistics should be complete. Herewith are extracts from the General Laws, Chapter 46.

GENERAL LAWS, CHAPTER 46, SECTION 3.

(As Amended by Chapter 281, Section 1, Acts of 1925).

Every physician, or hospital medical officer registered under section nine of chapter one hundred and twelve, in this chapter called officer, shall keep a record of the birth of every child in cases of which he was in charge, showing date and place of birth, the name, if any, of the child, its sex and color, the name, age, birthplace, occupation and residence (including the street number, if any, and the ward number, if in a city) of each parent, the maiden name of the mother and the name of the physician or officer, if any, personally attending the birth. If the child is illegitimate, the name of, and other facts relating to the father shall not be set forth except upon written request of both the father and mother; provided, that if an illegitimate child shall have become legitimate by the intermarriage of his parents and the acknowledgment of his father, as provided in section seven of chapter one hundred and ninety, prior to the mailing or delivery of any report herein required, such report shall read, in all respects, as if such child had been born to such parents in lawful wedlock. Said physician or officer shall, within fifteen days after such birth, mail or deliver to the clerk or registrar of the town where such birth occurred, a report stating the facts hereinabove required to be shown on said record and also the said written request, if any; provided, that if said report is not so made within forty-eight hours after such birth, said physician or officer shall, within said

forty-eight hours, mail or deliver to said clerk or registrar a notice stating the date and place of the birth, the street number, if any, the ward number, if in a city, and the family name. Upon presentation to him of a certificate of the town clerk stating that any such birth has been duly reported, the town treasurer shall pay to such physician or officer a fee of twenty-five cents for each birth so reported. Any physician or any such officer violating any provision of this section shall forfeit not more than twenty-five dollars. The said town clerk or registrar shall file daily with the local board of health a list of all births reported to him, showing, as to each, the date of birth, sex, color, family name, residence, ward and physician or officer in charge.

GENERAL LAWS, CHAPTER 46, SECTION 6.

Parents, within forty days after the birth of a child, and every householder, within forty days after a birth in his house, shall cause notice thereof to be given to the clerk of the town where such child is born * * *.

Blanks may be obtained upon application to the town clerk.

TOWN TREASURER'S STATEMENTS.

There is deposited in the Milford Savings Bank, known as the Knowlton School Fund, in trust with the Town Treasurer as trustee, \$28.91, to be used by the School Committee to defray the extraordinary expenses of the Knowlton School Building.

There is deposited in the Milford Home National Bank, known as the Ella (Whitney) Risteen Fund, in trust with the Town Treasurer and School Committee as Trustees, one thousand dollars, (\$1,000.00) the income to be divided between the two pupils in our public schools who make the most progress during each year. The amount of the Fund, Jan. 1, 1933, \$1,020.00. \$45.50 interest of this fund was used this year.

There is deposited in the Worcester County Institution for Savings, known as the Charlotte A. Batchelor School Fund, in trust with the Town Treasurer as trustee, five thousand (\$5,000.00) dollars, the income to be used for the Public Schools. \$199.98 was used this last year.

There is deposited in the Milford Savings Bank, known as the Charlotte A. Batchelor Library Fund, in trust with the Town Treasurer as trustee, five thousand dollars (\$5,000.00) the income to be used for the Public Library. \$212.50 was used last year.

There is deposited in the Milford Savings Bank as a nucleus of a fund for a library building as voted by the Town, February 7, 1925, the sum of \$2,282.61.

LIBRARIAN'S REPORT.

TO THE TRUSTEES OF THE UPTON LIBRARY:—

The librarian herewith submits her annual report following which are library statistics and the catalog of new books.

That the town may receive the income from the Carpenter Fund of \$1,000.00, at least \$60.00 worth of books must be added each year to the "Carpenter Alcove." This has been done the past year.

During April and May about seventy pictures of places of interest from Mt. Desert, Maine to Mt. Vernon, Virginia, were on exhibition. These were loaned to the library by the Woman's Education Association.

Through the kindness of Henry R. Hoyle, who made and gave it, a sign with the name of the library in gold letters is now in place above our entrance to the Hall.

Friday afternoon the Freshman class of the High School visited the library and the librarian gave a short talk on the use of the reference books and the card catalog. REPORT OF THE SUPERINTENDENT OF SCHOOLS.

TO THE SCHOOL COMMITTEE OF UPTON:—

The following is my twelfth annual report:

SCHOOL COSTS.

The present financial depression has increased the burden of local taxation to such an extent that it is imperative that those in control of the expenditure of public money scrutinize the items of those expenditures with the utmost care. The school budget,—the largest single item in the Town's costs,—is appropriated for the purpose of training the children of the Town for intelligent citizenship. It seems to me that any consideration of reductions in that budget should first and always be guided by the following:

1. That there be no lowering of standards in caring for the health of the pupils and the cleanliness of the schools.
2. That the quality of leadership in the schools, be not lowered by lowering the standard of efficiency or the morale of the teaching staff.
3. That no educational opportunity now offered be removed unless absolutely necessary.
4. That, if curtailments of educational opportunities must be made, it is the function and duty of the school committee to decide what those curtailments should be.

MEANS OF REDUCING COSTS.

Reductions in school costs would have to be made in one or more of the following ways:

1. Reducing the number of teachers by increasing the number of pupils per teacher.
2. Elimination of courses.
3. Salary reductions.
4. Curtailments in transportation.
5. Curtailment of books and supplies.

REDUCTION IN NUMBER OF TEACHERS.

This is an average of 35 pupils per teacher in the elementary grades, all of whom will have two grades each. The sixth grade will be very large and can only be accommodated with the present teaching force by dividing the grade into three parts,—one part in each of the three schools. The average number of pupils per teacher in the high school will

be 25,—the maximum number recommended by the State Department for approval of high schools of A grade. No reduction in the number of high school teachers can be made without elimination of essential courses, nor in the number of elementary teachers without creating classes so large that seating-room would not be available.

ELIMINATION OF COURSES.

No elimination of courses will save any appreciable amount of money unless it makes possible salary reductions brought about by dismissal of teachers. In considering this it is best to divide the courses into two classes.

1. Courses taught by teachers serving full time.
2. Special courses taught by part time teachers.

As no reduction of the number of full-time elementary teachers is possible the question of elimination of courses taught by full-time teachers must be confined to the high school alone. At the present time we are giving two courses, academic, or college preparatory, and commercial, the latter added a few years ago without increasing the number of high school teachers. If the latter course were eliminated no reduction in the number of teachers would be possible as the pupils taking the commercial subjects would have to be enrolled in other classes making many of them so large that they would have to be divided, for lack of rooms large enough to accommodate them. To eliminate this course would compel all the pupils to take what is practically a college preparatory course although only a small portion plan to go to college, and would deprive a large percentage of them from having the opportunity of training in a course, for them more practical.

The Town is spending \$200. a year for a teacher of drawing who, besides directing the work of the elementary grades is giving instruction to groups of high school pupils, a training which pupils who go to normal schools and colleges find to be necessary.

The cost of music instruction and supervision is \$300. per year. This teacher also gives instruction in the high school which,—as in the case of the art instruction,—can be given only by some one specially trained for that work.

The cost of instruction in the domestic arts is confined to the cost of gas and electricity, the expenses of the student teacher who comes from the state college at Framingham, and some small costs for equipment and supplies,—most of which are paid for by the contributions by pupils, taking the course and by the \$100. a year contributed by the Upton Women's Club.

The manual instructor gets a salary of \$200. a year. He has had long experience and is giving instruction in the use of tools and training pupils of grades 7 to 8 in manual skill,—opportunity for which few or none of them would get in any other way.

If all the above courses were eliminated, the saving would be \$750. or \$800. a year while the loss of the pupils in educational opportunity would be considerable.

SALARY REDUCTIONS.

No considerable saving can be made without taking the greater portion of it from the item of *major cost*,—salaries of teachers, superintendent and janitor. During the last few years the salaries of teachers have amounted to about \$15,000. annually, while the state has returned to the town from \$7,000. to \$7,500., (in 1932 it was \$7,458.04) making the net cost of salaries of teachers from \$7,500. to \$8,000. That our salaries are low compared with the state standards is shown by the fact that if the salaries of eight of the elementary teachers reported to the state the past year had been \$750. more than they were the town would have received \$425. more from the state.

Upton salaries are among the lowest paid in towns of the state of similar size as is shown in the following table:

The teachers, superintendent and janitor have unanimously expressed their willingness to cooperate in any general economy movement which may be found necessary. But before the salaries of the teachers are reduced I think careful consideration should be given to what is just and whether most if not all are not now serving for as little as they ought.

TRANSPORTATION.

It is difficult to see how we could do with less transportation. Two of the drivers are now under contract at prices that at the time were as advantageous as the committee could obtain, considering the equipment and service required. During the year laws have been passed requiring a high standard of equipment for school busses and inspection four times a year. Whether any immediate saving can be made in this item depends on the consent of those now under contract and future savings depend on the prices the committee is able to get for the service and equipment required.

BOOKS AND SUPPLIES.

These items have always been conservatively supplied and carefully used. Prices of paper and some other items have dropped sharply during the past year or so the cost of these items being about \$340. less than last year and \$60. less than the average cost of the last four years. No further saving could be made without curtailing essential supplies and lowering the standard of teaching.

SUMMARY.

To recapitulate the above:

1. No reduction of the corps of full-time teachers is practicable, or even possible without creating conditions which will seriously impair efficiency.
2. Elimination of any full-time courses would not result in any saving. Part-time courses can be elimi-

nated if the town wishes for the slight saving effected to deprive the pupils of valuable educational opportunities.

3. Teachers, superintendent and janitor are willing to cooperate in any general economy measures found necessary, but the salaries of teachers are now very low and any considerable reduction would be unjust.
4. Cost of transportation depends on prices the committee is able to get, and reduction in cost of books and supplies cannot be made without curtailing essentials.

The Town appropriated \$25,500 for schools of which a balance of \$1,070.76 remains unexpended. Subtracting this unexpended balance and the amount shown above as received from the state leaves \$15,949.62, the amount of the school costs for 1932 that comes from local taxation.

DRAWING.

MRS. STUART REPORTS:

Just ten years have elapsed since I resigned from the position of drawing teacher in the public schools of Upton. It was with the deepest sense of appreciation that I accepted this opportunity of once again taking up this most enjoyable work.

It would be impossible for anyone who has been in the school work right along to get the same perspective as that of one who has stepped out of the picture completely for a period of years before coming back. I had no idea that so much progress had been made, so many changes for the better taken place, all making possible a much higher standard of scholarship and citizenship.

Perhaps the most noticeable improvement in the discipline of grades 6, 7, 8 at the high school building. As a junior high, confusion and disorder made accomplishment out of the question. I once approached those classes with dread, now I look forward to them, they are doing fine work.

We have organized a high school class this year. The first, to my knowledge, that Upton high has ever had. We have one period per week and meet in the domestic science room. Since it is elective the class is small, but all pupils show unquestionable signs of talent, some to a surprising degree. We are correlating our art work with other activities of the school. If these periods were doubled, and if we could have a few necessary, inexpensive materials to work with, I know the results would be well worth the extra time and the small expense involved.

I have one criticism to make. As every one knows the Knowlton School is situated in front of a hill, this darkens one of the rooms more or less at all times. On dark, stormy days it is almost impossible to read, write or draw in any of the rooms and especially in the darkest room. There are lights at the high school and at the Ball School. During the past year it was thought necessary to pay out nearly two hundred dollars to wire the town farm for electricity for the benefit of the few residents there. But the fact that precious school hours are being only partially utilized, and that the eyes of at least one hundred girls and boys is being needlessly impaired, is of no importance. Why the parents themselves are not concerned about this I cannot understand. It is a most wasteful measure of economy.

In closing I wish to say that the fine attitude shown by our girls and boys in my work is a constant source of inspiration toward greater achievement for the coming months.

However, most of all I appreciate the splendid cooperation of each and every teacher. It is their never failing help that is making possible the beginning of a promising future for the art department. It is by no mere chance that our schools have been climbing steadily forward, but rather because of the hard work of our teaching force. We must allow no false idea of economy to under estimate the value of their services, nor allow our schools to slide backward, destroying quickly what has been slowly and painfully gained.

All pupils were examined by school physician Dr. Capen assisted by school nurse.

Arrangements are made for the Chadwick Clinic to be held in January. More than 80% of our pupils have returned consent slips to be given this test.

MANUAL TRAINING.

MR. STANLEY REPORTS:

Instruction in Woodwork is offered to the boys of the seventh and eighth grades who have this year shown as much, if not more, interest in this line of work. However, due to very limited time we cannot accomplish as much in this department as we wish.

The articles made by the seventh grade boys are necessarily simple in design and construction, such as key boards, pen and pencil racks, necktie holders and book supports. The boys in the eighth grade construct larger and more difficult projects,—making table lamps, taborets, fern stands, foot stools, etc. It is to be regretted that when these pupils develop strong interest and good ability in this subject that they cannot pursue it during their high school course.
