TOWN CLERK'S REPORT.

WARRANT FOR THE ANNUAL TOWN MEETING,
FEBRUARY 4, 1946.

THE COMMONWEALTH OF MASSACHUSETTS.

Worcester, SS.

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the Town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday, the Fourth day of February, punctually, at Seven o'clock forenoon, then and there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, Town Treasurer, three Selectmen, Collector of Taxes, Auditor, five Constables, Road Commissioner and Tree Warden, all for one year; one Assessor of Taxes, one member of the Public Welfare Board, one member of the School Committee, one Cemetery Commissioner and three Trustees of Public Library, all for three years.

All of the above to be voted for upon one ballot.

The polls shall be closed at 8 o'clock P. M. on the day of said meeting. In accordance with Article 2, Section 1 of the By-Laws of the Town of Upton, the remaining articles contained in this warrant will be acted upon at an adjourned

meeting of the Voters in Town Hall, Saturday afternoon, February 9, 1946, at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To hear reports of any committees appointed by the town.

Article 4. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1946, and to issue a note or notes therefor, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 5. To raise such sums of money as may be necessary to defray town charges for the ensuing year, or act thereon.

Article 6. To see if the Town will vote to authorize the transfer of unexpended balances of following special appropriations to surplus revenue in the Town's Treasury: 1941, Portable Lighting system, \$1.50; 1942, Observation Tower, \$21.88; 1942, Town Hall Toilets, \$24.17; 1943, Counsel Fees and Expenses, \$33.00; 1943, Moroney Brook Bridge, \$2.92; High School Building, 33 cents; Civilian Defense, \$115.73; Rationing Board, \$72.30, and 1945, Russell Avenue Street light, \$3.39, totaling Two Hundred Seventy-five Dollars and Twenty-two cents (\$275.22) or act in any manner pertaining thereto.

Article 7. To see if the Town will vote to establish the salary of the chairman of the Cemetery Commission at Twenty-five Dollars (\$25.00) per annum, or take any action in relation thereto.

Article 8. To see if the Town will vote to establish the salary of the chairman of the Assessors of Taxes at Four Hundred Dollars (\$400.00), and each of the other Two Assessors of Taxes at Three Hundred Dollars (\$300.00) as requested by the Assessors, or take any action in relation thereto.

Article 9. To see if the Town will vote to raise and appropriate a sum of Four Hundred Eighty-one Dollars (\$481.) for expenses in 1946, as requested by the Board of Assessors, or take any action in relation thereto.

Article 10. To see if the Town will vote to appropriate the proceeds of the 1945 Dog Tax Refund, the sum of Five Hundred Twenty-seven Dollars and Fifty-two Cents (\$527.52) to the School Account, or take any action in relation thereto.

Article 11. To see if the Town will vote to raise and appropriate, or transfer from unappropriated available funds in the treasury, a sum of money for Chapter 81 Highways, or take any action in relation thereto.

Article 12. To see if the Town will vote to raise and appropriate, or transfer from unappropriated available funds in the treasury, a sum of money for Chapter 90 Highway Maintenance or take any action in relation thereto.

Article 13. To see if the Town will vote to raise and appropriate Seven Hundred Twelve Dollars and Eighty-eight Cents (\$712.88) for payment of a Snow Removal bill incurred in 1945, or take any action in relation thereto.

Article 14. To see if the Town will vote to raise and appropriate Three Hundred and Fifty Dollars (\$350.00) for the purchase of Snow Fencing to be used by the Highway Department, or take any action in relation thereto.

Article 15. To see if the Town will vote to instruct the Assessors of Taxes to use Twelve Thousand Dollars (\$12,000.) from unappropriated available funds in the treasury in establishing the 1946 Tax Rate, or take any action in relation thereto.

Article 16. To see if the Town will vote to raise and appropriate Two Hundred Dollars (\$200.00) to be used under the supervision of the Selectmen for improvements to the town's Parks and Howard R. Leland Athletic Field, or take any action in relation thereto.

Article 17. To see if the Town will vote to raise and appropriate, or transfer from unappropriated available funds in the treasury, Two Thousand Dollars (\$2000.00) for Chapter 90 Highway Construction on Mendon Street, or take any action in relation thereto.

Article 18. To see if the Town will vote to accept the provisions of Chapter 723, Acts of 1945, being an act to authorize the establishment and maintenance of municipal departments and of districts for furnishing information, advice and assistance to veterans of World War II or other veterans.

And you are directed to serve this Warrant by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-Offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE ANNUAL TOWN MEETING
FEBRUARY 4, 1946.

THE COMMONWEALTH OF MASSACHUSETTS.

Worcester, SS.

Pursuant to the foregoing warrant, the legal voters of the Town of Upton met in Town Hall, in said Upton, on Monday, the Fourth Day of February, 1946. The meeting was called to order at Seven o'clock, A. M. by Moderator Malcolm C. Temple.

The call of the meeting by the Selectmen and Constable's return were read by the Town Clerk.

Moderator Temple announced that reading of special articles in the warrant, excepting Article 1, would be waived at this time as they were to be read at the adjourned Town Meeting, February 9, 1946, unless there was opposition. There was no opposition.

On motion of Merrill S. White, duly seconded, it was voted to adjourn action on Articles 2 to 18, inclusive, until Saturday, February 9, at 2 P. M.

Article 1. William A. Prentiss, George V. DesBarres, Patrick Slattery and Raymond K. Smith, having been appointed by the Selectmen as election officers, with Police Officer J. Harry Shears in charge of the ballot box, were sworn to faithfully perform their duties by the Town Clerk. Moderator Temple opened the ballot box which was shown to be empty. Indicator on ballot box was set at 0000. Keys to the ballot box were placed in custody of Mr. Shears.

Cards of instruction to voters and specimen ballots had been posted as the law directs. A wax-sealed package purporting to contain 1500 official ballots as received by the Town Clerk from the printer was delivered to Messrs. Prentiss and DesBarres at the so-called check-in table.

Ernest L. Aldrich was the first voter to cast his ballot after the polls were declared open by Moderator Temple. Mrs. Harriet F. Edmond was the first woman to cast a ballot.

At hourly intervals during the voting hours, the ballot box registered the following number of ballots cast: 8 A. M., 31 ballots; 9 A. M., 50; 10 A. M., 80; 11 A. M., 133; 12 noon, 180; 1 P. M., 259; 2 P. M., 325; 3 P. M., 408; 4 P. M., 468; 5 P. M., 542; 6 P. M., 693; 7 P. M., 779, and 8 P. M., 879.

Moderator Temple closed the polls at 8 P. M. Upton had 1289 registered voters eligible to vote. Sixty-eight per cent of the town's voting populace cast their ballots during the voting hours, 454 men and 425 women. Weather was fair throughout the day.

Following persons having been appointed by the Selectmen to canvass the vote, reported at 2 P. M. and were duly sworn by the Town Clerk to perform their duty as tellers: Miss Grace M. Murphy (D), Mrs. Margaret A. Gurry (D), Ralph A. Thompson (R), Burton W. Walker (R), Mrs. Elinor S. Varney (R), James F. Sheehan (D), Mrs. Ann E. Bingel (D), Victor C. Person (R), Mrs. Luella E. Wood (R), Mrs. Elizabeth Victor (D), Mrs. Ruth A. Sweet (R), and Gerald L. Shaughnessy (D).

Raymond F. Lyford (R) and George F. Daigle (D), who had been appointed by the Selectmen to tabulate, were sworn.

Following the closing of the polls, check lists were compared by Messrs. Prentiss and DesBarres at the check-in table with Messrs. Slattery and Smith at the check-out table at the ballot box. They reported 879 voters had been checked on their respective voting lists.

Ballots having been canvassed and tabulation completed, public declaration of the vote was read by Town Clerk Newton at 9.25 P. M.

PROCEEDINGS OF ADJOURNED ANNUAL
TOWN MEETING.

FEBRUARY 9, 1946.

The meeting was called to order by Moderator George A. Whittemore with a large attendance of voters present.

Rev. Francis A. Foley, pastor of Holy Angels Church, delivered the invocation by invitation of Moderator Whittemore.

1945 TOWN REPORT.

Article 2. On motion of Town Counsel Henry C. Walker, seconded by Ward A. Robinson, action on reports of town officers was postponed until the next town meeting. Mr. Walker stated that the printed town reports had only reached the voters as they entered the hall for this meeting. Town Clerk George G. Newton explained there had been no delay of any town department heads in submitting their respective report for publication but a previous commitment at the print shop had delayed the Upton town report being printed. He added, he went to Milford after the reports this morning (Feb. 9) to have them for distribution this afternoon.

SPECIAL COMMITTEES.

Article 3. Town Counsel Henry C. Walker, clerk of Committee for Revision of By Laws, submitted the following report:

"During the past three years, material has been compiled and many new sections added for the proposed new laws of Upton. A complete set of automobile and traffic laws has been drawn, and a complete set of rules drawn governing public health. Both of these phases of the law concern themselves closely with public safety and health, and are complete and

considerably more in detail than those under which our town is presently functioning.

"A final draft with all sections is not as yet ready, and after that has been examined and studied by the committee, it is our suggestion that mimeograph copies of the draft be submitted to the voters for consideration at a meeting in the future, and if accepted may then be put into permanent form for printing. An appropriation for work and printing will be necessary. It would appear that \$100.00 should cover the preliminary work and presentation of mimeographed drafts for the voters.

"Voters are invited to submit any suggestions for the consideration of the Committee with particular reference to sections of the General Laws which the town has not previously accepted and which the voters believe may be of benefit to the welfare of the town and its people."

Voted: on motion of Selectman Daniel H. Bates, duly seconded, that the report be accepted as one of progress.

MEMORIAL HIGH SCHOOL.

Moderator Whittemore then called Malcolm C. Temple, chairman of the Memorial High School Building Committee, to the front of the hall.

Mr. Temple stated that the Special Committee had had 21 formal meetings plus three other meetings when visits were made to inspect out-of-town, that the attendance of committee members at the meetings totaled 800-man hours to date, and in addition, there had been hours of time expended by

educational consultants and an architect to propose a building they considered for the best interests of the townspeople.

Continuing, Mr. Temple asserted a set of plans was ready and that an architect had colored slides prepared of the proposed building which could be better shown at night owing to the lighting conditions of the hall.

Speaking, he said for the majority of the special committee, he moved that further consideration of the report and action be postponed to February 18, 1946 at 8 P. M.

Then followed a discussion of nearly an hour as to whether the full report be heard at this time, an abbreviated report made, or the entire report deferred until a future date.

During the discussion of Mr. Temple's motion, Rev. Charles DeVries moved to amend Mr. Temple's motion that there be a report of salient facts and figures by the special committee, limited to 10 minutes.

Among those speaking were Henry R. Hoyle, Selectman Daniel H. Bates, Harrison E. Bates, clerk of the Finance Committee; Raymond C. Whiting, Edward L. Prentiss, Frank Fowler, Sr., Rev. Mr. DeVries, George N. O. Poirier, Dr. Bernard F. McKernan, and Mr. Temple, the latter three being members of the special committee.

In reply to a question, Mr. Temple stated that it would take at least one hour to make a detailed and comprehensive report, and that it might extend to four hours to give all information requested. He also stated that because of the hall's lighting condition the majority of the special committee had deemed it not advisable to hire a projector to show the colored slides of the proposed building at this afternoon's adjourned town meeting. He further said that he was voicing the sentiment of the majority of the Committee in asking for post-

ponement to Feb. 18 but if it were the decree of the voters he would make a report as far as time allotted him.

Rev. Mr. DeVries' amendment for a 10-minute report was lost on a standing vote: 84 No, 70 Yes. Constable Eugene A. Closson and Henry R. Hoyle were appointed tellers by Moderator Whittemore to take the count.

Mr. Temple's motion for the majority of the special Committee to defer a full report and action on the proposed Memorial High School Building plans, etc. to February 18, was then favorably acted upon by a voice vote.

George N. O. Poirier advocated that an amplifying system be installed for the Feb. 18 adjourned town meeting in order that every person could be heard who desired to speak.

A standing vote was taken. There was no opposition.

(*) Highways, Chapter 81. Road Commissioner Harry C. Snow moved that the sum of \$4500.00 be raised and appropriated to meet the town's share of the cost of Chapter 81 Highways, and that, in addition, the sum of \$10,000.00 be transferred from unappropriated available funds in the treasury to meet the State's share of the cost of the work, the reimbursements from the State to be restored, upon their receipt, to unappropriated available funds in the treasury.

Chapter 90 Maintenance. Road Commissioner Harry C. Snow moved that the sum of \$1000.00 be raised and appropriated to meet the town's share of the cost of Chapter 90 Highway Maintenance.

(**) Public Welfare—General. Robert K. Sweet, clerk of the Public Welfare Board, moved that the sum of \$3200.00 be raised and appropriated for Public Welfare-General, as requested by the Board, which was duly seconded. Selectman Harold S. Hopkins, former chairman of the Finance Committee prior to Feb. 6, 1946, stated the Finance Committee recommended \$2900.00. Harrison E. Bates, clerk of Finance Committee, and Charles A. Davis, member of the Public Welfare Board, also spoke. Mr. Sweet's motion for appropriation of \$3200.00 was lost by a standing vote: 52 No, 40 Yes. Messrs. Closson and Hoyle were tellers. Merrill S. White then moved that \$2900.00 be raised and appropriated and it was so voted by a voice vote.

(***) Schools. The Finance Committee's printed report stipulated \$45,000.00 was asked for by the School Department, \$44,064.48 recommended by Finance Committee. Selectman Hopkins explained that with the appropriation of

\$44,064.48, plus incomes from trust funds and 1945 Dog Tax Refund that the School Account would have \$45,000.00 available. Frank O. Ogden of the School Committee stated this was agreeable to the School Committee. Merrill S. White moved to raise and appropriate \$44,064.48 and it was so voted.

TRANSFERS TO SURPLUS REVENUE.

Article 6. Voted: on motion of Town Treasurer Leo F. Murphy that the unexpended balances of following special appropriations: 1941, Portable Lighting System, \$1.50; 1942, Observation Tower, \$21.88; Town Hall Toilets, \$24.17; 1943, Counsel Fees and Expenses, \$33.00; 1943, Moroney Brook Bridge, \$2.92; High School Building, 33 Cents; Civilian Defense, \$115.73; Rationing Board, \$72.30, and 1945, Russell Avenue Street Light, \$3.39, totaling Two Hundred Seventy-five Dollars and Twenty-two Cents (\$275.22), be transferred to surplus revenue in the Town's treasury.

CEMETERY COMMISSION CHAIRMAN'S SALARY.

Article 7. Voted: on motion of Chairman of Selectmen Earl G. Crockett to establish the salary of the Chairman of the Cemetery Commission at Twenty-five Dollars (\$25.00) per annum.

ASSESSORS' SALARIES.

Article 8. Voted: on motion of Selectman Daniel H. Bates that the salary of the Chairman of the Assessors of Taxes be established at Three Hundred and Fifty Dollars (\$350.00) and for each of the other two Assessors of Taxes at Two Hundred and Seventy-five Dollars (\$275.00), as recommended by the Finance Committee.

The Assessors had requested a salary of Four Hundred Dollars (\$400.00) for the Chairman and Three Hundred Dollars (\$300.00) for each of the other two Assessors.

It was stated that the increases voted would be provided from the appropriation of "Town Officers and Expenses" under Article 5.

ASSESSORS' EXPENSES.

Article 9. Voted: on motion of George E. Bradley, chairman of Assessors of Taxes, that the sum of Two Hundred and Eighty-one Dollars (\$281.00) be raised and appropriated for expenses of the Assessors, with the understanding that the cost of printing of the Valuation Book to be taken from the Printing Account.

1945 DOG TAX REFUND.

Article 10. Voted: on motion of Town Treasurer Leo F. Murphy that the sum of Five Hundred and Twenty-seven Dollars and Fifty-two Cents (\$527.52), proceeds of the 1945 Dog Tax Refund, be appropriated to the School Account.

SPECIAL HIGHWAY APPROPRIATION.

Articles 11 and 12. As these appropriations had been acted upon under Article 5, it was voted to pass over these articles.

1945 SNOW REMOVAL BILL.

Article 13. Voted: on motion of Merrill S. White that the sum of Seven Hundred and Twelve Dollars and Eighty-eight Cents (\$712.88) be raised and appropriated for payment of a 1945 Snow Removal Bill.

As a four-fifths vote is necessary on such action at an annual town meeting in accordance with Section 64, Chapter 44, General Laws, a standing vote was taken. There was no opposition.

Mr. White in making the motion stated that Upton residents should consider themselves most fortunate for the effi-

cient manner in which the snow had been removed this winter from public highways in Upton. His comment was applauded.

Selectman Harold S. Hopkins, former chairman of the Finance Committee, stated that the reason why the amount requested in this article had not been transferred from the Reserve Fund during the closing days of the 1945 fiscal year was because of insufficient money remaining in the Reserve Fund.

HIGHWAY SNOW FENCE.

Article 14. Voted: on motion of Road Commissioner Harry C. Snow that the sum of Three Hundred and Fifty Dollars (\$350.00) be raised and appropriated for the purchase of Snow Fencing.

ESTABLISHING 1946 TAX RATE.

Article 15. Voted: on motion of Chairman of Selectmen Earl G. Crockett to instruct the Assessors of Taxes to use Twelve Thousand Dollars (\$12,000.00) from unappropriated available funds in the Town Treasury in establishing the 1946 Tax Rate. Standing vote on motion: 62 Yes, 54 No.

Previous to the taking of the vote, there was a discussion on the motion.

Dr. Bernard F. McKernan said he favored leaving this sum of money in the unappropriated available funds in the town treasury at this time in view of possible public projects, such as a new High School Building, sewers and water. Malcolm C. Temple stated that for economic reasons that it might be beneficial to the town to leave the said sum in the treasury at this time.

Selectman Crockett asserted that he had discussed the use of unappropriated available money with Henry F. Long,

Commissioner of Corporations and Taxation, and received authority for use of \$12,000.00 in establishing the 1946 Tax Rate. He added, that in view of Upton's high tax rate in 1945, partly due to an error when it was computed, that he felt that the taxpayers should have the benefit of a reduction this year.

HOWARD R. LELAND ATHLETIC FIELD AND PARKS.

Article 16. Voted: on motion of Harrison E. Bates that the sum of Two Hundred Dollars (\$200.00) be raised and appropriated for use under supervision of the Selectmen for improvements to the Howard R. Leland Athletic Field and town Parks.

In answer to a query by Alexander Kennedy, Town Counsel Henry C. Walker said that in his opinion the income from the Ella W. Risteen Fund for beautification of the town could be used only in certain ways.

Selectman Crockett stated that repairs are needed on the bleachers at the athletic field.

MENDON STREET.

Article 17. Voted: on motion of Town Treasurer Leo F. Murphy that the sum of Two Thousand Dollars (\$2000.00) be appropriated from unappropriated available funds in the town treasury to be used with monies received from the State or County, or both, for Chapter 90 Highway Construction on Mendon Street.

ESTABLISH VETERANS' DEPARTMENT.

Article 18. Voted: on motion of Edward L. Prentiss, World War II veteran, that the town accept Chapter 723, Acts of 1945, "An Act Authorizing the Establishment and Maintenance of Municipal Departments and of Districts for Furnishing Information, Advice and Assistance to Veterans of

World War II and Other Veterans", and appoint a committee of three to investigate the administration of this Act as needed in Upton, and report at a special town meeting.

When Moderator Whittemore inquired as to the manner in which the said Committee would be named—from the floor or by the Moderator—Raymond C. Whiting moved that Mr. Prentiss be appointed as chairman of the Committee and empowered to name the other two members. It was so voted.

Prior to adjournment, Town Treasurer Murphy moved that all appropriations voted during the session, unless otherwise stipulated in their respective motion, be raised by taxation. It was so voted.

Malcolm C. Temple then moved adjournment of this meeting to the previously set date and time—February 18, 1946 at 8 P. M.—and it was so voted.

Adjournment was at 5.25 P. M.

During the meeting, a total of \$127,427.59 was appropriated.

From unappropriated available funds in the town treasury: \$10,000.00 for Chapter 81 Highway until reimbursements from the State are received, \$2000.00 for Chapter 90 Construction on Mendon Street, and \$12,000.00 to be used by Assessors in establishing the 1946 Tax Rate. In addition, \$527.52 from 1945 Dog Tax Refund to the School Account.

Balance to be raised by taxation: \$102,900.07.

ADJOURNED ANNUAL TOWN MEETING
FEBRUARY 18, 1946.

Nearly every seat on the main floor, Town Hall building, was occupied when Moderator George A. Whittemore called the session to order at 8.20 P. M. Rev. Charles DeVries, minister of the Unitarian Church, delivered the invocation by invitation of Moderator Whittemore.

A large screen had been placed on the stage for the showing of plans and sketches of Upton's proposed Memorial High School building as recommended by the Committee. Various samples of materials used in school building construction were exhibited on tables at the front of the hall.

In accordance with a motion made at the first adjourned town meeting, February 9, 1946, Moderator Whittemore announced that a report of the special Memorial Building Committee would be made by Malcolm C. Temple, Committee chairman. (This report was being made under Article 3 of the warrant.)

Harrison E. Bates at the opening of the meeting called attention to the fact that no action had been taken on the 1945 reports of town officers. (Distribution of the town reports was delayed until February 9, 1946 as they were not received from the printer until that date.) No action was taken.

Mr. Temple then proceeded to outline in general the authorization of the naming of the Committee as voted at the annual town meeting in February 1945, that the Committee had conducted 21 regular meetings and three informal gatherings, two of which were at the High School site and so-called White lot and one trip to Medfield High building; that a sub-committee visited school buildings at Northboro, Shrewsbury and West Boylston; engaging of William T. Upham of Norwood as committee architect, conferences with

educational consultants, and a building plan prepared that would be explained by Mr. Upham.

Mr. Temple stated that the Committee's records of the meetings were open to the public.

Chairman of Selectmen Earl G. Crockett moved that permission be granted to Mr. Upham, a non-voter of Upton, to address the assembly and it was so voted.

Mr. Upham commended Mr. Temple for his manner of presentation of the Committee's report to the voters and then stated he would outline his remarks in four parts: (1) the building, (2) location or site, (3) cost and (4) materials used in construction.

Mr. Upham showed on the screen a colored slide of the proposed two-story fireproof structure, interior plans of the first and second floors, auditorium, gymnasium and boilerroom.

The building has a 208 ft. frontage and 61 ft. depth. In addition, there is an auditorium-gymnasium in the rear of the center of the building, 87 ft. in length and 72 ft. wide.

The first floor would include two classrooms, drawing room, shop, cafeteria and kitchen, lockers, toilets, administration offices, cloak and storage rooms. On the second floor there would be four classrooms, library, science, typewriting and commercial course rooms. Only the boilerroom is in the basement.

The auditorium-gymnasium to include stage, shower rooms for boys and girls, lockerrooms which could also be used as dressingrooms for entertainments, and toilets. It would seat approximately 750 in the balcony and on the main floor. When floor space is used for basketball, seats could be placed on the stage. When seats were not in use they could

be placed in a storage place under the balcony provided for them.

The site of the proposed building developed into a lengthy discussion. Two sites considered by the special Committee were: (1) the High School lot on which was located the 47-year old building destroyed by fire in December 1944 and (2) the adjacent White lot, at the rear of the High School lot. The High School lot fronts on Main street. The White lot fronts on Fiske avenue (also known as Warren road) between Main street and Hartford avenue.

As the meeting progressed it was stated four locations had been considered by the special Committee; one on the White lot and three on the High School lot.

In his remarks, Mr. Upham replied that he had made the plan of the building as presented on the White lot as he had been informed it was favored by a majority vote of the special Committee. Further discussion developed as to whether it was a "majority vote of the Committee (comprising 15 members)" or "a majority vote of Committee members present" when the plan was adopted.

Edward L. Prentiss moved and it was so voted that minutes of the meeting of the special Committee be referred to. Mrs. Ada W. White, clerk of the Committee, was not in the hall owing to illness, it was stated, but that the records were in custody of Miss Sabatella Mango, a Committee member.

Chairman Temple read the record of the Committee's meeting and explained it in further detail. He stated that five Committee members favored the proposed building on the White lot with four not caring to vote. Further, the speaker said, Fred W. Wood, then a Committee member, arrived at the meeting after the plan had been explained but not asked

to vote as he had not heard a detailed explanation of the question. Mr. Temple added that Dr. Bernard F. McKernan, Committee member, also arrived late and recorded in favor of the White lot for the building.

This discussion clarified that the plan was a "majority of Committee members" attending the meeting when the plan was adopted for the White lot. The plan of the proposed building, regardless of location, had been approved by 10 Committee members over their signatures, it was stated by Mr. Temple.

Mr. Upham was asked by Gordon E. Benson, member of the special Building Committee, if he had sketches in the hall of a proposed building on other locations on the High School lot in addition to the sketch he had shown of the proposed building on the site of the destroyed building. Mr. Upham replied he did not have these additional sketches on slides to be shown to the voters.

Mr. Benson stated that at the expense of the Wm. Knowlton & Sons Co. the E. J. Cross Co. of Worcester, building construction engineers-contractors, had been engaged to send a representative to Upton to look over the High School and White lots.

Mr. Benson then read a letter from the E. J. Cross Co. under date of December 5, 1946. A copy of which was filed at the Town Clerk's office.

During the meeting it was stated that Ralph G. Briggs, owner of a vacant lot fronting on Main street and adjacent (to the left) of High School lot, would sell it to the Town for \$400.00.

Selectman Crockett stated he did not care to bring another Town issue into this meeting but that there were Fed-

eral funds to provide for drawing of plans for school buildings and read from a government publication. He explained that if the municipality did not vote to construct the building after obtaining the plans, the town did not repay the Federal government. If the building was erected from such plans, the Town would reimburse the Federal treasury for the loan. It was explained that the Town selected its architect where Federal funds were allotted.

Mrs. Sarah E. Pearson stated she understood by vote taken at the February 1945 annual town meeting authorizing the appointment of the special Building Committee that more than one plan would be offered for consideration by the voters. She added that the plan as presented was a beautiful building if it could be afforded.

Selectman Daniel H. Bates stated that during a meeting of the special Building Committee of which he was a member, by virtue of being a selectman, he had made a motion and it was voted that more than one plan be presented at the town meeting. He inquired into the legality of the Committee presenting but one building plan.

It was explained that the plan being presented had been approved by 10 Committee members.

On the question of cost of erecting the proposed building at the present time, Mr. Upham said he could not quote a price because of the changing costs of materials and labor. But based on 1941 prices, cost of constructing the building on the White lot would be approximately \$201,450 for construction.

Selectman Crockett, also a member of the Legislature, stated that estimated cost of buildings contemplated to be erected by the Commonwealth had been recently made before Legislative Committees.

Edward L. Prentiss said he was not only speaking for himself but other voters in asking that if a motion was made to accept the Committee's report if it would accept the presented High School Building plan.

Malcolm C. Temple replied that a motion could be made to accept the report as one of progress by the Committee. He then motioned that the report be accepted as one of progress and that the Selectmen be instructed to call a special town meeting when requested by the special Memorial High School Building Committee. It was so voted.

On motion by Selectman Bates, seconded by Selectman Crockett, it was voted to adjourn the meeting. Adjournment was at 11.45 P. M.

PROCEEDINGS OF THE SPECIAL TOWN MEETING
MARCH 29, 1946.

COMMONWEALTH OF MASSACHUSETTS.

Worcester, ss.

A large attendance of voters were present when Moderator George A. Whittemore called the meeting to order. The call of the meeting and officer's return of the warrant were read by the Town Clerk.

Rev. Charles DeVries, minister of the Unitarian Church, gave the invocation by request of Moderator Whittemore.

The Moderator requested all non-voters to take seats in the balcony.

PICCADILLY STREET LIGHT.

Article 1. Voted: on motion of Chairman of Selectmen Earl G. Crockett and duly seconded to appropriate Twelve Dollars (\$12.00) from unappropriated available funds in the town treasury for installation of an electric light on Piccadilly Street.

ACTING POLICE CHIEF AND SALARY.

Article 2. Voted: on motion of Daniel H. Bates, member of the Board of Selectmen and Acting Chief of Police, which was duly seconded, that the Selectmen be authorized to appoint one of its members as Acting Chief of Police until the next annual town meeting and that his salary be Two Hundred and Fifty Dollars (\$250.00) in accordance with General Laws, Chapter 41, Section 4A, said money to be taken from the Police Appropriation.

1945 TOWN REPORT.

Article 3. Voted: on motion of Harrison E. Bates, duly seconded, to accept the 1945 Town Report of town officers as printed with notation of a typographical error on Page 77, report of Town Treasurer. Town Treasurer Leo F. Murphy informed the voters that in his report it should state he received from "1 Inn Holder License \$4.00" instead of "\$8.00".

REPORT FOR ADMINISTRATION OF CHAPTER 723,
ACTS OF 1945.

At this point in proceedings of the meeting, Edward L. Prentiss, who was appointed Chairman of a Special Committee at the February annual Town Meeting to investigate the administration of Chapter 723, Acts of 1945, accepted by the Town on February 9, 1946, stated his Committee was ready to report although no article was in this meeting's warrant to

hear it. Malcolm C. Temple moved that Mr. Prentiss be permitted to make the report, and it was so seconded, and voted.

(Other members of the Committee were Rev. Francis A. Foley and Ward A. Robinson).

Mr. Prentiss read the report. (Copy on file at Town Clerk's office).

Mr. Prentiss was roundly applauded upon completion of reading the report.

Fire Chief George N. O. Poirier moved that the Town accept the very fine report as one of progress and it was so voted.

MEMORIAL HIGH SCHOOL BUILDING.

Moderator Whittemore read Articles 4, 5 and 6 in the Town Warrant and then recognized Malcolm C. Temple, chairman of the special Memorial High School Building Committee.

Mr. Temple stated that in his opinion it would not be possible to segregate Articles 4, 5 and 6 for discussion and debate but that they would be segregated when voted upon. He added, that it was his plan in making a further report on the building to have William Upham (Building Committee architect) and Dr. Jesse B. Davis, Boston University, educational consultant, speak as part of the report he was to make.

Chairman of Selectmen Crockett stated he had no objection to Mr. Upham and Dr. Davis speaking when the site or plan came up for discussion but did object to the two non-residents speaking as part of the Committee's report. Moderator Whittemore sustained Selectman Crockett's objection.

Mr. Temple estimated it would take at least one hour to read the Committee's written report of meetings, etc. Se-

lectman Crockett said that to his knowledge there had been but one meeting of the special Committee since the last Town Meeting when an oral report was made by Mr. Temple.

Eugene Whiting moved that Mr. Temple be given permission by the assembly to make his report in his own manner. The motion was seconded.

Moderator Whittemore asked Town Counsel Henry C. Walker if Mr. Upham and Dr. Davis could speak as part of the report to be made by Mr. Temple as special Building Committee chairman if so voted by the assembly. Town Counsel Walker ruled that in his opinion that it was permissible for the non-residents to speak if they were part of the report to be made.

Mr. Whiting's motion was then favorably acted upon.

Mr. Temple made an oral report concerning the Committee's efforts to present to the voters a proposed building and site for the welfare of Upton's school children in future years.

Mr. Upham, architect, showed slides on a screen of how the plan accepted of the proposed building accepted by a majority of the Committee would appear on various locations on the old site (where the former High School Building stood which was destroyed by fire in December 1944); the fill that would be necessary and the handling of sewage and drainage. He also showed floor sketches of two different building plans for old site with approximately as much room space as plan accepted by the Committee for so-called White lot.

(The White lot is adjacent to the old site, fronting on Fiske avenue, between Main street and Hartford avenue.)

Dr. Bernard F. McKernan, member of the Building Committee, showed aerial views of the old High School lot front-

ing on Main street and the White lot. He compared the advantages and benefits derived, in his opinion, of the White lot for the new building site.

Dr. Davis, educational consultant, spoke mainly on the need of a building as large as the plan accepted by the Committee because it was to be erected to accommodate two Grade 6 classes, in addition to Grades 7 to 12, inclusive, making a total of seven grades to be housed. He also pointed out the subjects to be taught and hours per day the schoolrooms would be used.

Mr. Temple discussed at length the comparison of the two sites under consideration. He referred to a communication from the State Board of Health concerning the present sewage disposal at the old site. Speaking of the cost he said the townspeople could afford the size building as accepted by the Committee. He stated he wanted to be recorded in favor of the White lot as the site for the new building.

At 11.10 P. M. Moderator Whittemore declared a five minute recess.

When the meeting reconvened Gordon E. Benson, member of the Building Committee, stated that he had advocated the old site for the proposed new school building unless it could be proven to him that it would be more economical to select the White lot. He stated that he was on record in favor of the plan submitted by the special Committee but not its size or site which had been recommended. He compared the town's population and school enrollment for the years of 1900 and 1945 and stated that the proposed building is much larger than needed based on town's increase of population and students during the past 45 years.

Mrs. Ada W. White, Chairman of the School Committee and member of the Building Committee, said she had been a

teacher for 20 years and that good schools and Water system, which she said she hoped that the town could have, would attract people to come to Upton to reside. She said there were about $3\frac{1}{2}$ acres of land in the tract offered to the town for the proposed building.

Selectman Crockett, member of the Building Committee, said he realized the value of an education and wanted to be recorded in favor of a new High School Building that the taxpayers could afford. In his remarks he stated that the cesspool which was built as a WPA project to care for sewage from the old High School Building had never leaked or overflowed to his knowledge. He further discussed soil tests which had been taken by representatives of the State Board of Health on the two sites.

George E. Nydam, member of the School Committee and special Building Committee, stated he had visited the Medfield and Uxbridge High School Buildings and that they were shorter in length than the proposed building for Upton. He said he had worked on the construction of school buildings and that a suitable school building could be erected on the old High School site.

During the above discussions, Moderator Whittemore had ruled that the various members of the Special Building Committee speaking had done so as part of the report.

Moderator Whittemore offered members of the Building Committee an opportunity to be polled on the report made by Chairman Temple. Selectman Daniel H. Bates, member of the Building Committee, stated that the Committee had unanimously voted that the chairman of the Committee make the report.

At midnight, Fred W. Tuttle motioned that the report be accepted as one of progress and so voted under Article 4.

Under Article 5, Selectman Bates said that in his opinion that it was unfair to ballot on the site location at the late hour as some voters had left the hall and other voters had been unable to be present. He then motioned in writing that "The Selectmen be empowered to call a special Town Meeting and prepare a ballot with one or more articles to vote on the two sites." Halbert K. Struthers arose and seconded the motion.

Malcolm C. Temple motioned to amend to adjourn the meeting until Monday, April 1, at 8 P. M. which was seconded by Walter H. Allen.

George N. O. Poirier member of the Building Committee motioned to adjourn which was not recognized by Moderator Whittemore. Selectman Crockett likewise motioned to adjourn and subsequently rose to point of order. Moderator Whittemore called for order in the hall. Town Treasurer Leo F. Murphy, member of the Building Committee, spoke about the lateness of the hour and then called for voting on the amendment and motion.

Mr. Temple's amendment was defeated on a voice vote. Selectman Bates' motion was then favorably acted upon.

It was then voted to adjourn, the time being 12.30 A. M.

Moderator George A. Whittemore called the meeting to order after additional seats and settees had been placed on the main floor of the Town Hall to accommodate voters present. The attendance was the largest at a special town meeting in many years, if not in the town's history.

At 10.33 P. M., Town Clerk George G. Newton in announcing the result of voting, stated that 413 ballots were cast—238 men and 175 women. Also that the total on the ballot box indicator—413—corresponded with the number of men and women voters' names checked on both check lists.

Result of voting: Old High School site—300 votes; White site—112; blank—one, total 413.

Selectman Crockett then moved for adjournment of the meeting which was voted.

PROCEEDINGS OF SPECIAL TOWN MEETING,
DECEMBER 9, 1946.

Worcester, ss.

Pursuant to the foregoing warrant, a special town meeting was called to order by Moderator George A. Whittemore with less than 200 voters present. The warrant was read by the Town Clerk.

JAMES ROAD STREET LIGHTS.

Article 1. Voted: on motion of Selectman Daniel H. Bates, seconded by David A. Coleord, to install three street lights on so-called James Road.

REPORT OF UPTON MEMORIAL HIGH SCHOOL
BUILDING COMMITTEE.

Article 2. Samuel B. Young, Chairman of the Upton Memorial High School Building Committee, was given the floor by Moderator Whittemore to make the said Committee's report. He said that the report would include showing of stereopticon slides of the proposed building, exterior and floor plans, being submitted by the Committee for the voters' consideration, and an explanation of the plans by William T. Upham of Norwood, Committee architect.

Chairman of Selectmen Earl G. Crockett moved that Mr. Upham be given permission by the assembled body to show such slides and explain plans. There was no objection.

Mr. Young read as follows:

"I submit as a report of the Building Committee, the records of proceedings of your committee, which records are open for examination by any citizen of Upton at any time.

"Your Committee has held 14 meetings since May 9, 1946, the reading of which would probably take the entire evening, so I will give you a summary of the conclusions arrived at by the majority of the Committee.

"By vote of the Town, the site of the old building was selected as the site of the new building, if and when built. The so-called "A" Plan is not economically adaptable to this site, so your architect, Mr. Upham, was requested to make new sketches of a building for this site to conform with recommendations of your Educational Advisor, and the laws of the State so that the Committee might arrive at some kind of rough estimate of cost of constructing a suitable building. Mr. Upham has completed such sketches and with your consent will display them to you.

"Your Committee submitted these sketches to two contractors and received rough estimates of cost but no contractor would give a positive estimate without plans and specifications, and then such estimates would have to be subject to cost of labor and price of material at time of construction.

"On September 12, Mr. Charles Alikonis of the Bathelt Construction Company was present to answer questions regarding cost and availability of materials at the present time.

"(The Minutes of the September 12 meeting of the Upton Memorial High School Building Committee were incorporated in Mr. Young's report.)"

"(The report for the Federal Grant by Mr. G. E. Benson was also included.)"

Upton, Mass., September 12, 1946.

"A regular meeting of the Upton High School Building Committee was called to order at 8.30 P. M. with nine members present. Mr. Bates, Mr. Bartlett, Dr. McKernan, Mr. Crooker, Mr. Hopkins and Mr. Ogden were absent.

"The minutes of the previous meeting were read and approved.

"Mr. Benson gave a verbal report of a meeting with Mr. Upham relative to filling out applications for advance for plan preparations.

"Mr. Charles Alikonis of Holyoke, Massachusetts, of the Bathelt Construction Company, was present at the meeting to answer questions regarding the cost and availability of materials at the present time.

"Mr. Alikonis stated that all building materials and labor have gone up considerably in price the past two years, and there is no guarantee that they will not go still higher. Brick has gone up \$3.50 a thousand; lumber, \$35.00 a thousand; steel, \$60.00 a ton; concrete, around \$1.50 per cubic yard, and plaster and all other materials have gone up. A job two years ago will run around 40% higher today.

"Mr. Alikonis suggested using cinder block for the inside and brick for the outside. This would be much cheaper and would be satisfactory for a school building.

"Mr. Young asked how much the prices had gone up over 1941 prices.

"Mr. Alikonis advised they were 40% and 50% over the 1941 prices, and labor has gone up about 60%.

"Mr. Young asked if the materials necessary in the construction of a building are available now.

"Mr. Alikonis advised that it is necessary to plan far ahead, and to place your orders early for all materials in order to obtain the necessary materials. It takes approximately six months to get steel frame; some materials it takes longer. Flooring is very hard to get.

"Mr. Benson asked what the price of brick is today.

"Mr. Alikonis stated that the common sand-kiln brick, delivered on the job, is approximately \$28.50. However, by substituting cinder block at \$.21½ a piece, wherever possible, it would cut the price considerably.

"Mr. Poirier asked if it would be possible to get all of the necessary plumbing materials by next spring, or the next building season.

"Mr. Alikonis advised that such materials are available, but it is necessary to place your order at least six months ahead of time as deliveries are so slow. Even then you may not receive them on time.

"Mr. Alikonis stated that as it would require more slate and materials, naturally the cost would be higher.

"Mr. Young asked if any type of building would be 40% and 60% over 1941 prices.

"Mr. Alikonis believes it would, figuring all expenses. Some materials have not gone up so much, but figuring labor and all materials together, the price has gone up around 40%.

"Mr. Benson asked what the average was that a brick layer could lay in a day.

"Mr. Alikonis remarked that it depends on the type of work you want done. He figures on around 800, but of course this figure varies according to the number of doors and windows.

"My. Nydam asked if heating and ventilating systems were available now.

"Mr. Alikonis advised that they are, but like all other materials and supplies they must be ordered several months in advance, and they are sold with the understanding that you must pay what the price is at the time of delivery. When a contractor is making a bid, he must allow for all these price changes.

"Mr. Poirier asked what percentage of money we should ask the townspeople for over the 1941 prices.

"Mr. Alikonis advised 60% over the 1941 prices.

"Mr. Poirier asked how long it would take to construct a building, such as our present plans, if all of the necessary materials were on hand.

"Mr. Alikonis stated that it possibly could be completed in nine months, but would probably take about a year; it depends upon the labor and materials that are available. He remarked that at the present time the Boston Scale for carpenters is \$1.50 per hour, and is \$1.99½ for bricklayers.

"Mr. Poirier asked how the Pan System, where they put in the rods and make a concrete floor, compares in cost with a steel frame.

"Mr. Alikonis advised that the Pan System is supposed to be cheaper, but it depends on the market; the price of steel, concrete, etc.

"Mr. Poirier asked what the cost of borings is.

"Mr. Alikonis stated that it is not too expensive. It depends on the ground. If eight foot borings are made and everything seems to be okay, that is all that is necessary. Four borings would probably cost \$400 or \$500. He stated that the contractor who is going to do the job, usually does some borings himself to make sure it isn't going to be all ledge. This usually costs about \$22.00 a piece for eight foot holes, however, a company that specializes in this type of work charges more.

"Mr. Poirier asked if the finishing up of the outside of a Modern Design building could be built cheaper than that of a Colonial Design.

"Mr. Alikonis stated that it depends entirely on the plans of the building. That is, a Colonial Design may be adopted and the outside of the building be left very plain, therefore, would be less expensive, while a Modern Design may be adopted and all fixed up, which would make it more costly.

"Mr. Alikonis left at 9.50 P. M.

"Mrs. White gave an oral report of the number of pupils enrolled this year, also the transportation and tuition expenses. There are 17 pupils more than last year; the cost of transportation to Whitinsville and Grafton is approximately \$4,896 on a 180-day basis; total tuition, \$16,876, or a total of \$21,772 for transportation and tuition for the Whitinsville and Grafton students. Mrs. White reports that it is believed that this figure will run quite a bit higher this year. The total school appropriation in 1944 was \$30,000.

"Mr. Benson made a motion that the meeting be adjourned at 10.20 P. M. which was seconded by Dr. Crockett, and carried.

"REPORT OF APPLICATION FOR FEDERAL GRANT."

"On September 24, 1946, the writer (G. E. Benson), accompanied by Mr. Young, chairman of the Upton Memorial High School Building Committee, and Mr. Upham, architect, met with Mr. Dine in the Office of the Department of Corporations and Taxation. The writer gave Mr. Dine a preliminary and brief report of the problems that are now confronting the Building Committee, particularly as to financing, and then showed him the applications, which were made out by the Clerk, under the supervision of Mr. Upham, for advances from the Federal Government to complete the working drawings.

"While Mr. Dine was very sympathetic, yet he definitely stated that inasmuch as we could not show on the form that we were able to finance our proposed costs, which figures were also included on the form, he advised that our request definitely would not be granted.

"He further advised that in all cases that have been previously submitted to his office for approval, the one stipulation is that the towns must definitely show how they expect to finance the costs; therefore, the writer asked Mr. Dine just what steps the Upton Memorial High School Building Committee could take in order to obtain a method of showing on the form as to how the Town could expect to pay for the project. Mr. Dine replied that inasmuch as we could borrow only 5% of our assessed valuation, which amounts to approximately \$66,000, it would be necessary for the Town to apply, through the State Legislature, for permission to borrow in

excess of this \$66,000 figure. He intimated that if we applied through the proper channels for this permit he could see no reason why our request should not be granted; however, this was just his opinion.

Dear Mr. Benson:

For the purpose of making an appropriation, in order that you may authorize the Architect to proceed to write specifications and make working drawings (exclusive of details) based on the last sketches submitted to the committee of the proposed Junior-Senior High School Building for the Town of Upton, Massachusetts, I would suggest that you estimate the class Room section of the building to cost \$150,220.00.

"The above costs of the proposed Junior-Senior High School Building for the Town of Upton, Massachusetts, are only estimates of what the building may cost when you decide to build and the Architect assumes no responsibility for their accuracy. If the building was to be built today, I feel quite sure that the costs of same would be considerably higher.

"Based on the figures and sketches, the Architect's commission for writing specifications and making working drawings (exclusive of details) for the building, including Class Room and combination Auditorium-Gymnasium sections of the Junior-Senior High School building for the Town of Upton, Massachusetts, would be \$14,246.72 in addition to the amount already paid the Architect.

"There should also be an amount included in your appropriation for Architect's traveling expenses. I would suggest that this amount be \$150.00.

"I would recommend that before specifications are written and working drawings are made, that you have borings made to determine the nature of the soil where the proposed building is to be built. If you should decide to do this, I think it would cost in the vicinity of \$600.00, and I suggest that you include at least this amount in your appropriation.

"If I can be of any further help to you, please feel free to call upon me.

In reply to queries, Mr. Upham stated that the proposed building would be approximately 149 ft. in length and 62 ft. deep; that it would comprise ground, first and second floors, Colonial Design entrance, and constructed so that additional classrooms or auditorium, or both, could be added at any future time; that wholly as a guess because of changing prices that the cost of erecting proposed school building would be \$219,707 and furnishings approximately \$10,000 with cost of auditorium only about \$150,220. He added that building costs today are approximately 60% higher than 1941 prices.

Selectman Daniel H. Bates moved that the report of the Upton Memorial High School Building Committee as read by Mr. Young and explanation by Mr. Upham, be accepted. Motion was seconded. As a result of a discussion, Mr. Young explained that acceptance of the Committee's report did not mean acceptance of the plan according to his understanding.

Voted: that the report of the Upton Memorial High School Building Committee be accepted. The vote was de-

clared unanimous by Moderator Whittemore, there being no dissenting voice.

PLAN ACCEPTED.

Article 3. Voted: on motion of Selectman Daniel H. Bates, seconded by Harrison E. Bates that the plan as presented in the report of the Building Committee for the Upton Memorial High School without auditorium be accepted.

Before the vote was taken there was a discussion during which Town Counsel Henry C. Walker asked Mr. Upham, architect, through the Moderator, if he (Mr. Upham) understood that the acceptance of the plans by the town under this article would bind the town to the extent it would be obliged to build. Mr. Upham replied "No" and added that without funds nothing could be done. Moderator Whittemore further explained that as he understood it, acceptance of the plans would not commit the town to erecting the school building. The vote was then taken.

PURCHASE OF BRIGGS LOT.

Article 4. Harrison E. Bates, clerk of the Finance Committee, stated that the said Committee recommended purchase of the Briggs Lot for the sum stated in the article.

Voted: on motion of Selectman Daniel H. Bates, duly seconded, that the Town appropriate Four Hundred Dollars (\$400.00) from unappropriated funds in the Town treasury for the purchase of the so-called Briggs Lot situated on northerly side of Main Street, bounded on the east by other land owned by the Town, on the west by property of Reuben Fiske, and on the south by Main Street.

WORKING PLANS FOR HIGH SCHOOL PROJECT.

Article 5. Voted: on motion of Dr. Bernard F. McKernan, member of the Upton Memorial High School Building

Committee, that the Town appropriate Twelve Thousand Dollars (\$12,000.00) from unappropriated funds in the Town treasury for working plans for the High School project. Motion seconded by Walter H. Allen. Result of standing vote: Yes 38, No. 29.

Prior to the final vote there was a lengthy discussion on the article.

Dr. McKernan explained that while no plan had been accepted for the auditorium he deemed it advisable to have working plans drawn at the same time as those for the school building in order to have them ready should Federal funds be available for a grant for such a building at a future date.

Others speaking for or against the motion included Harrison E. Bates, clerk of the Finance Committee, who stated the said Committee recommended \$8500 for preparation of working plans for the proposed school building only; Selectman Bates, Selectman Earl G. Crockett, Selectman Harold S. Hopkins, Mrs. Charles Pearson and Mrs. Ada White.

During the discussion it was stated that to have working plans prepared for the Memorial High School and auditorium, borings, topographical survey and architect's travel fee, the cost might total between \$15,000 and \$16,000. Drawings of the plans for both structures would alone cost \$14,246.72, it was stated.

Moderator Whittemore ruled that as the article called for a stipulated sum—\$12,000—that no sum could be appropriated above this amount at this meeting.

On the first voice vote taken on the motion to appropriate \$12,000, Moderator Whittemore stated he was unable to determine the result. On the second voice vote, the Moderator declared it appeared the motion was lost. Over seven voters arose and doubted the declaration of the result of the voice

vote. Moderator Whittemore called for a standing vote and named Constable Benjamin E. Swift and Police Officer Edward L. Orff as counters. The result announced after tabulation by the Moderator was 38 in favor of the motion made by Dr. McKernan, 29 opposed.

PETITION LEGISLATURE.

Article 6. Voted: on motion of Dr. Bernard F. McKernan, seconded by Arthur M. Bartlett, also a member of the Building Committee, to instruct the Selectmen to petition the General Court for authority of the Town to borrow \$200,000 outside the debt limit for the construction of the Upton Memorial High School Building. Moderator Whittemore declared the vote unanimous, there being no dissenting voice.

Dr. McKernan's original motion did not stipulate the maximum amount desired to be borrowed outside the debt limit if the Legislative authority was granted. Gordon E. Benson, clerk of the Building Committee, submitted the amount \$200,000 which was accepted by Dr. McKernan and included in the revised motion before being presented to the voters for action.

Selectman Crockett moved to dissolve the warrant at 10.25 P. M. and it was so voted.

RECOUNT OF BALLOTS CAST FOR REPRESENTATIVES (2) IN 10th WORCESTER DISTRICT, LIEUTENANT GOVERNOR AND AUDITOR.

A petition was filed with the Registrars of Voters by Nathan Rosenfeld (R) of Milford for recount of ballots cast at the State Election, November 5, 1946, in Upton, in the con-

test for Representatives in 10th Worcester District (two to be elected) and notice received from Secretary of the Commonwealth, Frederic W. Cook, directing recount of ballots cast at same election in contests for Lieutenant Governor and Auditor.

The recount took place in main hall, Town Hall Building, on the night of December 10, 1946. Notices had been sent to each of the candidates named in Mr. Rosenfeld's petition for a recount; also to each of the candidates for Lieutenant Governor and Auditor, and to offices of the Democratic and Republican State Committees. Notices were mailed at least three days before said recounts giving date, place and hour.

Submitting credentials were: Representatives' contest, for Maurice E. Fitzgerald (D) were Daniel F. Carney as attorney and agent; Walter Vols, James Mullen, William J. Fitzgerald, John Crowley, Robert Phillips and Andrew Power. Mr. Fitzgerald, candidate, was in attendance.

For Nathan Rosenfeld (R) were Daniel Jones as attorney, Daniel H. Bates, Arthur E. Vesperi, Harold Morrison, Louis DeGaetano, Anthony Ciprini and John Gandolfi. Mr. Rosenfeld, candidate, was in attendance.

Also present were Earl G. Crockett (R), a candidate for Representative, and George A. Whittemore, who was an announced sticker candidate for Representative.

Lieutenant Governor: for Arthur W. Coolidge (R), Leroy W. Prentiss.

Auditor: for Thomas J. Buckley (D), Michael Shaughnessy and Walter J. Stank: for Russell A. Wood (R), Earl G. Crockett, Nicholas Tosches and Raymond Smith.

Tellers named by the Registrars of Voters to recount the 1047 ballots cast November 5, 1946 were Miss Grace M. Mur-

phy (D), Harry C. Snow (R), Miss Helen A. Fay (R), Leo F. Murphy (D), Gordon E. Benson (R) and Edward J. Gurry (D) with George E. Daigle (D) and Raymond F. Lyford (R) tabulating. They were sworn to perform their respective duties by the Town Clerk. Constable E. A. Closson, succeeded by Officer C. H. Southland, were on duty.

Reading of the recount petitions was waived by interested candidates present.

Messrs. Fitzgerald and Rosenfeld with the respective attorneys and others accompanied the Registrars of Voters to the town vault where the ballot box covering was removed by the Town Clerk. The indicator of the box read 1047. The sealed boxes containing used and unused ballots were carried to the main hall.

Regulations for the recount by the Registrars of Voters were read by the Town Clerk, also clerk of Registrars.

Seven ballots were protested after rulings by the Registrars of Voters: three in the interest of Mr. Fitzgerald, three in the interest of Mr. Rosenfeld and one by Messrs. Crockett and Fitzgerald.

There is deposited in the Milford Savings Bank, \$9.22 known as the Knowlton School Fund with the Town Treasurer as Trustee to be used by the School Committee to defray extraordinary expenses at the Knowlton School Building.

There is deposited in the Milford Savings Bank, one thousand dollars (\$1000.00) known as the Ella (Whitney) Risteen Fund in trust with the Town Treasurer and School Committee as Trustees, the income to be divided between the two pupils in our High school who make the most progress during each year. \$30.30 was received this year. No awards.

There is deposited in the Worcester County Institution for Savings, one thousand dollars (\$1000.00) known as the Dr. Carpenter Library Fund, the income of which is to be used for the Public Library. No interest was collected this year.

Charlotte A. Batchelor and George W. Knowlton established a Trust Deed at the Worcester County Trust Co., with

the Bank as trustee, the income to be paid to the Town of Upton for use of Public Schools. \$191.94 was received this year.

There is deposited in the Milford Savings Bank, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in trust with the Town Treasurer as trustee, the income to be used for the Public Library. \$100.00 was received this year.

There is deposited in the Worcester County Institution for Savings, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor School Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Schools. \$100.00 was received this year.

There is deposited in the Milford Savings Bank a War Bonus Surplus Fund to be used as a nucleus of a Fund for a Public Library Building as voted by the Town, February 7, 1925. \$64.14 Interest was received and the amount of this fund on January 1, 1947 was \$3,255.70.

There is deposited in the Milford Savings Bank of Milford, five thousand dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Board of Selectmen, to be used to help the townspeople who are in distress. \$115.56 Interest was received and the balance on January 1, 1947 was \$5,865.39.

REPORT OF TOWN COUNSEL.

December 31, 1946.

TO THE BOARD OF SELECTMEN, TOWN OF UPTON:

As Counsel for the Town of Upton, I submit my seventh annual report.

Fortunately for the town this was not a litigious year, and no particularly outstanding legal problems were presented. At the Selectmen's request I attended some of the regular meetings, and the meetings of the town. Forty requests for written and oral opinions were received from the various departments and officials, and forty opinions were rendered.

The only case pending is that of Upton vs Case in the Land Court.

Two deeds of redemption were drawn, executed and delivered.

Two proposals and notices to bidders on town work and materials were drawn and executed for publication.

Two unrecorded deeds were placed on record at the Registry of Deeds covering land to which the town has title.

The Bowker tax title property (Instrument No. 23923) was sold for \$150.00 and deed drawn and delivered.

The Dunn tax title property (Instrument No. 23930) was sold for \$50.00 and deed drawn and delivered.

The Hallberg tax title property (Instrument No. 23925) was sold for \$250.00 and deed drawn and delivered.

ELLA W. RISTEEN TRUST.

Acting under the authority of the Selectmen I investigated the above with a view toward making recommendations to the town as to the future handling of the funds and securities now with the Hartford Connecticut Trust Company. I intend to present this matter to the voters of the town during 1947. In a recent conference with the Hartford Connecticut Trust Company the following assets comprise the trust estate with values, based on the market, as of December 31, 1946:

It now becomes necessary to terminate the trust in the Probate Court at Hartford which will necessarily terminate the trustee relationship between the trust company and the town. The property then becomes the property of the town

in accordance with the directions and conditions under the will.

In connection with the Beautification Clause Under this Trust it is noted that the purpose is broad and inclusive of many possibilities for the improvement and beautification of Upton. The fact that there are hundreds of ways in which this income may be properly used has very likely occurred to many of our interested citizens. The Selectmen are the persons who have the discretion and authority in the matters in the absence of the appointment of a committee by the voters. In cases of this nature it is not easy for any elected or appointed body to route the funds into an improvement or beautification project which is pleasing or satisfactory to every voter and for this reason, it is my opinion that ideas and suggestions for definite beautification projects may well be unspoken in the minds of the citizenry. It is undisputed that there are endless avenues where beautification would be a welcome change to the general appearance of Upton which was once a good looking, typical symbol of New England. It is therefore my recommendation that the voters submit to the Selectmen suggestions and opinions for their guidance and action. Some of the income has been used, and properly so, when the occasion presented itself. It would, however, seem that a wider and more definite horizon would be of particular interest to the town, and it is my opinion that the Selectmen would welcome suggestions which will result in a complete representation of the voters and a constant adherence to the directions of a benefactor.

I extend to the Selectmen and other town officials and the voters my appreciation for their cooperation and interest.

REPORT OF THE SUPERINTENDENT OF SCHOOLS.

TO THE SCHOOL COMMITTEE:

I have the honor to submit my second annual report on the public schools of the Town of Upton.

Schools opened in September with the following enrollment:

George S. Ball School	97
Knowlton School	130

This past year, with its many necessary adjustments, has been indeed trying for many of our students who attend schools out of town. It is pleasant to record, however, that in both Northbridge and Grafton the Upton students have entered wholeheartedly into the life of their respective schools. They have contributed their share and have been granted equal opportunities without distinction. Fortunately, these privileges can be extended for some time to come.

During the year we had only one change in our personnel. We were fortunate to obtain the services of Mrs. Ruth Morgan as teacher of Grade I in the George S. Ball School to replace Miss Barbara McNamara who resigned.

America is experiencing the most critical teacher shortage in its history. The list of graduates from teachers' colleges during the past four years has been only a fractional part of the number needed to fill the vacancies occasioned by retirements and those caused by teachers leaving the profession for more lucrative positions in industry. The simplest law of economics tells us that as a commodity or a service becomes scarce its value increases. Teachers everywhere are demanding higher salaries due to this scarcity, coupled, as it is, with the high cost of living.

When in competition with larger towns and cities, small towns are at a disadvantage because they generally offer smaller salaries and because teachers are anxious to work in larger systems which furnish greater opportunity for professional advancement. To offset these conditions and to fill the vacancies which are bound to occur, it seems advisable that small towns, temporarily, at least, be prepared to meet or even surpass the salaries of larger surrounding towns. We should be aware of these circumstances and make provision for meeting them in the future.

READING.

The ability to read is recognized generally as one of the most important skills that a person can have. The knowledge contained in textbooks is useless to pupils if they cannot read; the ability to read and to comprehend the printed English language is a prerequisite to academic success. It plays a significant part, also, in citizenship, in vocational success, and in the recreation of adults.

The past year we have changed our reading system to the Alice and Jerry Books. This is one of the most popular reading systems. The complete program for the first six grades has been developed over many years of scientific research and experimentation. It is based upon the aims stated in my previous report. The system has been enthusiastically received by both teachers and pupils.

The following features have contributed to the outstanding success of this reading system:

1. It contains a new type of content: Child experience material—Continuity of stories and a literary style attractive to children.
2. It has a new approach to the subject of reading which definitely provides teaching levels for individual differences.
3. It provides a reading readiness program for each grade level.
4. It prevents reading difficulties through a completely controlled and carefully chosen word list.
5. It has a complete set of administrative materials which provides a workable method of teaching and checking.

RISTEEN FUND.

In accordance with the provision of the will, the teachers, school committee and superintendent voted to spend the sum of five hundred dollars (\$500.00) of the accumulated income of the Ella Whitney Risteen Trust for classroom library books for the Knowlton and Ball Schools. The following number of books have been purchased:

- 2 Sets of Compton's Pictured Encyclopedia.
- 15 Sets of fifteen books each for group reading.
- 187 Individual books for library shelves.

Book shelves have been built in several classrooms. Many of these books are now being enjoyed by the pupils.

ARITHMETIC.

There is now practically universal agreement as to what should be the major outcome of a course of study in arithmetic

at all grade levels. "Textbooks are being based more and more on sound principles of educational psychology. Many topics of remote significance have disappeared from the curriculum of the elementary school. Remaining topics have been examined critically for effective grade placement. Many processes formerly taught in the lower grades have been moved upward to coincide more nearly with normal stages of child growth and where they may be taught effectively with the least expenditure of time and energy. Some topics have been given greater spread. Today in most schools of this country arithmetic is taught for its uses in the life of the community. It is taught to be useful to the children who learn it, useful to them here and now. It is taught so that the children's drill in arithmetic will not be carried beyond the limits of its uses by average adults in the community."

The arithmetic text now in use has been in use for many years. The authors and publishers of this series, recognizing the findings of research revised this series several years ago in the light of these findings. We are still in the old edition. I recommend, therefore, that we make provision in the budget for 1947 to replace our present books with a newer edition.

Science and Health readers have been placed in grades five and six.

REPAIRS AND UPKEEP.

The following repairs have been accomplished during the past year:

1. The roof on the Ball School has been temporarily repaired.
2. Repaired leak in Knowlton School roof.
3. Painted one classroom at Ball School.
4. Painted two classrooms at Knowlton School.
5. Built a walk in front of Knowlton building.
6. Repaired chimney at Knowlton School.

Besides these, many minor repairs have been done.

CONCLUSION.

In closing I wish to take this opportunity to express my appreciation to the school committee and all school personnel for their spirit of co-operation and for their conscientious efforts to make our schools better.

REPORT OF SCHOOL NURSE.

I hereby submit my annual report on the health program in the Upton Schools.

The routine work of classroom inspection, weighing, measuring, testing sight and hearing has been carried on throughout the year. All defects including sight and hearing are reported to teachers and parents.

Dr. Capen has completed the health examinations including examination of feet as required by the State Department of Health.

A Pre-school Clinic was held in July. Sixteen children entering school in September were examined by Dr. Capen. Few defects were found. These were recorded and reported.

Daily inspections conducted by the teachers help in controlling disease and maintain better health.

In closing my report I wish to thank all for their co-operation during the past year to help in the control of communicable diseases.

REPORT OF MUSIC SUPERVISOR.

I herewith submit my annual report.

There are three main reasons for studying music in our schools. First, it adds to the enjoyment of school life. Second, it gives children the opportunity to learn the most beautiful songs written by the most famous composers. Third, it provides a source of pleasure for others.

Throughout the grades children enjoy singing together. It's natural for children to sing when they are happy. In school both the talented and untalented have a chance to express their feelings through music.

Music appreciation is started in our elementary grades by rote singing and the use of a victrola. Many beautiful melodies, including our patriotic songs, folk songs and modern classics are taught to the children by rote. Opera, children stories set to music, and modern popular songs are listened to on the victrola. In these grades we aim to improve the children's speaking and singing voices by trying to produce tones

that are rich and flexible. Rhythm study is started through the dramatization of songs.

Music more than any other subject provides occasions for giving pleasure to others. The better the children know music the better performance they give, therefore, we must teach the children to "Read Music." That is why all our songs must be taught first by reading "Notes." The more easily we can read music, the wider is our command of the rich resources of musical literature.

I wish to thank the School Committee and the Superintendent of Schools, and the teachers for their co-operation with me in trying to bring about better music in the Upton Schools.
