WARRANT FOR ANNUAL TOWN MEETING FEBRUARY 6, 1950

Worcester, ss

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs to meet at the Town Hall, in said Upton, on Monday the Sixth day of February, punctually, at Seven o'clock A.M. to cast their votes for the following Town Officers:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, Town Treasurer, three Selectmen, Collector of Taxes, Auditor, five Constables, Road Commissioner and Tree Warden, all for one year: one Park Commissioner for three years, one Park Commissioner for two years, one Park Commissioner for one year; one Assessor of Taxes, one member of Board of Public Welfare, one member of School Committee, one Cemetery Commissioner, three Trustees of Public Library and one Town Clerk, all for three years; one member of Upton Housing Authority for five years, and one Trustee of Public Library, to fill vacancy, for one year.

All the above to be voted for upon one ballot.

The polls shall be closed at 8 o'clock P. M. on day of said meeting.

The remaining articles in the Warrant to be acted at an adjourned meeting of the voters in Town Hall, Saturday afternoon, February 11, 1950 at two o'clock.

Article 2. To hear the reports of all town officers, and take any action thereon.

Article 3. To hear reports of any committees appointed by the Town, and take any action thereon.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided in Section 108 of Chapter 41, General Laws, as amended: Moderator, Selectman, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Auditor, Cemetery Commissioners, Constables, Trustees of Public Library, Road Commissioner, Tree Warden, Park Commisisoners, and Upton Housing Authority, or take any action in relation thereto.

Article 5. To raise and appropriate such sums of money as may be necessary to defray expenses of town departments for the ensuing year, or take any action in relation thereto.

Article 6. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1950, and to issue a note or notes therefor, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 7. To see if the Town will vote to raise and appropriate the sum of One Hundred Sixty Eight Dollars and Sixty Cents (\$168.60) for payment of Industrial School bills incurred in 1949, or take any action in relation thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of Two Thousand Five Hundred Dollars (\$2,500.00) for continuation of Chapter 90 Construction on Mendon Street, said appropriation to be used with monies allotted by the State and County, or take any action in relation thereto.

Article 9. To see if the Town will vote to transfer the sum of Fifty-Five Dollars and Twenty-Five Cents (\$55.25) from the Machinery Fund to the Machinery Account, or take any action in relation thereto.

Article 10. To see if the Town will vote to appropriate the proceeds of the 1949 Dog Tax Refund, a sum of Seven Hundred Ten Dollars and Seventy Eight Cents (\$710.78) to the School Account, or take any action in relation thereto.

Article 11. To see if the Town will vote to raise and appropriate the sum of Five Hundred Dollars (\$500.00) for the purchase of equipment for the Police Department, or take any action in relation thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of Five Hundred Fifty-Five Dollars (\$555.00) for purchase of equipment for the Fire Department, or take any action in relation thereto.

Article 13. To see if the Town will vote to raise and appropriate Two Hundred Seventy Five Dollars

(\$275.00) for purchase of forest fire hose for the Forest Fire Department, or take any action in relation thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of Three Hundred Twenty Dollars (\$320.00) to the Highway Department Employees' Vacation Fund or take any action in relation thereto.

Article 15. To see if the Town will vote to raise and appropriate the sum of Three Hundred Seventy Five Dollars (\$375.00) for a new ceiling in Grand Army Hall, or take any action in relation thereto.

Article 16. To see if the Town will vote to raise and appropriate a sum of money for the installation of two street lights on River Street, or take any action in relation thereto.

Article 17. To see if the Town will vote to raise and appropriate a sum of money for the installation of one street light on Stoddard Street, or take any action in relation thereto.

Article 18. To see if the Town will vote to raise and appropriate a sum of money for the installation of three street lights on Mechanic Street between Fowler Street and the home of George H. Donham, or take any action in relation thereto.

Article 19. To see if the Town will vote to raise and appropriate the sum of Two Hundred Ninety Nine Dollars and Twenty Cents (\$299.20) in accordance with provisions of Chapter 32, Section 22, General Laws, for Pension Fund and Expense Fund of the Worcester County Retirement System for 1950, or take any action in relation thereto.

Article 20. To see if the Town will vote to raise and appropriate a sum of money for the installation of a street light on Farm Street, or take any action in relation thereto.

Article 21. To see if the Town will vote to accept the provisions of Chapter 529, Acts of 1949, relating to the appointment of a wire inspector, or take any action in relation thereto.

Article 22. To see if the Town will vote to elect, or authorize the appointment of a Committee for the purpose of investigating the possibility of building and zoning laws for Upton, or act in any manner pertaining thereto.

Article 23. To see if the Town will elect, or authorize the Board of Selectmen to appoint one of its members as Chief of Police or Acting Chief of Police, and to establish a salary to be taken from the Police Appropriation for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to rescind vote of February 7, 1925 under Article 14 relative to establishing a fund as a nucleus for a Library Building, or take any action in relation thereto.

Article 25 To see if the Town will vote to rescind vote of February 6, 1926 under Article 16 relative to the addition of a sum of money to the Library Building Fund, or take any action in relation theerto.

Article 26. To see if the Town will vote to appropriate the sum of Three Thousand Four Hundred Fifty Five Dollars and Ninety-Six Cents (\$3,455.96) by trans-

ferring the same from the Library Building Fund to provide for the erection of a World War II Memorial on the Common at Central Square, or take any action in relation thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE ANNUAL TOWN MEETING
FEBRUARY 6, 1950

With 28 voters present according to Moderator Malcolm C. Temple, he called the meeting to order to read the Warrant.

After reading the call of the meeting and Article 1 for the election of certain town officers today, Chairman of Selectmen Ernest B. Porter moved that reading of the remaining articles be waived to an adjourned town meeting, Saturday, February 11, at 2 P. M. Motion was seconded and voted. Moderator Temple resumed reading of the remainder of the Warrant and Constable's return.

Prior to opening the meeting Moderator Temple and other election officials inspected the ballot box. The indicator of the ballot box was set at 0000. The keys were turned over to Officer J. Harry Shears on duty at the ballot box. A sealed box purporting to contain 1600 ballots were turned over to Messrs. Lyford and Bingel.

The checkers had been sworn in by the Town Clerk. They were Raymond F. Lyford and Peter Bingel at check-in-table; Keneth W. Wood and Gerald L. Shaughnessy at check-out table.

Indicator on ballot box read at intervals during the day at follows: 8 A. M., 50 ballots cast; 9 A. M., 83; 10 A. M., 122; 11 A. M., 170; 12 noon, 215; 1 P. M., 265; 2 P. M., 324; 3 P. M., 391; 4 P. M., 464 5 P. M., 574; 6 P. M., 749; 7 P. M., 913, and 8 P. M., 1037.

At 4:15 . M. the first ballots were removed from the ballot box under supervision of Moderator Temple, the checkers and Officer Shears. A total of 450 ballots were counted in blocks of 50 and placed in respective envelopes. Officer Eugene Bissonnette relieved Officer Shears at the ballot box at 4:30 P. M. When the polls were declared closed at 8 P. M. the ballot box indicator registered 1037. The total number of ballots removed from the ballot box was 1037.

Following persons appointed by the Selectmen to canvass the vote reported at 4 P. M.: LeRoy W. Prentiss, Joseph J. Driscoll, Mrs. Rita Cutler, Mrs. Elizabeth Victor, Mrs. Elinor Varney, Mrs. Alice Martindale, Mrs. Yvonne Bissonnette and Mrs. Helen Poirier.

Reporting at 6 P. M. were: George Daigle, Samuel B. Young, Alfred Blanchard, Ernest Henchey, Edward Gurry, Donald Varney, Gerald McAuliffe and Ernest Aldrich.

Mrs. Violet Picard and Mrs. Ada White tabulated the votes from the tally sheets.

All of the above took oath to perform their respective duties.

After the polls were closed at 8 P. M. the voting lists used were compared by Messrs. Lyford, Bingel, Wood and Shaughnessy. They reported 1037 names checked,

approximately 72 per cent of Upton's total registered voters.

Used and unused ballots and voting lists were placed in containers by election officials and sealed. They were placed in the town vault.

With the canvassing of the vote and tabulating completed, public declaration was read at 11:55 P. M.

PROCEEDINGS OF ADJOURNED ANNUAL TOWN
MEETING FEBRUARY 11, 1950

Moderator Malcolm C. Temple called the meeting to order.

George A. Whittemore spoke to the voters without being given the floor after he declined to address Mr. Temple as Moderator.

1949 TOWN REPORT

Article 2. Gordon E. Benson of the Finance Committee stated that on Page 157, "Report of Finance Committee," that the Reserve Fund appropriation for 1949 should have read \$1,500.00 instead of \$3,000.00. Harrison E. Bates motioned to accept the Town Report as printed with the correction to be noted. Motion seconded and so voted.

UPTON MEMORIAL HIGH SCHOOL

Article 3. Gordon E. Benson, clerk of the Upton Memorial High School Building Committee, stated that full settlement had been made with William Upham, architect, for plans which had been submitted. Copies of the settlement agreement, Mr. Benson, had been filed with the Town Treasurer and Town Clerk.

Selectman Daniel H. Bates then motioned to dismiss the said committee. Motion was seconded and so voted.

SALARIES AND EXPENSES

Article 4. Gordon A. Benson as Acting Chairman of the Finance Committee as Peter Robson, chairman, was unable to be present, read an explanation of the Committee's action on several articles.

"Review of Salaries.

"Town Treasurer. The Selectmen proposed \$100.00 increase as they feel that the salary should be comparable to that of the Tax Collector. However, the Finance Committee feels that for this year at least, the Town Treasurer's salary should remain as is, namely \$750.00

"Town Clerk. A little over a year ago the salary of the Town Clerk as proposed by the Selectmen and recommended by the Finance Committee was increased in the amount of \$100.00. However, due to an error on the part of the Selectmen, or the Finance Committee, or both, this proposed increase was not brought to the attention of the voters at the annual meeting in 1949. The Selectmen proposed an increase of \$150.00. However, it is understood by the Finance Committee that the Town Clerk will only accept the increase of \$100.00 which was supposed to have been acted upon last year. Therefore, your Finance Committee does recommend that the salary of the Town Clerk be affixed at \$450.00 per year.

"Expenses.

"Assessors. The Assessors asked for \$500.00 for expenses, an increase of \$50.00 over their 1949 expense account. This is due to a desire to purchase an adding machine. The Finance Committee appreciates that the Board of Assessors have a very definite need of an adding machine, perhaps more so than any other department, yet we also feel that no particular attempt has as yet been made to utilize the equipment on hand. Namely the adding machine that is at present used by the Tax Collector.

"We firmly believe that the machine now used by the Tax Collector should be available to the Board of Assessors or for that matter, to any department who has need of such machine. Therefore we suggest that the

Board of Assessors, with the knowledge and consent of the Selectmen, make arrangements with the Tax Collector for the use of this machine. For this reason we recommend the sum of \$450.00 as expenses for the Board of Assessors.

"General Appropriations.

"Signs—Expended in 1949—\$24.28. Asked for \$100. We recommend \$50.00.

"From Mr. Snow (Road Commissioner) the Finance Committee understands there are no additional signs to be erected. Therefore the sum of \$50.00 is recommended as we feel this amount should be sufficient to take care of any repairs that may be necessary.

"Old Age Administration (Town).

"When the Welfare Board met with the Finance Committee it was explained that the increase was to take care of salary and expenses of a Social Service Worker, which we understand would be a Civil Service appointee. At that meeting all present felt this should be in the Warrant as a Special Article. However, it has since been ruled by Mr. Walker, Town Counsel, that this did not have to be considered as a Special Article—it could be decided by the Welfare Board. When this item is reached under General Appropriations a further explanation will be given by the Welfare Board.

"Public Welfare, General.

Expended in 1949	\$4,177 78

"The amount of money needed for this account cannot be predetermined. Additional cases mean increase in costs, but if some cases are eliminated it means reduced costs. At best it is an arbitrary figure. Possibly \$4,000.00 will be sufficient. It is also possible that \$5,000.00 would not be sufficient. However, in an effort to keep the tax rate somewhat in line with this past year, we have recommended \$4,000.00. Due to the larger amount in the Reserve Fund it may be possible to help this account should it be needed.

"Schools.

Expended	\$70,701 91

"The amount recommended includes the amount received from the Dog Tax Refund, plus the interest received from the Knowlton and Batchelor Funds.

"There were many equipment replacements purchased in 1949 which will not be repeated in 1950, therefore the members of the School Committee are in accord with the Finance Committee's recommendations.

"Town Officers and Expenses.

"Any changes made in the breakdown of Salaries and Expenses as recommended by your Finance Committee will be reflected in the amount listed under the 'General Appropriations.'

"Article 11. We understand that this request from the Police Department is to equip ten (10) men with revolvers and ammunition, to be placed in the hands of men whom the Acting Chief of Police feels is qualified to handle them properly.

"There is much to be said on this Article—both for and against—in fact there was a difference of opinion amongst the members of the Finance Committee. However, after considerable discussion the Finance Committee voted not to recommend this article as it was felt by the majority of the members that in the event of an emergency the State Police should be called.

"Articles 16, 17, 18 and 20. The above articles all in reference to the installation of Street Lights have been passed over by the Finance Committee as it is our understanding that if the articles are voted, the costs of same will be taken care of by the 'Street Light' appropriation.

"Articles 24, 25, 26. The above Articles were passed over by the Finance Committee as they pertain to the rescinding of a vote previously taken and a transfer of money rather than an appropriation."

Moderator Temple said that unless there was objection that the list of salaries and expenses of certain town officials would be read item for item. If a voter wished to be heard on any item, he or she would say "Pass". After the list was completed, each "Passed" item would be taken up for discussion.

"Passed" on printed report of the Finance Committee were "Town Treasurer, Town Clerk, Assessors, Board of Public Welfare, and Elections, Primary."

Voted to increase salary of Town Treasurer from \$750.00 to \$850.00.

Voted to increase salary of Town Clerk from \$350.00 to \$450.00.

Voted to establish salaries of each of three members of the Board of Assessors of Taxes at \$350.00. (Previous-

ly, \$450.00 for chairman, \$325.00 for clerk, and \$300.00 for third member.) Also, voted to increase Expense Account for Assessors from \$450.00 to \$500.00.

Salaries of Public Welfare Board established at: \$100.00 for Chairman, \$140.00 for clerk, and \$75.00 for third member.

Voted to change wording from "Elections, Primary" to "Town Meetings, Elections, Primary". Recommended amount, \$600.00, voted.

Also remuneration of Moderator established at: \$10.00 for Annual Town Election, \$10.00 for first adjourned Annual Town Meeting; \$5.00 for each additional adjourned Annual Town Meeting; \$5.00 for each Special Town Meeting, and \$5.00 for each adjourned Special Town Meeting with \$40.00 in "Town Officers and Expenses" Account earmarked for this purpose.

Remuneration of Tree Warden voted to be \$1.00 per hour for labor and \$1.85 per hour for use of truck.

Vote taken to establish other salaries and expenses as recommended by Finance Committee.

Deferred items were taken up for consideration as follows:

(a) Highways, Chapter 81. Road Commissioner Henry C. Snow moved that the sum of \$4,500.00 be raised and appropriated to meet the Town's share of the cost of Chapter 81 Highways, and that, in addition, the sum of \$16,500.00 be transferred from unappropriated available funds in the Treasury to meet the State's share of the cost

of the work, the reimbursements from the State to be restored upon their receipt to unappropriated available funds in the Treasury. Voted.

(b) Highways, Chapter 90 Maintenance. Road Commissioner Harry C. Snow moved that the sum of \$500.00 be raised and appropriated to meet the Town's share of the cost of Chapter 90 Highway Maintenance, and that, in addition, the sum of \$1,000.00 be transferred from unappropriated available funds in the Treasury to meet the State's and County's shares of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the Treasury. Voted.

(c) Signs, Selectmen Daniel H. Bates moved that the sum of \$50.00 be raised and appropriated for signs. Voted.

(d) Old Age Assistance Administration. Charles F. Caton, chairman of Old Age Assistance Bureau, stated that the Board favored an appropriation of \$3,000.00 instead of the sum of \$300.00 as recommended by the Finance Committee.

Mr. Caton said in substance that the Board believed that a full-time social worker was required. He said that there were certain requirements by the State and Federal governments in order for the Town to receive grants for Old Age Assistance cases, such as investigation of cases, written reports on visits to Old Age recipients, and other details. He said that the number of cases handled by the local Bureau warranted a social worker. He added that such an appointment would be from a Civil Service list.

Others speaking on the subject included Harrison E. Bates, Mrs. Ada W. White, Raymond Whiting, Charles

Goodhue, Mrs. Sarah E. Pearson, Robert E. Maynard and Norman E. Walker.

After a lengthy discussion motion to appropriate \$3,000.00 for Old Age Assistance Administration was lost.

Harrison E. Bates motioned to appropriate \$300.00 for Old Age Administration. Following another discussion he withdrew his motion.

Gordon E. Benson then motioned to raise and appropriate \$400.00 for Old Age Assistance Administration, seconded by Harrison E. Bates, and so voted.

(e) Parks—Athletic Field. Alfred H. Nichols motioned to increase the appropriation for "Parks—Athletic Field" from the amount of \$300.00 requested by the Selectmen to \$500.00.

Speaking on the subject included Mr. Benson, Forrest P. Salisbury, Donald R. Keniston, Leo F. Murphy and Raymond Whiting.

Moderator Temple said that if Mr. Nichols would ask permission of the assembly to act upon an increase over the original amount requested he would entertain such a motion. Mr. Nichols made such a request. Motion to appropriate \$500.00 was declared lost on a voice vote.

Harrison E. Bates then motioned to raise and appropriate \$300.00 for Parks and Athletic Field. Voted.

(f) Public Welfare. No discussion. Amount recommended by Finance Committee, \$4,000.00 was appropriate.

(g) Schools. Article 10 was taken up at this time without opposition. Motion by Town Treasurer Leo F.

Murphy, seconded by Gordon E. Benson, to transfer the sum of \$710.78 from 1949 Dog Tax Refund to School Account. Voted.

Motion by Mr. Murphy that the sum of \$66,640.47 be raised and appropriated for Schools, and in addition, that \$710.78 be transferred from the Dog Tax Refund, to the School Account. Motion seconded. Voted.

(h) Town Officers and Expenses. Motion by Gordon E. Benson that the sum of \$7,640.00 be raised and appropriated for Town Officers and Expenses. Motion seconded. Voted.

Moderator Temple then accepted a motion to raise and appropriate money for all items under "General appropriations" with changed amounts noted. Seconded. Voted.

BORROWING MONEY

Murphy, duly seconded, that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1950, and to issue note or notes therefor, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, G. Article 14. Voted: on motion of Harrison E. Bates to raise and appropriate the sum of Three Hundred Twenty Dollars (\$320.00) to the Highway Department Employees' Fund.

G. A. R. HALL CEILING

Article 15. Voted: on motion of Harrison E. Bates to raise and appropriate the sum of Three Hundred Seventy Five Dollars (\$375.00) for a new ceiling in Grand Army Hall.

RIVER STREET LIGHT

Article 16. Voted: on motion of Chairman of Selectmen Ernest B. Porter to install one street light on River Street, the sum of \$18.00 to be taken from the Street Lighting Appropriation.

STODDARD STREET LIGHT

LIBRARY BUILDING FUND

Article 24. Motion by Alfred H. Nichols to rescind vote of February 7, 1925 under Article 14, relative to established a fund as a nucleus for a Library Building, was lost by a voice vote.

Prior to taking the vote, Chairman of Selectmen Ernest B. Porter said a committee appointed by the Selectmen had plans for a World War II Memorial. He explained how the Library Building Fund was established by monies received from balance of a World War I Bonus assessment and that at a Town meeting in 1926 (Article

25) money received from sale of the old Upton High School Building was added to the Library Building Fund. He said he favored a Library Building but that it would be years before the present fund would be sufficient to erect such a building.

Other voters speaking included Town Counsel Henry C. Walker, Mrs. Helene D. Robinson and Moderator Temple, who turned the chair over to the Town Clerk during his remarks.

PASSED OVER

Articles 25 and 26. Motion of Chairman of Selectmen Ernest B. Porter to pass over the two articles was so voted.

Town Treasurer Leo F. Murphy moved that all appropriations voted during the meeting be raised by taxation unless otherwise specified when acted upon.

Motion to adjourn and dissolve the warrant was voted.

WARRANT FOR SPECIAL TOWN MEETING
DECEMBER 27, 1950

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Wednesday, the Twenty-seventh day of December, punctually, at Eight o'clock P. M. to act on the following articles:

Article 1. To see if the Town will vote to amend the By-Laws of the Town by adding thereto the following:

CIVIL DEFENSE

Section 1. Department of Civil Defense. There is hereby established a department of civil defense (hereinafter called the "department"). It shall be the function

of the department to have charge of civil defense as defined in Section 1, Chapter 639, Acts of 1950 and to perform civil defense functions as authorized or directed by said chapter or by any and all executive orders or general regulations promulgated thereunder, and to exercise any authority delegated to it by the governor under said Chapter 639.

Section 2. Director of Civil Defense. The department shall be under the direction of a director of civil defense (hereinafter called the "director"), who shall be appointed by the Selectmen. The director shall have direct responsibility for the organization, and for the administration of the department, subject to the direction and control of the Selectmen. The director may, within the limits of the amount appropriated therefor, and subject to the approval of the Selectmen, appoint such experts, clerks and other assistants as the work of the department may require and may remove them, and may make such expenditures as may be necessary to execute effectively the purpose of Chapter 639 of the Acts of 1950.

The director shall also have authority, subject to the approval of the Selectmen, to appoint district co-ordinators and may accept and may receive, on behalf of the Town, services, equipment, supplies, materials or funds by way of gifts, grant or loan, for purposes of civil defense, offered by the federal government or any agency or officer thereof or any person, firm or corporation, subject to the terms of the offer and the rules and regulations, if any, of the agency making the offer. The director shall cause appropriate records to be kept of all matters relating to such gifts, grants or loans.

Section 3. Civil Defense Advisory Council. There is hereby established a civil defense advisory council (hereinafter called the "council"). Said council shall

serve without pay and shall consist of the director of civil defense, and such other department heads and other persons as the Selectmen may deem necessary. Such member of said council, as the Selectmen shall designate, shall serve as chairman of said council. The council shall serve subject to the direction and control of the Selectmen and shall advise the Selectmen and the director on matters pertaining to civil defense.

Section 4. Police Aid to Other Cities and Towns in Event of Riots or Other Violence Therein. The police department is hereby authorized to go to aid another city or town at the request of said city or town in the suppression of riots or other forms of violence therein.

Section 5. Termination of By-Law. This by-law shall remain in force during the effective period of Chapter 639, Acts of 1950 and any act in amendment or continuation thereof or substitution therefor.

Section 6. Definition. All references to Chapter 639, Acts of 1950, as now in force, shall be applicable to any act or acts in amendment or continuation of or substitution for said Chapter 639.

Article 2. To see if the Town will vote to transfer from the following appropriation: Chapter 90, Highway Construction, One Hundred and Two Dollars and Sixty-Two Cents (\$102.62) to Old Age Administration Appropriation, or do or act in any manner pertaining thereto.

Article 3. To see if the Town will vote to transfer from the following appropriation: Chapter 90, Highway Construction, Two Hundred and Sixty-One Dollars (\$261.00) to Public Welfare, General, Appropriation, or do or act in any manner pertaining thereto.

Article 4. To see if the Town will vote to transfer from the following appropriation: Sidewalks, Two Hundred and Forty-Eight Dollars (\$248.00) to Public Welfare, General, Appropriation, or do or act in any manner pertaining thereto.

Article 5. To see if the Town will vote to transfer from the following appropriation: Bridges, One Hundred and Ten Dollars (\$110.00) to the Department of Civil Defense, or do or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE SPECIAL TOWN
MEETING, DECEMBER 27, 1950

At 8 P. M. with not a quorum (20 voters) present, Moderator Malcolm C. Temple declared a recess of 10 minutes during which additional voters arrived in Town Hall. When he called the meeting to order there were 25 voters by count. More voters arrived in the hall as the meeting proceeded.

Moderator Temple in opening the meeting said if there were no objections, he would read the call of the special town meeting and constable's return, omitting the reading of each article at the time as they would subsequently be taken up separately during the meeting. There was no objection.

CIVIL DEFENSE

Article 1. Voted: on motion of Chairman of Selectman Ernest B. Porter to amend the by-laws of the Town by adding the provisions entitled "Civil Defense" as set forth in Article 1 and duly seconded:

Section 1. *Department of Civil Defense.* There is hereby established a department of civil defense (hereinafter called the "department"). It shall be the function of the department to have charge of civil defense as defined in Section 1, Chapter 639, Acts of 1950 and to perform civil defense functions as authorized or directed by said chapter or by any and all executive orders or general regulations promulgated thereunder, and to exercise any authority delegated to it by the governor under said Chapter 639.

Section 2. *Director of Civil Defence.* The department shall be under the direction of a director of civil defense (hereinafter called the "director"), who shall be appointed by the Selectmen. The director shall have direct responsibility for the organization, and for the administration of the department, subject to the direction and control of the Selectmen. The director may, within the limits of the amount appropriated therefor, and subject to the approval of the Selectmen, appoint such experts, clerks and other assistants as the work of the department may require and may remove them, and make such expenditures as may be necessary to execute effectively the purpose of Chapter 639 of the Acts of 1950.

The director shall also have authority, subject to the approval of the Selectmen, to appoint district co-ordinators and may accept and may receive, on behalf of the Town, services, equipment, supplies, materials or funds by way of gifts, grant or loan, for purposes of civil defense, offered by the federal government or any agency or officer thereof or any person, firm or corporation, subject to the terms of the offer and the rules and regulations, if any of the agency making the offer. The director shall cause appropriate records to be kept of all matters relating to such gifts, grants or loans.

Section 3. *Civil Defense Advisory Council.* There is hereby established a civil defense advisory council (hereinafter called the "council"). Said council shall serve without pay and shall consist of the director of civil defense, and such other department heads and other persons as the Selectmen may deem necessary. Such member of said council, as the Selectmen shall designate, shall serve as chairman of said council. The council shall serve subject to the direction and control of the Selectmen and shall advise the Selectmen and the director on matters pertaining to civil defense.

Section 4. *Police Aid to Other Cities and Towns in Event of Riots or Other Violence Therein.* The police department is hereby authorized to go to aid another city or town at the request of said city or town in the suppression of riots or other forms of violence therein.

Section 5. *Termination of By-Law.* This by-law shall remain in force during the effective period of Chapter 639, Acts of 1950 and any act in amendment or continuation thereof or substitution therefor.

Section 6. *Definition.* All references to Chapter 639, Acts of 1950, as now in force, shall be applicable to any act or acts in amendment or continuation of or substitution for said Chapter 639.

(The foregoing Civil Defense By-Law was approved by Attorney General Francis E. Kelly, January 15, 1951.)

Moderator Malcolm C. Temple declared the vote on the above article unanimous, there being no dissenting voice.

OLD AGE ADMINISTRATION

Article 2. Voted: on motion of Chairman of Selectmen Ernest B. Porter, duly seconded, that the town transfer from Chapter 90 Highway Construction, the sum of One Hundred and Two Dollars and Sixty-Two Cents (\$102.62) to the Old Age Administration Appropriation.

PUBLIC WELFARE, GENERAL

Article 3. Voted: on motion of Chairman of Selectmen Ernest B. Porter, duly seconded, that the town transfer from Chapter 90 Highway Construction, the sum of Two Hundred and Sixty-One Dollars (\$261.00) to Public Welfare, General, Appropriation.

PUBLIC WELFARE, GENERAL

Article 4. Voted: on motion of Chairman of Selectmen Ernest B. Porter, duly seconded, that the town transfer from Sidewalks Appropriation, the sum of Two Hundred and Forty-Eight Dollars (\$248.00) to the Public Welfare, General, Appropriation.

CIVIL DEFENSE

Article 5. Voted: on motion of Chairman of Selectmen Ernest B. Porter, that the town transfer from Bridges Appropriation, the sum of One Hundred and Ten Dollars (\$110.00) to the Department of Civil Defense Appropriation.

REPORT OF TOWN COUNSEL

December 31, 1950

To the Board of Selectmen:

As Counsel for the town, I submit my eleventh annual report.

During the year I advised and assisted the various departments of the town, when requested, and rendered opinions. Phone conferences took place with the Attorney General's office, the Division of Accounts, Civil Service Commission, State Planning Board and the Department of Education, County Treasurer and Department of Public works.

The land damage case of Emale Newton was settled for \$135.00 in the Superior Court, before trial.

There is pending in the Superior Court a land damage case brought by Stanley and Virginia Craib.

Two instruments of taking were drawn and recorded.

The By-Laws were published in accordance with General Laws, Chapter 40, Section 32.

As of June 5, 1950, the Ella W. Risteen Trust was reported by the Hartford-Connecticut Trust Company to be valued at \$84,200.

As previously suggested, because of the request of the Department of Corporations and Taxation, I recommend

that the trust funds be brought to Massachusetts into the actual custody of the Town Treasurer. This will place more work on the Treasurer but will represent a saving to the town of about two hundred (\$200.00) dollars.

I am grateful for the assistance and cooperation of the town officials and citizens.

Annual Report of the Cemetery Commissioners

To the Board of Selectmen and to the Voters of Upton:

It may be somewhat of an innovation for the Cemetery Commissioners to have a foreword to their annual printing of the balance sheet for the year. However, we feel that regardless of the seeming picayune nature of the duties involved, it is well to let the voters know how and why their money was spent.

Initially, we surveyed our most urgent needs and found the following to be necessary:

1. To repair and paint the iron fences situated in the center of the cemetery.
2. To refill as many as possible of the sunken graves.
3. To maintain the excellent general condition of the cemetery accomplished during the previous year.
4. To develop the new section facing No. Main Street.
5. To purchase two new mowers and a trimmer.
6. To reactivate many annual care accounts in arrears.

With the exception of not being able to cope with the serious problem of sunken graves, we can report that all these needs have been fulfilled.

Looking to the future, we recommend that vaults of some type be used in the place of pine boxes in order that

eventually we may eliminate the source of our most prevalent complaint, and our major problem, that of sunken graves.

Also, for the future, we plan for the following:

1. To improve the avenues and get a hardened surface on as many of the gravel avenues as possible.
2. To revise the outmoded prices for the sale of lots and perpetual care.

(Note: From a fifty dollar single lot perpetual care account we receive the sum of seventy-five cents in interest yearly for the labor necessary to maintain the appearance of that lot. How much work could one expect today for the sum of seventy-five cents?)

3. To re-invest some of the monies in the perpetual care account in order that the town may realize more interest.
4. To work toward the completion of the new section.
5. To purchase new canvass for burials and survey practicality of obtaining a tent for the protection of personnel and families at burials during inclement weather.
6. To increase hourly pay to superintendent and helpers for work done in order to keep our cemetery one of the assets in our community.

In summary, we wish to thank any and all of you who, in any way, helped us to carry out the duties of our office.

TOWN TREASURER'S STATEMENT

There is deposited in the Milford Savings Bank, \$9.96 known as the Knowlton School Fund with the Town Treasurer as Trustee to be used by the School Committee to defray extraordinary expenses at the Knowlton School Building.

There is deposited in the Milford Savings Bank, one thousand dollars (\$1,000.00) known as the Ella (Whitney) Risteen Fund in trust with the Town Treasurer and School Committee as Trustees, the income to be divided between two pupils in our High School who make the most progress during each year. \$24.73 Interest was received this year. No awards were made.

There is deposited in the Milford Savings Bank, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Library. \$112.50 was received this year.

There is deposited in the Worcester County Institution for Savings, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor School Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Schools. \$112.50 was received this year.

There is deposited in the Milford Savings Bank a War Bonus Surplus Fund to be used as a nucleus of a Fund for a Public Library Building as voted by the Town, February 7, 1925. \$78.18 Interest was received and the amount of this fund on January 1, 1951 was \$3,534.14.

There is deposited in the Milford Savings Bank of Milford, five thousand dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Board of Selectmen to be used to help the townspeople who are in distress. \$121.11 Interest was received and the balance on January 1, 1951 was \$5,475.00. None was used this year.

The Industrial Accident Insurance Fund established in 1937 is deposited in the Milford Savings Bank. \$49.35 Interest was received and the balance on January 1, 1951 was \$2,120.72. Payment from this Fund is to be made only in accordance with rules to be established by the Board of Selectmen. \$110.00 was used this year.

The Department of Veterans' Service

To the Honorable Board of Selectmen and Voters of
Upton:

The year 1950 has found many more Veterans and their Dependents using the facilities of this Department than in previous years. During the year all rights and privileges enjoyed by World War II Veterans under the Veterans' Administration and this Department have been made available to all Veterans of the Korean Conflict with few exceptions.

Veterans' Benefits (aid to needy Veterans) makes up the bulk of the work of this Department. In the past year twenty-one cases have been processed and aid rendered. All money expended in these cases have had State Approval. Where cases were disapproved Veterans were aided usually by finding them suitable employment.

This Office has filed five Disability Compensation applications and Pension forms with the Veterans' Administration, fifteen applications for Hospitalization, four Insurance Conversion applications, and ninety-five Veterans have been given various general information upon request. Photostats have been made of official papers, Discharges, and records for sixty-five Veterans.

I wish to thank the Board of Selectmen and other Town Officials for the fine assistance and cooperation rendered to the Department and myself in the past year. Also to the various local agencies and Townspeople who have assisted this Department I want to extend my sin-

cere appreciation. It has been indeed a great pleasure to serve the Veterans and their Dependents of our Town under such fine cooperative circumstances.

As directed by you, I have made an audit of the books and accounts of the town of Upton for the period from December 13, 1948, the date of the previous audit, to February 19, 1950, the following report being submitted thereon:

The records of financial transactions of the several departments receiving and disbursing money for the town or committing bills for collection were examined, checked, and verified by comparison with the records in the treasurer's office, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on February 19, 1950.

The books and accounts on the town treasurer were examined and checked. The recorded receipts were compared with the records of the several departments collecting money for the town and with the other sources from which money was paid into the town treasury, while the payments were checked with the approved orders of the selectmen authorizing the treasurer to disburse town funds.

The treasurer's cash book additions were verified throughout for the period of the audit, and the cash balance on February 19, 1950 was proved by reconciliation of the bank balance with a statement furnished by the bank of deposit and by examination of a savings bank book.

The securities, including savings bank books, representing the investment of the trust and investment funds in the custody of the town treasurer and trustees were examined and listed, the income being proved and the withdrawals being verified.

The books and accounts of the tax collector were examined and checked. The commitments were compared with the warrants issued by the board of assessors, the abatements as recorded were checked with the assessors' records of abatements granted, the recorded collections were checked with the payments to the treasurer as recorded on the treasurer's cash book, and the outstanding accounts as of February 19, 1950 were verified.

Verification of the outstanding accounts was made by sending notices to a number of persons whose names appeared on the books as owing to the town, and from the replies received it appears that the accounts, as listed, are correct.

The town clerk's records of dog licenses issued on behalf of the county and of sporting licenses, the proceeds of which are paid to the State, were checked, and the payments to the town and to the Division of Fisheries and Game were verified.

The surety bonds of the officials required by law to furnish them were examined and found to be in proper form.

In addition to the departments mentioned, the books and accounts of the sealer of weights and measures and of the selectmen as well as of the police, health, public welfare, veterans' services, school, library, and cemetery departments, were examined and checked, the payments to the treasurer being verified.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's and the collector's cash, summaries of the tax, excise, tax title, and departmental accounts, as well as tables showing the transactions and condition of the trust investment funds.

During the progress of the audit, cooperation was extended by all town officials, for which, on behalf of my assistants and for myself, I wish to express appreciation.

Upton Civil Defense

On September 25, 1950 the Selectmen, in compliance with Section 50 of Chapter 639 of the Acts of 1950, appointed me as Director of Civil Defense for the Town of Upton. A few days later a Defense council was appointed consisting of Charles R. Stewart, Edward Prentiss, Dr. Bernard F. McKernan, Henry J. Poirier, and Edward J. Kuczinski.

They all accepted the office and as soon as they were sworn in we started to organize a Civil Defense Program and Organization to carry it out.

It involves a great deal of work and study and planning. I feel that a good deal of progress has been made; I have attended 3 meetings in Boston and one in Worcester receiving instruction.

The over all picture is too big to describe in this report; it consists, mainly, of organized groups to function along definite lines. Perhaps, most important is the Educational Program that must be carried out to help people to help themselves by knowing what to do if a disaster of any kind occurs.

The School Committee will play an important part, by an organized plan in the schools.

The Selectmen as a board have been very cooperative; this also applies to the School Committee, Town Clerk and other Town Officers so far as they have signed up as members of the Organization.

The Fire and Police Departments have signed up nearly 100%. All this is gratifying and I am appreciative of this co-operation. Because of this, I feel we have made definite progress. There is a sad side which is discouraging; we need many more members—as of December 31st. only 76 had signed out of some 1500 or more who are eligible. That is too small a percentage.

We need a minimum of 125 and more if we can get them. We need them at once so that when the training program starts all members will have the benefit without our having to go back and start over for new members.

I expect this report will go into every home in Town and I appeal to every able bodied man and woman to recognize the need, the responsibility and the opportunity that we should all share as fellow citizens and as Americans.

JOIN CIVIL DEFENSE NOW

In this effort the welfare of each is bound up in the good of all; I have lived among you too long, to believe, as citizens you would willingly shirk your responsibility to yourself and others; so thru this report, I again appeal to you to offer your services in Civil Defense.

REPORT OF COMMITTEE ON
ZONING AND BUILDING LAWS

THE HONORABLE BOARD OF SELECTMEN:

Upton, Massachusetts

Confirming the verbal report given to you at the joint meeting October 11, 1950, the Committee "to study the possibilities of Zoning and Building Laws for Upton," wishes to submit the following.

The committee has had a number of meetings. In order to get as much information as possible on the subject, questionnaires were sent to the sixty-two Towns in Massachusetts with a population of 2,000 to 3,500, and we received replies from fifty-eight of these towns.

Of the fifty-eight replies, fourteen Towns have complete Zoning and Building Laws, one Town with Building Laws only and one Town with Zoning Laws only. Eleven Towns are contemplating either Zoning or Building Laws, and the remaining thirty-one Towns are not planning either Zoning or Building Laws. The State Planning Board and our State Officials were contacted and sent helpful literature.

A map of the Town was tabulated showing all residential building starts from January 1, 1946 to October 7, 1950. This map shows that eighty-four homes were started in Town during this period. Thirty-seven of these

have been finished, and thirteen more are moving rapidly towards completion. Twenty-four range from excavations to completed cellars, and included in this group are basement homes. Ten of the eighty-four, the committee feel are not an asset to the community (14% of total starts).

An intensive study was made of available information and it seems that some kind of regulations are needed to protect and encourage the prospective home owner in the growing trend to move from the city to the suburb and at the same time care for the interests of the present property owners.

After surveying all facts, the Committee unanimously voted that a mild set of Protective By-Laws would be helpful and desirable for the Town of Upton.

Supporting maps, charts and figures shown during October 11th joint meeting are on file with our Clerk.

REPORT OF
UPTON SCHOOL BUILDING COMMITTEE

The Upton School Building Committee was elected August 9, 1949, at a special town meeting. Mr. Donald Johnson was named Chairman and Mr. Allan Donham, Secretary, at its organization meeting, August 11.

Nine meetings were held and four architects consulted before the Perley F. Gilbert Associates of Lowell were directed on September 20 to prepare preliminary sketches for approval of the committee and Mr. Marshall, Chairman of the School Building Assistance Commission.

The present sketch of the school was accepted on October 14, 1949 and approved with some changes by Mr. Marshall on October 29. On November 14, 1949, a contract was signed between the committee and Gilbert Associates.

On February 5, 1950, working plans and specifications were accepted for advertisement for bids and were so advertised on February 8, in Worcester, Boston and Milford papers. The bids were opened at a public meeting in Town Hall, March 1, 1950, with the Wexler Construction Company of Brookline submitting the low figure of \$213,333. Seven meetings were held with the committee, architects and the low bidder, in order to revise plans and specifications, so that we could let the contract at a figure within the money voted by the town. On March 25, 1950, a contract was signed with Wexler at a contract price of \$186,436 and performance bonds were executed. On May 31, a contract for water pump and tank was signed with James E. Heaney of Rutland at a price of \$1635.

Since the contract was signed sixteen formal meetings and several telephone and informal meetings have been held in order to expedite completion of the building, to revise plans when some materials were not available, to make improvements where deemed necessary, and to correct errors and otherwise protect the interest of the town. Every effort has been made to minimize the cost of extras over and above the contract price.

Attendance at committee meetings has been very good. Although none of the committee had previous experience in such a complex job and have undoubtedly made many mistakes, we feel that the job has been conscientiously done. We will let the building itself stand as our record.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

TO THE MEMBERS OF THE UPTON SCHOOL COMMITTEE:

Gentlemen:

I have the honor to submit my sixth annual report on the Public Schools of the Town of Upton.

Schools opened in September with the following enrollment:

This is an increase of forty-one over the enrollment in September 1949.

PERSONNEL

Mrs. Susan W. Brousseau, a teacher in the Public Schools of Upton since 1913, retired March 1, 1950. Mr. James J. Duffy was appointed to this position. Other changes in the school staff which took place during the year are as follows:

Mrs. Bonita L. Lynch was appointed teacher of Grade IV.

Miss Mary E. Ferrari, Supervisor of Art, resigned in June and was replaced by Miss Margaret H. Johnson.

Mrs. Virginia Moreland, Supervisor of Physical Education resigned in June and her place has been filled by Miss Barbara A. Gould.

Miss Barbara J. Bosquet was appointed as part time reading coordinator. The purpose of this appointment is to help teachers locate and remedy reading difficulties of children who are retarded in reading. Her report will outline the work already done.

TUITION

In September both the Town of Northbridge and the Town of Grafton increased the tuition rate per pupil from One Hundred Fifty Dollars to One Hundred Sixty Dollars per year. There is every indication that these rates will be increased again as costs continue to rise. It should be very clear, however, that a modern program in secondary education could not be housed and taught within the Town of Upton for an amount equal to twice the present rate.

NEW SCHOOL

One of the most serious problems facing the school committee, that of properly housing the elementary school pupils, has been overcome by the erection of the Upton Memorial School.

Contracts were signed in April 1950 for the construction of this building and its completion was scheduled for September 1950. Shortages caused by the present world condition, along with the many other problems incident to such an undertaking, have made this impossible to achieve. At the time of the writing of this report, it seems safe to predict that the building will be completed by early February 1951.

The School Building Committee has worked diligently throughout the year. They have given generously of their time and energy. They have been constant in their desire to provide the best school, within the appropriation available, for the school children of Upton. It is generally agreed that the same building would cost a great deal more if contracts were to be negotiated at the present time.

The Upton Memorial School embodies many of the characteristics of a modern school building. It is my recommendation, that in the future, money be appropriated from year to year to improve the present conditions, caused necessarily by financial limitations, by adding such things as more chalkboards, more bulletin boards, and more book shelves, filing and storage cabinets, large closed-in type wardrobes, the installation of an automatic bell system and such other items as from time to time seem essential.

During the past two years, sufficient classroom furniture for the new building has been purchased from the regular school appropriation and put into use in the Knowlton and Ball Schools. This has proven to be a wise investment because, at the present time, school furniture, if available at all, is priced higher than formerly. Consequently, a considerable amount has been saved and conditional delays in filling furniture orders will not prevent occupancy of the new school, as might have happened had we waited till now to place orders.

MAINTENANCE

During the past year the regular program of repairs and maintenance has been curtailed to include only the minimum essentials. These have included temporary repairs on the Ball School roof, repairs upon the plumbing in both the Knowlton and Ball Schools and those expenditures necessary to prepare the temporary extra classroom in the basement of the Ball building.

CONCLUSION

Education is unquestionably the greatest single influence for the preservation and the strengthening of "American Freedom" at a time when the very air in every civilized community on this globe is charged with a fateful mixture of hope and foreboding.

Every plan that we make for the future is tinged with the acute awareness of the peril in which we live. The guarding of American democracy may require powerful armies, navies, and air fleets, but these are not enough. If democracy is to survive, it must do far more than appropriate billions of dollars for military defense, build tanks, airplanes, and battleships, master the correlated military skills and knowledges. The defense of

democracy is, in the last analysis, a question of the values, and ideas to be defended. It is a question of the EDUCATION of free people to desire these values.

The greatest single factor in the determination of what America is to be tomorrow and for generations to come is the character of our educational system. Our schools will keep us free.

I am grateful to all employees of this department for their continued co-operation and to the School Committee for its advice and support of school policies.

REPORT OF THE READING CO-ORDINATOR

Mr. Ralph C. Sturke
Supt. of Schools

Dear Mr. Sturke:

There are many problems involved in setting up a new program such as a program for remedial reading instruction in a system where such instruction has not been given previously. However, after consulting with Donald D. Durrell, Dean of the Boston University School of Education, and head of the school's Reading Clinic, the Superintendent of Schools, and others in the field of reading, an initial program was planned. It was decided to begin with a survey testing program to obtain more information about the capacity for and level of achievement in reading of the children in our schools. The *Durrell-Sullivan Reading Capacity and Achievement Test, Form A*, was administered to both third grades.

In the first and second grades, a somewhat different testing program is being followed. Among the essentials for good reading are adequate quick perception of words, an adequate method of word analysis, and a well built foundation of reading habits and study skills. These depend on ability to perceive and discriminate with one's eyes and ears. Since a certain level of mental maturity must be reached before audio-visual discrimination and reading are possible, a measure of general mental ability was administered to help determine reading capacity. The *Kuhlmann-Anderson General Intelligence Test*, was used

for this purpose. It is entirely non-verbal, and provides the closest agreement with individual intelligence tests. This test was administered to both the first and second grades.

In addition, the Murphy-Durrell Diagnostic Reading Readiness Test was administered in the first, and when needed, in the second grades. This test measures auditory and visual discrimination, and learning rate.

Using these test results as a guide, materials are being prepared and provided to meet the needs of each child at his own reading level. Games and other devices are being prepared to provide a variety of exercises or practice, through which these children can build a basic vocabulary and word analysis skill. As soon as they have acquired a vocabulary adequate for pre-primer reading, pre-primer reading material, with a carefully controlled vocabulary, yet of high interest, is provided. As far as possible this reading material is interesting enough to help develop a desire to read, yet at a low enough reading level to assure success and provide pleasure in reading.

It is yet too soon to evaluate the program. However, in some cases where materials and techniques of instruction have been adapted to the needs of the child, encouraging progress has been made.

During the Fall months the Physical Education program in the schools of Upton progressed very well. The children were kept outside, on the playgrounds, for as long as the weather permitted, in this instance, up until two weeks before Christmas.

Classroom space and facilities are so very limited that indoor activities cover only the bare essentials of a physical education program. With the opening of the new elementary school, and the acquiring of additional equipment, the program will expand.

Pupil response has been very good, and enjoyment of the activities ran high. However, with level playing areas, standards and nets, and other outdoor equipment, the program could be greatly rounded.

Many Upton girls in the high school group have turned out for basketball and are helping to make the teams more effective. Games to be played total ten in number, and are with towns in this area. Those who have come out are sophomores, and while this causes dismay for the season which is now in progress, it means that they will be veterans for the coming years. They are

young to carry the full weight of varsity players, but their enthusiasm and earnestness promise to make the games exciting.

The Physical Education Program in the elementary schools has taught the following:—chasing-fleeing type games, team games, relays, individual skills, guidance in leadership and sportsmanship, enjoyment and participation, co-operation, self-realization through physical activity, and making games fun for all those playing.

I wish to express appreciation to all faculty members for their co-operation in helping to make the Physical Education Program effective.

REPORT OF THE SUPERVISOR OF ART

I hereby submit the following report as Supervisor of Art in the Town of Upton.

The Art Classes in the Schools of Upton have been conducted with the following objectives in mind:

- (1) To instill general understandings in drawing which will help the student express his own ideas.

- (2) To integrate the Art activities with other subject matter being studied, i. e. social studies, sciences, health, etc.
- (3) To foster individual growth by encouraging the student to organize, execute, and complete his own work.
- (4) To encourage the students exploration and experimentation of materials presented to him.
- (5) To give the students the best available ideas on design and arrangement.

All grades from 1-7 have been given a review of color, with enjoyment and practical applications as an aim. Grades 1-7 have also been given instruction in figure drawing plus drawing aids in many other things which are in the realm of their personal interests and every day life. The students are then prepared to meet the problems of a particular subject because of their enriched background.

The students are motivated by appealing to their personal interests and experiences, family, community life, nature, and school subjects.

Originality, independent thinking, control of materials, and confidence in work done is subject to evaluation both by the student and the teacher; however, work is not judged by adult standards of "correct" or natural drawing but rather by expressiveness, originality, honesty of effort, individual growth of progress, accomplishment of purpose, design, color, and feeling for texture.

Teachers display all the students work if only for a short time.

The Art Program is intended to correlate with such subjects as Social Studies, Geography, English, and History, and all teachers were asked to give an outline of their course of study from September to June so that the Art Program could be correlated with it.

Media which has been taken up are crayon, pencil, powder paint (grade 1-5), and cloth. Materials to be used in the future are water colors (grade 6-7), chalk, pen and ink, and plasticine.

Pamphlets have been issued to all the teachers, giving them guidance and instruction concerning the aims of the Art Program. These pamphlets are supplemented with a monthly guide sheet.

The Art Program intends to include these topics during the year's work:

Drawing and Color

Design and Composition

Handicraft Work

Lettering

Plasticine Modeling

Principals and teachers of each school have been notified of available exhibitions at the Worcester Museum of Art. These have been used in the schools.

REPORT OF THE SUPERVISOR OF MUSIC

Dear Mr. Sturke:

It is with pleasure that I submit to you my annual report as Music Supervisor in the Schools of Upton.

There are three main reasons for studying music in our public schools. First, it adds to the enjoyment of school life. Second, it gives children the opportunity to learn the most beautiful songs written by the most famous composers. Third, it provides a source of pleasure for others.

The music period brings a pleasant change from other school work. It is natural for children to sing when they are happy and in school it gives children the opportunity of singing together which they all enjoy and take part in.

In the first grade great care is given to the child's voice and great emphasis is put upon the quality of tone. We attempt to develop good singing while building a repertory of songs. Rhythmic expression is developed through activity songs, marching, free body movements and listening to records. A course in Music Appreciation is given throughout the grades by the use of a victrola.

In the second grade elementals of theory are introduced and children become familiar with the staff, scale and note arrangements.

This program is continued through the third, fourth, and fifth grades with added drill on note reading and sight singing. The more easily we can read music, the wider is our command of the rich resources of musical literature.

In the sixth and seventh grades children should be able to sing a new song with a minimum of assistance from the teacher. In these grades two and three part music is sung with special attention given to the boys changing voice.

In closing I would like to thank Mr. Sturke, the School Committee, and the teachers for their co-operation with me at all times.

I hereby submit my annual report as School Nurse for the Town of Upton.

The aim of the health program is better health in our schools by finding defects early and helping to have them corrected.

The usual routine of weighing, measuring, testing eyes and hearing was carried out throughout the year.

Dr. McKernan has completed his annual health examination. All defects found last year were thoroughly checked and many were found improved. The greatest defect noted was teeth. A special check-up will be made to see if this can be improved.

The new audiometer loaned us by the Massachusetts State Department of Health found several pupils with defective hearing. Home visits were made and 80% of these pupils visited physicians for treatment.

During the National Diabetic Week, the Diabetic Screening Test Clinic was held, 257 school pupils responded to this test, all were found negative. We aim to make this an annual clinic.

I wish to thank the Kiwanis and the Salvation Army for their donation of glasses.

May I express my appreciation for the co-operation I have received from you, the School Board, teachers and parents.
