

WARRANT FOR ANNUAL TOWN MEETING

MARCH 1, 1954

Worcester, ss.

To the Constable of the Town of Upton, in the County
of Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday, the First day of March, 1954, punctually, at Seven o'clock A.M. to cast their vote for the following town officers:

Article 1. To choose all necessary officers for the ensuing year: Moderator, three Selectmen, Town Treasurer, Collector of Taxes, five Constables, Road Commissioner and Tree Warden, all for one year; one member of Assessors of Taxes, one member of Board of Public Welfare, one member of School Committee, one member of Cemetery Commission, one member of Sewer and Water Commission, three trustees of Public Library and one member of Park Commission, all for three years; one member of Housing Authority for five years, and one member of Park Commission for two years to fill a vacancy.

All of the above to be voted for upon one ballot.

The polls shall be closed at Eight o'clock (8) P.M. on the day of said meeting.

The remaining articles in the Warrant to be acted upon at an adjourned meeting of the voters in Town Hall, Saturday afternoon, March 6, 1954 at two o'clock P.M.

Article 2. To hear the reports of all town officers, or do or act in any manner pertaining thereto.

Article 3. To hear reports of any committees appointed by the Town, or do or act in any manner pertaining thereto.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective town officers of the Town as provided by Section 108 of Chapter 41, General Laws, as amended: Moderator, Selectmen, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Cemetery Commissioners, Constables, trustees of Public Library, Road Commissioner, Sewer and Water Commissioners and Tree Warden, or do or act in any manner pertaining thereto.

Article 5. To raise and appropriate such sums of money as may be necessary to defray expenses of Town Departments for the ensuing year, or do or act in any manner pertaining thereto.

Article 6. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Select-

men, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1954, and to issue a note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 7. To see if the Town will vote to authorize the Board of Selectmen to appoint one of its members as Chief of Police or Acting Chief of Police, and to establish a salary to be taken from the Police Appropriation for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 8. To see if the Town will vote to appropriate the proceeds of the 1953 Dog Tax Refund, the sum of Seven Hundred and Sixty-Four Dollars and Ninety Cents (\$764.90) received from the County, to the School Account, or do or act in any manner pertaining thereto.

Article 9. To see if the Town will vote to authorize the School Committee to appoint one of its members as School Physician, and to establish a salary to be taken from the School Account for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 10. To see if the Town will vote to authorize the Cemetery Commissioners to employ one of its members as a supervisor of Lakeview Cemetery and other town cemeteries, and to establish the rate of pay for

such appointee to be taken from the Cemetery Account, in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 11. To see if the Town will vote to authorize the Park Commissioners to employ one of its members, to establish the hourly rate of pay for such appointee to be taken from the Parks and Playgrounds Account, in accordance with provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of Four Thousand Dollars (\$4,000.00) for the purpose of installing a new heating system in the George S. Ball School Building as requested by the School Committee, or do or act in any manner pertaining thereto.

Article 13. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2000.00) for Chapter 90 Highway Construction on Pleasant Street, or do or act in any manner pertaining thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of Fifteen Hundred Dollars (\$1500.00) for Chapter 90 Highway Maintenance, or do or act in any manner pertaining thereto.

Article 15. To see if the Town will vote to authorize the Board of Sewer and Water Commissioners to dis-

pose of old hydrants, or do or act in any manner pertaining thereto.

Article 16. To see if the Town will vote to authorize the Board of Sewer and Water Commissioners to appoint one of its members as superintendent of said Department, and to establish the salary of such appointee to be taken from the Sewer and Water Account in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 17. To see if the Town will vote to authorize the Board of Sewer and Water Commissioners to purchase or take by eminent domain an easement in and over land of Elizabeth C. McClure, situated on the northerly side of Warren Street, for the purpose of installing, maintaining, repairing and replacing water mains, together with a right of way for entering upon such premises for said purpose, and to transfer from the Water Construction Loan the sum of Six Hundred Dollars (\$600.00) to defray the cost of such purchase or taking, or do or act in any manner pertaining thereto.

Article 18. To see if the Town will vote to authorize the Board of Sewer and Water Commissioners to purchase or take by eminent domain an easement in and over land of Gertrude I. Fiske and Beatrice A. M. Fiske, situated off the northerly side of Warren Street, for the purpose of installing, maintaining, repairing and replacing water mains and standpipe, together with a right of way for entering upon such premises for such purposes, and to transfer from the Water Construction Loan the sum of Five Hundred Dollars (\$500.00) to defray

the cost of such purchase or taking, or do or act in any manner pertaining thereto.

Article 19. To see if the Town will vote to authorize the Board of Sewer and Water Commissioners to purchase or take by eminent domain an easement in and over land of Rudolph J. Scholl and Ruth Scholl, situated off the northerly side of Warren Street for the purpose of installing, maintaining, repairing and replacing water mains and standpipe, together with a right of way for entering upon such premises for said purposes, and to transfer from the Water Construction Loan the sum of Five Hundred Dollars (\$500.00) to defray the cost of such purchase or taking, or do or act in any manner pertaining thereto.

Article 20. To see if the Town will vote to raise and appropriate, or transfer from available funds in the treasury, the sum of Three Thousand Dollars (\$3000.00) for the purchase of an ambulance, said money to be used with any allowance received from the trade or sale of the present ambulance, the same to be expended under the supervision of the Board of Fire Engineers, or do or act in any manner pertaining thereto.

Article 21. To see if the Town will vote to transfer the sum of One Thousand and Eleven Dollars and Twenty-Five Cents (\$1011.25) from the premium on Loans Account in the general treasury to the Notes and Interest Account, or do or act in any manner pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of Fifteen Hundred Dollars

(\$1500.00) for repairs on so-called Reservoir Street Extension, or do or act in any manner pertaining thereto.

Article 23. To see if the Town will vote to raise and appropriate the sum of Three Hundred Dollars (\$300.00) for construction and maintenance of water holes for fire protection purposes, or do or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to transfer Twenty-Eight Dollars and Sixty Cents (\$28.60) from Machinery Fund to the Machinery Account for Highway Department use, or do or act in any manner pertaining thereto.

Article 25. To see if the Town will vote to raise and appropriate the sum of Six Hundred Thirty-Eight Dollars and Forty-Six Cents (\$638.46) for pension, expenses and military services funds of the Worcester County Retirement System as provided by law, or do or act in any manner pertaining thereto.

Article 26. To see if the Town will vote to appropriate from available funds in the treasury, the sum of One Thousand Nine Hundred and Twenty-Five Dollars (\$1925.00) to reimburse the R. H. White Construction Co. of Auburn, Mass. in connection with the construction of the Town Water System and installation of hydrants, or do or act in any manner pertaining thereto.

Article 27. To see if the Town will vote to raise and appropriate the sum of Two Thousand Three Hun-

dred and Fifty Dollars (\$2350.00) for hydrant rental, or do or act in any manner pertaining thereto.

Article 28. To see if the Town will vote to transfer One Hundred Sixteen Dollars and Eighty-One Cents (\$116.81) from the Hartford Avenue Bridge Account to the town treasury, or do or act in any manner pertaining thereto.

Article 29. To see if the Town will vote to take any action on any reports or information brought forward on the disposition of the Grand Army Building, or do or act in any manner pertaining thereto.

Article 30. To see if the Town will vote to authorize the Selectmen to sell its rights in a certain spring and well situated off northerly side of Main Street and westerly of land of one Williams as acquired under deed of William Knowlton dated February 13, 1875, and recorded with Worcester District Deeds, Book 953, Page 69, or do or act in any manner pertaining thereto.

Article 31. To see if the Town will vote to raise and appropriate the sum of Ninety Dollars (\$90.00) for the installation of five street lights on Taft Street, or do or act in any manner pertaining thereto.

Article 32. To see if the Town will vote to raise and appropriate the sum of Eighteen Dollars (\$18.00) for the installation of one street light on Wildwood Avenue, or do or act in any manner pertaining thereto.

Article 33. To see if the Town will vote to raise and appropriate the sum of Twenty-Eight Dollars (\$28.00) for installation of a street light on Fisk Street, near the entrance to the Nipmuc Rod & Gun Club, Incorporated, clubhouse, or do or act in any manner pertaining thereto.

Article 34. To see if the Town will vote to elect the Board of Selectmen as follows: One member to be elected for a three-year term, one member to be elected to a two-year term, and one member to be elected to a one-year term; to become effective at the annual election of Town Officers in 1955. Each year thereafter one Selectman to be elected for a three-year term.

Article 35. To see if the Town will vote to authorize the Town Treasurer, with approval of the Selectmen, to borrow Ten Thousand Dollars (\$10,000.00) in anticipation of reimbursement by the State, to finance a portion of the State's share for Chapter 81 Highway work for 1954, or do or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF ANNUAL TOWN MEETING

March 1, 1954

Pursuant to the Warrant, Moderator Halbert K. Struthers called the meeting to order at 7 o'clock A.M.

After reading the call of the meeting and Article 1 for choosing of all necessary officers, Mrs. Ruth M. Fiske moved that reading of the remaining articles be waived to be acted upon at adjourned town meeting March 6, 1954 at 2 P.M. Motion was seconded and voted. Moderator Struthers then continued to read the remainder of the Warrant and Constable's return.

Moderator Struthers invited any voter to inspect the ballot box which was opened. The box's indicator was set at 0000. Officer Oscar K. Bates was on duty at ballot box and held the box keys.

A sealed box purporting to contain 1900 ballots was turned over by the Town Clerk to Moderator Struthers, who delivered the box to William J. Gorman (D) and Raymond F. Lyford (R). At the check-out table at ballot box were Mrs. Adelaide E. Bartlett (R) and Edward J. Gurry (D). The checkers were sworn to perform their duties by the Town Clerk.

Mrs. Ruth M. Fiske was the first voter to cast a ballot. Harry C. Snow was second voter.

Indicator on ballot box read at hourly intervals as follows: 8 A.M., 27 ballots cast; 9 A.M., 58; 10 A.M.,

115; 11 A.M., 166; 12 noon, 200; 1 P.M., 254; 2 P.M., 338; 3 P.M., 390; 4 P.M., 428; 5 P.M., 571; 6 P.M., 738; 7 P.M., 912, and 8 P.M., 1038. There were 1036 ballots cast and counted. Likewise voting lists showed 1036 names checked. Ballots 678 and 852 became caught in ballot box mechanism, causing indicator to register twice for each ballot.

First removal of ballots was at 3.50 P.M. when 400 ballots were counted and placed in envelopes in presence of election officials. At 7.40 P.M. an additional 100 ballots were removed. After polls were declared closed by the Moderator at 8 P.M., 536 more ballots were removed, making total 1036 ballots.

Tellers reporting at 4 P.M. to canvass vote were: Mrs. Rita C. Cutler (D), Mrs. Shirley E. Kirby (D), LeRoy W. Prentiss (R) and Mrs. Ada W. White (R).

Tellers reporting at 6 P.M. were: Mrs. Nina L. Allard (R), Mrs. Yvonne M. Bissonnette (D), Mrs. Alice G. Cooley (D), Mrs. Helen I. Donham (R), Mrs. Mary A. Gilchrist (D), Ernest J. Henchey (R), Mrs. Ruth A. Sweet (R) and Mrs. Elizabeth Victor (D).

Edward F. Furphy (D) and Edward L. Prentiss (R) reported at 6 P.M. to tabulate the vote.

The Town Clerk administered the oath to above election officials.

Voting lists used at the two tables were compared. Each group of checkers reported 1036 names checked: 534 men and 502 women.

Used and unused ballots, including one spoiled ballot in separate envelope, were deposited in containers, sealed, and placed in town vault.

Public declaration was made of the result of voting by Moderator Struthers, as recorded by the tabulators, at 10.50 P.M.

MARCH 6, 1954

(a) District Nursing Association. Voted: on motion of Selectman Malcolm C. Temple, seconded, with amendment accepted, to postpone action until next special town meeting in order to arrange proper wording of an article for voters' consideration which would allow reimbursement to the town for certain services by the Association's nurse, and that the directors of the Association be so notified.

(b) Highways. Chapter 81. Harry C. Snow, retiring Road Commissioner and Street Superintendent, moved "that the sum of \$4500.00 be raised and appropriated to meet the Town's share of the cost of Chapter 81 Highways, and that, in addition, the sum of \$16,500.00

be transferred from unappropriated available funds in the Treasury, or borrowed for the purpose as provided in Article 6 to meet the State's share of the cost of the work, the reimbursements from the State to be restored upon their receipt to funds in the treasury. Seconded. Voted.

(c) Bridges. Four hundred dollars (\$400.00) voted to be raised and appropriated as recommended by the Finance Committee.

(d) Notes and Interest. Action deferred. Sum of \$30,000.00 recommended by Finance Committee. Item to be considered after action on Article 21.

(e) Schools, including Industrial. Voted: to raise and appropriate \$104,344.10 for Schools, including Industrial, following a lengthy discussion during which there was mention of unused Knowlton Schoolhouse for which a trust fund was established by certain members of the Knowlton family for its upkeep with provision that the town also appropriate money for like purpose.

Mrs. Elsie J. Craib of the School Committee stated that the interest money received from the fund was used to repair broken windows. She said there was plaster off in the building and the committee had not planned to repair it.

Others speaking included Harold S. Hopkins, Town Counsel Shaw, George N. O. Poirier, Robert E. Maynard, Walter H. Allen and Mrs. Ada W. White. Mr. Hopkins,

chairman of Finance Committee, said it seemed that some repair work could be done on the Knowlton building.

Mrs. Craib explained that the increased appropriation asked for Schools was partly due to more pupils to attend Grafton High School and opening of the cafeteria at Memorial School.

(f) Water and Sewer Department. Sum of \$3400.00 was voted to be raised and appropriated.

At this point of the meeting (3:40 P.M.), Donald L. Varney moved to recess for 10 minutes. Motion seconded. Motion voted in negative.

AUTHORIZATION TO BORROW MONEY

Article 6. Voted: on motion of Town Treasurer Leo F. Murphy, duly seconded, that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1954, and to issue a note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws. Unanimous vote declared by Moderator Struthers.

AUTHORIZING SELECTMEN TO APPOINT ONE OF ITS MEMBERS AS POLICE CHIEF

Article 7. Voted: on motion of Raymond E. Griffin, duly seconded, that the Selectmen be authorized to ap-

point one of its members as Chief of Police and establish his salary at \$50 a month to be paid from the Police Appropriation. Standing vote was taken with Constables Alfred H. Nichols and Alvin P. Nichols as tellers. Result announced by Moderator Struthers: Yes—44; No—27.

This action was taken after Article 11 was disposed of.

When Article 7 was originally presented to the voters, Selectman Daniel H. Bates moved that the Board of Selectmen be authorized to appoint one of its members as Chief of Police in accordance with the provisions of the General Laws, Chapter 41, Section 4A, and a salary be set at \$50.00 a month and salary to be taken from the Police Appropriation.

Selectman Malcolm C. Temple moved to amend motion that a ballot vote be taken which was seconded. Standing vote taken on Mr. Temple's amendment for a ballot vote on the question: Yes—53, No—29. Constables Alfred H. Nichols and Alvin P. Nichols made the count. Moderator Struthers announced the count.

Moderator Struthers appointed Ernest I. Bentley, David A. Colcord, Harold S. Hopkins and Donald B. Johnson as tellers. "Yes" and "No" ballots were passed out at the first checking table (Messrs. Bentley and Johnson) by the Town Clerk as a voter gave his or her name. The checkers also served as tellers. Result of voting: "Yes" in favor of Mr. Bates' motion, 45 votes: "No"—60 votes. Vote was declared at 4.50 P.M. by Moderator.

Jonas E. Carter moved that a rising vote of thanks be given to Daniel H. Bates for his service as chief of police and as a police officer. Voted with some hand applause.

Selectman Bates thanked the voters for their expression of appreciation for his police work. He said he had never allowed the duty of either office — selectman or police chief to interfere with the other. He stated he would not serve as a member of the Board of Selectmen as a result of the vote.

After Article 11 had been acted upon, Gordon E. Benson moved for reconsideration of Article 7 which was seconded and voted.

Mr. Benson then moved to rescind action that had been originally taken on Article 7. Motion seconded. Lengthy discussion followed as to Mr. Benson being in order to present such a motion. He stated that he had originally voted in favor of Mr. Bates' motion. Result of standing vote to rescind action on Article 7: Yes—46, No—20, declared by Moderator Struthers after count made by Constables Alfred H. Nichols and Alvin P. Nichols.

Mr. Griffin then made motion, duly seconded, as above stated and subsequently favorably acted upon after another discussion period.

1953 DOG TAX REFUND

Article 8. Voted: on motion of School Committee member Mrs. Elsie J. Craib, duly seconded, to appropriate the proceeds of 1953 Dog Tax Refund, the sum of Seven Hundred Sixty-Four Dollars and Ninety Cents (\$764.90) received from the County to the School Account.

Previous to above motion, Raymond C. Whiting moved that the Dog Tax Refund of \$764.90 be appropriated to School Account and earmarked for repairs at the Knowlton School Building. Negative voice vote.

Ralph P. Montenegro at this point asked to take up Article 7 for reconsideration. Following a brief discussion, he withdrew motion.

AUTHORIZING SCHOOL COMMITTEE TO APPOINT
ONE OF ITS MEMBERS AS SCHOOL PHYSICIAN

Article 9. Voted: on motion of Selectman Daniel H. Bates, seconded, to authorize the School Committee to appoint one of its members as School Physician, and to establish a salary of \$300.00 for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A. Mr. Bates' original motion called for salary of \$200.00. School Committeeman Donald B. Johnson stated that the School Committee had allotted \$300.00 for this year. Mr. Bates accepted Mr. Johnson's amendment.

AUTHORIZING THE CEMETERY COMMISSIONERS
TO EMPLOY ONE OF ITS MEMBERS

Article 10. Voted: on motion of Cemetery Commissioner Raymond K. Smith, seconded, to authorize the Cemetery Commissioners to employ one of its members in Lakeview Cemetery and other town cemeteries, and to establish the rate of pay at \$1.10 per hour, to be taken from the Cemetery Account, in accordance with the provisions of General Laws, Chapter 41, Section 4A.

AUTHORIZING THE PARK COMMISSIONERS
TO EMPLOY ONE OF ITS MEMBERS

Article 11. Voted: on motion of Park Commissioner Francis E. Aldrich, seconded, that the Park Commissioners be authorized to appoint one of its members as an employee in accordance with Chapter 41, Section 4A, and fix the rate of pay at \$1.10 per hour, to be paid from the Parks and Playgrounds Appropriation.

RETURN TO ARTICLE 7

Article 7. Voted to reconsider Article 7 at this point in the meeting. (Record of action under said Article.)

Voted: on motion of George H. Donham to adjourn to next Saturday (March 13, 1954), amended to designated hour of 2 P.M. Seconded. Moderator Struthers declared meeting adjourned. (Time: 5.45 P.M.)

PROCEEDINGS OF SECOND ADJOURNED ANNUAL
TOWN MEETING
MARCH 13, 1954

Moderator Halbert K. Struthers called the meeting to order. Voters entering the hall had their names checked at entrance by William J. Gorman (D) and Mrs. Lucille E. Mettey (R), who took oath before Town Clerk.

Kenneth W. Wood motioned, which was seconded, that all remaining articles in the warrant be acted upon by secret paper ballot. Lost on voice vote, Moderator declared.

G. S. BALL SCHOOL HEATING SYSTEM

Article 12. Voted: on amended motion of Selectman Malcolm C. Temple, seconded, that the Moderator appoint a committee of three to work with the School Committee to prepare specifications and get bids on proposed new boiler at the G. S. Ball School.

Preceding the above action, Supt. of Schools Harry Y. Hilyard of Grafton was granted permission to address the assembly. Mr. Hilyard explained the need of improving heating conditions at the school building.

(Moderator Struthers subsequently named the following committee: Harold S. Hopkins, Samuel F. Wentworth and G. Marshall Carlson.)

Preceding action on Selectman Temple's amendment motion, Mrs. Elsie J. Craib, member of the School Com-

mittee, motioned that the Town raise and appropriate the sum of \$4000.00 for the purpose of installing a new heating system in the George S. Ball School. Seconded by Norman E. Walker.

PLEASANT STREET

CHAPTER 90 CONSTRUCTION

Article 13. Road Commissioner Henry J. Poirier moved "that the sum of \$2000.00 be raised and appropriated to meet the Town's share of the cost of Chapter 90 Highway Construction on Pleasant Street, and that in addition, the sum of \$6000.00 be transferred from unappropriated available funds in the treasury to meet the State and County's share of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the treasury." Seconded. Voted.

CHAPTER 90 HIGHWAY MAINTENANCE

Article 14. Road Commissioner Henry J. Poirier moved "that the sum of \$1500.00 be raised and appropriated to meet the Town's share of the cost of Chapter 90 Highway Maintenance, and that in addition, the sum of \$3000.00 be transferred from unappropriated available funds in the treasury to meet the State and County's share of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the treasury." Seconded. Voted.

DISPOSAL OF OLD HYDRANTS

Article 15. Voted: on motion of Commissioner Raymond E. Griffin, seconded, authorizing the Board of

Sewer and Water Commissioners to dispose of old hydrants.

AUTHORIZING BOARD OF SEWER-WATER COMMISSIONERS
TO APPOINT ONE OF ITS MEMBERS AS SUPERINTENDENT

Article 16. Voted: on motion of Commissioner Raymond E. Griffin, seconded, that the Board of Sewer and Water Commissioners appoint one of its members as superintendent of said Department and establish a salary of Five Hundred Dollars (\$500.00), all in accordance with the provisions of General Laws, Chapter 41, Section 4 A. Standing vote directed by Moderator Struthers to determine action on motion. Police Officers Alfred H. Nichols and Alvin P. Nichols made count. Moderator Struthers announced result: Yes—60, No—6.

Preceding final action, a motion, duly seconded, to take a ballot vote on Mr. Griffin's motion, was defeated.

After action on Article 16, Chairman Edward L. Orff of the Sewer-Water Commission, motioned to take up Article 19 at this time. Seconded. Voted with no objection.

EXTENDING WATER SYSTEM

Article 19. Voted: on motion of Commissioner Orff, seconded, "that the Board of Sewer and Water Commissioners be authorized to purchase or take by eminent domain, an easement for the purpose of installing, maintaining, repairing and replacing water mains and a standpipe, together with poles and wires or underground electric cable necessary to the maintenance and use of said standpipe, in and over land of Rudolph J.

Scholl and Ruth Scholl situated on the Northerly side of Warren Street, in Upton, and being more particularly bounded and described as follows (voters waived reading of description). And to transfer from the Water Construction Loan the sum of \$500.00 to defray the cost of such purchase or taking.

Moderator Struthers stated that a two-thirds' vote was necessary for favorable action. Officers Alfred H. Nichols and Alvin P. Nichols made count. Moderator Struthers announced result: Yes—84, No—0.

Said description as referred to above:

“Beginning at a stone wall on the northeasterly side of said Warren Street, at the southeasterly corner of land of Elizabeth C. McClure and at the southwesterly corner of the granted premises;

“thence N. 5 degrees 26 minutes, and following the stone wall, 530.0 feet;

“thence N. 14 degrees 04 minutes, W., 96.03 feet;

“thence N. 27 degrees 34 minutes W., 152.83 feet to the end of a stone wall;

“thence N. 26 degrees 10 minutes W. with said stone wall 72.71 feet to an angle;

“thence N. 33 degrees 16 minutes W., 95.50 feet;

“thence N. 20 degrees 39 minutes E., 107.60 feet to a stone bound at the southeasterly corner of land now or formerly of one Fiske; the last six lines bounding on said McClure land;

“thence N. 44 degrees 54 minutes E., 40.32 feet;

“thence N. 1 degree 30 minutes E., 93.61 feet to a drill hole in a ledge;

Article 18. Voted: on motion of Chairman Edward L. Orff of Sewer-Water Commission, seconded, "that the Board of Sewer and Water Commissioners be authorized to purchase or take by eminent domain, an easement for the purpose of passing and repassing on foot and with vehicles of all kinds, over a strip of land belonging to Beatrice A. M. Fiske and Gertrude I. Fiske, lying off the northerly side of Warren Street, in Upton, and being more particularly bounded and described as follows (voters waived reading of description). And to transfer from the Water Construction Loan the sum of \$500.00 to defray the cost of such purchase or taking.

Moderator Struthers directed a record vote be taken on motion. Officers Alfred H. Nichols and Alvin P. Nichols made count. Moderator Struthers announced result: Yes—81, No—0.

Description as referred to above:

"Beginning at a stone bound at the northwesterly corner of land of Rudolph J. Scholl and being the southeasterly corner of land commonly known as Upton Lead Aqueduct Land;

"thence northwesterly, about 362 feet to a corner of wall at land of the Commonwealth of Massachusetts known as the Upton State Forest;

"thence northeasterly, following a stone wall and bounding on said Commonwealth of Massachusetts land 113.25 feet;

"thence southeasterly and running parallel to and 100 feet from the line first above described: 460 feet to an angle;

NEW AMBULANCE

Article 20. Voted: on motion of Fire Chief George N. O. Poirier, seconded, "to appropriate from available funds in the treasury, the sum of \$3000 for the purchase of an ambulance, said money to be used with any allowance received from the trade or sale of the present ambulance, the same to be expended under the supervision of the Board of Fire Engineers." Several voters spoke on the question before vote was taken.

TRANSFER TO NOTES

AND INTEREST ACCOUNT

Article 21. Voted: on motion of Town Accountant Harvey L. Martindale, seconded, to transfer the sum of \$1011.25 from the premium on Loans Account to the Notes and Interest Account.

Following action on above article, Mr. Martindale moved to return to Article 5, "Notes and Interest" under "General Appropriations" which item was "passed" at time said article was acted upon until Article 21 was considered. Mr. Martindale's motion was favorably acted upon.

Subsequently, Mr. Martindale motioned, seconded, that the Town raise and appropriate \$29,000 for the "Notes and Interest" Account under Article 5. Voted.

SO-CALLED RESERVOIR STREET EXTENSION

Article 22. Voted: on motion of William A. Bellofatto, seconded, that the Town appropriate from available funds in the town treasury the sum of \$1500.00 for repairs on so-called Reservoir Street Extension.

WATER HOLES

Article 23. Voted: on motion of Selectman Daniel H. Bates, seconded, to appropriate \$300.00 from available funds in the town treasury to repair and construct water holes.

MACHINERY FUND TO MACHINERY ACCOUNT

Article 24. Voted: on motion of Selectman Daniel H. Bates, seconded, to transfer \$28.60 from Machinery Fund to Machinery Account.

COUNTY RETIREMENT SYSTEM

Article 25. Voted: on motion of Selectman Daniel H. Bates, seconded, to raise and appropriate the sum of \$638.46 for pension, expenses and military services of Worcester County Retirement System as provided by law.

REIMBURSEMENT TO R. H. WHITE
CONSTRUCTION Co. OF AUBURN

Article 26. Voted: on motion of Commissioner Raymond E. Griffin of Sewer-Water Commission, to appropriate from available funds in the treasury, the sum of One Thousand Nine Hundred and Twenty-Five Dollars (\$1925.00) to reimburse the R. H. White Construction Company of Auburn, Mass. in connection with the installation of hydrants in the Town Water System.

HYDRANT RENTAL

Article 27. Voted: on motion of Commissioner Raymond E. Griffin of Sewer-Water Commission, seconded, voted to raise and appropriate the sum of Two Thousand Three Hundred and Fifty Dollars (\$2350.00), said money to be used for hydrant rental.

HARTFORD AVENUE BRIDGE

Article 28. Voted: on motion of Selectman Daniel H. Bates, seconded, to transfer the sum of One Hundred Sixteen Dollars and Eighty-One Cents (\$116.81) from Hartford Avenue Bridge Account to the town treasury.

GRAND ARMY HALL BUILDING

Article 29. Voted: on motion of Forrest P. Salisbury, seconded, that a report read by Walter H. Allen, chairman of the GAR Building, be accepted as read.

Then voted on Mr. Salisbury's motion, seconded, that "G.A.R. Hall be retained until some action be taken later to restore its use."

(The motions were separated by Moderator Struthers and so presented to the voters after being read by Mr. Salisbury as one motion.)

After article was read by the Moderator, Mr. Allen read a report signed by him (on file at Town Clerk's office) in which he suggested that Grand Army Hall Building be "undisturbed" at present "since no funds are available for repairs or maintenance." A discussion preceded action presented in motion by Mr. Salisbury.

VOTE TO SELL RIGHTS
IN SPRING AND WELL

Article 30. Voted: on motion of Chairman of Selectmen Gladys G. Crockett, seconded by Selectman Malcolm C. right to put in a pipe to supply one house with water or the same in amount for purposes connected with grantor's land".

FIVE LIGHTS ON TAFT STREET

Article 31. Voted: on motion of William H. Tobey, seconded by Selectman Gladys G. Crockett, to install five lights on Taft Street, the cost to be defrayed from the Street Lights Appropriation.

ONE STREET LIGHT

ON WILDWOOD AVENUE

Article 32. Voted: on motion of Selectman Gladys G. Crockett, seconded, to install one street light on Wildwood Avenue, the cost to be defrayed from the Street Lights Appropriation.

ONE STREET LIGHT

ON FISKE STREET

Article 33. Voted: on motion of Selectman Daniel H. Bates, seconded, to install a 2500-lumen light on Fisk Street, near entrance to Nipmuc Rod & Gun Club Inc. Clubhouse, cost to be taken from Street Lights Appropriation.

CHANGING TERM OF OFFICE

OF BOARD OF SELECTMEN

Article 34. Voted: on motion of Gordon E. Benson, seconded, that the Town "elect the Board of Selectmen as follows: One member to be elected for a three-year

term, one member to be elected to a two-year term, and one member to be elected to a one-year term; to become effective at the annual election of Town Officers in 1955. Each year thereafter one Selectman will be elected for a three-year term." Standing vote: Yes—29; No—21.

PASS OVER

Article 35. Voted: on motion of Town Treasurer Leo F. Murphy, seconded, to pass over article after it had been read by Moderator Struthers.

Town Treasurer Leo F. Murphy moved that all monies appropriated during the meeting and at the adjourned annual town meeting, March 6, 1954, unless otherwise provided in the motion, be raised by taxation. Seconded. Voted.

During the meeting, on motion of Town Clerk George G. Newton, seconded, a rising vote of thanks was given to Harry C. Snow, for his faithful service to the Town of Upton over a period of many years as elected road commissioner and appointed superintendent of streets; also for his service as town auditor at one time and as a member of the Board of Selectmen and Board of Health for several terms. Mr. Snow was not a candidate for an elective office at the 1954 annual town election.

On a motion of Ralph Montenegro it was voted to strike from the records a previous motion made by him and the action taken at the March 6, 1954 meeting.

Motion to dissolve warrant, seconded, was voted. Adjournment declared by Moderator at 5:40 P.M.

About 40 voters were present when Moderator Halbert K. Struthers called the meeting to order at the specified hour. The attendance increased as the meeting proceeded.

Articles pertaining to appropriations had been considered by the Finance Committee, it was stated by Harold S. Hopkins, Committee chairman, during the meeting.

DISTRICT NURSING ASSOCIATION

Article 1. Voted: on motion of Forrest P. Salisbury, seconded by Selectman Malcolm C. Temple, to raise and appropriate One Thousand Dollars (\$1000.00) for the District Nursing Association to be used for purposes named in Article 1. (Pre-natal, post-natal and pre-school nursing services, crippled children and well-child clinic services.)

RESCIND CHAPTER 81 HIGHWAYS VOTE

Article 2. Voted: on motion of Selectman Malcolm C. Temple, seconded by Selectman Daniel H. Bates, to rescind a vote of March 6, 1954 under Article 5, General Appropriations, pertaining to appropriation for Chapter 81 Highways.

CHAPTER 81 HIGHWAYS APPROPRIATION

Article 3. Voted: on motion of Selectman Malcolm C. Temple, seconded by Selectman Daniel H. Bates, that

"the Town vote to raise and appropriate the sum of Forty-Five Hundred Dollars (\$4500.00) to meet the Town's share of the cost of Chapter 81 Highways work, the same to be used in conjunction with funds allotted by the State in the sum of \$16,500.00".

CRAIB LAND DAMAGE JUDGMENT

Article 4. Voted: on motion of Mrs. Gladys G. Crockett, chairman of Selectmen, to raise and appropriate the sum of Three Hundred Fifty-Six Dollars and Twenty-Five Cents (\$356.25) to pay judgment for land damages in the case of Stanley M. and Virginia F. Chapter 40, Sections 42A to 42F, inclusive, which sections relate to the collection of rates and charges due the Town for supplying or providing for water or rendering service or furnishing materials in connection therewith." Moderator Struthers declared the vote to be unanimous.

MEMORIAL SCHOOL PROPERTY

CURBSTONE OR FOUNDATION STONE

Article 6. Voted: on motion of Selectman Mrs. Gladys G. Crockett, duly seconded, to authorize the Selectmen to sell used curbstone or foundation stone, or act in any manner pertaining thereto.

Mrs. Crockett explained that if Selectmen determine it advisable to keep the said stone, it will be moved to a safe location.

Before final action was taken on this article, Selectman Malcolm C. Temple moved that the Selectmen be authorized to sell, move or otherwise dispose of curbstone or foundation stone on Memorial School grounds to the best advantage of the town. Seconded. Lost on voice vote.

Also a motion was made by Mrs. Crockett to have the stones moved to a place of safety under the supervision of the School Committee. Not seconded.

During the discussion, George N. O. Poirier stated that in his opinion there will be need of a retaining wall on Memorial School property and suggested that the stone be kept for such purpose, if needed.

Dr. Bernard F. McKernan, chairman of School Committee, stated that the pile of stone had been on the grounds for several years; that the Committee had no funds to pay to move said stone, and that as the stone had been considered obsolete, it had been given away in order to get the pile moved.

VETERANS' SERVICE APPROPRIATION

Article 7. Voted: on motion of Selectman Daniel H. Bates seconded by Selectman Gladys G. Crockett, that the sum of Fifteen Hundred Dollars (\$1500.00) be taken from unappropriated available funds in the treasury to be applied to the Department of Veterans' Account.

M. Fiske and Gertrude I. Fiske situated off the northerly side of Warren Street, in the Pratt Hill section so-called, in said Upton, for the purpose of passing and repassing on foot and with vehicles of all kinds necessary or reasonable in constructing, maintaining, repairing and replacing a standpipe and water mains in and on land of one Scholl lying southeasterly of said Fiske land, said strip being more particularly bounded and described as follows:—

REPORT ON NEW HEATING
SYSTEM FOR G. S. BALL SCHOOL

Article 12. Oral reports were made by Harold S. Hopkins, a special member of a committee authorized at annual March town meeting to make a study of heating system at George S. Ball School Building with members of the School Committee, and Dr. Bernard F. McKernan, chairman of the School Committee.

(Members of the special committee named by Moderator Struthers comprised Mr. Hopkins, Samuel F. Wentworth and G. Marshall Carlson.)

Specifications were obtained and eight bids received, it was reported. Lowest of bids was \$3635.00.

Motion of Henry C. Walker, seconded, to accept the report of the special committee with thanks.

APPROPRIATION FOR NEW HEATING
SYSTEM AT GEORGE S. BALL SCHOOL

Article 13. Voted: on motion of Dr. Bernard F. McKernan, chairman of School Committee, duly seconded, "that the Town transfer from unappropriated available funds, the sum of Three Thousand Six Hundred Thirty-Five Dollars (\$3,635.00) for the purpose of installing a new heating system in the George S. Ball School as per specifications."

G.A.R. BUILDING

Article 14. Selectman Daniel H. Bates stated that to get the question before the voters for the discussion, he moved that Seven Hundred Seventy Dollars (\$770.00) be transferred from unappropriated available funds in the Town Treasury for preparation of plans and specifications for rehabilitation of Grand Army Hall Building. Seconded by Henry C. Walker. Declared by Moderator Struthers to have been lost on voice vote when placed before the voters for action.

Preceding taking of the vote, Selectman Malcolm C. Temple read excerpts of a letter from Lester W. West, a Worcester structural engineer, who made a survey of Grand Army Building at the request of the Selectmen, April 10. Mr. West set forth that he would prepare a set of plans and specifications for rehabilitation work which would meet the requirements and pass the approval of the State Department of Public Safety for \$770.00.

Others speaking during the discussion concerning the building included Atty. Henry C. Walker, Walter H.

Allen and Chairman of Selectmen Mrs. Gladys G. Crockett. Harold S. Hopkins, chairman of the Finance Committee, stated that the Committee did not favor any expenditure until it was definitely determined whether or not the town was to preserve the building.

Motion to dissolve the Warrant and adjourn was voted at 9:50 P.M.

At 6 P.M., tellers reporting for duty and who took oath to perform their said duties: Mrs. Yvonne M. Bissonette (D), Mrs. Alice G. Cooley (D), Mrs. Helen I. Donham (R) and Mrs. Norma L. Taft (R).

At 5.10 P.M., 50 Republican ballots were taken from the ballot box, counted by the ballot clerks; 50 more Republican ballots at 7.30 P.M., and at close of polls at 8 P.M., 17 Republican and 34 Democratic ballots.

Edward J. Furphy (D) and Edward L. Prentiss (R) reported at 8 P.M., were sworn, and supervised tabulation.

Result of Republican voting was announced by Town Clerk at 8.46 P.M. and Democratic voting at 8.55 P.M.

Of the 151 ballots cast during the eight-hour voting, 89 were men and 62 women.

Of the 117 Republican ballots cast, 68 were by men and 49 by women; 34 Democratic ballots, 21 men and 13 women.

PROCEEDINGS OF STATE ELECTION

November 2, 1954

Pursuant to the foregoing Warrant, the meeting was called to order at Seven o'clock A.M. by Selectman Daniel H. Bates, who also read the Warrant calling for the election of certain National, State and County Officers and action on certain questions on the ballot.

Raymond F. Lyford (R), William J. Gorman (D), Ernest J. Henchey (R) and Edward J. Gurry (D) took oath to serve as ballot clerks and checkers before polls were opened.

Police Officer Alfred H. Nichols was in charge of the ballot box and held the keys for the same. The indicator read 0000 before voting began. The interior of the ballot box was shown to several voters who were present and election officers.

Alice E. Kerr was the first person to vote. Theodore J. Nelson was the first male voter to cast a ballot.

Tellers reporting at 2 P.M. and taking oath before assuming their duties were: Mrs. Rita C. Cutler (D), Joseph J. Driscoll (R), Mrs. Ruth A. Sweet (R), Leo

F. Murphy (D), Samuel B. Young (R), Mrs. Ada W. White (R), James C. Kelly (D) and Mrs. Mary A. Gilchrist (D). At 5 P.M. tellers reporting were Mrs. Yvonne Bissonnette (D), Mrs. Shirley E. Kirby (D), Mrs. Helen Poirier (R) and Mrs. Helen I. Donham (R). At 6 P.M. tellers reporting were LeRoy W. Prentiss (R), Eugene J. Bissonnette (D), Mrs. Elizabeth Victor (D) and Mrs. Norma L. Taft (R).

Edward L. Prentiss (R) and Edward J. Furphy (D) reported at 6 P.M. as tabulators and took oath.

The polls closed at 8 P.M. in accordance with the Warrant. Indicator on ballot box read 1175 ballots cast at this hour. After ballots were removed, 14 Absent Voters' Ballots (three servicemen and 11 civilians) were cast. Envelopes containing ballots and jurats were examined by the election officers before ballots were cast by the Town Clerk. With this voting completed, the indicator read 1189.

Hourly reading of ballot box indicator: 8 A.M., 60; 9 A.M., 96; 10 A.M., 157; 11 A.M., 209; 12 Noon, 249; 1 P.M., 298; 2 P.M., 360; 3 P.M., 403; 4 P.M., 443; 5 P.M., 636; 6 P.M., 823; 7 P.M., 1064; 8 P.M., 1175. With the additional 14 Absent Voters' Ballots, the total was 1189.

Ballots were removed from the ballot box under the direction of Selectman Bates, presiding officer, 1.50 P.M., 200 ballots; 2.45 P.M., 150; 5.30 P.M., 250; 7.50 P.M., 150 and 8.05 P.M., 425. Subsequently the 14 Absent Voters' Ballots were removed to be canvassed.

Check lists at ballot table and ballot box were compared by Messrs. Lyford, Gorman, Henchey and Gurry. The lists agreed. They announced that 600 men and

589 women voted which was 79 per cent of registered vote.

Ballots, check lists, used and unused ballots, and applications for absent voter's ballot placed in containers and sealed. The containers were deposited in the town vault.

MEETINGS AND EVENTS

On June 8 Joseph P. Bibeau and I attended an important meeting of civil defense leaders for "Defense of Sector Four" at the Milford High School. Preparations were made for the *State Wide Alert* which was held on Monday, June 14. The Red Alert at 10 A.M. The All Clear at 10.10 A.M. Dr. McKernan reported in at 10.05 that he was at the Knowlton Manor.

On Tues., Aug. 31, *Hurricane Carol* arrived. C. D. was alerted from 10 A.M. to 3 P.M. Power off in some sections of town from 12 noon until 8 A.M., Sept. 1. Winds up to 75 miles per hr. prevailed, and the damage was considerable to property and trees.

On Sat., Sept. 11, *Hurricane Edna* visited us and there were heavy rains and high winds of 75 miles per hour. C. D. was alerted from 9:30 A.M. until after 4 P.M. Much damage was done to town roads, some to property and trees.

On Sat., October 16, the Civil Defense Directors of all cities and towns in Massachusetts met at The Little Theatre in the Municipal Auditorium, Worcester. Dr.

McKernan and I attended. It was an all day session. I met all the top personnel of the State Organization. A practical demonstration of mass feeding was accomplished at noon. This meeting brought to our attention the seriousness of the results of the H Bomb if used and what the State agency was doing in the way of planning and developing its program to save lives. I met with the Women's Division headed by Mrs. Marion L. Johnson. Women can be of great help in this defense program. The Upton Woman's Club is co-operating.

On Tues. P.M., November 9, an *important* C. D. meeting was held in the Upton Town Hall. 150 members of Upton families were present. Col. Harold B. Hilton, Chief of the Warden Service of the Mass. Civil Defense Agency was the principal speaker. Others were Harold F. Rossi, Administrative Assistant Region III; Chairman Gladys G. Crockett of the Selectmen; Malcolm C. Temple, Selectman and George N. O. Poirier, Fire Chief. Local Civil Defense leaders were introduced by your director to all those present. Civil Defense films were shown. The notices for this meeting were run off without charge by the Rev. Carlyle Lewis, and I am grateful to both the Brooks Farm Dairy and the Town Line Dairy Farm for delivering these notices to the people of Upton—gratis.

A 28 page booklet of the Family Action Program entitled "Home Protection Exercises" was distributed to those present. More of these booklets are available, so if Upton residents are interested in obtaining a copy, just request the same by sending me a post card. *Every family should know what to do in the case of an emergency.*

A *Rescue School* was opened at the Westboro Town Hall in November for Area 3, and it meets twice a month until spring of 1955. Those attending from Upton are:— Henry J. Poirier, Henry H. Wood, Henry J. Poirier, Jr. and myself.

Communications. On Thursday evening, December 9 Gerald and Edith Shaughnessy and I attended a meeting of the Framingham Radio Club. Both of them now have amateur radio licenses it is well to note.

Warden Service. Will all those persons interested in setting up such a service in Upton please advise your director. *This is very important.*

Report of Board of Water and Sewer Commissioners

For the year ending December 31, 1954

We stopped excavating in the late fall of 1953 on Plain Street. In the early spring of 1954 the extension was carried to Mendon St. Johns Manville 8-inch transite pipe was laid. From there we moved to Glen Avenue and laid 8-inch cast iron cement-lined pipe from Main Street to the pumping station.

A right of way was obtained from Rudolph and Ruth Scholl on the northerly side of Warren Street, for the purpose of installing a 12-inch transite pipe to the stand pipe, and with a right of way for entering upon such premises for the purpose of repairing and maintaining.

A right of way was obtained from the State Dept. of National Resources over Hurley Trail, and from Beatrice A. M. Fiske of Conn. A right of way from Gertrude I. Fiske is still pending. A release over land for a right of way from the Lead Aquaduct Society was obtained.

With right of ways obtained, we preceded to build a road to the site where the stand pipe was to be erected. The contract for the stand pipe foundation was awarded to, and built by the R. H. White Construction Co. of Auburn. The contract for erecting the stand pipe was awarded to the Pittsburgh-Des Moines Steel Co., the stand pipe having a dimension in diameter of forty-four feet, a height of forty-six feet, and a capacity of five-hundred thousand gallons.

After much consideration, the board decided to relieve Johnson Bros. the obligation of repairing the streets where water mains had been laid, and turned it over to the Highway Dept. of the Town of Upton. All work was done on bid prices submitted to the Town of Upton, resulting in a saving to the town. The Board of Water Commissioners wish to thank all who were inconvenienced by the conditions of the roads before they were repaired.

The settling tanks at the filter beds were cleaned this year. No work was done on the filter beds this year. We felt a survey should be made to see if we can meet the recommendations of the State Dept. of Public Health, as the space at the filter beds is limited.

The contract for the development of the well fields was awarded to the R. E. Chapman Co. of Oakdale. Eleven new wells have been driven in the new well field. When the field is completed we will be pumping from twenty-four wells.

We have, at this report, made all decisions pertaining to the pumps and controls for our new pumping equipment. The reports are now in the hands of Delwyn K. Barnes, our engineer, who is drawing up specifications so they can be let out for bids. We hope to have the new pumps working and tank filled by springtime at the latest. We also want to keep cost down so it will be possible to install another Street with Water Service. We want the people of Upton to know that we are working to balance the budget as soon as possible and expect the year 1955 will be nearer to that goal.

Report of Highway Department

Chapter 81 funds took care of our Maintenance work during the year, including surface treatments, graveling, drainage, patching and brush cutting.

Chapter 90 Maintenance money was used for surface treatment on Westboro, Hopkinton, and Mendon Streets. On Westboro Street we had two sections below grade that we raised with Type I.

Funds from Hurricane Edna and the Bridge Account repaired Cobb Bridge on Fowler Street, the lower bridge on Fowler Street and lower Hartford Avenue.

Hurricane Carol and Edna funds made passable washouts that were caused from the hurricanes. Debris was cut and cleaned up.

The sum of \$6,000 for Snow Removal was insufficient this year because of the snow storm of December 21, which necessitated an expenditure of \$1,329.95 over the appropriation.

On Reservoir Street, bounds were set; trees, ledge and boulders removed, and the street widened with the exception of approximately 500 ft. More money is needed for drainage, gravel and clean up on this road.

I wish to thank all the Town Departments and the Department of Public Works for their cooperation during the year.

Selectmen's Report

The Board met and organized on the afternoon of March 6, 1954. Mrs. Gladys G. Crockett, State Representative, was re-elected Chairman and Gordon A. Shaw Milford was appointed town counsel. Town Clerk George G. Newton was reappointed Clerk of the Board and Selectman Daniel H. Bates was reappointed Police Chief. The other two members of the Board were Daniel H. Bates and Malcolm C. Temple.

The past year has been one filled with many problems. The Board has given much thought and serious consideration to the disposition of these matters, with the welfare of the Town and its citizens uppermost in their minds at all times.

One of these problems included delay in the building of Pleasant Street. Chapter 90, which was caused by the County not furnishing the town with the proper survey so that work could be started earlier in the year.

The controversial matter of disposition of G A R Hall in Central Square was placed on the ballot at the Annual meeting to obtain a decision on the matter. The petition was filed by Representative Gladys G. Crockett, Chairman of the Board and signed by Messrs. Bates, Temple and George G. Newton, clerk. This decision was reached due to the fact that the building, condemned for public assembly by the State, had stood idle for nearly three years. It was impossible to obtain disposition of the matter at a special or regular town meeting or to reach an agreement by appointed committees.

The Board authorized that monies obtained from the William Knowlton trust fund be spent for repairs and painting of the Knowlton School Building, repairs and painting of the Upper Town Hall, lower hall corridor, entrance hall, and plumbing, repairs and painting of the two sanitation rooms in the basement. It is the earnest wish of the Board that further improvements to the hall will be made.

A retaining wall was built, with foundation stone from the Old High School, at the left of the Memorial School grounds, near the oil storage.

A cement sidewalk was built at the entrance of the George S. Ball School to accommodate bus children. It created a better safety condition.

The Board, through local petition, and a request by Representative Gladys G. Crockett, obtained official confirmation that Upton would be included in the regional spraying of trees by the State in the 1955 gypsy moth program.

The installation of several street lights is affording increased protection. Street lighting is one of the best services that a Town can give its citizens.

We have enjoyed serving our town and our citizens. We thank all department heads, officials and townspeople for the co-operation and courtesy extended to us during the past year, especially during the hurricanes Carol and Edna. We are grateful.

Charlotte A. Batchelor and George W. Knowlton established a Trust Deed at the Worcester County Trust Co., with the bank as Trustee, the income to be paid to the Town of Upton for use of Public Schools. \$75.00 was received this year.

There is deposited in the Milford Savings Bank, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Library. \$150.00 was received this year.

There is deposited in the Worcester County Institute for Savings, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor School Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Schools. \$150.00 was received this year.

There is deposited in the Milford Savings Bank, a War Bonus Surplus Fund to be used as a nucleus of a Fund for a Public Library Building as voted by the Town, February 7, 1925. \$115.64 interest was received, and the amount of this Fund on January 1, 1955 was \$3,942.08.

There is deposited in the Milford Savings Bank of Milford, five thousand dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Board of Selectmen, to be used to help the townspeople who are in distress. \$152.16 Interest was received and the balance on January 1, 1955 was \$5,126.82. \$260.00 was used this year.

The Industrial Accident Insurance Fund established in 1937 is deposited in the Milford Savings Bank. \$60.13 Interest was received and the balance on January 1, 1955 was \$2,049.47. Payment from this Fund is to be made in accordance with rules to be established by the Board of Selectmen. None was used this year.

January 8, 1955

To The Board of Selectmen:

I herewith submit my report as Town Counsel for the year 1954.

During the past year numerous conferences and meetings were held with various department heads, boards and committees, particularly with the Board of Sewer and Water Commissioners in respect to matters arising in connection with the installation of the water system.

Several opinions, both oral and written, were furnished when requested, and assistance rendered in connection with drafting of papers and the recording of the same as required.

One land damage case against the Town was closed. One case against the Town based upon assistance rendered by the City of Worcester, is pending in the Worcester Superior Court. One claim based upon assistance rendered by the Town is still outstanding in Worcester Superior Court although arrangements have been made for closing this case in favor of the Town. One other Welfare claim secured under the lien statute is pending, and it seems that a substantial or full recovery can be expected.

A small property damage claim arising out of a motor vehicle accident, was settled in favor of the Town.

I am grateful for the co-operation and courtesies extended to me by the various boards and committees, and by the Town Officers during the past year.

Sir:

As directed by you, I have made an audit of the books and accounts of the town of Upton for the fiscal year 1953, and submit the following report thereon:

The records of the financial transactions of the several departments receiving or disbursing money for the town or committing bills for collection were examined, checked, and verified by comparison with the records and reports in the offices of the town accountant and the treasurer.

The books and accounts of the town accountant were examined and checked in detail. The recorded receipts were compared with the treasurer's books and with the records in the several departments collecting money for the town or committing bills for collection, and the recorded payments were checked with the selectmen's warrants authorizing them. The appropriations and transfers, as entered on the ledger, were checked with the town clerk's records of town meeting votes and with the finance committee's authorization of transfers from the reserve fund.

The general and appropriation ledger accounts were analyzed, the necessary adjusting entries resulting from the audit were made, and a balance sheet, a copy of which is appended to this report, was prepared showing the financial condition of the town on December 31, 1953.

The books and accounts of the town treasurer were examined and checked. The cash book was footed throughout, and the cash balance on February 22, 1954 was verified by actual count of the cash in the office, by examination of a savings bank book, and by reconciliation of the bank balances with statements received from the banks in which town funds are deposited.

The recorded receipts were analyzed and checked with the town accountant's books, with the records of the several departments collecting money for the town, and with other sources from which money is paid into the town treasury. The payments were compared with the

treasury warrants authorizing the treasurer to disburse town funds and with the town accountant's ledger.

The payroll deductions from employee's salaries for Federal taxes and for the county retirement system were examined and checked. The amounts withheld were compared with the treasurer's recorded receipts, and the payments to the Federal depository and to the county treasurer were checked with the vouchers on file.

The payments on account of maturing debt and interest were proved with the amounts falling due and with the cancelled securities and coupons on file.

The savings bank books and securities representing the investment of the trust and investment funds in the custody of the town treasurer and trustees were examined and listed, the income being proved and the withdrawals being verified.

In connection with the investment of trust funds, attention is directed to the provisions of Section 54, Chapter 47, General Laws, which reads as follows:

"Trust funds, including cemetery perpetual care funds, unless otherwise provided or directed by the donor thereof, shall be placed at interest in savings banks, trust companies incorporated under the laws of the commonwealth, banking companies incorporated under the laws of the commonwealth which are members of the Federal Deposit Insurance Corporation, or national banks, or invested by cities and towns in paid-up shares and accounts of and in co-operative banks, or in shares of savings and loan associations or in shares of federal savings and loan associations doing business in the common-

wealth to an amount not exceeding ten thousand dollars, or in bonds or notes which are legal investments for savings banks. This section shall not apply to Boston."

The records of tax titles and tax possessions held by the town were examined and checked in detail. The amounts added to the tax title account were compared with the collector's and the accountant's books, and the redemptions were checked with the entries in the treasurer's cash book. The tax titles and tax possessions on hand were listed and reconciled with the ledger controls, and all transactions were checked with the records at the Registry of Deeds.

The books and accounts of the tax collector were examined and checked. The tax and excise accounts outstanding at the time of the previous examination, as well as all subsequent commitments, were audited and proved with the assessors' warrants issued for their collection. The cash book additions were verified, the recorded collections were compared with the treasurer's cash receipts, the abatements were checked with the assessors' records of abatements granted, the transfers to the tax title account were verified, and the outstanding accounts were listed and reconciled with the respective ledger controlling accounts.

The records of departmental, water, and sewer accounts receivable were examined. The commitments were verified, the recorded collections were proved with the payments to the treasurer, the abatements as recorded were compared with the departmental records of abatements granted, and the outstanding accounts were listed, checked with the available records in the several departments, and reconciled with the controlling accounts in the accountant's ledger.

Verification of the outstanding tax, excise, water and sewer accounts was made by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The receipts of the town clerk for dog and sporting licenses were checked with the records of licenses issued, the payments to the town treasurer and to the Division of Fisheries and Game, as well as the cash on hand, being verified.

The appropriations as voted by the town meetings were listed from the records of the town clerk and compared with the aggregate appropriations raised by the assessors.

The records of the board of selectmen, the sealer of weights and measures, and the milk inspector, as well as of the police, health, public welfare, veterans' services, school, library, and cemetery departments were examined and checked, the payments to the treasurer being verified.

Appended to this report, in addition to the balance sheet, are tables showing reconciliations of the treasurer's and the tax collector's cash, summaries of the tax, excise, departmental, and water accounts, as well as schedules showing the condition and transactions of the trust and investment accounts.

During the progress of the audit cooperation was extended by the several town officials, for which, on behalf of my assistants and for myself, I wish to express appreciation.

Librarian's Report

To the Trustees of the Upton Library:

The librarian respectfully submits her annual report with library statistics, list of periodicals and the catalog of new books.

Books have been added to the Dr. Carpenter Alcove as required and purchased from the George H. Schultz Fund.

Gifts of magazines and books have been received from Mrs. Alice Hall, Mrs. Eleanor Merrill, Miss Marjorie Taft, Mrs. Kartiganer, Mr. Chester Walker, Mr. David Colcord, the Tupper Foundation, Kiwanis Club, Rosen Foundation and Norton Co.

A much appreciated check for \$100 was given to the librarian from the Tupper Foundation to buy new children's books.

A much appreciated check for \$50 was given by the Kiwanis Club, also to be used for the children.

These wonderful gifts will be an inspiration and incentive to the children to continue their reading at the Library.

In July and August, a Story Hour was held for the younger children and because of the large attendance, two Reading Clubs were held for the older groups. The children read books from the State Reading List. Fourteen received State Certificates. Seven children received certificates for reading five books on the list and seven received Honor Certificates for reading twenty books, five of which were non-fiction.

The older Reading group made a study of Louisa May Alcott's life and books and at the end of the summer

visited the Louisa May Alcott House in Concord. Mrs. Robert Maynard generously assisted with the transportation.

Art Week was observed in November with a fine exhibit of oil paintings by Albert Gunther of Upton, portraits by Doris Daniels Cox of Mendon and sketches by Mrs. Alice Hall and Mrs. Ward Robinson of Upton.

For Book Week there was a large display of new books. Posters exhibited at the schools and library with the slogan, "Reading for Fun," and book marks were distributed. Sixteen classes from the schools visited the library with their teachers. The librarian gave book reviews of the new books suitable to the individual grades.

In December a Christmas Story Hour was held with an attendance of 54.

On March 27, Mrs. Alice Hall, Miss Helen Fay and Mr. Chester Walker, trustees and the librarian attended the Centennial Anniversary of the Boston Public Library with trustees and librarians from all over the state. It included a conducted tour of the Central Library and a visit to one of the new branch libraries in Dorchester. The history and reports of the library work in Massachusetts was very inspiring.

To Mrs. Eleanor Merrill who has assisted both Wednesday and Saturday afternoons during the winter and fall months I wish to express my sincere appreciation for her fine work.

I also express appreciation to the Trustees for their generous support.

Report of the Superintendent of Schools

To the School Committee and Citizens of Upton:

My second annual report as Superintendent of Schools, which I am privileged to submit, will concern itself this year primarily with two very obvious circumstances. First will bear directly upon the increase in the cost of the schools to the citizens of Upton as reflected in the School Budget for 1955, and second upon those objectives which we have achieved and considered to be of utmost importance to the children of Upton.

The following table will illustrate the sharp increase in the number of pupils to be educated, both now and in the foreseeable future. The purpose of this table depicting the projected school enrollment for Upton is to emphasize the need for increased and improved physical facilities.

The citizens of Upton will be called upon forthwith to raise and appropriate a reasonable amount of money to restore the Knowlton School to make it available in September 1955. At the present time we are housing a grade in the basement of the Ball School. The State Department of Safety has indicated to the Upton School Committee that this can only be a temporary arrangement, possibly for the remainder of the present school year. Still another most undesirable educational situation is the housing of two 1st Grades at the Memorial School in a room designed to care for but one. Imagine if you will, two teachers and nearly 50 1st Graders trying to adjust to a new situation and to begin formal learning in such a set up; this must be corrected.

All are conscious, I am sure, that due to increased enrollment at the Grafton High School it was necessary this past September for the Upton School Committee to make arrangements to send its Freshmen group to the Northbridge High School. This arrangement will continue each succeeding year until all Upton students have ultimately been graduated out of the Grafton High School. It became imperative, therefore, that the members of your Regional School Committee take immediate steps for an arrangement that would be both more educationally and financially sound in the long run. Certain recommendations relative to this problem will be made at once. Upton, as well as most other communities, certainly faces an expanding school plant.

Improvements in existing school facilities of Upton have been made this year. I cite the new heating plant in the Ball School, new toilet facilities in the same building, and the establishment of cafeterias at the Memorial and Ball Schools. These improvements have been made in conjunction with regular maintenance work. Much yet

needs to be done to bring these schools to the place I know parents and citizens of Upton most desire.

For the year 1955, the School Committee is requesting a total budget of \$123,473. This represents an increase of \$17,114.75 over what was spent in 1954.

In 1954 the Town of Upton received from the State, on account of Schools, reimbursement amounting to \$33,033.04. In 1955, the estimated reimbursement on account of schools to the town amounts to \$41,589.42. This represents an increase of approximately \$8,556.38 over income for 1954. Thus, the net increase from local taxation will be about \$9,548.37. This is the amount that reflects in the local tax rate.

Of the \$18,104.75 increase over last year's expenditures, \$9,355 is contained in teachers' salaries; in tuition and transportation, \$3,000, due to Chapter No. 514, which is a mandatory legislation providing for setting up of special schools of instruction for mentally retarded children residing in the town. Of this amount, 50% is reimbursed by the State. Additional increases in the budget are represented by the need to re-open the Knowlton School to eliminate the class now housed in the cellar of the Ball School, and the two first grade classes now held in a room designed for one class at the Memorial School.

It is interesting to note also, that we are certain of an opening enrollment in September, 1955, of at least 600 students, which is an increase of more than forty pupils compared with September, 1954. This will necessitate one additional teacher as provided for in the 1955 School Budget. The increase in enrollment in the Upton schools, and the enactment into law of Chapter No. 514, which is mandatory, and makes provision for the educa-

tion of the mentally retarded children residing in the various communities of the Commonwealth; and the improvement in teachers' salaries made effective a year ago, make it notable that the per pupil cost in Upton continues below that of comparable communities of 5,000 population with no high school, and the average for the State. Following, you will find a table indicating a comparative cost of education in Upton with comparable communities and in the State.

The work of the special departments has been most commendable. I refer you to the respective reports of the Cafeteria Manager, Handwriting, Art, Music Supervisors and Public School Health.

In closing, let me express my thanks to the School Committee, School Personnel, and the citizens of Upton, as well as the Parent Teachers Association and allied groups, who have so generously supported the administration of the Upton schools during the past year.

Dear Mr. Hilyard:

It is becoming increasingly apparent that music is a vital part of a child's existence not only through school years, but occupying an extremely important part in the enrichment of his entire life.

The aims of Music Education are:

1. To instill in each child a true appreciation and love of good music leading to aesthetic and cultural growth.
2. To train the child in habits of concentration and thinking.

In the development of a child, the contribution of music is two-fold—cultural and intellectual.

In the lower grades we have concentrated primarily on producing good tone, accurate rhythm and proper posture for singing. In the upper elementary grades, the emphasis is placed on part singing.

The matter of music reading is a very important one. We begin teaching theory in the first grade, so that by the time a child has reached the fifth and sixth grades, he should be provided with an adequate knowledge and perception of reading music.

In Junior High School, the music classes include some additional theory, listening, and, of course, singing.

To afford our students the experience and opportunity of public performance, we have presented a musical program every Memorial time.

I would like to express to you my sincerest thanks for your understanding help in my work, and to all teachers for their co-operation; and to my students, whose interest in music and earnest effort have been truly heartwarming.

The scope of art education is as wide and varied as life itself. Constructing, picture making, modeling, lettering, selecting and arranging everyday objects—all are part of our program.

The children are given every opportunity to learn about and to try new materials and techniques. All the while we must understand and accept the wide difference in children's potentialities and rate of growth. Some children are essentially creative—producing, inventing, expressing something from within. Others are of an appreciative nature—observing, feeling, comparing or discussing something from without. Each is dependent on the other. We have tried to elevate the sights and culture of all.

I have tried to suggest simple and direct ways of achieving desired goals. I have tried to teach the chil-

dren to be familiar with various art materials, tools and techniques.

At the high school level, which was added this year, this has been especially true. Since most of these children have chosen art because they are talented in and like art, I have tried to conduct classes on an art school level and help the children get to know art material, tools and techniques. This, I hope, will encourage them to work at home to improve their ability to "see." A most important part of their training.

Last spring, the teachers chose samples of each child's work and an exhibit was held. This gave me an opportunity to show parents the wide scope of media we have tried to cover. We are looking forward, as I hope you are, to another year of art activities for all the children, not just the talented few.

REPORT OF HANDWRITING SUPERVISOR

Dear Mr. Hilyard:

I am pleased to submit the following report on the operation of the handwriting program in the Upton schools for the school year of 1953-1954.

In the initial handwriting tests administered to your pupils in September, 1954, 26% received a grade of "A" (Excellent); 26% received a grade of "B" (Good); and

48% were scored less than "B". In the tests administered in June, 1954, 89% of your pupils received a grade of "A"; 9.3% received a grade of "B"; and 1.7% scored less than "B". Handwriting certificates were awarded to all eighth grade pupils who qualified.

During the school year we graded approximately 3,800 formal and 11,500 informal handwriting samples for your pupils. A formal test was administered monthly at four teaching-week intervals and a report was furnished each teacher giving a careful diagnosis of the handwriting of each pupil in the room.

We furnished the following instructional materials: teachers' outlines, pupil folder outlines, room motivation certificates, handedness tests, individual handwriting certificates, term envelopes, seals, etc.

My supervisors join with me in expressing our appreciation for the splendid co-operation we have received at all times. We are very pleased with the results obtained in your schools.

I hereby submit my annual report as school nurse.

In June, a pre-school registration was held in the Memorial School—Mrs. Lucy Lowe in charge. In the

George S. Ball School, Mrs. Mary Greany was in charge. Later, a pre-school health examination was held in the Memorial School. Dr. McKernan was in charge, assisted by the school nurse and two pupils from the High School.

The routine health work of weighing, measuring, individual examinations, checking absentees, and home visits have been carried on throughout the year. Dr. McKernan is completing the physical examinations in grades one, four, seven, and eight.

The Massachusetts State Department of Health requires that all pupils in grades one through twelve receive annual hearing tests given by using the Audiometer, and the vision test, using the Massachusetts Vision Test. If a pupil fails in either or both of these tests, parents are notified by letter advising care from a physician.

Mr. Hilyard has made arrangements with the Worcester County Health Association to hold a Patch Test Clinic in January, 1955.

I would like to thank Mr. Hilyard, the School Committee, teachers and parents for their co-operation with me.
