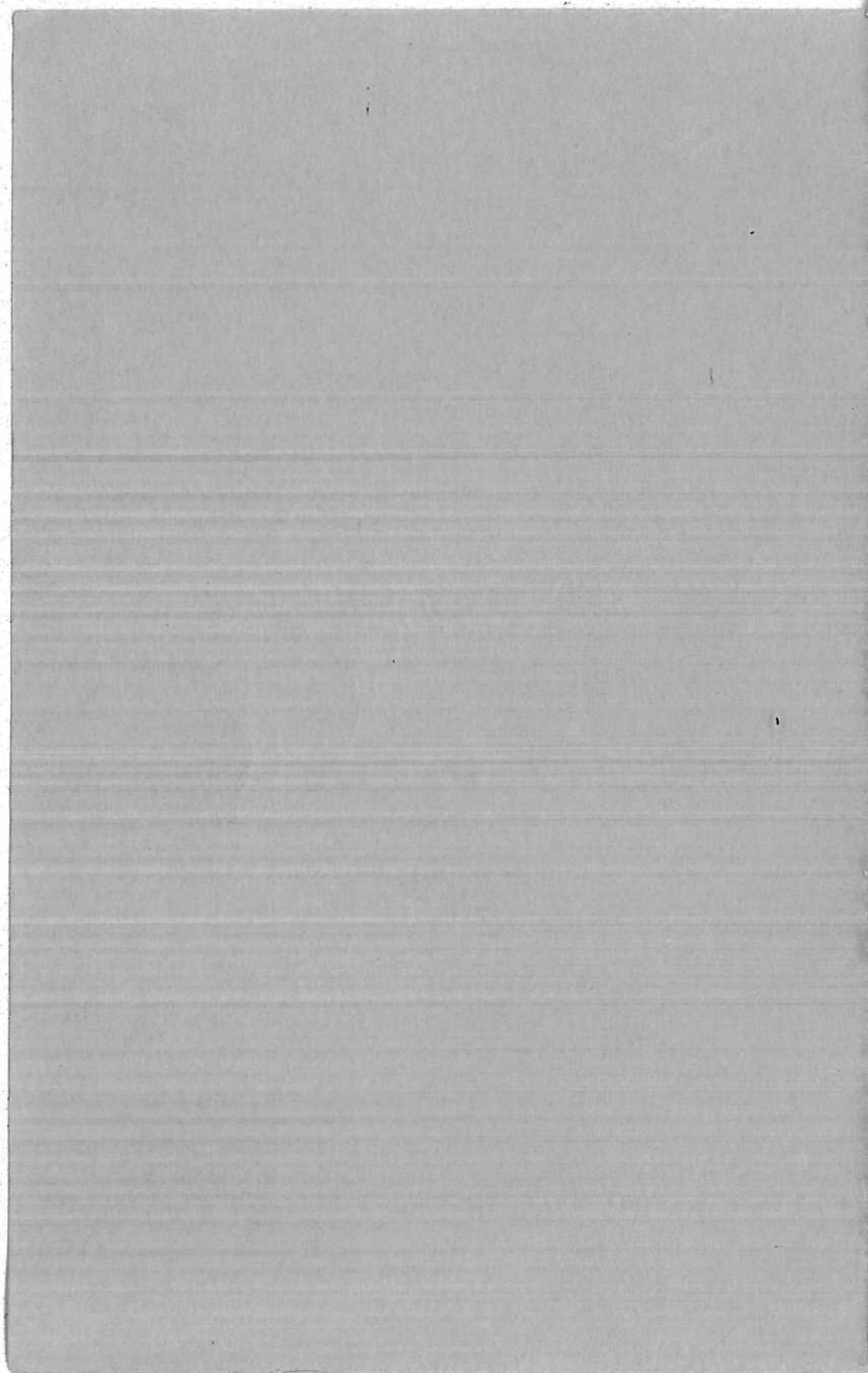

ANNUAL TOWN MEETING WARRANT

MARCH 2 and MARCH 7, 1959

Worcester, ss.

To the Constable of the Town of Upton, in the County
of Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the TOWN HALL, in said Upton, on Monday the Second day of March, 1959, punctually, at Seven (7) o'clock A.M. to cast their vote for the following town officers:

Article 1. To choose all necessary town officers as follows: Moderator, Town Treasurer, Road Commissioner, Tree Warden, one member of the Board of Health and five Constables, all for one year; Town Clerk, one Selectman, one Assessor of Taxes, one member of the Board of Public Welfare, two members of the School Committee, one member of the Water-Sewer Commission; one Cemetery Commissioner, one Park Commissioner, three Trustees of the Public Library, one member of the Board of Health and one member of the Mendon-Upton Regional District School Committee, all for three years; one member of the Board of Health and one member of the Mendon-Upton Regional District School Committee, each for two years, and one member of the Planning Board for five years.

Also, upon said ballot, the voters shall give in their vote "Yes" or "No" on the following question:

QUESTION

To ascertain the will of the voters of the Town of Upton with reference to the question of providing life

tenure for Clement Lambert, incumbent of the Office of Tax Collector of the Town of Upton.

Shall an act passed by the General Court in the year nineteen hundred and fifty-nine entitled "An Act providing life tenure for Clement Lambert, incumbent of the office of tax collector of the Town of Upton", be accepted?

The polls shall close at Eight (8) o'clock P.M., on the day of said meeting.

All of the above to be voted for upon one ballot.

The remaining articles contained in the Warrant will be acted upon at an adjourned meeting of the voters in Town Hall on Saturday afternoon, March 7, 1959 at Two (2) o'clock P.M.

Article 2. To hear reports of all Town Officers, or do or act in any manner pertaining thereto.

Article 3. To hear the reports of any Committees appointed by the Town, or do or act in any manner pertaining thereto.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective officers to the Town as provided by Section 108, Chapter 41, General Laws, as amended: Moderator, Selectmen, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Cemetery Commission, Constables, Trustees of Public Library, Park Commission, Tree Warden, Road Commissioner, Water and Sewer Commission, Housing Authority, Planning Board, and Board of Health, or do or act in any manner pertaining thereto.

Article 5. To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray expenses of Town Departments for the ensuing year, or do or act in any manner pertaining thereto.

Article 6. To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) to be used by the Upton District Nursing Association for pre-natal, and pre-school nursing services, crippled children and well-child clinic services, or do or act in any manner pertaining thereto.

Article 7. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1959, and to issue a note or notes therefor, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws, or do or act in any manner pertaining thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of One Thousand Five Hundred Eighty-four Dollars and Sixty-seven Cents (\$1,584.67) in accordance with the provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund, Military Service Fund and Workmen's Compensation Fund of the Worcester County Retirement System, or do or act in any manner pertaining thereto.

Article 9. To see if the Town will vote to raise and appropriate the sum of Fifty Dollars and Fifty Cents (\$50.50) to pay a 1958 bill owed the Worcester Communication Company for work necessary on the Police Radio, or do or act in any manner pertaining thereto.

Article 10. To see if the Town will vote to raise and appropriate from unappropriated available funds in the Town Treasury the sum of Five Thousand Dollars (\$5,000.00) to add to the Stabilization Fund established in 1958, in accordance with the provisions of Section 5B of Chapter 40 of the General Laws, as amended, or do or act in any manner pertaining thereto.

Article 11. To see if the Town will vote to accept a layout, relocation or alteration of Warren Road made by the Board of Selectmen, or do or act in any manner pertaining thereto.

Article 12. To see if the Town will vote to accept a layout, relocation or alteration of so-called Town Hall Road located westerly of Town Hall connecting Main Street with Nelson Street as made by the Board of Selectmen, or do or act in any manner pertaining thereto.

Article 13. To see if the Town will vote to raise and appropriate the sum of Four Thousand Five Hundred Seventy-five Dollars (\$4,575.00) for Chapter 81 Highway Work, said money to be used in conjunction with any money allotted by the State for this purpose, or do or act in any manner pertaining thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2,000.00) for Chapter 90 Maintenance Highway Work, said money to be used in conjunction with any money allotted by the State or County, or both, or do or act in any manner pertaining thereto.

Article 15. To see if the Town will vote to raise and appropriate or appropriate from unappropriated available funds in the Town Treasury the sum of Four Thousand Dollars (\$4,000.00) for Chapter 90 Highway Construction on Pleasant Street, or do or act in any manner pertaining thereto.

Article 16. To see if the Town will vote to raise and appropriate or appropriate from unappropriated available funds in the Town Treasury the sum of Four Thousand Dollars (\$4,000.00) for General Highway Maintenance and Betterments on Chapter 81 Roads, or do or act in any manner pertaining thereto.

Article 17. To see if the Town will vote to appropriate the proceeds of the 1958 Dog Tax Refund, the sum of Six Hundred Forty-eight Dollars and thirty-two Cents (\$648.32) received from the County, to the School Salary Account, or do or act in any manner pertaining thereto.

Article 18. To see if the Town will vote to raise and appropriate the sum of Four Hundred Twenty-five Dollars (\$425.00) for culvert work on Warren Street, or do or act in any manner pertaining thereto.

Article 19. To see if the Town will vote to return the balance of Seven Dollars and Ninety-nine Cents (\$7.99) remaining in the J. P. Benoit Memorial Account to the Town Treasury, or do or act in any manner pertaining thereto.

Article 20. To see if the Town will vote to appoint a committee of seven to obtain estimates of cost of a Library Building, said Committee to be named by the Moderator, four members to be from the Board of Library Trustees, or do or act in any manner pertaining thereto.

Article 21. To see if the Town will vote to appoint a committee of three members, said committee to be appointed by the Moderator, who will make a study of and report back to the Town at a later Regular or Special Meeting, their Recommendations as to disposition or use of the building known as the Knowlton School, or do or act in any manner pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of Eighteen Hundred Fifty-six Dollars and Fifty-seven Cents (\$1,856.57) for a Water Mains (not less than six (6) inches) Extension Account, or do or act in any manner pertaining thereto.

Article 23. To see if the Town will vote to transfer the sum of Nineteen Hundred Eighty Dollars and Ninety-nine Cents (\$1,980.99) from the 1956 Water Mains Loan, Main Street and Hartford Avenue Account, to the Water Mains (not less than six (6) inches) Extension Account, or do or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to transfer the sum of One Hundred Twenty-Two Dollars and Forty-Four Cents (\$122.44) from the Pumping Station Original Equipment Account, to the Water Mains (not less than six (6) inches) Extension Account, or do or act in any manner pertaining thereto.

Article 25. To see if the Town will vote to transfer the sum of Forty Dollars (\$40.00) from the Water Mains Extension Loan of 1953 Account, to the Water

Mains (not less than six (6) inches) Extension Account, or do or act in any manner pertaining thereto.

Article 26. To see if the Town will vote to name the way in the West Upton area leading from Main Street to Centennial Court as "Driscoll Lane" and to instruct the Road Commissioner to erect suitable street name signs thereon, or do or act in any manner pertaining thereto.

Article 27. To see if the Town will vote to amend Section 11, of Chapter 2 of the existing Town By-Laws by adding at the completion of the now existing Section 11 of Chapter 2, the following sentence: "A ballot vote shall be taken when requested by seven voters at a regular or special Town Meeting.", or do or act in any manner pertaining thereto.

Article 28. To see if the Town will vote to appropriate from the Excess and Deficiency Account, a sum not to exceed Thirty Thousand Dollars (\$30,000.00), said money to be used by the Board of Assessors of Taxes in establishing the 1959 tax rate, or do or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting: — At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF ANNUAL TOWN MEETING

MARCH 2, 1959

Pursuant to the Warrant, Moderator George W. Grebenstein called the meeting to order at 7 A.M.

The ballot box had been opened for inspection by election officials and several voters in the hall. The box indicator was set at 0000. Sealed boxes containing ballots received from the printer were turned over by the Town Clerk to the Moderator. The boxes were then placed in custody of the ballot clerks.

Previous to the voting, Ernest J. Henchey (R) and Mrs. Rita C. Cutler (D) were assigned to the check-in table as ballot clerks and LeRoy W. Prentiss (R) and Mrs. Frances E. Page (D) as clerks at the check-out table at the ballot box. They were sworn to perform their said duties before the voting started. Officer Ralph P. Montenegro was in charge of the ballot box and held keys to the same.

After the reading of the call of the meeting and Article 1 for the choosing of all necessary officers and that action on remaining articles would be taken up at adjourned

Annual Town Meeting, Saturday, March 7, 1959 at 2 P.M., Chairman of Selectmen Ernest B. Porter moved that reading of the remaining articles be waived. Motion was seconded by Town Treasurer Harvey L. Martindale and so voted. There was no objection to motion. Moderator Grebenstein then directed that the remainder of the Warrant and Constable's return be read.

W. Vincent Powers was the first voter to cast a ballot. Mrs. Shirley E. Kirby was the first woman voter.

Hourly reading of ballot box indicator of number of ballots cast: 8 A.M., 42; 9 A.M., 64; 10 A.M., 103; 11 A.M., 161; 12 Noon, 208; 1 P.M., 277; 2 P.M., 333; 3 P.M., 380; 4 P.M., 459; 5 P.M., 645; 6 P.M., 793; 7 P.M., 975 and 8 P.M., 1132.

Voting lists were checked. Ballot clerks and checkers stated their lists corresponded in number of persons voting; 576 Men and 556 Women, total 1132; approximately 70 per cent of the town's voters.

First removal of ballots was at 1:30 P.M. when 300 were taken out and counted by the ballot clerks and checkers. The ballots were placed in envelopes in the presence of Moderator Grebenstein, Police Officer Montenegro, and Town Clerk.

Other removal of ballots were: 3:30 P.M., 100; 4:45 P.M., 150; 5:45 P.M., 100; 6:15 P.M., 100; 6:55 P.M., 150, and after polls closed at 8 P.M., 232, making a total of 1132.

Tellers to canvass the voters were: Mrs. Ada W. White (R), Mrs. Helen T. Jonis (D), Mrs. Helene D. Robinson (R), Mrs. Claire B. Praskiewicz (D), Mrs. Helen J. Porter (R), Mrs. Norma L. Taft (R), Mrs. Shirley E. Kirby (D), Mrs. Joanne H. McClure (D), Mrs. Helen I. Donham (R), Mrs. Elizabeth Saucier (D), Mrs. Elizabeth Victor (D), Miss Helen A. Fay (R), Mrs. Muriel J. Mitchell (R), Mrs. Yvonne Bissonnette (D), Mrs. Bertha M. Felton (D) and Gilbert A. Higgins (R).

Edward J. Furphy (D) reported at 5:30 P.M. and Charles F. Caton (R) at 6 P.M. They assisted at checkers' table and subsequently tabulated the vote.

All election officials took oath before the Town Clerk before assuming their respective duties.

Used and unused ballots were sealed and deposited in containers. They were placed in Town Hall vault.

Moderator Grebenstein read the result of the voting at 9:45 P.M.

PROCEEDINGS OF THE
ADJOURNED ANNUAL
TOWN MEETING

MARCH 7, 1959

Moderator Halbert K. Struthers called the adjourned annual town meeting to order at the designated hour with more than a quorum (20 voters) present. He deferred reading Article 2 until a number of voters in line at check list table came into the main hall.

Voting list was used at the main entrance with Mrs. Shirley E. Kirby (D) and William A. Prentiss (R) serving as checkers. They were sworn to perform this service by the Town Clerk.

Moderator Struthers requested any non-voter seated on the main floor to take a seat in the balcony.

1958 TOWN REPORT

Article 2. Voted: on motion of Chairman of Selectmen Ernest B. Porter, seconded by Selectman Gladys G. Crockett, to accept the 1958 Town Report as printed.

SPECIAL COMMITTEE REPORT

Article 3. Voted: on motion of Chairman of Selectman Ernest B. Porter, seconded by Selectman Gladys G. Crockett, to accept a report of a survey made of street lighting by the Planning Board (authorized at March 8, 1958 town meeting) with proviso that the Selectmen and Planning Board to further discuss recommendations made in report.

Planning Board's report in part: "We have talked with representatives of the Worcester County Electric Company and find that it is no longer necessary to pay a spacing charge if street lights are more than four hundred feet apart. With this in mind, we recommend the removal of twenty-five lights. The lights we recommend removing are not located at intersections, in front of any residence or driveway. By removing these lights the town will save \$450.

"We recommend the installation of two 7000 lumen MV lights near Williams Funeral Home; also, a similar light at the corner of Main Street and Fiske Ave., and another on Fiske Ave. at the entrance to the school drive. The net cost of these four lights will be \$220, leaving balance of \$230.

"We recommend the changing of the 13 existing 6000 lumen incandescent lamps in Upton Center and West Upton Center to 7000 lumen MV lights, with a net saving of \$130, or a total saving of \$360.

"We recommend replacing four existing 2500 lumen incandescent lights and one 1000 lumen incandescent light near the hat shop with eight 7000 lumen MV lights. The

net cost to the town will be \$310, or an overall saving of \$50.

"The above recommendations are based on an improved lighting plan for the town solely from a safety aspect in connection with these hazardous locations. The recommended lights also coincide with an overall improved lighting plan for the town."

At this time in the meeting, Chairman of Selectmen Ernest B. Porter asked permission for Town Counsel J. Laurence Doyle, who arrived at the hall after the meeting opened, to be permitted to be seated on the main floor and give his opinion on any legal question he might be asked. Motion seconded and voted. No dissenting voice.

ESTABLISH SALARIES AND COMPENSATION OF ELECTIVE OFFICERS

Article 4. In taking up Article 4, Moderator Struthers said that if there was no objection the recommendation of the Finance Committee would be read. He stated if a voter desired to speak on any item to request a "Pass" for later consideration. Such procedure was voted on motion of Selectman Gladys G. Crockett, seconded by Chairman of Selectmen Ernest B. Porter.

(a) Police—Expense of Department. James J. Gallagher, Chairman, stated the Finance Committee recommended \$2,750 instead of printed \$2,500. Voted.

(b) Snow Removal—Kenneth C. Stanley motioned that \$9,000 be raised and appropriated for Snow Removal instead of \$10,000 recommended, seconded by Raymond E. Griffin, and so voted. Robert E. Maynard moved for reconsideration of vote which was seconded and favorably acted upon. Chairman of Selectmen Ernest B. Porter moved that \$10,000 be provided for snow removal, seconded, and voted.

(c) Highways—Chapter 81, Chapter 90 Construction, Chapter 90 Maintenance, Chapter 81 Maintenance and Construction. Voted; on motion of Road Commissioner Henry J. Poirier to "pass over" items as there are special articles in Warrant for these projects.

(d) Street Lights—Voted: on motion of Chairman of Selectmen Ernest B. Porter, seconded, \$5,600.

(e) Board of Health—Salary. James J. Gallagher, chairman of Finance Committee, moved to change wording "Salary, Clerk, \$50" to read "Salaries, \$300."

(f) Social Worker, Clerk and Expenses—Voted: motion of Daniel H. Bates, duly seconded, to follow recommendation of the Finance Committee that the appropriation be \$3,700. A previous motion by Charles F. Caton of the Public Welfare Board to appropriate \$3,900 was not seconded.

(g) Schools—Salaries. Town Treasurer Harvey L. Martindale motioned that \$70,688.18 be established for this item. (Finance Committee's recommendation, \$71,499.) Mr. Martindale referred to Article 17 which called for appropriating the 1958 Dog Tax Refund of \$648.32 to the School-Salary Account. Also, interest received from certain trust fund. Both incomes in addition to appropriation he recommended. Voted.

(h) Insurance—Motion by Samuel Nahra to increase recommendation of Finance Committee for Insurance from \$2,600 to \$3,000 to provide for Comprehensive Liability Insurance, Town Hall Building. After lengthy discussion it was voted to lay item on table.

At this point in the meeting, Edward F. Gorman moved to take up Article 27, seconded, and so voted to act on it. Mr. Gorman's motion was to amend Section 11 of Chapter 2 of the existing Town By-laws by adding the following sentence: "A ballot vote shall be taken at a regular or special Town Meeting when a motion is made and seconded by seven (7) voters and is carried by a majority vote." Moderator Struthers directed a standing count after the motion was seconded. Result announced: Yes—64; No—12. Count was made by Constables Alfred H. Nichols and Alvin P. Nichols. (Attorney General Edward J. McCormack approved the amendment to said by-law, April 21, 1959. Published in Milford Daily News, April 24-27-29, 1959).

After Article 27 had been acted upon, it was voted to take the "Insurance" item from the table.

Mr. Nahra subsequently moved to withdraw his motion of \$3,000 for Insurance. There was no opposition. Chairman of Selectmen Ernest B. Porter then motioned, duly seconded, to establish the "Insurance" appropriation at \$2,600. Voted.

Voted: on motion of Town Treasurer Harvey L. Martindale to raise and appropriate Departmental amounts, General Appropriations Budget, as recommended by the Finance Committee and adopted changes during calling of certain accounts. Motion seconded and voted. (Total, \$396,990.68.)

DISTRICT NURSING ASSOCIATION

Article 6. Voted: on motion of Selectman Gladys G. Crockett, duly seconded, to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) to be used by the Upton District Nursing Association for pre-natal and pre-school nursing services, crippled and well-child clinic services.

AUTHORIZATION TO BORROW MONEY

Article 7. Voted: on motion of Town Treasurer Harvey L. Martindale, duly seconded, to "authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1959, and to issue a note or notes therefor, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws." No dissenting voice. Moderator Struthers declared vote unanimous.

REPORT OF THE HIGHWAY DEPARTMENT

Chapter No. 81 and No. 81 Maintenance and Betterment funds provided for the upkeep of No. 81 streets, with graveling, patching, surface treatments, and drainage. In addition, the hard-surfacing of Chestnut Street was completed this year; Hartford Avenue from Glen Avenue beyond the Henry Sadler residence was hard-surfaced; and a portion of Fowler Street from Mechanic toward the Old Grafton Road was hard-surfaced.

With the Federal Government building a new bridge on Pleasant Street for Flood Control, the 1959 Chapter No. 90 Construction monies is being used to relocate the road to meet the bridge approach.

Chapter No. 90 Maintenance fund was used for the usual upkeep of Westboro, Hopkinton, Pleasant, Mendon Streets, and a portion of North Street.

Sidewalk fund was expended for hard surfacing of the sidewalk beyond the Methodist Church on Grove Street and the maintenance of the present sidewalks.

Bridge and Guardrail account maintained bridges and replaced guardrails, which were necessary for safety.

Owing to the late storms in December, additional money was necessary for the Snow Removal account.

May I extend my sincere thanks to all the Town Departments, the Department of Public Works, and the Townspeople, for their cooperation during the year.

REPORT OF MODERATOR

In 1959, there was the annual Town Meeting and two Special Town Meetings.

At the annual Town Meeting, the following by-law was adopted and later approved by the attorney general:—a motion calling for a ballot vote may be had, if a motion for a ballot vote is made, and seconded by seven voters and upon a majority vote, a ballot vote may be had.

The voters accepted as a public way, the private road leading from Main Street to Nelson Street, and Warren Road leading from Pleasant Street.

A committee was appointed to look into the advisability of constructing a Public Library Building and report at a later Town Meeting. At a later Special Town Meeting five hundred dollars was appropriated for such purpose.

A committee was appointed to investigate the possibilities of using the Knowlton School Building for some town purpose, and report back at a later Town Meeting.

At a Special Town Meeting the voters voted to borrow the necessary money to pay Upton's share in the construction of Mendon-Upton Regional School.

I wish to express my thanks for the cooperation from the officers and voters of the Town during the past year, in conducting the Town Meetings.

REPORT OF THE DIRECTOR OF CIVIL DEFENSE

To the Board of Selectmen:

The year 1959 has passed and Upton is still in a *Non-Reception Zone* which means that thousands of persons in vehicles will pass through the town from North Grafton and Shrewsbury via Route 140, however, we must always be in a position to have Aid Check Points as well as to house evacuees when there is a nearby bombing.

Upton is located in Area 3, Sector 3B with Sector Headquarters at the Millford High School (Tel. GReenleaf 3-0851 *Administrative*) operational GReenleaf 3-3911, 3-3912 and 3-3913 and *Staff* GReenleaf 3-3910. In an emergency the Sector Headquarters will be manned. The Area Headquarters are at the Lyman School in Westboro and as with the Sector Headquarters will be manned in time of emergency by Harold F. Rossi. *Upton's Control Center* may be contacted by telephoning Lakeside 9-6901.

The Two-Way Radio Communication System (Motorola) installed in 1958 and licensed by the Federal Communications Commission, has its *Main Station* at the Central Fire Station on Church Street with the Remote Control at the residence of the Chief of Police, Daniel H. Bates on Main Street. A Portable Radio Phone is located at the Civil Defense Headquarters in the Town Hall. Mobile units are installed in the Fire Dept. Pumper, the Forest Fire Truck, the Chief of Police's automobile, and the Service Truck of the Supt. of Streets.

Surplus Property. Through Civil Defense we have been able to purchase from the State Agency for surplus property at Myles Standish, Taunton, Mass. surplus materials and equipment for training purposes.

Radioactive Fallout. Upton has two complete sets of equipment for monitoring and testing "fallout." One set

is located at the Church Street Fire Station with Francis E. Aldrich in charge. The other set is at the home of Radiac Officer Eugene I. Whiting on South Street.

Shelters. It is our belief that a thorough study should be made of Bomb Proof Shelters for schools, public buildings and especially for individual homes.

CD Meetings and C.C.X's. There have been a number of exercises and meetings at Area Sector Headquarters which have been attended by your director and members of the Upton Staff.

Communication Tests have been made by Gerald Shaughnessy and Joseph A. Deering.

The Defense Council members are Charles R. Stuart, Edward Prentiss, Henry J. Poirier, Edward J. Kuczinski and Dr. Bernard F. McKernan.

The *Control Center* is located at the Upton Town Hall. Tel. LA 9-6901 in time of emergency.

REPORT OF WATER AND SEWER COMMISSIONERS

For the year ending December 31, 1959

To the Honorable Board of Selectmen
Town of Upton, Massachusetts
Gentlemen:

Herewith we submit a report of Water and Sewer Department activities for the year 1959.

We installed 250 feet of 8-inch main on Lower Mendon Street. This was to connect a new residence and also to start the main trunk line to connect with Plain Street in the future. This work was done under the Betterment Act. We also installed 225 feet of 8-inch water main on Lower Pleasant Street, connecting two new services. This work was done at the contractor's expense, the Town of Upton furnished material only. We installed on River Street 730 feet of 6-inch main that will add six services to the Dept. and also in the future will connect to North Main Street to form a loop that will make better circulation and flow in our water system. We painted the hydrants this year also.

We have come to an agreement concerning the well fields. They will be raised on an average of six feet at no cost to the town. The sewer beds are still being discussed with the State Board of Health and Army Engineers. We hope to reach an agreement in the very near future.

We have an article in the Town Warrant to paint the water tank this year. The tank has been installed six years and should be scraped and painted inside and out. During the past year we pumped 51,085,000 gallons of water with the month of April, with 5,036,000 gallons, being the highest.

We also installed 850 feet of new 6-inch water main with one hydrant on Depot Street. This extension was a maintenance project, replacing the old gal. 2-inch line and 1-inch line that was used before. This project completes the replacing of all remaining old piping system of Knowlton water system.

We have today a good sound water system that can be added to in the future without changing any of the main supply piping system. We employed local help and equipment on all water extensions this year and received a very good return on monies spent. We want to thank the Townspeople and men working on these projects for a job well done.

BOARD OF HEALTH REPORT

The Board of Health was organized as a separate board for the first time in 1959.

The Board conducted inspections of all food handlers within the town and several questionable residences. One residence was condemned as unfit for habitation and two warnings were issued for changes to be made.

A great deal of assistance and guidance was obtained by the Board in meetings of the Central Mass. Assoc. of Boards of Health.

In June and July the Board conducted two polio clinics at Memorial School. These clinics afforded townspeople of all ages the opportunity to receive polio shots at a minimal fee. As a result of these clinics the percentage of people receiving polio protection in Upton was high or higher than any town in the state.

In September the Board conducted an inspection of the town dump and Kiwanis Beach and the surrounding areas at Pratt Pond. From this inspection several pressing problems were brought to the attention of the Board. After due consideration and study the Board offers the following recommendations to correct these problems in 1960.

1. Town dump. As is obvious to all, the present conditions at the dump are deplorable. It is also obvious that some drastic changes are in order. The Board feels that there are two possible solutions to the problem. The first is to allocate sufficient funds to permit proper attention to the upkeep, also to set and enforce stringent rules and regulations in regard to the use of the dump. To further ease the problem of garbage dumping, the Board would have the town consider awarding a contract for garbage removal.

The alternative would be relocation of the dump to a location suitable to a sanitary fill method of disposal.

2. Rules and regulations in regard to sewage, food handling and other problems relating to public health. These would allow the Board to operate and enforce under a standard procedure.
3. Kiwanis Bathing Beach. The Board will insist on installation of sanitary facilities to conform to state standards before opening in 1960.

REPORT OF SELECTMEN

The Selectmen held an organizational meeting following the Annual Adjourned Meeting on March 7, 1959, Ernest B. Porter being voted chairman; George G. Newton, Clerk; Daniel H. Bates, Chief of Police; and Eugene A. Closson, Deputy Chief of Police. No affirmative action was taken at this meeting on the appointment of a Town Counsel. At a later meeting held on April 7, 1959, Atty. Jacob Oppewal of Whitinsville, Mass., was appointed to the office of Town Counsel.

Many improvements were made during the year in the Town Hall building. The new showers were completed and put into operation at the start of the basketball season, a new burner installed in the boiler, and the heating system extended and zoned in the building. Many more alterations are expected to be made within the building during 1960. Money for these projects are being drawn against the William Knowlton Fund.

The Board attended the ground breaking ceremonies of the West Hill Dam Project—a project designed to protect the lower Blackstone Valley in case of floods. Many hours of discussion were necessary with the Federal Engineers and fellow Town officials to accomplish, what we feel, are those things necessary to protect the Town, its inhabitants and its installations in time of flood when the waters will be held back through the South and Western ends of our Town. To those Town Officers who gave of their time and voiced their opinions at these meetings, the Selectmen are most grateful.

May we add here also, that although the feeling may be prevalent in many minds that the Lake Wildwood Dam is a dormant issue, the Board is quite optimistic that the summer of 1960 will see quite some change in this area.

From a standpoint of the Town in General, the Board takes pride in the fact that 1959 brought to a conclusion the question of our new Regional School. We are mindful of the fact that the initial start made to the forming

of a Regional District for our School System was started in the summer of 1947, hence—twelve years have elapsed before reaching the ultimate goal. Much praise should be leveled on the Building Committee for the long hours of diligent thought and action necessary to accomplish this final product.

At this writing, it is much too early to forecast predictions on the 1960 Tax Rate, but feel confident, that through the efforts of your Finance Committee and the various Town Departments, a concerted effort is being made to hold budgets to a minimum in the face of an anticipated increase in the rate.

May we take this opportunity of thanking the various Boards, Officials and Citizens, whose cooperation and assistance so helped to make our efforts more pleasant and fruitful during the year 1959.

Major Items Considered 1959:

Nipmuc Regional School:

Recommended approval of right of Regional Committee to incur debt up to \$1,150,000 at Special Town Meeting May 2nd, 1959. Your Committee wishes to thank the Regional Committee for its cooperation in providing information and for the time given in the many meetings which preceded this recommendation.

Lake Wildwood Project:

Met with Selectmen to consider progress and to receive assurance of eventual worth of Town Funds already expended on this item. Your Committee was given to understand that State funds for this Project had been noted by the Legislature and would be allocated "when available." Your Committee feels that the Lake Wildwood Project should have the closest follow-up by Town Officials concerned to make sure that the money for the undergrowth removal was well spent.

An accurate estimate of the total expense to the Town should also be obtained and the Town's share of the expense reported to the Voters.

West Hill Project:

On June 18th the Committee voted to request a review of the status of this Project with Selectmen and other interested boards because of apparent potential expense and damage to Town services in the event of maximum flood. A series of subsequent meetings with Selectmen, Planning Board, Water and Sewer Commissioners, Federal Flood Project Officials, and other interested personnel resulted in additional Federal concessions to protect Upton's well fields, sewer beds, and other important facilities. Your Committee is appreciative of the prompt action taken by Selectmen to assure these concessions.

Other Activities:

Members of this Committee attended the annual meeting of Massachusetts Assn. of Finance Boards at Cambridge on October 7, 1959. Much of value was gained from talks presented on State Finance and Municipal Statistics. Exchange of information with other Finance Boards developed that while Upton's approach to Town Finance can still benefit from some refinement, most other towns do not work as smoothly as ours and for this your Committee thanks the Town boards and departments who have made it possible.

TOWN TREASURER'S STATEMENT

There is deposited in the Milford Savings Bank \$12.89 known as the Knowlton School Fund with the Town Treasurer as Trustee, to be used by the School Committee to defray extraordinary expenses at the Knowlton School.

There is deposited in the Milford Savings Bank, One Thousand Dollars (\$1,000.00) known as the Ella (Whitney) Risteen fund in Trust, with the Town Treasurer and School Committee as Trustees, the income to be divided between the two pupils in our High School who make the most progress during each year. \$36.38 interest was received this year. Nothing was used this year.

There is deposited in the Worcester County Institution for Savings One Thousand Dollars (\$1,000.00) known as the Dr. Carpenter Library Fund, the income of which is to be used for the Public Library.

Charlotte A. Batchelor and George W. Knowlton established as Trust Deed at the Worcester County National Bank (formerly Worcester County Trust Company) with the Bank as Trustee, the income to be paid to The Town of Upton for use of the Knowlton School. \$255.32 was received this year.

There is deposited in the Milford Savings Bank, Five Thousand Dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in Trust with The Town Treasurer as Trustee, the income to be used for the Public Library. \$168.75 was received this year.

There is deposited in the Milford Savings Bank a Fund known as The Library Construction Fund (vote of

Town May 15, 1958) \$151.48 interest was received this year and the amount of the account on December 31, 1959 was \$4,603.12.

There is deposited in the Milford Savings Bank, Five Thousand Dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Selectmen, to be used to help townspeople who are in distress. \$176.75 interest was received this year and the balance December 31, 1959 was \$5,364.76. \$66.00 was used this year.

The industrial Accident Fund established in 1937 is deposited in the Milford Savings Bank. \$77.60 interest was received and the Balance December 31, 1959 was \$2,004.05. Payment from this fund is to be made in accordance with rules established by the Board of Selectmen. \$354.20 was used this year.

There is deposited in the Home National Bank of Milford a Fund known as the Post War Rehabilitation Fund. Income from the Bond was deposited in this fund and the Balance on December 31, 1959 was \$9,089.19.

There is deposited in the Worcester County Institution for Savings two thousand dollars (\$2,000.00) known as the George H. Schultz Library Fund in trust with the Town Treasurer and Library Trustees as Trustees, the income to be used only for the purchase of books. \$90.84 interest was received this year.

There is deposited in the Milford Savings Bank \$35.26, known as the Nellie Bagley Lakeview Cemetery Fund, with the Town Treasurer and Cemetery Commissioners as Trustees. All of this fund is available for use by the Cemetery Department for improvements at Lakeview Cemetery. None was used this year.

CEMETERY PERPETUAL CARE FUNDS

There is deposited in Worcester County Institution for Savings \$22,735.00.

There is deposited in Milford Federal Savings and Loan Association \$4,350.00.

Receipts are deposited each year and the interest received is used by the Cemetery Department to care for lots covered by perpetual Care. 1958 deposits were \$750.00. Interest received was \$1,157.40.

REPORT OF STATE AUDIT

July 13, 1959

I submit herewith my report of an audit of the books and accounts of the town of Upton for the period from January 1, 1958 to April 14, 1959, made in accordance with the provisions of Chapter 44, General Laws. This is in the form of a report made to me by Mr. William Schwartz, Assistant Director of Accounts.

Sir:

As directed by you, I have made an audit of the books and accounts of the town of Upton for the period from January 1, 1958, the date of the previous audit, to April 14, 1959, and submit the following report thereon:

The financial transactions, as recorded on the books of the several departments receiving or disbursing money for the town or committing bills for collection, were ex-

amined, checked, and verified by comparison with the records in the offices of the town accountant and the town treasurer.

The books and accounts in the accountant's office were examined and checked, the recorded receipts being compared with the treasurer's books and with the records in the several departments collecting money for the town. The payments, as entered, were checked with the treasurer's books and with the treasury warrants, while the appropriations and transfers were checked with the town clerk's records of financial votes passed by the town meetings and with the finance committee's authorizations of transfers from the reserve fund.

The general and appropriation ledger accounts were analyzed, the necessary adjustments resulting from the audit were made, and a balance sheet showing the financial condition of the town on April 14, 1959 was prepared and is appended to this report.

The books and accounts of the town treasurer were examined and checked in detail. The cash book was footed and the recorded receipts were compared with the town accountant's books, with the departmental records of payments to the treasurer, and with other sources from which money was paid into the town treasury. The payments were compared with the warrants approved by the selectmen and with the accountant's books.

The treasurer's cash balance on April 14, 1959 was proved by reconciliation of the bank balances with statements furnished by the banks of deposit, by examination of a savings bank book, and by actual count of the cash in the office.

The payments on account of maturing debt and interest were proved with the amounts falling due and checked with the cancelled securities on file. The outstanding coupons on April 14, 1959 were listed and reconciled with the balance in the bond and coupon account as shown by a statement received from the bank of deposit.

The records of payroll deductions for Federal and State taxes, and for the county retirement system were examined. The payments to the proper agencies were verified, and the balances on hand were reconciled with the respective controls in the accountant's ledger.

The securities and savings bank books representing the investments of the several trust and investment funds in the custody of the town treasurer and the trustees were examined and listed. The income was proved, and all transactions and balances were verified and compared with the books of the town accountant.

The records of tax titles and tax possessions held by the town were examined and checked. The amounts transferred to the tax title account were checked with the collector's books, the reported redemptions were compared with the treasurer's recorded receipts, and the tax titles and tax possessions on hand were listed, reconciled with the accountant's ledger controls, and checked with the records at the Registry of Deeds.

The books and accounts of the town collector were examined and checked in detail. The commitments of taxes and excise were compared with the warrants issued by the assessors; the recorded collections were checked with the payments to the treasurer, as shown by the treasurer's and the accountant's books; the abatements, as entered, were compared with the assessors' records of abatements granted; the transfers to the tax title account were proved; and the outstanding accounts were listed and reconciled with the controlling ledger accounts.

The records of departmental and water accounts receivable were examined and checked. The accounts outstanding at the time of the previous examination, as well as all subsequent commitments, were audited and proved. The recorded collections were compared with the payments to the Treasurer; the abatements, as entered, were checked with the departmental records of abatements granted; and the outstanding accounts were listed and reconciled with the accountant's ledger controls.

The outstanding tax, excise, and water accounts were further verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The financial records of the town clerk were examined and checked. The collections on account of dog and sporting licenses issued, and from miscellaneous receipts, were verified and compared with the payments to the town treasurer and to the Division of Fisheries and Game.

The records of departmental cash collections by the board of selectmen, the sealer of weights and measures, and the wire inspector, as well as by the police, fire, health, sewer, highway, school, and library departments, and by all other departments in which money was collected for the town, were examined and checked. The payments to the town treasurer were verified by comparison with the treasurer's and the accountant's books, and the cash on hand in the several departments was proved by actual count.

The surety bonds of the officials required by law to furnish them for the faithful performance of their duties were examined and found to be in proper form.

In addition to the balance sheet, there are appended to this report tables showing reconciliations of the several cash accounts, summaries of the tax, excise, tax title, departmental and water accounts, as well as schedules showing the transactions and condition of the trust and investment funds.

For the cooperation extended by the several town officials during the progress of the audit, I wish, on behalf of my assistants and for myself, to express appreciation.

LIBRARIAN'S REPORT

To the Trustees of the Upton Library:

The librarian respectfully submits her annual report with library statistics, list of periodicals, and the catalog of new books.

Books have been added to the Dr. Carpenter alcove as required.

Gifts of magazines and books have been received from Mrs. Ruth E. Cormier, Mrs. Marion Davis, Paul Prentiss, Mr. Stanton Baker, Mr. David Colcord, the Woman's Club and Kiwanis Club.

During the year 83 new borrowers were registered; 38 adults and 45 children.

Vacation Reading Clubs were held in the summer for Grades 3 & 4; Grades 5 & 6 and Grade 7. Also a weekly Story Hour for the younger Children.

In November, National Book Week was observed with a large display of new books, and an exhibit of the Blackfoot Indians loaned to us from the Natural History Museum in Worcester. All the grades from the Ball School visited the Library, and a morning Story Hour was held for the Kindergarten children.

In December a Christmas Story Hour was held; 30 children came on a very stormy Saturday morning.

The Monday opening which was started in the fall has been of real value to the students. This has not made an appreciable difference in the circulation but it has made a great increase in reference work and school assignments done at the library. It was opened primarily for this service.

Shelves of books are set up for the required reading lists. There is a section for History and Problems in Democracy for the Senior High pupils.

A shelf in "Adventures in Reading" was set up for the Woman's Reading Club of the Congregational Church and has been well patronized by the members.

We are proud to have a "Great Books Discussion Group" who meet regularly at the library.

Mrs. Helen Bentley has kindly loaned us an interesting display of shells.

I wish to express my deep appreciation to Miss Helen Fay for substituting for me on my leave of absence in April and for her help in choosing the new books.

I also thank Mrs. Adele Fields for substituting for me in the summer; and for Marion Temple's help in the library.

I thank the Trustees for their generous support and cooperation.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the Upton School Committee
Upton, Massachusetts

Mrs. Kathleen Maynard and Gentlemen:

The citizens of Upton beginning a decade ago were determined to improve and insure adequate educational facilities for their children. A modern elementary school was built, improved salaries guaranteeing a high quality of instruction, textbooks and educational facilities were brought up to meet the demands of a modern elementary school program, the results of this effort should be obvious to all. Continued study into ways and means by which secondary school pupils could be adequately trained under local control was surveyed and after much hard exploratory work and effort the citizens approved the formation of a regional school district embracing the Town of Mendon. The Committees, in their wisdom, voted to dissolve the Grafton - Upton School Union and to align themselves in a new union with the Town of Mendon so that provision could be made for a more efficient administration and to provide continuity in planning the educational program for grades one through twelve. The years 1950 - 1960 will go down in the history of Upton as years of great educational progress and harvest. The Superintendent has enjoyed a most satisfactory professional experience in working with Committees made up of men and women of great quality, people who were willing to contribute their time, intelligence and physical stamina to this tremendous effort in order that the children of Upton, both now and in the future, would be assured of the quality of education comparable to that offered in other communities of the Commonwealth.

The years I have spent as Superintendent of Schools and Educational Consultant for the Upton School Com-

mittee and the Regional School Committee have been both pleasantly and professionally profitable. I shall hold myself ever ready to befriend the public schools of Upton. The counsel I would give at the close of my school administration in Upton is to continue the excellence of effort made over the past decade and to make certain that men and women of good report, high ideals and who recognize fully the contribution of education to a free society, have the honor of serving on your school committees of the future.

The Upton School Committee, past and present, and those who have served on the Regional School Committee, past and present, to all of these, my thank you for your cooperation in all administrative matters related to the development and growth of our educational endeavors.

May I refer you to the reports of the several departments, Art, Music, and Health, the report of the Director of Elementary Education which is intended to supplement that of the Superintendent of Schools.

May I commend to you, the citizens of Upton the efforts of your professional and non-professional staff who have been associated with me over the years, taken in the total, their contributions have been of excellence. May I also express my deepest appreciation to all who have supported the public schools of Upton. My association with the several committees, Town Officials, the schools and the Community has been one in which any school man could take great personal and professional pride.

REPORT OF THE DIRECTOR OF ELEMENTARY EDUCATION

The following is the third and final report concerning the elementary schools of Upton.

The dissolutionment of the Grafton-Upton School Union should not basically alter the elementary school program in the Town of Upton. During the tenure of the Supervisor of Elementary Schools in the Town of Upton, he has come to appreciate the faculty members for their professional ability and personal character, and the non-professional workers, as sincere and enthusiastic supporters of the schools. There has been much professional and personal satisfaction in working with the people of Upton.

During this time, teachers have participated in an in-service type of program which has been designed to promote professional growth within the community. The School Committee, being aware of the need for this type of program, has permitted teacher participation during the school day. The rewards from this release time activity in terms of improved teaching practices should be sufficient cause for the continuation of this program. The grouping techniques which permit all children to work to their capacity, have been practiced by all teachers in the developmental reading program. Long range planning would cause this technique to be introduced in other subject areas soon.

The promotion of the present long-range plan required that basic material changes had to be made. In addition to grouping techniques, the superintendent of schools had caused to be established; standardized time allotments for each subject at different grade levels; the replacement of antiquated text books by new copyrights which are consistent with today's curriculum; and, as a result of controlled purchasing and distribution of materials, supplies which heretofore were difficult to secure, are now in abundance. Audio-visual materials and library

and reference books are supplementing the basic curriculum every day. In addition, a co-basal or supplementary reading series has been introduced in the basic reading program and has already proved its worth in improved reading scores on standardized tests.

One of the outstanding improvements made during this period has been the decrease in the teaching load in the elementary grades. The effectiveness of the teaching-learning situation in today's elementary schools is directly proportionate in the number of children in attendance upon any single class. The maximum number of children in any elementary grade should be 30, the ideal maximum being 25. At the time of this writing, the average number of children in each class in the elementary schools of Upton is 26. This fact cannot be boasted by many communities and is one upon which the citizens of Upton should be proud. These ideal maximum loads permit the faculty to practice modern teaching techniques among which is the opportunity of the teacher to lend particular attention to children requiring it and to afford the above average child the opportunity for lateral growth.

The standardized testing program which was introduced about five years ago, has been strengthened and expanded to enhance the scientific approach to the analysis of learning and teaching. Complementing the testing program is the guidance service which has been practiced in the elementary schools. Although guidance and counseling, as such, has not yet found its proper place, most of the mechanical preparation and understanding thereof have been introduced in addition to the testing program. This includes a well-organized, highly developed and easily understandable case history cumulative folder system and a system of reporting pupil progress to the home.

In addition to the attention given to the academic program in itself, it has been necessary to provide for a steadily increasing elementary enrollment. The elementary school population during this period has increased by approximately two and one-half classrooms of children. All available rooms in the elementary schools of Upton are being used. In a three year period the average number of classrooms used for each grade is somewhat greater than two. Each of the primary grades utilize three classrooms

and the intermediate grades use two classrooms. If there is to be a stabilization, or levelling-off, of children entering the elementary schools it will come in the higher rather than the lower figure.

Of outstanding importance to the promotion of a sound program in the elementary schools, is the need for supervising personnel. The National Elementary School Principals Association recommends that an elementary school larger than eight rooms and/or housing more than 250 pupils should be provided with a supervising principal. At the time of dissolutionment of this school union, there was in the Town of Upton, 15 elementary classrooms, housing approximately 400 pupils. The people of Upton would be in error to assume that a superintendent of a regional school district would have sufficient time to personally conduct an elementary school program which would perpetuate the present program and expand this long-range potential. The nature of the elementary curriculum in Upton is such that it will require direct supervision by personnel whose main task is to promote the elementary school program.

As a result of the minimum salary scale, established by the Upton School Committee to be effective in September 1960, this community is in a position to be competitive in the teacher market with all neighboring communities. Upton can demand and secure the finest in available teaching candidates.

The transportation system in Upton has been improved beyond what had been considered to be a more than adequate system in itself. The bus contractors who had been doing a magnificent job of transporting children of this community, have increased the efficiency of their routing system and have established modes of conduct, the only purpose of which has been to secure the safety of the children. With an increase in school enrollment, it had been necessary during this past year to make some basic alterations in routing and buses themselves.

All buses are now of the 60 passenger size and can accommodate a maximum seating of 360 pupils. These buses are adequate to transport the children of Upton on a single-trip system, to the elementary school and the

regional high school, at least for the duration of this present contractual period. Because the town is providing a secondary public school, the transportation to Milford can be eliminated.

It is recommended that no basic changes be made in the projected program for the elementary school. To insure the promotion of the present objectives, it is further recommended that:

1. An elementary school supervising principalship be established.
2. The program of release-time for in-service growth continue.
3. Continuous curriculum evaluation by teacher committees continue.
4. Classroom loads be kept below suggested maximums.
5. The guidance and testing program receive extra consideration through:
 - a. stress on parent, pupil, teacher conferences.
 - b. continued evaluation and interpretation of standardized test scores.
 - c. expansion of diagnostic testing program.
6. A program of cooperation and understanding between the elementary and junior high school be incorporated as a primary objective. Considered in this program should be a continuation of the guidance and testing program and in-service meetings involving upper elementary and junior high school teachers.

Appreciation is extended to the Superintending School Committee, all school personnel, parents and citizens of Upton for their consideration and cooperation in promoting the elementary school program of Upton.

REPORT OF THE MUSIC SUPERVISOR

The aim of music instruction in the schools is to cause children to know, to love, and to understand music in as many forms as possible, and thus to bring added joy into their lives.

During Thanksgiving, Christmas, and Easter time the children are taught numerous seasonal songs and entertain each grade throughout the building. At Memorial time each grade gives a musical program at the Memorial School which is open to the public. The parents and various organizations of Upton look forward to this program with a great deal of interest.

REPORT ON INSTRUMENTAL MUSIC

During the past year we have made steady progress in the development of our instrumental music program in Upton. During the 1958-59 school year there were approximately 35 children enrolled in the program throughout the year. A very small number discontinued study this year. Most of those who started are continuing their work while they are students in Upton and upon graduation they will take their places in the high school band program at Northbridge.

A group of beginners was started in the fall of 1959 and it is expected that these pupils, with the ones who are continuing, will make up a fine band for Upton this year. The band presented a concert during the spring of 1959 and took part in other school and community functions.

It is recommended that consideration be given to obtaining a simple uniform for the band this year. Uniforms will give the band a more unified and attractive appearance and will make it possible for them to serve the school and community in a more effective manner.

With the coming of the Regional High School for Upton plans have been developed to make the Upton boys and girls prepared for a more expansive high school music program when the new school is ready.

At this time I would like to express my appreciation to the Superintendent, the Director of Elementary Education, the Principal and Teachers for their unfailing cooperation in the development of our program during the past year.

REPORT OF THE HANDWRITING SUPERVISOR

An excellent handwriting product is not achieved by accident. Instead, it is the result of painstaking teaching on the part of devoted classroom teachers working under intelligent supervision with adequate instructional and motivational materials.

An examination of the results obtained in handwriting for the school year ending in June 1959, shows that an excellent handwriting product has been forthcoming in your schools indicating that the materials have been adequate, the work of the teachers highly satisfactory and that the motivation and instruction, materials, and consistent diagnosis has been effective. Our major objective, naturally, is to teach technical handwriting to a point where the student has attained or surpassed the national norm in speed and quality. There are other objectives, however, of almost equal importance such as to help the pupil appreciate and enjoy good handwriting and at the same time to have him acquire and enjoy good work habits that will insure neatness, accuracy, and attention to details.

At the end of the last school term we found that 92.8% of the grades given to students in a formal handwriting test were A (excellent); 5.8% were graded B (good); and one 1.4% were graded C or fair. During the school year we graded the handwriting on approximately 8,712 spelling, arithmetic, and English papers. In addition to this we graded a formal test paper for each child each month for the items of neatness, letter forms, size, alignment, spacing, slant, ending strokes, and line quality. During the year we supplied new instructional and motivational materials for the pupils and teachers along with the necessary instruction in the use of these materials.

In general, we are very pleased with the results obtained and the splendid cooperation of the administrative staff and the teachers.

REPORT OF THE SCHOOL NURSE

The health program consists of helping maintain and improve the health of the school children, frequent classroom visits, conferences with Principals and Teachers, and home visits to parents to act as liaison between parent and teacher.

Physical health examination by the school physician, assisted by the nurse, are given to pupils in grades one and four. Notices are sent to the parents of children who have been found to have physical defects and home visits made if necessary.

Vision and hearing tests are given all children and home visits made to recommend further care if children fail to pass these tests.

We were fortunate to have the Mantoux Test, which was given by the Worcester County Health Association through the Christmas Seal Program. All children in the Upton Schools and the Upton pupils in Northbridge Jr. Sr. High School were given a chance to have this test. Pupils having a positive reaction were given a chest x-ray. The Upton School nurse took over the reports on the Upton pupils from the Northbridge School Nurse. I am happy to report all x-ray reports negative.

A dental clinic examination was held in March by a dental hygienist from the Massachusetts Department of Public Health, Division of Dental Health. This a good beginning on dental health and dental education. Notices were sent home with children needing dental care. I hope we will soon have a dentist and dental clinic as many children would benefit from one.

Two preschool clinics were held in May. The purpose of these clinics, a physical examination by Dr. McKernan assisted by the school nurse, a parent being present, is to find any physical defect which can be corrected before the child enters school in September.

I wish to thank Dr. Hilyard and his office staff for their kindness and help to me, as we leave them to go into a union with Mendon.
