**WARRANT FOR ANNUAL TOWN MEETING****MARCH 6, 1967**

Worcester, ss.

To the Constable of the Town of Upton, in the County of Worcester,  
Greetings:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the Town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday, the Sixth (6th) day of March, 1967, punctually at Seven (7) o'clock A.M. to cast their vote for the following town officers:

Article 1. To choose necessary officers for the coming year: Moderator, Tree Warden, Road Commissioner and One Member of the School Committee (to fill unexpired term), each for one year; One member of Board of Health (to fill unexpired term), each for two years; One Selectman, Treasurer, One Assessor of Taxes, One member of Board of Public Welfare, Two members of School Committee, One member of Sewer-Water Commission, One member of Cemetery Commission, One member of Park Commission, Three trustees of Public Library, One member of Board of Health, One member of Mendon-Upton Regional School District Committee and One member of Planning Board (to fill unexpired term), each for three years, and One member of Planning Board for five years.

All of the above to be voted for upon one ballot.

The polls shall be closed at Eight (8) o'clock P.M. on the day of said meeting.

The remaining articles in the Warrant shall be acted upon at an adjourned meeting of the voters in Town Hall, Saturday afternoon, March 11, 1967 at Two (2) o'clock P.M.

Article 2. To hear reports of all town officers or take any action pertaining thereto.

Article 3. To hear the reports of any committees appointed by the Town, or take any action in relation thereto.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective officers to the Town provided by Section 108, Chapter 41, General Laws, as amended: Moderator, Selectmen, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Cemetery Commission, Constables, Trustees of Public Library, Park Commission, Tree Warden, Road Commissioner, Sewer-Water Commission, Housing Authority, Planning Board, and Board of Health, or take any action pertaining thereto.

Article 5. To see if the Town will raise and appropriate such sums of money as may be necessary to defray expenses of town departments for the ensuing year, or take any action pertaining thereto.

Article 6. To see if the Town will vote to raise and appropriate the sum of Three Thousand (\$3000) Dollars to be used by the Upton District Nursing Association for pre-natal, post-natal, pre-school nursing service, crippled children, care of contagious diseases, follow-up on cancer and other cases, and well child clinic services, or act in any manner pertaining thereto.

Article 7. To see if the Town will authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1967 and January 1, 1968, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

Article 8. To see if the Town will vote to raise and appropriate the sum of Five Thousand Two Hundred and One Dollars and Sixteen Cents (\$5201.16) in accordance with the provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund, Military Service Fund and Workmen's Compensation Fund of the Worcester County Retirement System.

Article 9. To see if the Town will vote to raise and appropriate the sum of One Thousand Two Hundred Twenty-Six Dollars and Four Cents (\$1226.04) in accordance with the provisions of Chapter III, Section 85 of the General Laws for the Town's assessment for the care and treatment of persons suffering from tuberculosis, and for the care, maintenance and repairs of the Worcester County Sanitorium.

Article 10. To see if the Town will vote to raise and appropriate the sum of Twelve Thousand Six Hundred Thirty-Two Dollars and Eighty-Four Cents (\$12,632.84) for capital and operational costs of the Blackstone Valley Vocational Regional School District, being the Town's proportionate share of the interest and installment reduction of bond principal, to become due on its bonds in the current year, together with expenses of school operation during the year, or take any action pertaining thereto.

Article 11. To see if the Town will vote to transfer Three Hundred Dollars (\$300) from the Cemetery Sale of Lots Account to the Oiling and Grading Account, or take any action pertaining thereto.

Article 12. To see if the Town will vote to request the Great and General Court of the Commonwealth of Massachusetts, to enact legislation providing for life tenure to Rudolph J. Scholl, incumbent of the office of Chief of Police in the Town of Upton, tenure of office to be controlled and governed by the provisions of the General Laws of the Commonwealth of Massachusetts, Section Forty-Three (43) of Chapter Thirty-One (31).

Article 13. To see if the Town will vote to raise and appropriate the sum of Four Thousand Six Hundred and Fifty Dollars (\$4650) for Chapter 81 Highway Work, said money to be used in conjunction with any money allotted by the State for this purpose, or take any action pertaining thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of Two Thousand Nine Hundred Dollars (\$2900) for Chapter 90 Maintenance Highway Work, said money to be used in conjunction with any money allotted by the State or County, or both, or take any action pertaining thereto.

Article 15. To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5000) for Chapter 90 Highway Construction Work on Fiske Road, said money to be used in conjunction with any money allotted by the State or County, or both, or take any action pertaining thereto.

Article 16. To see if the Town will vote to transfer from proceeds received, or to be received, under Chapter 679, Acts of 1965, the sum of Eleven Thousand Eight Hundred and Four Dollars and Twenty-Eight Cents (\$11,804.28) to be expended for reconstruction on Mendon Street, or take any action pertaining thereto.

Article 17. To see if the Town will vote to amend Section 2 regarding location of District School or Schools of the agreement between the Town or Mendon and Upton for the Regional School District dated May 13, 1958, or take any action pertaining thereto.

Article 18. To see if the Town will vote to raise and appropriate the sum of Five Thousand Two Hundred Seventy Dollars and Thirty-Cents (\$5270.30) for the preparation of preliminary plans and estimates by the Mendon-Upton Regional School District for the new proposed Junior High School for the said region, or take any action pertaining thereto.

Article 19. To see if the Town will vote to raise and appropriate the sum of Eight Hundred and Eight-Five Dollars (\$885), said monies to supplement the Twenty Nine Hundred Dollars (\$2900) appropriated at the December 27, 1965 town meeting, for the foreclosure of tax titles, or take any action pertaining thereto.

Article 20. To see if the Town will vote to raise and appropriate, or take from available unappropriated funds in the town treasury, the sum of Eleven Thousand Three Hundred Eighty-Five Dollars (\$11,385.00) for the purchase of a forest fire truck, or take any action pertaining thereto.

Article 21. To see if the Town will vote to become a member of the Central Massachusetts Regional Planning District under the provision of Chapter 40B of the General Laws, the annual cost to the Town of operating the district to be an apportioned cost determined by the District Planning Commission on a per-capita basis as provided.

in Section 7 of Chapter 40B or an amount not to exceed eight (8) cents per capita, according to the most recent Federal Census, which ever is the lesser, or take any action pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of Two Hundred Fifty Dollars and Sixteen Cents (\$250.16) to meet the Town's share of the operation expenses of the Central Massachusetts Regional Planning District for the year 1967, or take any action relative thereto.

Article 23. To see if the Town will vote to have the Town Clerk appoint a committee of three to make a study of the feasibility of purchasing voting machines for the Town of Upton, or take any action pertaining thereto.

Article 24. To see if the Town will vote to raise and appropriate the sum of Three Hundred Fifty Dollars (\$350) for an extension of the summer recreation program under the direction of a committee previously appointed by the Park Commission. The appropriation to be used to hire a director to work with teenagers in carrying out a youth program, or take any action pertaining thereto.

Article 25. To see if the Town will vote to raise and appropriate the sum of Twenty Four Hundred Fifty Dollars (\$2450) for the purchase of a new police cruiser, or take any action pertaining thereto.

Article 26. To see if the Town will vote to raise and appropriate a sum of money not to exceed Fifteen Hundred Dollars (\$1500), to be administered by the Library Trustees, for preliminary plans and drawings for a proposed new Public Library Building, or take any action pertaining thereto.

Article 27. To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars (\$1000), said sum to be added to the Conservation Fund set up under Article 24 of the Annual Town Meeting on March 12, 1966, or take any action pertaining thereto.

Article 28. To see if the Town will vote to raise and appropriate the sum of Two Thousand Five Hundred Dollars (\$2500), said sum to be used for weed control at Pratt and/or Mill Pond in Upton, in accordance with regulations of the State Board of Health, or take any action pertaining thereto.

Article 29. To see if the Town will vote to raise and appropriate the sum of Ninety Five Hundred Dollars (\$9500), said monies to be used for painting and reconditioning the water tank, or take any action pertaining thereto.

Article 30. To see if the Town will vote to raise and appropriate the sum of Seven Hundred Dollars (\$700), said monies to be used by the Selectmen for the purchase of Two Hundred Folding Chairs for use in Town Hall, or take any action pertaining thereto.

Article 31. To see if the Town will vote to raise and appropriate the sum of Eighteen Hundred Dollars (\$1800), said monies to supplement the Eighteen Hundred Dollars (\$1800) voted at the March 12, 1966 annual town meeting to replace present slate with asphalt on the northwest portion of the Town Hall roof, or take any action pertaining thereto.

Article 32. To see if the Town will vote to raise and appropriate the sum of Twelve Hundred Dollars (\$1200) to be used by the Park Department to black top the two basketball courts at Howard Leland Field, or take any action pertaining thereto.

Article 33. To see if the Town will vote to raise and appropriate the sum of Twenty Dollars (\$20), said monies to be added to the Street Light Account for the purpose of installing a 1000 Lumen Street Light on Pole No. 1 on Milford Street, corner of Gable Street, or take any action pertaining thereto.

Article 34. To see if the Town will vote to raise and appropriate the sum of Twenty Eight Dollars (\$28), said monies to be added to the Street Light Account for the purpose of replacing the present street light with a 3500 Multi-Mercury Vapor Light on Church Street on Pole No. 9, or take any action pertaining thereto.

Article 35. To see if the Town will vote to amend the Town By-Laws by adding the following article: "No person shall suffer or permit two or more unregistered motor vehicles, or parts thereof, to remain on his premises and no person shall suffer or permit any unregistered or disabled motor vehicle, or parts thereof, to remain within 100 feet of any public way, unless a written permit be issued therefor by the Board of Selectmen. Said permit shall not be required for vehicles, or parts thereof, stored or garaged inside buildings."

Article 36. To see if the Town will authorize the Board of Selectmen to dispose of certain tax-title or town-owned land in exchange for land presently under control of the Department of Natural Resources, Commonwealth of Massachusetts, or take any action relative thereto.

Article 37. To see if the Town will vote to appropriate from available unappropriated funds in the town treasury the sum of Five Thousand Dollars (\$5000) to the Stabilization Fund, or take any action thereto.

Article 38. To see if the Town will vote to appropriate from available unappropriated funds in the town treasury the sum of Five Thousand Dollars (\$5000) to the Reserve Fund, or take any action pertaining thereto.

**PROCEEDINGS OF ANNUAL TOWN ELECTION**  
**MARCH 6, 1967**

Warden Robert K. Sweet (R) called the meeting to order at 7 A.M. the hour designated in the Warrant.

After Mrs. Shirley E. Kirby (D), deputy clerk, read Article 1 and notice of adjourned town meeting, Saturday, May 11, 1967, Chairman of Selectmen James J. Gallagher moved to waive the reading of remaining articles at this time. (Said articles to be read before acted on at the adjourned town meeting.) Mr. Gallagher's motion was seconded and so voted without a dissenting voice. Remainder of call of the meeting and constable's return were read. Mr. Sweet then declared the polls open.

Miss Ruth F. Cooley was the first woman voter and David I. Aldrich, first male voter.

Prior to opening of polls, Warden Sweet invited voters in the hall and election officials to inspect the ballot box. The box's indicator was

set at 0000. George W. Grebenstein (R), deputy warden, was on duty at ballot box which was locked after inspection.

A box purporting to contain 1800 ballots was turned over by the Town Clerk to Warden Sweet. The ballots were then delivered to the ballot clerks.

Mrs. Rita C. Cutler (D) and Chester W. Walker (R) were ballot clerks at check-in table. Mrs. Rose E. Daves (R) and Mrs. Claire B. Praskiewicz (D) checked at out-going table at the ballot box.

Hourly reading of ballot box indicator: 8 A.M., 29 ballots; 9 A.M. 33; 10 A.M., 57; 11 A.M., 86; Noon, 109; 1 P.M., 130; 2 P.M., 180; 3 P.M., 221; 4 P.M., 291; 5 P.M., 391; 6 P.M., 495; 7 P.M., 581, and 8 P.M., 657

At 7:05 P.M. mechanism of ballot box stopped when a ballot being cast became crumpled. Warden Sweet with Republican and Democratic observers removed said ballot and re-cast it. Thus the indicator registered twice for one ballot. Result: total ballots cast 656.

Mrs. Blanche M. Banister of Pleasant Street, who observed her 94th birthday on March 4, voted.

During the 13-hour period the polls were open, 350 Men and 306 Women voted.

Weather conditions curtailed voters going to the polls in Upton and in many other municipalities where elections were taking place. Approximately 40.5 per cent of total registered voters cast their ballot here. Highways were ice-coated during the early morning with a freezing drizzle which kept sanding crews busy. The "No-School" signal was sounded in Upton. Travel conditions improved during the day and there was an increase in voters going to the polls in the afternoon. But in early evening snow began to fall and increased in density.

Tellers reported at 8 P.M. They were: Mrs. Helen I. Donham, Mrs. Ada White, Mrs. Norma L. Taft, Mrs. Marjorie I. McLaughlin and Mrs. Ruth A. Sweet, Republicans; Mrs. Helen T. Jonis, Mrs. Rita F. Drapeau, Mrs. Theresa Y. Martin, Mrs. Mary V. Powers and Mrs. Joanne McClure, Democrats.

Edward J. Furphy (D) and Mrs. Celestine I. Mason (R) tabulated.

Mrs. Katherine E. Coluci, assisted deputy clerk, Mrs. Kirby. Samuel Nahra, Jr., election clerk, was not eligible to work at polls as he was a candidate for re-election as an assessor of taxes.

Used and unused ballots were sealed in separate containers and placed in a locked cabinet in Town Hall vault.

Police Officer David I. Aldrich, an elected constable, was on duty during the morning and early afternoon. He was relieved by Police Officer George E. Nydam, and Police Officer Lloyd C. Hill.

Town Clerk George G. Newton announced the result of the voting at 10:25 P.M.

The "Hold" items were then acted on:

(a) Item 46 — Treasurer, Expenses. Town Treasurer Ashley M. Perkins stated an additional \$129.50 had been requested for purchase of an adding machine. Vincent A. Jonis, clerk of Finance Committee, agreed the extraordinary expense was favored. Voted: to raise and appropriate \$829.50 for "Expense Account" instead of \$700.00.

(b) Item 91 — Police, Extraordinary Expense. Police Chief Rudolph J. Scholl moved, seconded, that the recommendation of \$499.00 be reduced to \$299.00. Latter sum voted to be raised and appropriated.

(c) Item 104 — Fire Department Total. Norman E. Walker, member of Finance Committee, said that an "extraordinary expense" appropriation of \$448.50 for certain equipment, (nozzles, etc.) had been recommended by the committee but inadvertently omitted from the printed report. Motion to raise and appropriate \$448.50, seconded, and voted.

(d) Items 130, 131, 132 — Highways. Appropriations for Chapter 81, 90 Construction and 90 Maintenance, special articles in Warrant.

(e) Item 136 — Snow Removal. Voted to raise and appropriate \$20,000.00 as requested. Town Accountant Charles H. Ferris said that such sum was needed, otherwise a balance would have to be raised for this item in 1968. Finance Committee's recommendation, \$18,000.00, being established before recent storms.

(f) Item 146 — Veterans' Officer, Salary. On motion of Selectman Ernest B. Porter, seconded, voted to raise and appropriate \$750 as Veterans' Officer, Salary, the amount requested. Finance Committee recommended \$650.00.

(g) Item 164 — Conservation. Special article in Warrant.

(h) Item 173 — Water-Sewer, Maintenance. Voted to raise and appropriate \$8,500, recommendation of Finance Committee. Thomas L. Francis, chairman of Water-Sewer Commission, stated \$9,220 had been requested for this account. Selectman Porter moved, seconded, by Assessor Samuel Nahra, Jr., that \$9,220 be raised and appropriated. Mr. Jonis, clerk of Finance Committee, informed Chairman Francis during discussion additional money was needed for certain departmental equipment that the committee would consider a transfer of money from Reserve Account if a request was made. Selectman Porter and Mr. Nahra withdrew their motion. Action was voted on the Finance Committee's recommended amount, \$8,500.

(i) Item 179 — Cemeteries, Care and Improvement. Special article in Warrant.

(j) Item 139 — Schools, Salaries. Appropriated, \$148,585.00; by taxation, \$147,775.84, plus \$609.16 from 1966 Dog Tax Refund and \$200. Bachelor School Fund Interest. Motion made by Town Accountant Ferris, seconded, and voted.

**Memorial Tribute to Lt. Richard P. Rand  
and William R. Summers**

Town Clerk Newton requested a standing memorial silent tribute be given to Lieut. Richard P. Rand, who was killed on his 22nd birthday, March 31, 1966 when ambushed by the enemy in Vietnam, and to the late William R. Summers, a retired American League Baseball umpire, who was a member of the Upton Council For Aging at the time of his death. September 12, 1966.

**District Nursing Association**

Article 6. Voted: on motion of Chairman of Selectmen James J. Gallagher, duly seconded by Selectman Harold F. Francis, "to raise and appropriate the sum of Three Thousand Dollars (\$3,000.00) to be used by the Upton District Nursing Association for pre-natal, post-natal, pre-school nursing service, crippled children, care of contagious

diseases, follow-up on cancer and other cases, and well-child clinic services."

#### **Authorization to Borrow Money**

Article 7. Voted: on motion of Selectman Ernest B. Porter, duly seconded, "to authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1967 and January 1, 1968, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17." Moderator declared vote unanimous.

#### **County Retirement System Assessment**

Article 8. Voted: on motion of Selectman Francis, seconded by Town Treasurer Perkins, "to raise and appropriate the sum of Five Thousand Two Hundred and One Dollars and Sixteen Cents (\$5,201.16) in accordance with the provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund, Military Service Fund and Workmen's Compensation Fund of the Worcester County Retirement System." Moderator declared vote unanimous.

#### **Worcester County Sanatorium Assessment**

Article 9. Voted: on motion of Selectman Francis, seconded by Norman E. Walker of the Finance Committee, "to raise and appropriate the sum of One Thousand Two Hundred Twenty-Six Dollars and Four Cents (\$1,226.04) in accordance with the provisions of Chapter III, Section 85 of the General Laws, for the Town's assessment for the care and treatment of persons suffering from tuberculosis, and for the care, maintenance and repairs of the Worcester County Sanatorium."

#### **Blackstone Valley Vocational Regional School District Assessment**

Article 10. Voted: on motion of Selectman Porter, duly seconded, "to raise and appropriate the sum of Twelve Thousand Six Hundred Thirty Two Dollars and Eight-Four Cents (\$12,632.84) for capital and operational costs of the Blackstone Valley Vocational Regional School District, being the Town's proportionate share of the interest and installment reduction of bond principal, to become due on its bonds in the current year, together with expenses of school operation during the year."

#### **Transfer Money in Cemetery Accounts**

Article 11. Voted: on motion of Selectman Porter, seconded by Town Accountant Ferris, "to transfer Three Hundred Dollars (\$300) from the Cemetery, Sale of Lots Account, to Oiling and Grading Account." Moderator declared vote unanimous.

#### **Life Tenure For Police Chief Rejected**

Article 12. Rejected: by voice vote, a motion to Selectman

Francis, seconded by William S. Evans, Jr., "to request the Great and General Court of the Commonwealth of Massachusetts to enact legislation providing for life tenure to Rudolph J. Scholl, incumbent of the office of Chief of Police in the Town of Upton, tenure of office to be controlled and governed by the provisions of the General Laws of the Commonwealth, Section 43 of Chapter 31."

John E. Craib, chairman, stated that the Finance Committee recommended a minimum of five years' service before a request of life tenure. (Mr. Scholl appointed chief of police in 1965.)

John Tumolo, Jr. requested an explanation of Section 43, Chapter 31, which was given in substance by Town Counsel Oppewal.

#### **Chapter 81 Highway Work**

Article 13. Voted: on motion of Road Commissioner Henry J. Poirier, seconded by Selectman Francis, "to raise and appropriate the sum of Four Thousand Six Hundred Fifty Dollars (\$4,650.00) for Chapter 81 Highway work, said money to be used in conjunction with any money allotted by the State for this purpose." Moderator declared vote unanimous.

#### **Chapter 90 Maintenance Highway Work**

Article 14. Voted: on motion of Road Commissioner Poirier, seconded by Selectman Porter, "to raise and appropriate the sum of Twenty Nine Hundred Dollars (\$2,900.00) for Chapter 90 Maintenance Highway Work, said money to be used in conjunction with any money allotted by the State or County, or both." Moderator declared vote unanimous.

#### **Chapter 90 Highway Construction**

Article 15. Voted: on motion of Road Commissioner Poirier, seconded by Chairman of Selectmen Gallagher, "to raise and appropriate the sum of Five Thousand Dollars (\$5,000.00) for Chapter 90 Highway Construction Work on Fisk Road, said money to be used in conjunction with any money allotted by the State or County, or both." Moderator declared vote unanimous.

#### **Pass Over**

Francis, duly seconded, "to appropriate from available unappropriated funds in the Town treasury the sum of Six Thousand Five Hundred Dollars (\$6,500.00), said sum to supplement the Welfare Aid Account to meet necessary obligations for the remainder of the 1967 calendar year." (Recommended by Finance Committee). Moderator declared vote unanimous.

### **Veteran Benefits Account**

Article 2. Voted: on motion of Selectman Harold F. Francis, duly seconded, "to appropriate from available unappropriated funds in the Town treasury the sum of Fifteen Hundred Dollars (\$1500.00), said sum to supplement the Veteran Benefits Account to meet necessary obligations for the remainder of the 1967 calendar year. (Recommended by Finance Committee.) Moderator declared vote unanimous.

### **Change Date Of Annual Meeting Of Regional Vocational High School District**

Article 3. Voted: on motion of Chairman of Selectmen James J. Gallagher, duly seconded by Edward S. Henderson, Upton's representative on said District Committee, "that the Town approve the amendment of sub-section I, (E) Organization, of the Agreement between the Towns of Bellingham, Blackstone, Douglas, Grafton, Hopedale, Mendon, Milford, Millville, Northbridge, Sutton, Uxbridge, Upton and Millbury, with respect to the establishment of a Regional Vocational High School District, by deleting 'April 1' and substituting the following 'the first regular meeting night in April' in the first sentence." (Recommended by Finance Committee.) Moderator declared vote unanimous.

### **Transfer Control of Former Knowlton School Property To Upton Housing Authority**

Article 4. Voted: on motion of Chairman of Selectmen James J. Gallagher, duly seconded by Selectman Harold F. Francis, "to authorize the Board of Selectmen to transfer the former Knowlton School property now under their control to the Upton Housing Authority for their use as the site for the Housing for the Elderly complex." (Recommended by majority of the Finance Committee voting 6-1, it was stated by Committeeman Vincent A. Jonis.) Acted on favorably by voters with one dissenting voice, the Moderator declared.

Before acting on the motion, Jonas E. Carter, a member of the Finance Committee, stated he was emphatically in favor of a Home for Elderly People but firmly opposed to the former Knowlton School property site because of safety reasons.

In his opinion, Mr. Carter said that with the opening of Route 495, Hartford Avenue will have a large increase of traffic, making it more hazardous for elderly citizens residing at the home to cross the highway to go to the West Upton post office and shopping area.

### **Transfer Control of About One Acre of Land By Selectmen To Upton Housing Authority**

Article 5. Voted: on motion of Chairman of Selectmen James J. Gallagher, seconded by Selectman Harold F. Francis, "to authorize the Board of Selectmen to transfer to the Upton Housing Authority approximately one acre of the former Rhodes property, now owned by the Town, to assure minimum area required for the Housing for

the Elderly complex." (Recommended by a majority of the Finance Committee, 6-1, it was stated by Committeeman Vincent A. Jonis.) Acted on favorably by voters with one dissenting voice, Moderator declared.

Voted: on motion of Selectman Ernest B. Porter, duly seconded, to dissolve the Warrant. Moderator declared vote unanimous.

The meeting was in session 12 minutes, the Moderator stated.

### REPORT OF UPTON HISTORICAL COMMISSION

#### REPORT OF SELECTMEN

A meeting to organize was held following the adjourned annual Town Meeting March 11, 1967. James J. Gallagher was re-elected Chairman of the Board. Appointments made at this time were: Clerk of the Board, Mrs. Celestine Mason; Town Accountant, Charles H. Ferris; Town Counsel, Jacob Oppewal; Chief of Police, Rudolph J. Scholl.

On April 9, 1967 Rodney Marshand was appointed full time Police Sergeant and Building Inspector. Among other appointments made during the year were Louis Gregory to the Finance Committee, Richard Varney as Measurer of Wood, Bark and Lumber and Robert Prentiss in charge of Town Radios.

A repair program for the Town Hall was started two years ago when it was realized that much work needed to be done to both the interior and exterior of the building. When presented with plans to repair the hall, the citizens of Upton recognized the need and responded by appropriating funds each year for special projects in this regard. During the past year, new quarters for the Welfare Department and a Ladies' Room have been built. The work started on the boiler room and locker room was finished and renovations were made to the Men's Room. This remodelling was made possible by appropriations and monies used from trust funds. It is our hope to be able to continue these renovations to our Town Hall until the building is again in excellent repair.

The Board has met several times during the year with the Mendon Selectmen and the Nipmuc Regional School Committee in the interest of an addition to the present Regional Junior-Senior High

School or a new free standing building. Little progress has been made, but meetings will continue in the hope that a solution will be arrived at in the near future.

We intend to strive to hold to a minimum any anticipated increase in the tax rate for 1968 and in this regard will give much thought to forthcoming appropriations and careful consideration to the recommendations of our Finance Committee. Our thanks to this committee whose untiring efforts on behalf of the financial structure of the Town are greatly appreciated. Also sincere thanks to the many other Town Departments for their cooperation during the past year.

#### REPORT OF THE DIRECTOR OF CIVIL DEFENSE

During 1967 the Upton Civil Defense Unit improved its capabilities both in equipment and training. Upton was one of the communities in the State picked to participate in the nationwide alert in October. Most of our participation was by our communications men. Monthly check-ins have been continued.

Upton Civil Defense unit is available to townspeople both in manpower and with equipment for problems such as flooded cellars; need of electricity or lighting in remote locations, etc.

We have continued working on the emergency truck, painting at C.D. headquarters and supplied power and lighting for a dance held at Kiwanis Beach by the Niagara Associates. The emergency truck was at North and Pratt Ponds several times to make sure that its large pump was in good working condition. The C.D. emergency truck participated in Mendon's 300th anniversary parade as a float sponsored by the King Philip Chapter of DeMolay.

We will continue to keep abreast of changes in State and nationwide C.D. operations and maintain equipment in the best possible manner. Equipment personnel is needed. **REPORT OF THE WATER AND SEWER COMMISSIONERS**

**For the year ending December 31, 1967**

To the Board of Selectmen  
Town of Upton

We submit the following report of the activities of the Water and Sewer Department for the year of 1967:

On June 29th there was an inspection of the Upton Sewer Treatment Plant by the State Board of Health and Department of Natural Resources.

Their report to the Upton Board of Water and Sewer Commissioners was that this treatment plant had to be rebuilt for the present time to satisfy their approval.

In August a Special Town Meeting was held to appropriate Sixty Eight Hundred Dollars (\$6,800.00) to put all new pipes, stones and sand in the beds and chlorine to be added to all discharge sewage water.

This work has all been completed for the present time until the Town can make plans for a new plant.

In September we contracted Dobeck & Smith Painting Co., Inc. to clean, sandblast and paint the water tank. The tank was empty 14 days while the work was being done. The Dobeck & Smith Painting Co., Inc. were very cooperative and the work very satisfactory.

This fall there was two hundred and seventy five feet (275 ft.) of 6 inch cast iron cement lined pipe run from Grove Street down Station Street. All cost of this job was paid by the builder.

During the year 76,904,700 gallons of water was pumped, with the month of September being the highest with 8,705,800 gallons, and February being the lowest with 4,961,900 gallons.

At this time we wish to thank the Townspeople for their cooperation.


#### REPORT OF THE CONSERVATION COMMISSION

The Natural Resources Inventory, a study conducted by a technical team from the U.S. Conservation Service, Worcester County Extension Service, Mass. Division of Forests and Parks and Mass. Department of Fisheries and Game, has been completed. We are looking forward to the Report and the public meeting which will take place.

This year this Commission has taken action to try to improve our facilities for bathing, fishing, picnicking, etc., has continued its small program on conservation education, and has taken steps to acquire land for present, but more especially for future use of the townspeople.

The weed control project, voted at the last annual town meeting, has been completed at Pratt and Mill Ponds. Reports from sportsmen say the fish have not been harmed.

The discoloration of water at Lake Wildwood appears to be slowly diminishing. Fishing satisfactory. We placed picnic tables and trash barrels at the town beach-picnic area. Most of the visitors were

considerate, but unfortunately we had some vandalism. This year we will add to the facilities and improve the beach, the parking area and the road.

We sponsored Donald Sanborn at the Mass. Junior Conservation Camp for two weeks in July and expect to sponsor another boy this year. Candidates may contact the Commission. A four day conservation study was conducted for fourteen boys and girls by one of our members, Philip B. Stanton, at Grove Street.

We have concerned ourselves with never-ending pollution of our streams. Numerous checks were made. We have talked to private offenders and public. The Town is itself an offender, as we have reported to the Selectmen. Our concern is that use of the sewage facilities to a greater extent and continued expansion of the dump will cause greater pollution.

Acquisition of the remainder of the 32-acre site back of the old Knowlton School in West Upton for the Conservation Commission is recommended strongly. There is left behind land taken for the Housing Authority about 30-acres of undeveloped area of trees, stone, and cartpaths which have scenic and recreational value (which will be of immediate value to the elderly residents of the project). This land, which presently has no access to any street and has very little value, will, under the Conservation Commission, gradually become park land. We think this land should be preserved for use of the townspeople.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Upton School Committee and the Mendon-Upton Regional School District Committee:

It is a pleasure to submit my eighth annual report as your Superintendent of Schools. Working with you toward the improvement of educational programs in our towns is a pleasant and challenging opportunity.

To date, I feel that we have made great strides. However, it would appear that unless more space becomes available on the upper grade levels, we will weaken the program which is now offered. This possibility cannot be taken lightly as the futures of boys and girls are involved. What we do for them now determines the direction of their later lives, educationally, economically and socially. Parents should read carefully the report of Principal Frigard concerning this matter. It is serious.

We are still utilizing as many of the Federal Programs as seems feasible. We have received our full allotments under Titles I and II of the Elementary and Secondary Education Act and under Titles III and V of the National Defense Education Acts. We have also received funds from the Vocational Education Act of 1963. The money from these various funds has provided our system with better services, added equipment, more teaching aids, and productive ideas. We hope to continue with these projects in 1968.

Considerable time and energy has been expended in negotiating contracts with our teachers' associations. At the time they were signed, it appeared that our systems would stand very favorably in comparison with neighboring towns. However, it is now apparent that Mendon and Upton will probably have the lowest minimum salaries in the area, and our maximum will be low average. This means that we will have difficulty attracting candidates for positions and will encounter some difficulty in holding experienced teachers.

Regionalization in grades K through 12 still appears to be a constructive step for Mendon and Upton to take. There are both educational and financial advantages as well as an improvement in the administrative set-up.

Non-teaching employees are to be congratulated for their cooperation and their devotion to our schools. They perform necessary and important functions without which we could not have the educational environment we now enjoy.

Teaching staffs deserve appreciation for the part they play in our schools. They display a sincere interest in providing good teacher-pupil relationships and their cooperation is commended.

In closing let me continue to express my thanks to the School Committee members and town officials with whom I work. Our purpose is the same, to provide educational opportunities for our children of such a calibre that they will not be short-changed in life.

#### REPORT OF THE SUPERVISOR OF ELEMENTARY EDUCATION

It is a pleasure to submit my fourth annual report as Supervisor of Elementary Schools for School Union No. 59, Mendon and Upton.

A successful project in remedial reading and arithmetic was completed in August with funds provided under Title I of the Elementary and Secondary Education Act. Mendon received \$5,120.00 and Upton received \$10,700.00 at no cost to the towns. The services of two school psychologists were utilized to help in the diagnosing of learning difficulties. Equipment and materials to supplement the program was purchased under the Title I project.

We thank the following organization for donating overhead projectors and attachments for the benefit of our school: The Upton P.T.A., The Upton Woman's Club, and the Upton Bloomer Girls.

Our elementary school band, under the direction of Mr. Donald Thatcher, had a successful year. Once again the band was awarded a Division One rating.

The Elementary Glee Club, under the direction of Mrs. Faith Newark, Vocal Music Supervisor, presented a well-received Christmas concert. Our vocal music program has had a tremendous lift under Mrs. Newark's direction.

Mrs. Janet Stockwell, School Nurse, tested eyes, ears, and measured height and weight. Pupils in Grades one and four have physical examinations each year. Mrs. Stockwell has helped us greatly by keeping the staff informed of the physical problems and needs of the pupils.

Library books were again purchased under Title II ESEA for the Mendon-Upton elementary schools. The Federal funds have benefited and increased the volumes in our libraries. Mrs. Barbara Burke, School Librarian, has completed the cataloging of the new books purchased with Ristein funds and Title II Federal grants. Our library is increasing in volume rapidly. I will shortly make recommendations to change the elementary school classroom organization in reading and mathematics from the present homogeneous groupings to a continuous progress or non-graded structure. Since reading and mathematics are fundamental for a pupil's success in school, the school work in reading and arithmetic is divided into more levels of less interval. Moving progressively through these structures with less repetition is easier for all children. The program seeks to give every pupil a chance to learn each day, with less pressure to "catch up" because we have all been created as individuals and there is really no ONE learning pace that is right for all of us. The program also provided for continuity when a pupil is accelerated or slowed up. The continuous progress concept will operate in what is now termed Grades 2-4. Grades 5 and 6 will remain departmentalized at this time.

A problem which the towns must address themselves to centers around our special education program. We have students in our special education program who are too old to be in an elementary school situation. It is incumbent upon us to provide learning and vocational experiences for these pupils in an environment of their peers. We must provide equal opportunity for these pupils because they can become useful and productive citizens. I am happy to say that plans are being made and discussed to provide opportunities for these students.

The school housing problem which besets our towns is not indigenous to the Nipmuc Regional School. I firmly believe that we can not look at the Regional School program as a separate entity, but must perceive it as a part of the total Mendon-Upton school structure. To think otherwise is a false dichotomy. The towns of Mendon and Upton will be investing thousands of dollars in school construction, and I am sure we want the investment to be productive in terms of good education.

Specifically, the time is opportune to take a great leap into the educational revolution generating across the nation. New educational programs, teaching techniques, classroom patterns and organization, which have been tested, are now realities. I see no reason why our children should be left out. I recommend that new construction should center around the "Middle School Concept", housing Grades 5 through 8. This type of organization would not only solve for a long time the overcrowding which exists at the secondary levels but would also solve problems at the elementary levels. We would be able to phase in kindergarten classes with adequate classroom space available for expansion when needed.

Progress is being made by the elementary and secondary teachers in terms of coordinating the curriculum. Curriculum committees have been created in the language arts and social studies with members of the elementary and secondary meeting jointly every other week.

Consultants in reading, mathematics and social studies from the State Department of Education and Worcester State College will conduct workshops for the teachers in the above-mentioned areas.

Finally, recommend that the School Union obtain the services of an Elementary School Guidance Counselor. In today's society, the demands are great on our children. Our elementary school children should have the services of a Guidance Counselor for it is better to guide at an earlier age than to wait until it is too late.

I wish to express my gratitude to all those concerned with education and who with vigor support education which is the foundation of today's society.

To the Citizens of Mendon and Upton:

During the year the Mendon-Upton Regional School District Committee held regular meetings. Special meetings were also held with the Selectmen and members of the Finance Committees of both Mendon and Upton. A public meeting was held to discuss the 1968 budget.

After numerous meetings with representatives of the Nipmuc Teachers' Association, a contract was negotiated and signed by both parties. This Agreement was one of the first signed in this area and covers the period May 29, 1967 through August 31, 1969. Both parties stated that it is hoped that this will mean better education for your children.

I would like to call your attention to the reports of both the Superintendent of Schools and the High School Principal. Both refer to the growing problem of the shortage of space at Nipmuc. Because of this, the committee was forced to go to double sessions for the 7th and 8th grades. At best, this is a poor temporary solution.

As a result of the vote at the Mendon Town Meeting, your committee was not able to move ahead with plans to examine the possibility of building a new Junior High School on a separate location outside the one mile limit spelled out in the original Regional Agreement. Your committee continues to be of the opinion that the best solution for the taxpayers of each town would be a separate building on another piece of property that would allow for definite expansion if, and when, needed in the future.

It is hoped that in the very near future your committee will have a solution to bring up for your consideration at a future town meeting.

The budget for 1968 shows an increase of about 16.34% over that for 1967. Most of this is directly related to changes in the Teachers' salary schedule.

The Committee wishes to extend its thanks to the Administrators, Teachers, Town Officials and citizens of both Mendon and Upton for their assistance in the operation of the Nipmuc Regional School system.

### REPORT OF THE HIGH SCHOOL PRINCIPAL

As has been pointed out in my annual reports for the past four years, the need for additional facilities for the high school has been and will continue to be an increasingly acute problem. Double-platooning the seventh and eighth grades during this school year has enabled us to physically house our approximately 640 pupils but has not solved the basic problem of inadequate space to operate an effective educational program.

Our junior high school pupils are definitely being "short-changed" by a severe curtailment of many activities which contribute to the over-all development of a growing young person. Both seventh and eighth grade pupils are participating in only one-half of a normal minimal program in art, music, home economics, industrial arts, physical education and athletics. All of these activities are vital to the total education of a child. Even the academic phase of the afternoon session suffers because of the fact that this is not a normal school condition. The fatigue factor is of vital significance here because after a morning of out-of-school activity, the pupils as a whole are not ready physically or mentally to settle down to a classroom situation which is conducive to the best teaching-learning process.

Also of significance is that in order to utilize the teachers of the specialty activities mentioned above, these must be scheduled during the first two periods of the afternoon session. This schedule places all of the academic subjects into the last four periods of the afternoon, when the motivation for these subjects is at its lowest.

In order to take care of the expanded high school program during the present school year, three rooms in the junior high school wing are being used for high school classes and one for a high school home room. Next September, with over 140 eighth graders moving up to the high school to replace 68 graduating seniors, it is obvious that more use of the junior high wing will be necessary for high school classes. With a comparable sizable increase in the enrollment in grades nine through twelve occurring every year, it will be necessary in the very near future to utilize the junior high wing for high school classes to the extent that the entire school will need to be on double session. This will be necessitated by the fact if both seventh and eighth grades are forced into afternoon sessions then these grades would over-flow the junior high wing into rooms which are now used by high school classes. Although this prospect is not a pleasant one, we could be faced with it as soon as September of 1968 if high school class enrollments require a number of class sections in excess of the number of rooms which will be available for high school classes in the junior high school wing. By September of 1969, when another significant increase in the high school enrollment will occur, placing the entire school on double-sessions will be the only way in which we shall be able to house six grades in the building.

All of the above problems are also significantly associated with Nipmuc Regional High School's accreditation with the New England Association of Colleges and Secondary Schools. After we were evaluated by that Association in 1963 and were granted full accreditation, it was necessary for us to make a two-year report of progress to that organization in 1965 to indicate what we had done relative to their specific recommendations for improvement of our high school. This report was accepted because we had made sufficient progress on the recommendations. A five-year report will be due next May and several recommendation still have not been and cannot be implemented unless more facilities, staff and funds become available. Some of these are listed below and unless they are fulfilled, our accreditation may be in jeopardy:

1. More space for music, art, home economics, library, and physical education storage facilities.
2. The provision of a language laboratory.
3. The expansion of outdoor facilities to provide more space for physical education and sports.
4. Double laboratory periods at all levels in Home Economics.
5. The establishment of a Health Education program.
6. The introduction of a specific program to meet the needs of the slow learner and to assist pupils with serious learning problems.
7. The provision of more individual and laboratory work in Biology.

I wish to extend my deepest gratitude to all persons who assisted in any manner in the operation of the school during the past year. In particular, I wish to pay tribute to Henry Clough, who retired in June. Those of us who had the privilege of being associated with him know the splendid contributions he made to our school program and the exemplary influence he exerted upon all of us.

**DAY PROGRAM**

**January - June, 1967**

**1. Enrollment**

At the beginning of 1967 128 boys were enrolled in the freshmen class at the Blackstone Valley Regional Vocational Technical High School. The number of students in each of the departments was as follows: 14 in Auto Body; 13 in Auto Mechanics; 14 in Mill and House Carpentry; 14 in Drafting; 18 in Electronics; 26 in Machine Shop; 14 in Metal Fabrication; and 13 in Plant Maintenance. When we started with 132 boys in September of 1966, we fully expected that approximately ten percent of the students would want to return to their home town schools by the beginning of the second semester. It was therefore very gratifying to have 97% of our original enrollment at the beginning of the second semester.

**2. Exploratory Program**

During the first semester all students had been given an opportunity to spend approximately two weeks in each of the eight departments so that they would have some knowledge of and experience in each of the programs offered by the school. At the end of the first semester all students were given an opportunity to select any course in the program and only 12 boys decided to change from their original choices, made before they entered the school. Their original choices were based on the results of their aptitude tests and conferences with our school guidance counselor. Because the changes in the choice of vocational program were so minimal we feel that our program of aptitude testing and guidance counseling is very effective.

**3. Pupil Selection for the Fall of 1967**

During the months of January and February all the schools in the member towns were visited by the Superintendent-Director in order to give information to the boys in the eighth grade about the courses that are offered at the Blackstone Valley Regional Vocational Technical High School. Applications were distributed and the students were requested to indicate their first, second, and third choices among the courses offered. Specially designed information forms were given to each school administrator, to be completed for each

boy who planned to make application for admission to the Blackstone Valley Regional Vocational Technical High School.

At a later date applicant groups from the various towns were brought to the school so that they could visit each of the eight departments and actually see the program in operation. During the day they were given a series of aptitude tests involving verbal reasoning, numerical ability, mechanical reasoning, abstract reasoning, and spatial relations. The scores on the above tests and the information sheet provided by the sending school were evaluated in order to produce a profile of each applicant's characteristics. Each applicant's profile was recorded on a compilation sheet which served to identify the most qualified students in each town. Every effort was made to admit the best qualified boys in each town, to give them their course preference, to distribute the courses as equally as possible among the towns, and to select each boy for the course in which he appeared to have the best chance of success. Due to lack of space we were able to admit only 120 boys out of the 321 that applied for admission.

#### **4. Dedication of the School**

Sunday, March 19, 1967 was the most memorable day of 1967 because on that day the Blackstone Valley Regional Vocational Technical High School was dedicated. This marked the fulfillment of the dream of many individuals who had worked tirelessly over a period of many years to create a school that would fill a great need for many of the boys of the region.

Dr. Owen B. Kiernan, Commissioner of Education of the Commonwealth of Massachusetts, gave the dedicatory address. Mr. Walter J. Markham, Director of the Massachusetts Bureau of Vocational Education, was also a guest speaker on this occasion. After the dedication ceremony all were cordially invited to inspect the new school. The interest and enthusiasm of the citizens of the region was evidenced by the thousands that came to the dedication and inspection.

### **September - December 1967**

#### **1. Enrollment**

In September we started our second year of operation with 126 sophomores and 120 freshmen. The number of boys from each of the towns was as follows: 22 from Bellingham; 13 from Blackstone; 10 from Douglas; 30 from Grafton; 13 from Hopedale; 5 from Mendon; 42 from Milford; 32 from Millbury; 4 from Millville; 29 from Northbridge; 12 from Sutton; 10 from Upton; and 24 from Uxbridge.

#### **2. Physical Education**

With our excellent gymnasium, we were able to institute a physical education program that more than met the new requirements

set up by the State Board of Education.

In the middle of October we started an intra-mural basketball program in which every boy who was physically able participated. This was followed by a basketball game between the faculty and the students on the day before Thanksgiving.

We have organized a junior varsity basketball team and have scheduled 18 games with other junior varsity teams in the area. Next year we plan on having both junior varsity teams and varsity basketball teams.

### **3. Student Government**

The students elected representatives from each of the eight departments to draw up a student government constitution with the advice and guidance of a faculty advisor. This constitution was ratified by the student body and approved by the School Committee. The governing body is known as the Student Senate and is composed of one representative from each of eight departments.

On December 1 the students elected Kenneth Mathieu to represent the Blackstone Valley Regional Vocational Technical High School on Good Government Day which is held every year in the State House and is sponsored by both branches of the State Legislature.

### **4. Cafeteria**

We are very proud of our cafeteria staff because of the outstanding service they render to our students and we were very happy to have our opinion confirmed when our cafeteria was rated as one of the best ten in Massachusetts by the Massachusetts School Lunch Program.

## **ADULT TRAINING PROGRAMS**

### **1. Automotive Machinist Program**

On July 10, 1967, after many months of planning, the automotive machinist training course for adults was started at the Blackstone Valley Regional Vocational Technical High School. This is the only program of its type in the United States and is the result of the co-operation between the Automotive Wholesalers Association of New England (A.W.A.N.E.), the Massachusetts Vocational Bureau, the Division of Employment Security, and the Blackstone Valley Vocational Regional School Committee.

All of the major equipment was contributed by the principal manufacturers serving the automotive after-market, and all of the money for instruction and supplies was furnished by the Federal Government. Thus the entire expense of this program is borne by A.W.A.N.E., the equipment manufacturers, and the U.S. Government.

Thirty young men were enrolled in this course, which will train them to operate any of the intricate machines used in automotive jobber machine shops. They attend school from 8:00 A.M. to 4:30 P.M. five days a week for 44 weeks. Upon completion of the course they will receive a certificate of graduation and are guaranteed a well-paying job by members of A.W.A.N.E.

## **2. Evening Trade Extension Courses**

The evening trade extension courses for adults started Monday evening, September 25, 1967. These classes are open to persons over 16 years of age who are not attending school and who can show evidence of trade contact with the specific training desired. The following courses were offered: Auto Body Repair, Auto Mechanics, Mill and House Carpentry, Electronics, Machine Shop, Metal Fabrication, Plant Maintenance, and Blue Print Reading. A total of 180 men and women were enrolled in the eight courses and many others applied but could not be accepted due to the lack of space in our shops.

## **3. Nursing Aide Program**

Early in September several of the Nursing Homes in the Region requested assistance from the Blackstone Valley Vocation Regional School District Committee in organizing and operating a training program for nursing aides employed in the region. After several meetings with representatives of the nursing homes and hospitals in the region the Regional School Committee agreed to operate a special program to upgrade nursing aides.

Through the cooperation of the Massachusetts Vocational Bureau, Federal Funds were obtained which will pay for the entire cost of the program.

Due to the tremendous interest in this program it was necessary to have two sections. Classes meet for two hours per night, two nights per week and will continue for twenty weeks. The courses are expected to end on April 9 and graduation ceremonies are scheduled for April 11, 1968.

## **Conclusion**

At the end of our first full year of operation, we feel that the Blackstone Regional Vocational Technical High School is operating efficiently and serving the people of the area effectively in several divergent capacities, as shown in the number of students who enrolled in the various school training program.

1. About 250 freshmen and sophomore boys in the daily program.
2. 30 young men in the Automotive Machinist course.
3. 180 men and women in the Evening Trade Extension program.
4. 43 women in the Nursing Aide classes.

Thus we have enabled about 500 people to further their education through our school.

The morale, standards, and cooperative spirit of the school staff continue to remain high, and we look forward with confidence to an even brighter and busier future for the Blackstone Valley Regional Vocational Technical High School.

**APPORTIONMENT OF COSTS INCURRED BY THE DISTRICT****(A) Classification of Costs**

For the purpose of apportioning assessments levied by the District against the member towns, costs shall be divided into two categories: capital costs and operating costs.

**(B) Capital Costs**

Capital costs shall include all expenses in the nature of capital outlay such as the cost of acquiring land, the cost of constructing, reconstructing and adding to buildings, and the cost of remodeling or making extraordinary repairs to a school building or buildings, including without limitation the cost of the original equipment and furnishings for such buildings or additions, plans, architects' and consultants' fees, grading and other costs incidental to placing school buildings and additions and related premises in operating condition. Capital costs shall also include payment of principal of and interest on bonds, notes or other obligations issued by the District to finance capital costs.

**(C) Apportionment of Capital Costs**

Capital costs shall be apportioned annually in December for the ensuing year as follows:

- (1) Each member town's share of the capital costs incurred in connection with the construction, equipping and placing in operation of the initial district school building, including the payment of principal of and interest on bonds, notes or other obligations of the District to finance such capital costs, shall be determined by computing the ratio which the sum of its public school male pupil enrollments in grades nine through twelve, inclusive, on October 1 of the three years preceding the year in which the Committee votes to authorize the incurring of such capital costs bears to the sum of the public school male pupil enrollments in grades nine through twelve, inclusive, of all the member towns on October 1 of the same three years; and in the case of capital costs consisting of the payment of principal of the interest on bonds, notes or other obligations issued by the District, the ratio shall not be changed during the period in which such bonds, notes or other obligations are outstanding, except as provided in subsection VII(A). For the purpose of this clause (1) of Section (A) above, public school male pupil enrollments shall be defined as the number of male pupils in grades nine through twelve, inclusive, residing in each member town and receiving education at such town's expense.

#### (E) Apportionment of Operating Costs

Operating costs for the first calendar year next following the establishment of the regional school district and for every calendar year thereafter shall be apportioned to the member towns on the basis of their respective pupil enrollments in the regional school. Each member town's share for each calendar year shall be determined by computing the ratio which that town's pupil enrollment in the regional district school on October 1 of the year next preceding the year for which the apportionment is determined bears to the total pupil enrollment from all the member towns in the regional district school on the same date.
