

WARRANT FOR SPECIAL TOWN MEETING
February 23, 1987

Worcester, ss.

To either of the Constables of the Town of Upton in the County of Worcester GREETING.

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Town Hall in said Upton on Monday the twenty-third day of February next, at 7:30 o'clock in the evening, then and there to act on the following articles:

ARTICLE 1: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or transfer the sum of three thousand, eight hundred nine dollars and thirty-four cents (\$3,809.34), or any other sum, to be expended for legal services rendered by Withington, Cross, Park & Groden during the months of November and December, 1986, or, to take any other action relative thereto.

ARTICLE 2: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or transfer the sum of four thousand, four hundred ten dollars (\$4,410.00), or any other sum, to be expended for the purchase of an Intoxilizer (Breathylyzer) for use of Upton Police Department as State Mandated effective July 1, 1987, or, to take any other action relative thereto.

ARTICLE 3: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or transfer the sum of thirty-five thousand, one hundred fifty-seven dollars and nine cents (\$35,157.09), or any other sum, said amount needed under terms of Collective Bargaining Agreement between Town of Upton and M.C.O.P., Local 162 signed on Monday, January 26, 1987 by Selectmen Durwood A. Tetreault, Richard Desjardins, and James R. Bates and Sergeant Samuel E. Aldrich, President of Local 162, or, to take any other action relative thereto.

ARTICLE 4: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or transfer the sum of one thousand, five hundred dollars (\$1,500.00), or any other sum, for the Police Cruiser Maintenance Account, or, to take any other action relative thereto.

ARTICLE 5: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or transfer the sum of fifteen thousand dollars (\$15,000.00), or any other sum, for the Water Maintenance Account, or, to take any other action relative thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at the Post Office and the Town Hall in said Town, fourteen days at least before the time of holding said meeting.

**PROCEEDINGS OF SPECIAL TOWN MEETING
February 23, 1987**

The meeting was called to order by Moderator George W. Burnham at 7:30 p.m. with a quorum present. The call and constable's return was read by the Moderator. It was announced that the non-voters seated in the hall were Eileen Vigilante of the Milford Daily News and Daniel Concaugh., Circuit Rider Administrator.

ARTICLE 1: Voted: Unanimously that the Town transfer from free cash the sum of \$3,809.34 to be expended for legal services rendered by Withington, Cross, Park & Groden during the months of November and December, 1986.

ARTICLE 2: Voted: Unanimously that the Town transfer from free cash the sum of \$4,410.00 to be expended for the purchase of an Intoxilizer for use of the Upton Police Department.

ARTICLE 3: Voted: Unanimously that the Town transfer from free cash the sum of \$35,157.09 to be used for salaries under the terms of the Collective Bargaining Agreement between the Town of Upton and M.C.O.P., Local #162, signed on January 26, 1987 by Selectmen and Sergeant Samuel E. Aldrich, President of Local 162.

ARTICLE 4: Voted: Unanimously that the Town transfer from free cash the sum of \$1,500.00 for the Police Cruiser Maintenance Account.

ARTICLE 5: Voted: Unanimously that the Town transfer from free cash the sum of \$15,000.00 for the Water Maintenance Account.

During the meeting 45 voters were checked into the hall by Barbara E. Burke and Nancy E. Kennedy. It was voted that the warrant be dissolved and that this meeting adjourn. The meeting adjourned at 8:41 p.m.

**WARRANT FOR ANNUAL TOWN MEETING
May 7, 1987**

Worcester, ss.

To either of the Constables of the Town of Upton in the County of Worcester, Greeting.

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs to meet at the Upton Town Hall in said Upton on Monday the fourth day of May next, at seven o'clock in the forenoon, then and there to act on the following articles:

ARTICLE 1: To choose necessary officers for the ensuing year, all to be voted for upon one ballot. The polls will be closed at 8:00 p.m. on the day of said meeting. The remaining articles in the warrant will be acted on at an adjourned meeting in the Town Hall, Saturday, May 9, 1987, punctually at 2:00 p.m.

ARTICLE 2: To hear reports of all Town Officers and Appointed Committees, or, to take any other action relative thereto.

ARTICLE 3: To see if the Town will fix the salaries and compensation of all officers of the Town as provided by Chapter 41, Section 108, G.L. as amended, and appropriate such sums as may be necessary to defray expenses of Town Departments for the ensuing year, or, to take any other action relative thereto.

ARTICLE 4: To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow in anticipation of revenue for the fiscal year beginning July 1, 1987 in accordance with the provisions of G.L., Chapter 4, and to issue a note or notes therefor payable within one year in accordance with G.L., Chapter 44, Section 17, or, to take any other action relative thereto.

ARTICLE 5: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$46,861.00, or any other sum, in accordance with the provisions of Chapter 32, Section 22, G.L., for Pension Fund, Expense Fund, Military Service, or, to take any other action relative thereto.

ARTICLE 6: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$300.00, or any other sum, equal to that received from the sale of lots and graves during the fiscal year beginning July 1, 1987, in accordance with G.L., Chap. 114, Section 15, to be used for cemetery oiling and grading, or, to take any other action relative thereto.

ARTICLE 7: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury, or borrow, the sum of \$9,300.00, or any other sum, to be used in connection with and in addition to any funds allotted by the Commonwealth and/or County for the construction, reconstruction, and improvement of the town roads, or, to take any other action relative thereto.

ARTICLE 8: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury, or borrow, the sum of \$25,977.00, or any other sum, to be used for the construction and/or improvement of town roads to be reimbursed from the Commonwealth under Chapter 206, or, to take any other action relative thereto.

ARTICLE 9: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$10,000.00, or any other sum, to be used to complete the installation of the new culvert pipe at the site of the culvert on Pond Street (Upton's Share) at town line between Upton and Milford, or, to take any other action relative thereto.

ARTICLE 10: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury, or transfer the sum of \$20,000.00, or any other sum, for the Public Works Study Committee's Capital Acquisition Fund, or, to take any other action relative thereto.

ARTICLE 11: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,000.00, or any other sum, for the Conservation Fund set up under Article 24 of the 1966 Annual Town Meeting, or, to take any other action relative thereto.

ARTICLE 12: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$20,000.00, or any other sum, requested by the Computer Study Committee for the purchase of computer hardware and software for specific Town departments, or, to take any other action relative thereto.

ARTICLE 13: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$700.00, or any other sum, to be used to purchase commercially manufactured rafts for the Town Beach Park, or, to take any other action relative thereto.

ARTICLE 14: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,600.00, or any other sum, to reconstruct retaining walls on the first base side of the softball field at the Town Beach Park, or, to take any other action relative thereto.

ARTICLE 15: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$6,000.00, or any other sum, to be used to reconstruct the playing fields at the Memorial School, or, to take any other action relative thereto.

ARTICLE 16: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$50,000.00 or any other sum, to be used for the cleaning and repainting of the Pearl Street water storage tank, or, to take any other action relative thereto.

ARTICLE 17: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$18,000.00, or any other sum, to be used to purchase a truck for the Water and Sewer Department, or, to take any other action relative thereto.

ARTICLE 18: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$5,000.00, or any other sum, to purchase a tape recording system for use by the Fire and Police Departments, or, to take any other action relative thereto.

REPORT OF THE BOARD OF SELECTMEN

As our population continues to grow, Upton faces the challenge of providing expanded services to its citizenry while maintaining its attractive small town ambience. Due to increased efforts by volunteers on town boards and committees, governing requirements have been met. However, several posts are presently vacant, and we encourage community members to seek positions on these elected or appointed boards.

In response to our increased population and to meet general safety needs, a new patrolman post was added to the Upton Police Department — Alan J. Cyr was hired to fill this position. Three others were selected to maintain vacated posts — Philip D. Powers, Ralph E. Chambers, and Jeffrey P. LeBlanc. Lisa Vass and Andrea Sue Blackler were appointed to full-time dispatching positions.

A second contract was signed with the Upton Dispatchers and Police Union after several months of productive and mutually beneficial discussions.

Several of our meetings involved determination of requests by contractors for gravel removal permits. Careful consideration is given to these requests as effort is made to allow growth, but with consideration to quality development and protection of the environment.

The Upton Heritage Homecoming Week Committee guided by Chairman Edward Furphy and Co-Chairman Hugh Dugas planned and implemented weeklong celebrations in honor of Heritage Homecoming '87. Festivities included a ham and bean supper, a parade, and a concert on the Common, as well as a variety of activities in Upton and throughout the Blackstone Valley. We offer our special thanks to Ed and Hugh and to all those who volunteered and allowed us the opportunity to be reminded of the richness of our history as well as the potential for greatness in the future.

Several residents with a long record of service to the town resigned or retired from town departments and boards. We offer our thanks to all those who throughout the year have provided the time and expertise necessary to administer to the governing and maintenance needs of the Town.

A continuing and special thank you goes to our clerk Joan Varney for her constant support and invaluable aid.

CEMETERY COMMISSIONS OF UPTON

CONSERVATION COMMISSION

1987 was a year of challenge and opportunity for your commission — challenge to meet the ever-increasing demands made by accelerated residential development, and opportunity to better serve the interests of conservation of our communities natural resources, of which our wetlands are a vital part. The commission convened over 34 formal hearings and numerous subsequent meetings to deliberate our course of action in response to in excess of 42 notices of intent and requests for determination of applicability. (Notices of intent and request for determination are applications to the Conservation Commission which identifies work proposed in or near a wetland area. The commission responds to each with a written approval which includes conditions which must be met before and during construction, or a denial.)

A conservation "sign-off" is now required on all building permits and before an occupancy permit is issued. This has necessitated an onsite visit for each permit to ascertain if construction might impact a wetland or effect the protection of any of the other interests as set forth in the Massachusetts Wetlands Protection Act.

During 1987 commissioners attended numerous state sponsored symposiums and seminars in order to broaden their knowledge of conservation issues, regulations and changes.

The commission continues to improve communication with other town boards to facilitate better coordination and improved efficiency within our individual charges. This has been a particular mandate as a result of the more than nine major sub-division proposals brought before the commission where total new housing starts by major sub-division development in 1988 could be in excess of 190 homes.

New members added to the commission were Scott Heim and William Johnston. The commission elected Geoffrey Neale to succeed Harriet Fougere as commission chairman. The commission would like to acknowledge Harriet for her hard work and the many hours she devoted as chairperson. The commission also wishes to thank Francis Walleston for his tireless energy and many years devoted to the interest of conservation.

COUNCIL ON AGING

1987 was a year of changes for the Council. We began the year with a new Director, Linda K. Davis. We also have a new outreach worker, Sharon O'Quinn, and Elder Service Corps Volunteer, Irma Nelson. We also changed the interior of our building by adding sliding partitions to our main room. The new partitions were funded by the Executive Office of Elder Affairs, Region II Area Agency, and Friends of Upton Elders.

Our existing recreational and social service programs continue to be well attended and several have grown. Our nutrition site now serves forty to fifty people per day at the center, and 35-40 home delivered meals per day. The Mendon/Upton Senior van has seen an increase in riders and an increase in the number of trips made with the van. In the near future we hope to expand to two more days a month.

The Council on Aging Senior Center continues to be a community center by offering services that are available to the whole town. This year surplus food distribution served an average of 150 families with each distribution. Again this year the Council on Aging was a site for taking Fuel Assistance applications. This year there were 44 applications completed. In conjunction with the Board of Health, monthly blood pressure clinics are held with attendance of 20-30 people per month. At this year's flu shot clinic 100 vaccinations were given. As always the Senior Center Staff is available Monday through Friday 8:30 a.m. to 4:30 p.m. to provide information and referral services to any resident.

The Council on Aging and Senior Center Staff would like to thank the Friends of Upton Elders for their financial support and all our volunteers for their many hours of service.

The past year has been a very busy one for the Department's twenty-one EMTs. It was a year that saw several major new additions, and yet, served to bring into focus issues relative to the long term wellbeing of the Department.

The Department's new ambulance arrived the end of March and was placed in service the first part of April. The new ambulance replaces a nine-year old one, and features the latest in emergency prehospital equipment. The EMTs wish to thank all those individuals who over the years have contributed to the Ambulance Fund, thereby making the new ambulance possible.

In December the Board of Selectmen signed an agreement with the Milford-Whitinsville Regional Hospital for use of the hospital's new paramedic service. The Department is excited about having immediate access to on-scene Advanced Life Support (ALS) care. These paramedics effectively bring the emergency room to the patient, thereby saving valuable minutes in critical situations. To date, we have used this service several times and have been very impressed with the degree of professionalism and skill demonstrated by this service. The Department believes this service is very important and provides the townspeople a capability only seen in major metropolitan areas.

An important subject the Department wishes to highlight is the issue of daytime coverage. The Department in cooperation with the Fire Department is requesting that the Town fund a full-time EMT/Fire Inspector. While not completely resolving the problem with daytime EMT coverage, this individual would be a major step in ensuring that the Department continue to provide the high quality service that the Town has come to expect.

Finally, the Department wishes to thank all those individuals, especially our families, who make our job possible. If it were not for these people, we could not possibly provide the level of care and service that we do.

In April the Board sponsored a Rabies Clinic at the Fire Station, conducted by Dr. Richard Heller. Martha Williams, Town Clerk, was also available to license dogs at this time.

Food Inspection reports completed by Robert Rimbach, R.S. Food Inspector, have found that the Food Establishments in Upton are clean and meet the requirements for the State Sanitary Code.

During the year, the Board has been working together with various other towns to organize a Hazardous Waste Day, during which town residents will be able to dispose of hazardous wastes. The day will likely be held in the Spring of 1988.

The Board also acted on and resolved numerous complaints, including but not limited to, an investigation at Ferreira Garage. The Board along with other departments, inspected the property, due to numerous violations.

The town beaches were also tested periodically during the swimming seasons by the Water Control Labs of Hopkinton. The results found for all the beaches were safe and normal, within state limits for bathing water.

During 1987 the Board signed a twenty-year contract with Signal Resco/Wheelabrator of Millbury. The town of Upton will use this facility as a waste disposal site, the refuse being brought from Upton's Transfer Station. Along with the convenience of being a closer facility, it will be effective in keeping the cost down for Dump Maintenance.

HEALTH SERVICE COMMITTEE

The Town Nurse and the Health Service Committee respectfully submit this 1987 annual report to the Town.

By now, most residents of the Town are familiar with the health care crisis affecting this area. In order to provide adequate health care at a reasonable cost, the state and federal government have been working on legislative cures for the problem. Medicare and other third party payment sources such as Blue Cross/Blue Shield have responded by decreasing the number of home health visits covered by insurance, and by decreasing the type of services covered for home care. The Visiting Nurse Association of the Greater Milford-Northbridge Area Inc. provides all home health care services which are covered by insurance. The Upton Health Service covers Nursing care for home health care not covered by insurance, or care which is long term, so that the number of insured visits is surpassed. The V.N.A. and the Upton Health Service work together closely to insure continuity of care for all residents, regardless of payment source; however, the Upton Health Service provides only nursing care, and has no ancillary services such as home health aides available through the service. Residents in need of such services not covered by insurance must pay privately or seek the service of Tri-Valley Elder Services if age 60 or over, and the Dept. of Social Services if under the age of 60.

Fortunately for the townspeople of Upton, there is a strong network of Social Services in place. The Town Nurse, V.N.A. nurses, the Senior Center Director, Outreach workers, and representatives of various agencies meet on a regular basis

to provide and plan sufficient care for the townspeople while avoiding duplication of effort and to avoid having clients slip through beaurocratic cracks in the system.

In addition to home nursing care, the U.H.S. provides health screening clinics, immunization clinics, health education, patient advocacy, and has durable medical equipment such as crutches and walkers available for townspeople to borrow.

The Upton Health Service wishes to express appreciation to the health and social service agencies responsible for maintaining a smooth running health network for the town of Upton. Special thanks to our Emergency Medical System, the Upton Council on Aging, the V.N.A. of the Greater Milford-Northbridge Area, Inc. and Tri-Valley Elder Services.

HERITAGE HOMECOMING COMMITTEE

The Town of Upton again participated with the ten other towns in the Blackstone Valley in celebrating Heritage Homecoming Week. Also, on September 17, fourteen students from Miscoe Hill Middle School and Nipmuc High School participated in a mini-parade that started at Knowlton Manor, went to the Senior Center, Coach Road Apartments, Memorial School, and the Town Common. At each location, they recited the Pledge of Allegiance to the Flag along with those attending, and read the ten articles from the Bill of Rights. The flag

bearer was Tim Murphy, the drummer, Jon Frey, flutist, Nancy Smith, and the soldier, Patrick Moran. Those who each read one article from the Bill of Rights were: Lisa Cahan, David Smith, Jennifer Nealley, Kevin Korengel, Jennifer Lymneos, Dennis Barlow, Shawn Rezvi, Ryan Thieme, and Claire Freer. At 4 P.M., 200 red, white, and blue balloons were released under the sponsorship of the V.F.W. with Doug Kenniston in charge. Our local churches tolled their bells for 200 seconds to commemorate the exact time of the announced signing.

The Heritage Homecoming Week celebrations officially opened with a parade that started on Saturday, September 26 at 10:00 a.m. on Maple Avenue and proceeded down Main Street to the V.F.W. grounds where the official opening ceremonies were held. Those who spoke were Rep. Richard Moore, General Chairman of the Blackstone Valley Heritage Committee, Upton Selectman, Richard Desjardin, and Edward J. Furphy, Chairman of the Upton Heritage Homecoming Committee. The parade included Selectmen, Fire and Police Departments from the various towns, The United Parish, Holy Angels' Parish, V.F.W., Woman's Club, Upton Grange, Mothers' Club, Bloomer Girls, Upton Seniors, S.A.D.D., Cub Scouts and Boy Scouts, State Police, Registry of Motor Vehicles, Mass. National Guard units. Girl Scouts were prominently placed near the front of the parade in honor of their 75th Anniversary. Bands included the Miscoe Hill Middle School, Nipmuc High School, Buxton Fife and Drum Corps, and the Pulaski Brass Band from Webster. At 1:00 p.m. there was an exciting parachute jump with a display of skills, put on by the Mass. Sport Parachute Club from Orange, MA. Six jumpers made spectacular landings at the track area of Blackstone Valley R.V.T. High School.

At 2:00 p.m. there were two bus loads of people who took a very interesting tour of historical spots around Upton, guided by Kenneth Wood, Barbara Burke, and Carl Anderson from the Historical Commission.

From 10:00 a.m. to 5:00 p.m., the Touchstone Community School sponsored a Children's Festival coordinated by Diane Cunha. A special guest was "Ben Franklin", who answered questions about his inventions and his part in historic events. "Johnny Appleseed" also appeared. The festival also featured puppets, story telling, demonstrations of crafts, games and contests, and a host of activities to interest young children.

That same evening at 6:00 p.m. a buffet supper was served at Blackstone Valley High School and the very first honorees were named to the Upton Heritage Hall of Honor. Deceased citizens who were inducted were: George S. Ball, William Knowlton, John L. Moroney, George Grebenstein, and S. Otis Inman. George G. Newton, a journalist for over seventy years, was elected the first Living Outstanding Citizen. Mr. and Mrs. Russell Graves accepted the award. The names of the winners are inscribed on a suitable plaque which is now on display in the Town Hall. Next year, three additional deceased citizens and another living outstanding citizen will be added.

Local schools joined in the celebration with a Heritage Dance at Nipmuc High School on Friday, October 2, and another at Miscoe Hill Middle School on Saturday, October 3.

Upton's Seniors participated in a Walkathon sponsored by Tri-Valley Elder Services and Valley Councils on Aging with Bernice Szarek coordinating. The route began at Northbridge Senior Center on Highland Street in Whitinsville and proceeded along Church Street to Plummer's Landing Historical Site, at the Blackstone River and Canal Heritage State Park.

The Upton Mothers' Club and the Parks and Recreation Committee sponsored a Field Day for Children from 1:00 to 5:00 p.m. at Kiwanis Beach on Saturday, October 3rd. It was a fun-filled day for kids with fun, games, activities, pony rides, and refreshments.

The United Parish sponsored a Ham and Bean Supper in their parish hall at 6:00 p.m.

Due to some unusually strong, cold weather, and rain on Sunday, October 4th, some events were cancelled including the two-and five-mile hikes planned to go through the Upton State Forest and the Peppercorn Hill area. But the Pancake Breakfast was held at the Upton Grange with George Burnham in charge of arrangements.

Some of the crafts exhibits and the concerts moved indoors at Blackstone Valley Tech High School and were a popular success. The U.S. Army Band from Fort Devens started the musical extravaganza at 1:00 p.m. followed by the "Jolly Kopperschmidts" German Band and the Wayside Chapter of Sweet Adelines from Sudbury. In between these special acts, local talent entertained those present. Jeff Bouthiette, Terry Dodd and Paula McMorrow, Rose Paulson, Bill, Charlotte, and Laura Ethier, and Dennis Cabral were in the Talent Jamboree.

The 1988 Heritage Homecoming will be held between September 28 and October 2.

We sincerely hope that the size of the committee will grow as more of Upton's citizens join us in making plans for another memorable week of celebration of our heritage.

UPTON HISTORICAL COMMISSION

The Upton Historical Commission respectfully submits its report for the past year.

We are grateful to two Nipmuc Regional High School students, Randy Roche and Caroline Wood, for helping with the identification and photography of houses in Upton which have historic significance. This project, under the direction of the High School History Department, has aided in the documentation which is necessary for the Mass. Historical Commission.

This past year we have also been able to have a complete inventory of all the Upton cemeteries, and the information has been put on computer disks, as well as printed in booklet form. These booklets will be available for study through the Town Clerk, The Historical Society, and the John B. Fay Room of the Town Library. This remarkable project was accomplished through many years of researching cemetery records and various town and church records by Mrs. Carolyn Johnson Blomquist. We are all indebted to Carol for enabling us to have such valuable material available to anyone needing this information.

In our on-going projects with the Cemetery Commission, several improvements have been accomplished. During the celebration of the Blackstone Valley Home-

coming in September, the Commission worked with our members to give the First Burying Ground on Grove Street a much needed face-lift. Brush was removed, and mowing with specialized equipment made this area attractive, yet maintained the character of the era it represents. We intend to continue this cooperation as there is still much to do in other areas.

Lakeview Cemetery also received some extra help from Board members Carl Anderson, Hugh Dugas and Kenneth Wood, and the Cemetery Board members Richard Randall, Bill Sadler, Ray Smith and others. By donating their time and energies, the iron fence was straightened and given a fresh coat of paint. Cutting of brush and in some cases large trees helped to give the fence a new appearance. At the end of the year, all of these men were able to straighten the Chapin-Wood monument which had for years taken on an angle that we were afraid would end in its lying flat on the ground. Carl, Hugh, Kenneth, Bill, Dick and Ray should be thanked for their interest and willingness to make this cemetery a credit to our town. As a young child once wrote in a contest, "It shows everyone that in Upton, those who have died are still loved and cared for by the Town".

We are continuing the inventory of buildings and other historic sites in town, and are pleased to work closely with the Historical Society in their efforts to preserve all of the historical memorabilia which the Society members have cataloged and safeguarded over these past years.

HOUSING AUTHORITY

The Upton Housing Authority consists of forty units of elderly housing at Coachroad Apartments, 4 Hartford Avenue, West Upton and nine units of family and elderly housing at the Upton Inn, Main Street, West Upton. The source of funding for both of these developments is the State Office of Communities & Development, 100 Cambridge Street, Boston, Mass.

LOCAL SUPERINTENDENT OF INSECT AND PEST CONTROL

During 1987, fifteen (15) elms with Dutch Elm disease and ten (10) diseased maple trees and twenty (20) oak trees infected by the Gypsy Moth over the past years were removed in the town of Upton.

Poison ivy was sprayed on all town land used by the general public.

The 1987 Gypsy Moth infestation was the lightest we have had since 1980 because more home owners are having their yards sprayed or scraping the egg masses from their trees. It is a simple and thankful task to kill a few million future moths by scraping them into a can and burying or burning them.

I am happy to report that our department did not have to spray the common and other town properties that we did last year. Homeowners who wish to have their yards sprayed this year should contact the spray people early because some of last year's tree contractors have given up spraying because of the high cost of liability insurance.

I wish to thank public officials, state and district supervisors and the townspeople for their cooperation and help received in 1987.

PARKS AND RECREATION COMMISSION

This past year has brought us many successes in the Parks Department; this, sadly, after not having Nancy LeClair with us. Nancy was an able and dedicated public servant. We emphasize dedicated.

We began the year with the hiring of a new full-time employee who will work year round in both the Parks and Highway Departments. With a new salary base, a new job description, and the fine cooperation of the Highway Commissioner, we hired a very energetic young person. This individual has performed admirably, and we have accomplished much through his efforts. The Highway Commissioner is obviously pleased to have a spare hand on board, also during the winter season.

We entered into new cooperative agreements with other departments. Our first venture saw us working with the Selectmen to have the Water Department purchase a new truck while we got the current Water Department truck. We also have begun working with the Cemetery Commissioners to obtain new leaf pickup equipment. A new tank resistant gate was placed at the entrance of the Town Beach Park. This was obtained from the Cemetery Commissioners. We all welcome this added security feature.

Our ball fields have received added use. We had the Memorial School Field redone to provide extra space for teams that could not be accommodated at the Town Beach Park. It is anticipated that more requests will come in the future.

This report would not be complete without thanking the men who play Sunday Softball at the park. We had a hazardous wall condition at the park and they

volunteered all the manpower and materials required to permanently solve the problem. We now have a new cement retaining wall in place. This public spirited act has saved the town several thousand dollars.

Twelve new picnic tables were added to the Town's inventory thanks to the efforts of the Blackstone Valley Men's Softball League and the Multi-Sport Organization. Each added six tables which many people are now enjoying for picnicking.

We extended our outreach program to the Council on Aging, inviting the elders to make more use of the park. Their new bus made it possible for them to come. We can only hope that we will continue to see the folks enjoying the park. A suntan looks good at any age!

You will also notice that the park is much freer of debris. We had an extensive burn/cleanup during the winter months. The park's woodlands will be more accessible this coming summer. More work is planned to provide a good parks system to the residents. We invite all residents to utilize the park areas.

REPORT OF TREE WARDEN

This past year, the Upton Tree Department finished clearing up stumps and logs and cut down butts from hurricane Gloria. Also, twenty (20) maple trees were planted by Sudbury Nurseries, Inc. Five thousand seven hundred dollars (\$5,700) was received from the federal and state governments for this work.

During the year, forty-seven (47) trees were topped along our public ways by the use of a bucket truck. Twenty-eight (28) dead trees or trees too close to the road were removed. Twenty (20) trees were removed for the improvement of street drainage or installation of new cross drain pipes. The program of removing low

and dead branches was done with the help of a bucket truck. There were forty (40) new trees planted in 1987.

The Tree Department had twenty-eight (28) emergency calls during 1987.

PUBLIC WORKS STUDY COMMITTEE

REPORT OF WATER AND SEWER COMMISSION

The year 1987 saw 26 new connections made to the Upton water supply system, 18 of which are to serve the new development on Church Street.

We continued our program of meter replacement and repair. A total of 42 meters were replaced, complete with outside readers.

The system was again plagued with many major breaks which necessitated a supplement to our water maintenance budget. The additional funds approved at a special Town Meeting made it possible for us to meet our fiscal 1987 financial obligations.

The cleaning and flushing of the Glen Avenue well fields was undertaken. This will be completed in the spring of 1988.

The annual Town Meeting approved a 50% appropriation toward the cleaning and painting of the Pearl Street Water Tank. The remaining 50% will be up for approval at the 1988 annual Town Meeting.

A special Town Meeting appropriated funds for the purchase of a new truck for the Water Department. Delivery is scheduled for sometime in early 1988. The truck will be equipped with a plow to aid the Highway Department in snow removal.

There were 29 new connections to the sewer collection and treatment system during 1987. Of these, 11 were house connections within the existing sewer district and 18 in a short extension to service the Church Street development.

A new tractor was purchased for maintenance of the Sewer Treatment Plant and grounds. The purchase was approved at a special Town Meeting.

During 1987 a limited moratorium was placed on new connections to the sewer collection system where only houses within the existing sewer district would be allowed to connect. No extensions of the sewer district would be allowed.

Late in 1987, the Department of Environmental Quality Engineering mandated a complete moratorium on new sewer connections along with other mandates. A specification was prepared and bids received to respond to the D.E.Q.E.'s concerns. The major task for the Commission in 1988 will be to adequately answer all these concerns and make the necessary repairs to the Treatment Plant to be able to lift the moratorium as soon as possible.

The Commission would like to thank the various town officers, boards, committees and departments along with the residents of the Town of Upton for the cooperation and assistance given to us during the year and in particular Leo Morin, our superintendent, Sue Bonina, our clerk, and Ashley Perkins, our meter reader, for their dedication and willingness in serving the Town of Upton.

MENDON—UPTON REGIONAL SCHOOL DISTRICT

To the Citizens of Mendon and Upton:

The Mendon-Upton School District's goal of improving the quality of education for students and achieving academic excellence moved considerably forward during the 1987 school year. Programs initiated in the areas of curriculum development, improving the quality of student life, school effectiveness, and staff development were completed.

The effects of the school development program have left a positive mark on the student body and faculty at Nipmuc Regional High School. Last summer, a second retreat focused on the Faculty and Students Working Together Program (FAST). The program's goal was to develop a democratic school with greater student and faculty input into the decision making process. The retreat was opened to all faculty and students who wished to participate. At the one-day retreat, participants focused on the development of leadership skills, group processing, and the mutual goal of working together in order to develop strategies for identified school issues.

The high school curriculum has been supplemented by the addition of a number of new courses as recommended by the faculty and approved by the school committee. Students were able to select honor courses in math, science, history, computers, foreign language, and English. Other courses were upgraded in the general and college programs. With the implementation of computer scheduling, additional staff in English and Science, student instructional opportunities and smaller class sizes have created optimum learning opportunities.

The Nipmuc profile for the graduating class of 1987 supported the school district and community effort in improving the quality of education. A greater number of students entered four-year and two-year college programs. Students were able to be competitive with much larger school districts thus entering some of the most outstanding colleges in the country. Students who completed some of the schools specialty and career programs entered the job market with well-trained skills and the opportunity, at a later date, to continue their education.

The goals of continued growth and improvement in all facets of the high school program are ongoing. Future work has begun in planning for other FAST activities and the development of additional educational options for all students at Nipmuc. The community's support and stronger parent involvement in the educational process have been a factor in the success that has taken place at Nipmuc Regional High School.

Educational challenges have been underway at Miscoe Hill Middle School and the Clough and Memorial Elementary Schools. The development of strong curriculum teams and a new organizational structure with K-8 curriculum coordinators continues to examine current district instructional practices. Test scores taken from the California Test of Basic Skills and the State Skills Test provided base-line data indicating that district middle and elementary students have a strong mastery of learning concepts in all subject areas. The district's effort to monitor these scores in a critical manner enabled staff and administration to support educational curriculum recommendations.

The district's effort to provide staff with inservice activities to enhance teacher effectiveness played a major role in the district's instructional success. Staff's dedication to improve their instructional effectiveness and to participate in the development of critical thinking skills to enhance student learning was a major goal at the elementary levels.

The Miscoe staff has been involved in a Middle School Exchange Program. Staff and administration are viewing a number of programs (instructional and organizational strategies). Through the utilization of inservice funds, staff visitations to other middle school programs continue to be scheduled.

The district's desire to improve all phases of the school programs resulted in a number of administrative activities during the last year. A kindergarten and a building task force were formed. The kindergarten task force has been exploring a number of school day options that might provide different instructional and developmental options for our preschool and kindergarten population. A report of the committee's findings and recommendations will be presented to the school committee in early spring. A building committee task force was formed to examine the current school facilities and future district student growth. During the last year, the committee visited each facility and generated a preliminary report. Future endeavors of the committee will be the exploration of building and renovation strategies for each school. An architectural and engineering report was completed on the two elementary schools and is currently under review. The task force will make a preliminary report to the school committee when all available information is reviewed.

Horace Mann Scholars have been selected to enhance the instructional programs in computers, critical thinking skills, and teacher evaluation process. The Scholars program has provided staff the opportunity to study areas of district and personnel interest that are beneficial to district growth and instructional improvement.

The 1987 school year has truly been marked by educational success and growth. Transition programs, begun earlier, marked by hard work and dedication by staff, students, parents and the school committee have enabled the district to reach new heights. The district's approach to be open and involve all interested parties has created a strong bond for the ideas and philosophies that have emerged. School climate is epitomized by positive school morale and a caring, sensitive attitude toward assisting and providing the greatest educational opportunities for our students. The desire to have staff achieve these ends is reflected in the community's financial assistance and the school committee's vision to expect the very best for the Mendon-Upton Regional School District.

The school committee and faculty have appreciated the communities continued financial and moral support to achieve these goals and both school committee and staff look forward to meeting new challenges. This highly renewed educational spirit has enabled the district to be recognized as one of the most outstanding school districts in the area.



Regular School Committee meetings are held at the Blackstone Valley Regional Vocational Technical High School, Pleasant Street, Upton, MA on the third Thursday of each month in the School Committee Conference Room at 7:30 p.m.

DAY SCHOOL

The vocational-technical high school opened its 1986-87 school year on August 19, 1986 and concluded academic instruction/vocational training on June 8, 1987. Over nine hundred (900) high school students completed one hundred and eighty (180) days of educational activity designed to prepare them for gainful employment and/or further education upon graduation. Since its opening in 1966, this unique vocational regional high school has served approximately four thousand eight hundred and fifty (4,850) young men and women in their pursuit of an education which provides knowledge, skills and attitudes leading to fulfillment of personal aspirations and economic independence.

Each student participated in 990 hours of formal instruction/training during the school year. Students alternated in two week cycles between complementary components of **academic study** - English, math, science, social studies, physical education and business subjects - and **vocational instruction** in one of fifteen vocational programs - Auto Body, Auto Technology, Computer Information Processing, Culinary Arts/Baking, Drafting, Electrical, Electronics, Graphic Arts, Health Services, Heating/Ventilation & Air Conditioning, Machine Shop, Metal Fabrication, Carpentry, Painting & Decorating, and Plumbing. A school day consisted of 5½ hours per day with sessions starting at 7:55 a.m. and ending at 2:00 p.m.

In addition to regular education services, special education services were provided for one hundred and sixty-five (165) students. Each of the students received assistance in overcoming learning impedence as prescribed by an individual education plan. The majority of special education students were "mainstreamed" in complementary academic study and vocational-technical programs.

A unique training program, Cooperative Education, provided one hundred and twenty-eight (128) seniors with on-the-job experience during the school year. Students involved in the "outside" employment received credit for real work as employees-in-training with eighty-five (85) different employers who cooperated with the school by making positions available in their companies. The jobs allowed students to refine their occupational skills and to experience genuine work for which they were paid an entry level wage. The partnership between industry and the school has been a classic example of meaningful education by which the "learner" is introduced to meaningful work as a natural component of the educational experience. The community at-large benefits also, in that graduates become familiar with opportunities within the vocational regional school district thereby insuring a continuous infusion of educationally competent people for the expanding Blackstone Valley Region's economy.

GENERAL COMMENTS

Modernization and revision of the school's Program of Studies was fully implemented in 1986-87. As a result of the "three-year effort," academic subjects and vocational programs have been aligned in a coherent plan whereby every student is challenged academically and simultaneously is assured of receiving in-depth instruction/training in his/her chosen vocational-technical program. Each of the fifteen vocational-technical programs has a complementary core of academic subjects (English, math, social studies and science), sequentially arranged to enhance and reinforce learning in terms of individual abilities and occupational standards. Every student can be scheduled with a program of study which is individualized and which also assures personal accomplishment commensurate with the student's abilities or interests, provided the student applies himself or herself completely to the task at hand. Full use of electronic scheduling allows the complex scheduling of the entire student body.

Extra-Curricular

Interscholastic athletics were conducted primarily through the Dual Valley Conference. The "Valley Tech Beavers" competed in: Cross Country, Soccer, Basketball, Baseball, Softball, Track and Field, and Cheerleading. Female and male athletes played against teams from Blackstone-Millville Regional, Douglas, Hopedale, Mendon-Upton Regional, Sutton, Bromfield, Tahanto Regional, Keefe Vocational Regional, Assabet Vocational Regional and Tri-County Vocational Regional. The Cross-Country and Track/Field teams had outstandingly successful years. Both the boys basketball and baseball teams qualified for the first time to play in District tournaments at the conclusion of their seasons. Approximately 200 young men and women participated in the school's sports program.

Other extra-curricular activities in which students participated throughout the school year included: elected class officers for sophomore, junior and senior classes; sponsorship of two very successful blood drives at which over 200 pints of blood were collected; several school dances were organized and successfully carried out; Thanksgiving and Christmas collections drives were conducted. Funds raised from students provided food baskets and gifts which were distributed to needy families in the region. The Graphic Arts program developed and printed the senior yearbook for the 18th time. Also published was the students' literary magazine, BEAVER TALES. Approximately fifty (50) students competed in the Vocational-Industrial Clubs of America. A highlight of the school year was the Junior/Senior Prom which was held at the Framingham Sheraton-Tara on April 21, 1987.

Extended Facilities Usage

The school's training facilities were fully utilized throughout the year. Citizens of the region regularly used services of the Auto Body and Auto Technology programs. Likewise, the Three Seasons Restaurant also was very busy providing public luncheon services throughout the year. Each of the programs provided practical experience for students and served the regional community beneficially.

Evening adult training programs were conducted in the fall and spring semesters. Self-supporting training programs consisting of 48 hours of specific vocational-technical instruction were offered in the areas of Auto Body, cabinet-making, machine shop, welding, computers, graphic arts, electrical, electronics, computer-assisted

drafting and computerized-numerical-control. Over 200 men and women paid tuitions in order to receive instruction/training based on occupational standards.

During the months of July and August the school district cooperated with the Career Development Center in Hopedale to provide exploration/training for 55 boys and girls (ages 14-16) with experiences in graphic arts, food services, carpentry, auto body and welding. Funds for the program were provided by the Federal government.

Extensive planning begun in 1985-86 concluded this year with an agreement to initiate a unique two-year post secondary program. The goal of the program will be to enroll students who want to acquire an Associate Degree in Applied Science (Automotive Technologist) from Quinsigamond Community College and who will receive technical training at the vocational-technical school reinforced with practical experience at cooperating Ford-Mercury dealerships. Called ASSET, the specialized program will be supported from tuition paid by the students. Initial start-up costs will be provided through state/federal grants. This will be a self-sustaining effort at no cost to the district. The district will provide the training site for which a rental fee will be received. The Ford Motor Co. will furnish vehicles and other training equipment. We look forward to this exciting, worthwhile and needed venture.

Celebration and Recognition of American Vocational Education

During the week of February 9, 1987 a major effort was made to celebrate and recognize the role and accomplishments of American Vocational Education throughout the United States. The Division of Occupational Education and the network of public vocational schools joined forces in a statewide coordinated effort to rekindle public awareness of the importance and influence of vocational technical education.

The vocational-technical school was opened for public viewing throughout four school days. A magnificent vocational-educational fair in the converted gymnasium was held on the evening of February 11 where all educational programs (academic, vocational-technical and extra-curricular) were displayed in thirty-three booths; the cost of which was underwritten by contributions from vendors who supply the school. Several vocational-technical shops also displayed processes in which student-trainees were engaged. The Three Seasons Restaurant served 200 patrons from 5:30 p.m. to 8:30 p.m. An informational breakfast was held for local officials at which time a history of the school was presented along with a review of current activities and plans for the future. It was estimated that well over 3,500 visitors came to the school during the week of celebration.

As a culminating activity, a Recognition Banquet for twenty-five (25) outstanding vocational students, from every corner of the Commonwealth, was held at Mechanics Hall in Worcester. Former state senator and chairman of the Joint Committee on Education, Gerard D'Amico, was the featured speaker.

It was announced during the week that Blackstone Valley Tech was selected to be one of five vocational-technical high schools to be highlighted in a television promotion during the school year 1987-88.

M.G.L. Chapter 188 (School Improvement Act)

The Commonwealth's School Improvement Act provided the vocational regional school district with supplemental funds. Four grants were received. They were:

1. **School Improvement Council** - \$9,040. As required, an advisory council composed of two parents, a student, two teachers and the school principal, was organized. The council recommended: acquisition of two electronic typewriters for faculty use; hiring of a public information person; and purchase of equipment/software for electronic media. The School Committee approved the utilization of the funds as recommended.

2. **Horace Mann Grant** - \$6,480. As required, the School Committee and Teachers Association collectively agreed to establish liaison positions from within the faculty ranks to: coordinate revisions and modernization of academic and vocational/technical curricula; establish an assistant position for COOP education supervision; develop a health curriculum whose focus would address drug abuse issues, the problem associated with AIDS, teenage pregnancy and teenage suicide.

3. **Equal Educational Opportunity Grant** - \$149,669. As required, the funds were used to supplement appropriations for instructional purposes, the lunch program and to offset rising liability insurance costs. The school district's eligibility to receive these funds is based on the fact that its expenditures per pupil were considerably below 85% of the average expenditure per pupil statewide. Each of the member towns voted to permit the vocational regional school district to receive and utilize the funds as prescribed by statute.

4. **Professional Development Grant** - \$67,345. As required, the funds were used to supplement teacher compensation, based on a collective agreement between the School Committee and Teachers Association, whereby 64 eligible teachers/guidance staff applied for an equal remuneration in fulfillment of one of the following options: Vocational Program Modernization; Academic Course Modernization; completion of an approved college course (3 credits) in his/her subject area; visitations to three vocational-technical schools to compare specific programs and submit a report on findings; development of handbooks associated with either Guidance, Special Needs or Media. Each of the member towns voted to permit the district to receive and utilize this grant as prescribed by statute.

5. Basic Skills Tests were administered to 9th grade students in the fall of 1986. The results were satisfactory and helpful in identifying students who needed additional support.

6. Statewide Achievement Tests were administered to 11th grade students in 1986. Unlike Basic Skills, the Achievement Testing results are used to assess school curriculum and to compare results of school systems which have similar characteristics. The general areas tested included reading, mathematics and science. Juniors scored at an average level in reading and math; they scored above average in science when compared to general high schools of the Blackstone Valley. In the comparison to vocational-technical high schools across the state, results were better than most vocational-technical high schools. School officials worked on improving those areas in the curriculum which appeared to be less than average within the three broad categories.

Facilities

The School Committee continued improvement and maintenance of the school plant during the past year. The facilities manager applied for and received a state energy grant in the amount of \$122,957 to upgrade energy conservation measures. The funds were used to: replace two original oil burners installed in 1965, converted heat and ventilation controls to a fully automated system, installed heat barriers on outside doors and installed water saving devices on shower heads. This coordinated effort was designed to reduce energy waste by at least 20%. The plan received national recognition, having been rated the third best energy saving proposal advanced by a public facility throughout the nation.

Next year the School Committee will be taking steps to repair roofs installed in 1965. Normal maintenance is no longer stopping persistent leaks which are occurring more frequently.

Graduation - Class of 1987

The Class of 1987 held its graduation in outdoor ceremonies on Saturday, May 23, 1987. One hundred and eighty-five young men and women received diplomas and vocational-technical certificates from Vice Chairman Kevin Harvey of Bellingham. Class officers who led the seniors were: President, Brendan Cahill (Machine Shop Program-Uxbridge); Vice President, Kerri Lavoie (Graphic Arts Program-Uxbridge); Treasurer, Tammy Beauchamp (Drafting Program-Northbridge); Secretary, Jessica Kelliher (Graphic Arts Program-Uxbridge).

Reverend Daniel Dower of Sacred Heart Parish, Hopedale, opened the ceremonies with a very appropriate Invocation.

Dr. Carl F. Simmons, President Designate of Central New England College addressed the graduates. In addition to congratulating the graduates for their achievement in both academic and vocational pursuits, he urged them to use their knowledge, enthusiasm and skills to further their own well-being and to utilize their talents for the betterment of society. He stressed personal commitment and persistence in striving to achieve their highest aspirations.

Eight students were recognized for being on the Superintendent-Director's Commendation list, eleven and ten terms respectively. The Award recognized graduates who consistently and regularly excelled in their vocational field of training, achieved satisfactorily in their academic studies and conducted themselves with distinction throughout four years. They were:

Eleven Trimesters - Darren Brady (Electronics Program-Douglas), Lisa McNeill (Graphic Arts Program-Upton), Craig Picard (Electronics Program-Upton), Timothy Remillard (Automotive Technology Program-Upton)

Ten Trimesters - Steven Bazin (Information Processing Program-Sutton), Ellen Cote (Drafting Program-Upton), Jessica Kelliher (Graphic Arts Program-Uxbridge), and Christopher White (Culinary Arts Program-Millbury)

The Division of Occupational Education, Massachusetts Department of Education, awarded its first Commonwealth Outstanding Vocational Student Award to Craig Picard. The award was presented in ceremonies at Mechanics Hall, Worcester, where vocational students throughout the state were honored for their achievement, performance and extra-curricular participation during four years at their respective vocational schools.

Forty-six (46) young men and women planned to pursue advanced study at either public or private, two/four year institutions beyond high school. That represents twenty-five percent (25%) of the Class of 1987 accepted at schools of higher learning.

One hundred twelve (112) graduates were placed in occupations directly or indirectly related to the fields for which they trained. Eight (8) graduates planned to enter the military. Nineteen (19) young people were undecided what to pursue.

The graduating class consisted of 134 young men and 51 young women.

Student transportation (to and from school) was provided by five contracted conveyors covering twenty-two (22) bus routes throughout the 225 square mile district. In addition, four (4) late-afternoon buses were used on Tuesdays and Thursdays to return students to their towns after having been involved in extra-curricular activities or because they were detained for disciplinary reasons.

Four excellent professionals retired with the completion of the school year. They were: Roland Benoit (Machine Shop Instructor), Thomas Mullins (Automotive Instructor), Arthur Croteau (Technical Drawing Instructor) and Elizabeth Miller (Special Education Teacher). They will be missed. Collectively they represented over 70 years of teaching experience.

Two Valley Tech teachers were selected by their peers to receive Outstanding Teacher Awards presented by the VFW Post of Millbury. They were Pauline Westcott, Reading Teacher, and John Pierce, Painting and Decorating Instructor. They were honored at a presentation held on January 24, 1987 in Millbury. As usual, the collective wisdom of our professionals made it easy to select two Outstanding Teachers, who deserve our sincere congratulations. Mrs. Westcott and Mr. Pierce are outstanding professional educators who exemplify all the qualities and attributes reserved for the "best" in education. They deserve all the accolades commensurate with the public recognition as "Outstanding Teacher."

Conclusion

Completing twenty-one years of operation, we are pleased to report that the Blackstone Valley Vocational Regional School District continued to grow, develop, adapt and serve the needs of individual member towns and the area in general. Every effort has been made to correct imperfections as well as to introduce new ideas and adjust to prevailing circumstances. Commitment to attaining excellence, in every facet of the vocational regional school district's endeavor, has been the guiding principle of the school committee, administration, faculty, support staff and many advisory committees.

We genuinely believe that the concept of vocational-technical education, supported and sustained cooperatively through a regional agreement, is the most efficient and cost-effective means of providing for the preparation of youth to undertake adult responsibilities upon completion of publicly-supported secondary education.

In behalf of the students, past, present and future, all of us directly connected with the delivery of quality vocational-technical education, express our appreciation and thanks to the citizens of the Blackstone Valley Vocational Regional School District for their complete support — moral and financial. Without adequate public investment, this unique educational institution would not be possible.


