In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Upton Town Hall in said Upton on Monday the nineteenth day of March, 1990 next, at 7:30 o'clock in the evening, then and there to act on the following articles:

The meeting was called to order by Moderator Lloyd L. Hamm at 7:30 p.m. with a quorum present. The call and constable's return was read by the Moderator.

Non-voters seated in the main hall were Eileen Vigliante and Martha Woolverton of the Milford Daily News, State Representative Barbara Gardner, Dr. David Crisafulli, Superintendent of Schools, Ann Brien, Middlesex News and Jewel Bradstreet of the Worcester Telegram/Gazette.

ARTICLE 2: To see if the Town will vote to appropriate from available unappropriated funds in the Treasury, or borrow, the sum of \$53,200.00, or any other sum, to re-roof the Memorial Elementary School, or, to take any other action relative thereto.

Voted: That the Town transfer from Stabilization the sum of \$53,200.00 to re-roof the Memorial Elementary School.

ARTICLE 3: To see if the Town will vote to appropriate from available unappropriated funds in the Treasury, or borrow, the sum of \$6,000.00, or any other sum, for the construction of a sidewalk at the Memorial Elementary School, or, to take any other action relative thereto.

Voted: That the Town transfer from Stabilization the sum of \$6,000.00 for the construction of a sidewalk at the Memorial Elementary School.

ARTICLE 4: To see if the Town will vote to transfer the sum of \$500.00 from the Parks Department Fields & Courts Account to the Parks Department Building Maintenance Account, or, to take any other action relative thereto.

Voted: Unanimously that the Town transfer the sum of \$500.00 from the Parks Department Fields & Courts Account to the Parks Department Building Maintenance Account.

ARTICLE 5: To see if the Town will vote to appropriate from available unappropriated funds in the Treasury the sum of \$15,299.00, or any other sum, for the purchase and preparation costs of the police cruisers, or, to take any other action relative thereto.

Voted: That the Town appropriate from available unappropriated funds in the Treasury the sum of \$16,622.00 for the purchase and preparation costs of the police cruisers.

ARTICLE 6: To see if the Town will vote to appropriate from available unappropriated funds in the Treasury and transfer to accounts listed the following sums:

- A. \$16,670.00 to the Police Department Full Time Salaries Account;
- B. \$27,356.00 to the Police Department Part Time Salaries Account;
- C. \$3,240.00 to the Police Department Expense Account;
- D. \$1,800.00 to the Police Department Clothing Allowance Account;
- E. \$3,500.00 to the Police Department Cruiser Maintenance Account;

or, to take any other action relative thereto.

Voted: Unanimously that the Town appropriate from available unappropriated funds in the Treasury the sum of:

- A. \$16,670.00 to be transferred to the Police Department Full Time Salaries Account;

ARTICLE 21: To see if the voters of the Town of Upton will vote to petition the Legislature for the enactment of Special Legislation enacting a recall procedure applying to elected officials in the Town of Upton, as follows:

An Act Providing For Recall Elections In The Town Of Upton
Be it enacted, etc., as follows,

Section 1. Any holder of an elected office in the Town of Upton may be recalled therefrom by the qualified voters of the Town as hereinafter provided.

Section 2. Any ten qualified voters of the Town of Upton may initiate a recall petition by filing with the Town Clerk an affidavit containing the name of the officer sought to be recalled and a statement of the grounds of recall. Said Town Clerk shall thereupon deliver to the voters such affidavit sufficient number of copies of petition blanks demanding such recall, printed forms of which he/she shall keep on hand. The blanks shall be issued by the Town Clerk with his/her signature and official seal attached thereto; they shall be dated and addressed to the selectmen and shall contain the names of all persons to whom issued, the number of blanks so issued, the names of the

person(s) sought to be recalled, the grounds of recall as stated in the affidavit, and shall demand the election of a successor to such office. A copy of this petition shall be entered in the record book to be kept in the office of the Town Clerk. Said recall petition shall be returned and filed with the clerk within twenty days after filing of the affidavit and shall be signed by thirty percent of the qualified voters in said Town. To every signature shall be added place of residence of the signer, giving street and number. The said recall petition shall be submitted at or before noon time (12:00 p.m.) on the Thursday preceding the day on which it must be filed, to the registrar(s) of the voters in said Town, and the registrar(s) shall forthwith certify thereon the number of signatures which are the names of the voters of said Town.

Section 3. If the petition shall be found and certified by the said Town Clerk to be sufficient, he/she shall submit the same with his/her certificate to said selectmen without delay and said selectmen shall forthwith give written notice to the officer of the receipt of said certificate and shall, if the officer sought to be recalled does not resign within five days thereafter, thereupon order an election to be held on a date fixed by them, not less than sixty days and not more than ninety days after the date of certificate of the Town Clerk that a sufficient petition is filed; provided however, that if any other town election is to occur within one hundred days after the date of said certification, said selectmen may, in their discretion, postpone the holding of said recall election to the date of such other election. If a vacancy occurs in said office after a recall election has been so ordered, the election shall nevertheless proceed as in this section provided.

Section 4. Any officer sought to be recalled may be a candidate to succeed himself/herself and, unless he/she requests otherwise in writing, the Town Clerk shall place his/her name on the ballot without nomination. The nomination of other candidates, the publication of the warrant for the recall election, and the conduct of the same, shall all be in accordance with the provisions of law relating to elections, unless otherwise provided by this act.

Section 5. The incumbent shall continue to perform the duties of his/her office until recall election. If then re-elected, he/she shall continue in the office for the remainder of his/her unexpired term, subject to recall election as before, except as provided in this act. If not re-elected in the recall election, he/she shall be deemed removed upon the qualification of his/her successor, who shall hold office during the unexpired term. If the successor fails to qualify within five days after receiving notification of his/her election, the incumbent shall thereupon be deemed removed and the office vacant.

Section 6. Ballots used in a recall election shall submit the following proposition,

there shall be a square in which the voter, by making a cross mark (X), may vote for either of the said propositions. Under the proposition shall appear the word "Candidates", the directions to voters required by section forty-two of chapter fifty-four of the General Laws, beneath this the names of candidates nominated as hereinbefore provided. If a majority of the votes cast upon the question of recall is in the affirmative, the candidate receiving the highest number of votes shall be declared elected; provided that at least thirty percent of those entitled to vote in the election shall have voted. If a majority of votes on the question is in the negative, the ballot for the candidates need not be counted.

Section 7. No recall petition shall be filed against an officer within six months after he/she takes office, nor, in the case of an officer subject to a recall election and not recalled thereby, until at least six months after the election at which his/her recall was submitted to the voters. No person who has been removed from office or who has resigned from office while recall proceedings were pending against him/her, shall be appointed to any town office within two years after such removal or such resignation. or, to take any other action relative thereto.

Voted to pass-over this article.

It was moved and seconded that the Town adopt a Main Street Historic District by amending the By-laws of the Town of Upton by adding thereto under Title 3 — LAND USE, the following new Chapter 5: Chapter 5, Historic Districts (under the authority of M.G.L., C 40C, as amended). A 2/3 vote required, a standing count was taken. There were 55 Yes and 28 No. Moderator declared the motion lost.

It was moved and seconded to dissolve this Warrant and to adjourn this meeting. This meeting adjourned at 9:05 p.m.

REPORT OF THE BOARD OF SELECTMEN

1990

The decade of the nineties is promising to be one of challenge, opportunity and transition. Issues debated by the Board of Selectmen reflect the dual pressures imposed by the growing complexities and responsibilities of local government and by an increase in fiscal restraints.

The implementation of a major capital project, the conversion of the George S. Ball School into Upton's new Police and Communication Facility, reflects these challenges. A general contractor, Logan Plastering and Construction, Inc. of Billerica was selected through a lengthy bid process, and renovation of the facility is underway with completion projected for Fall of 1991. The renovated building will provide housing for the Upton Police Force that is in compliance with state and federal regulations; and in addition, state-of-the art communications and electronics equipment that will be utilized by several Town Departments. This equipment is designed to meet present demands and to accommodate future enhancements.

The search for a feasible site for the Department of Public Works municipal garage concluded with the selection of property on Walker Drive. Selectmen are in the process of closing on the Purchase and Sale agreement, and are optimistic about completing the process in 1991.

Several appointments involving a lengthy selection process were made during the year. Following incorporation of the Highway, Sewer, Water, Park, Cemetery, and Tree Warden's Departments into one Department of Public Works, a search committee was appointed to aid the Selectmen in determining the best candidates for the position of Director of Public Works. Primary considerations for selection were engineering experience and credentials, strong leadership qualities, and organizational skills. Numerous applications were reviewed, and, after careful deliberation, Hamid Hashemizadeh was selected and appointed to the position in November.

The Board also approved appointments presented by other Town boards. Included was the appointment of Arlene M. Hoell, R.N., as Town Nurse following the resignation of Sheila Porter. The Board extends its appreciation to Mrs. Porter for her nine years of service as Town Nurse and her total of fifteen years of work with the Upton Health Service.

Lt. Rodney B. Marchand retired from the Upton Police Force following 25 years of service to the town. In addition, Sgt. Samuel Aldrich retired after working on the Police Force for 24 years. The Board of Selectmen wish these people well, and on behalf of the Town offer thanks for their outstanding contributions. The Police Force added several full-time and part-time employees. The Board of Selectmen approved the appointments of full-time officers Thomas Stockwell, Erik Mager and Bruce Rivard.

A significant portion of the Board's time was spent deliberating land use issues. Gravel permit hearings for South Street and Glen Avenue were conducted, each commanding intense community attention. Gravel permits were extended after debate and consideration to impact on abutting properties and dwellings, damage to Town highways, and to truck routes and operation times.

Our appreciation is extended to all other Town boards and committees for their valuable aid to the Town, and to our Administrative Assistant, Joan Varney, for her expertise and constant support.

REPORT OF THE UPTON ARTS LOTTERY COUNCIL



The Upton Arts Lottery Council is pleased to be one of the 341 cities and towns in Massachusetts to be awarded funds from the Massachusetts Cultural Council.

Arts Lottery funds are awarded to community organizations, arts and humanities organizations and individual artists, to enrich, encourage and promote artistic and humanistic development in the Town of Upton.

The Council will fund: (1) Projects in the arts and humanities which encompass the study, pursuit, performance, exhibition, and enjoyment of cultural activities. (2) Projects which include rents, leases, acquiring, improving and maintaining facilities for the housing, support and presentation of cultural activities. (3) Activities which benefit the general population of Upton and not solely individuals.

* * * Awards are made on a reimbursement basis * * *

In addition, the Performing Arts Student Series (P.A.S.S.) program is also administered by the Upton Arts Lottery Council. The P.A.S.S. program allows Massachusetts school age children, grades K-12, including special needs, to attend performing arts events. Private, public, and parochial schools are eligible for funding. P.A.S.S. applicants may select events by any performing group listed in the P.A.S.S. roster.

Deadline and procedure:

A copy of the guideline handbook and P.A.S.S. roster are located in the Upton Town Library. Applications may be obtained at the Library or from any Council member. The original and two copies of the completed application must be returned to the Council by April 1st. All applications must be typed. Applications received after the deadline will not be considered. All questions on the application, as well as those on the local form, must be answered.

Proposals are evaluated on both artistic or humanistic quality and value to the community of Upton.

For 1990, grants totalling \$3087 were awarded to:

Upton Parents Club

CONSERVATION COMMISSION REPORT

During 1990, the Conservation Commission held hearings for 14 Notices of Intent and issued 12 Orders of Conditions as a result of those hearings. All of the applications were for single family homes or small construction projects; none was for subdivision construction. In addition, the Commission held numerous informal meetings, issued a number of Enforcement Orders and Certificates of Compliance, and signed numerous building permits.

At the end of 1989, the Aquatic Weed Control Committee, a subcommittee of the Commission, was formed in response to concerns expressed by many townspeople over the excessive growth of nuisance aquatic weeds in the town ponds. Committee members include Charles Pederson (Chairman), Pamela Foley, Gladys McKinstry, and Francis Wallston (liaison to the Commission). The Committee established the need for aquatic weed control in Pratt Pond, Lake Wildwood, and Taft Pond, and then interviewed and obtained treatment prices from several lake management firms. Herbicide treatment proved to be the only practical and cost-effective method available to the town at this time. The Committee sponsored an article at the October 1989 Special Town Meeting requesting the \$8,675.00 needed for aquatic weed control, which was approved.

On July 16, 1990, the three ponds were dewatered with the use of state and federally approved herbicides by ACT of Northborough, MA. A followup survey indicated that good weed control was obtained in all three ponds. Annual maintenance treatments are recommended by ACT at a cost of approximately \$4,000.00. The Commission wishes to thank the members of the Aquatic Weed Control Committee for their very successful efforts.

In February of 1990, Robert Sutton was appointed to the Commission as a new member. William Johnston, after serving two years as chairman, turned his position over to Ellen Chagnon in May. The Commission has an opening for one member at this time, and would welcome the addition of an individual interested in helping to administer the Wetlands Protection Act and in assisting the Commission in writing wetland by-laws for the town.

REPORT OF COUNCIL ON AGING

This year the Council on Aging added a Computer to our Senior Center office, thus enabling us to keep better records of all information both coming in and going out.

Our existing recreational and social service programs continue to be well attended and several have grown. Our nutritional site continues to provide a hot meal five days a week to 40 seniors per day at the Senior Center and 35 home delivered meals. Our Outreach worker, Maria LaBarge, has made over 600 visits and we now have over 90 clients. The Council on Aging van is available Tuesday and Wednesday. This year we provided over 2000 rides to Upton Seniors and disabled adults.

The Council on Aging Senior Center continues to be a Community Center by offering services that are available to the whole Town. This year surplus food distribution served an average of 125 households per distribution. The Council on Aging continues to be a site for taking fuel applications. In conjunction with the Board of Health, we continue to offer monthly blood pressure clinics and yearly flu clinics. As always, the Senior Center Staff is available Monday through Friday 8:30 a.m. — 4:30 p.m. to provide information and referral to any resident.

The Council on Aging would like to thank all our volunteers for their many hours of service.

EMERGENCY MEDICAL SERVICE

The Department of Emergency Medical Services hereby submits the following report for the year ending 31 December 1990:

With total calls increasing by 20% since 1988 (11% over 1989) our service continues to operate with a staffing of 15 certified EMT's and 5 EMT's in training. The burden of responding to so many alarms by an on-call department is often a difficult one, but our dedicated personnel continue to provide the highest degree of professional emergency care in the region. We were fortunate to recently certify several EMT's who are available during the daytime hours which are so difficult to cover.

As always, the residents and businesses of this community have supported us wholeheartedly during the past year including their gracious donation of over \$12,000.00 to our Semi-Automatic Defibrillator fund drive. The original hope was to obtain \$8,000.00 for the purchase of a single unit, but thanks to the public's generosity we were able to obtain a

Life-Pak monitor and defibrillator for the ambulance and a portable defibrillator unit that is assigned each night to an on-call EMT. The additional funds were also used to train and certify 10 EMT's in the use of the life-saving equipment.

In November 1984 our service was forced to cease transporting non-emergency (scheduled transport) patients due to several reasons including bulk of calls (302 in 1984), lack of available daytime personnel, and the danger of a true emergency occurring in town while the ambulance was out of town on a non-emergency transport. Not only is our service responding to 40% more calls than in 1984, but all of our calls are for emergency transport only! On July 01, 1988 we began charging \$150.00 per transport to offset the cost of running this Department. Through November 1990 we had billed a total of \$71,536.85 directly to clients and Medicare and had collected \$48,020.17, a 67.1% collection rate.

Through an aggressive billing procedure and the assistance of the Town Treasurer we have raised the collection rate from a low of 5% in July 1989 to its current rate.

During 1990 we treated and/or transported 320 patients. Of the 262 patients we transported, 100 were administered advanced life support by the Milford-Whitinsville paramedics. On 15 occasions our ambulance was on another call, and mutual aid was summoned from surrounding communities.

To the Upton Fire, Police and all other town departments we extend our gratitude for their assistance and we look forward to serving the Town of Upton in 1991, our 50th year of service!

UPTON FIRE DEPARTMENT ANNUAL REPORT 1990

The Board of Fire Engineers hereby submits its annual report for the year ending December 31, 1990.

The year of 1990 saw the Fire Department put to use much of its ongoing training with large diameter hose. On three separate occasions the ability to supply large quantities of water to a fire scene through a single four-inch hose line proved invaluable. In March, the Department assisted the Hopkinton Fire Department with a structure fire on West Main Street. The use of the large diameter hose provided enough water for both departments to operate effectively. In October, we again proved the value of LDH when a suspected arson fire at 127-129 West Main Street destroyed one building and heavily damaged another. The large volume of water necessary to contain the blaze was supplied by two (2) 4" lines. In the past, it would have taken five (5) 3" lines to provide the same amount of water. On Halloween night one single line was laid 1600 feet to a water hole to contain a house fire on West River Street.

Additional training was provided for State mandated "First Responder" and a required course in "Hazardous Materials". The hazardous materials course allows us to recognize potentially hazardous situations, identify the material and take the necessary precautions to safeguard the public and ourselves. These courses do not allow the Fire Department to do any decontamination or removal. Our training has proved invaluable. With all the incidents that were handled by the Fire Department in 1990, we had no one injured in the line of duty.

Firefighter/EMT/inspector, Scott Garland, also had a busy year handling commercial business inspections, fire prevention programs for all age groups and issuing various permits in accordance with Chapter 148. Scott has also worked very diligently with the collection of monies due from the EMS Service. He has followed through with second and third billing, which has resulted in a collection rate of slightly more than 70%. This is in contrast to other towns who are only able to collect 30-50% of their commitments. Scott should be commended for his diligence and dedication.

The Fire Department has begun writing specifications and gathering information for the purchase of a new rescue truck. The present vehicle is 13 years old and has in excess of 110,000 miles on it. The aluminum body is starting to separate from metal fatigue and needs to be upgraded and replaced.

The year 1990 proved to be a quiet one for the Board of Health as limited construction of houses were performed, believed to be due to the state of economy.

The Board did however have certain emergencies that needed the Board's attention, one being to monitor the restorations to the West Upton Plaza stores during a recent motor vehicle accident which caused damage to the stores and their provisions inside.

The Board also acted upon an apartment building which housed numerous violations causing the Board to condemn the building temporarily until repairs could be made.

Recycling made itself known in the year 1990. The Board has reviewed and discussed many different aspects of the project, finding many options available. Meetings were held at the town hall to discuss with the townspeople the various methods of recycling. The Board has now set up several different sub-committees consisting of volunteers from Upton to better organize the project and give the townspeople a chance to contribute.

The reports completed by state food inspector Robert Rimbach show all restaurants and convenience stores to be in good standing.

During the summer season of 1990, the three town beaches were tested every two weeks, with results meeting the standards set by the State.

The Board acted upon a total of 24 complaints ranging from dog bites to violations of housing codes.

The Board also held its annual rabies clinic in the spring, open to all dogs owned by Upton residents. Dr. Heller administered the vaccination, and Martha Williams, Town Clerk, also issued licenses for those needing them.

HEALTH SERVICE REPORT

The Town Nurse respectfully submits this 1990 annual report to the town.

With the resignation of Sheila Porter on July 16, 1990, the Upton Board of Selectmen appointed Arlene Hoell as the new Town Nurse. The transition has been smooth and the Upton Health Service (UHS) continues to provide health care services for townspeople with no insurance or for those whose insurance no longer covers services that are still needed. Services are funded by the Town of Upton and are available to all Upton residents. Services provided include home nursing care, information and referral, health education, immunization and screening clinics, maternal and child health assessments, and patient advocacy.

The UHS has an excellent working relationship with primary care physicians to insure that the physician recommendations and medical care plan are carried out. Referrals to and from the Greater Milford-Northbridge Visiting Nurse Association insures continuity of care. Working closely with the Upton Council of Aging and the Tri-Valley Elder Services to plan and deliver services to Upton's elderly population and with the Emergency Medical Services to offer support to the families of the Health Service patients establishes a broad health network. This network of health care providers assist the people of Upton in improving their quality of life and maintaining their independence for as long as possible.

In order to increase awareness of health problems through knowledge the UHS provides community education. Many articles of interest to the elderly have been written by the Town Nurse and published in the Upton Council of Aging Newsletter. Health Service students in the local school work with the Town Nurse to research opportunities in the health care field. The Town Nurse works with local organizations helping to meet the needs of the needy. Blood pressure management clinics are held monthly at Coach Road and the Senior Center. The Town Nurse continues to update her knowledge so as to maintain and learn new skills that meet today's requirement for health care professionals.

Aldrich, the founder of the Bloomer Girls, a non-profit organization that does a great deal of charitable work in the community — she also served in the Police Department, and was very active in town activities.

Among the guests were Rev. John McKenna who gave the invocation; Rev. Linwood Wrenn, who gave the blessing; Rev. Rocco Piccolomini, who gave the benediction. Also attending were living nominees Mrs. Nancy Beatty, George Kennedy, and Walter Stank. Other nominees who were unable to attend included Mrs. Hazel Forsberg, Ernest B. Porter, and Sidney Williams.

State Rep. Barbara Gardner spoke briefly as she congratulated the Upton Heritage Homecoming Committee for its work in keeping the town's heritage in the forefront. Robert Fleming represented the Board of Selectmen.

Entertainment was provided by the On Line Repertory Company as they sang several selections from "Carousel". Producer Heidi Leinonen, pianist Robert Gervais, and announcer Sue Nagi introduced the group. Sarah Hill, Christie Curran, and Diane Lyford, 2nd and 3rd graders at the Dance Works, did two dances as their instructor Christine Safstrom looked on.

Catch basins were cleaned, drainage ditches were cleaned out and the majority of roads were swept. We also continued our program of cutting back brush on the main roads, with Mendon Street being done in its entirety. Also completed was the relocation of street signs to the nearest utility poles. This practice eliminates the cost of maintaining metal poles and also places the signs at a more visible height.

April saw the traffic lights in West Upton Center finally placed into full operation. From all indications they appear to be doing their intended job. Rush hour traffic appears to move with more ease than previously. Various bridges were cleaned up by cutting brush on the approaches and adding new guard rail at the approaches. Various road sides were rebuilt because of damage done by plows when the sides were soft during the winter.

During the month of May the Department focused its attention on some of the side roads. Stones were removed on South Street and Chestnut Street for their entire length. Two stone culverts were replaced and both roads were sealed. Brush was also removed from major intersections.

In June, we oiled and sealed various roads that had not been done for some time. A schedule has been started whereby all roads are listed by dates done and work completed to have some regularity in maintenance.

During the month of July the employees replaced another culvert on North Street and more roads were sealed.

In August, we installed a new sidewalk on the Fiske Avenue entrance of the Memorial School at the request of the Selectmen. The old stone dust sidewalk was completely removed and relocated away from the roadway to increase the safety of the school children using it. The entire project was completed through the combined efforts of the Highway, Parks and Tree Departments, and we might add, at a great savings to the Town. At the same time the school parking lot was repaired.

Crockett Road was repaired during the month of September. Stones were removed and rough areas were resurfaced. Asphalt berms were installed on Fiske Mill Road to eliminate the repeated erosion of the road side during heavy rains. Pleasant Street was also done in the same manner.

In October the badly deteriorated concrete sidewalk near the United Parish was completely removed and replaced, again by the Highway and Parks Departments. Preparation of equipment for Winter was begun. Our small sander was completely done over by the employees of this department. Plows and various pieces of equipment were cleaned and painted.

The month of November was used for more winter preparations. Snow fence was installed at the usual locations and equipment was serviced. Several catch basins were rebuilt utilizing the expertise of our own people. A used front-end loader was purchased at the Massachusetts Turnpike auction. This is a necessary piece of equipment for yard use at our future facility on Walker Drive, which we hope to occupy in early 1991. This acquisition resulted in considerable savings over the purchase price of a new machine.

During December the Highway and Parks employees assisted at the Town Common by installing the underground conduit for the new lighting system. Several more catch basins were rebuilt during the month. On December 10, the Town's first Director of Public Works, Mr. Hamid Hashemi, assumed his new duties. His office will be located at the Highway Department Office in the town Hall until such time as the facilities at Walker Drive are finalized. We all welcome Mr. Hashemi and look forward to working together with him in the formation of the Public Works Department.

Most of this years construction was done by our own department employees which resulted in a cost savings to the Town because expenses incurred were only for materials used. Ron San Souci, Joe Drew, Vin Ozella and John Johnson should be commended for offering to use their expertise to save the Town the expense of outside labor in these trying economic times.

I would like to thank the various boards, departments and the Townspeople for their cooperation and assistance in the past year.

We thank Caroline Wood and Toni Vaccaro for the research and clerical work they have done, the Cemetery Commission, the Parks Commission, the Planning Board for their continued assistance, and the townspeople and Selectmen for their support and trust in our judgment.

HISTORIC DISTRICT STUDY COMMITTEE REPORT

The By-Law for an Historic District was written by the Committee and approved by the Massachusetts Historical Commission (as was our Main Street Historic District). The By-Law states its purpose "is to promote the educational, cultural, economic and general welfare of the public through the preservation and protection of the distinctive characteristics of buildings and places, significant in the history of the town of Upton or their architecture, and through the maintenance and improvement of settings for such buildings and places and the encouragement of design compatible therewith."

The District chosen by the Committee was the Main Street Historic District because of its historic significance in the town of Upton. Each building was researched and the owner given a packet containing information on the building. The Committee, wherever possible, made personal contact with the home owner.

The wish to establish a Commission resulted in the loss by one vote at Town Meeting in December of 1990. (A two-thirds vote was required.) Notwithstanding, the Committee met January 3, 1991 and wishes to pursue our goal to pass the By-Law at Annual Meeting in May of this year.

ANNUAL REPORT OF THE UPTON HOUSING AUTHORITY

Upton Housing Authority funding is directly from the Executive Office of Communities & Development in Boston, a State Agency. All of the regulations and guidelines are set forth by that agency in accordance with each Housing Authority's Contract for Financial Assistance, Upton's signed on 9/6/67.

Anyone may apply for housing in Upton — there is no residency requirement. There are 40 units of elderly housing at Coachroad Apartments. Waiting time for an apartment is unpredictable, but is usually long as we have a very slow turnover in apartments — no vacancies in 1990 for example.

Upton Housing subsidizes nine apartments of family and elderly housing through the State's Chapter 707 program at the Upton Inn — three two bedroom units and six one bedroom units. No families larger than four persons can be accommodated.

The requirements for housing are as follows:

PARKS AND RECREATION COMMISSION

The past year has once again been busy for the Parks and Recreation Commission. Many thanks to our Parks Supervisor, John Johnson, who is solely responsible for the maintenance of the recreational areas of town which include the Howard Leland Field at Memorial School, the Town Beach, the Ernest "Squint" Ramsey Memorial Recreational Building and fields, the Town Common, and the memorial islands that are located throughout the town.

The Ernest "Squint" Ramsey Memorial Recreational Building was utilized extensively this year by Cub Scouts, Girl Scouts, the Twin Valley Softball League (of which the Upton Youth Club is a member) and the Bass Fisherperson's Club.

Our ball fields are also very busy and fully scheduled. The fields at the beach facility along with the Howard Leland field are being utilized. A master plan to renovate the fields and courts at the Howard Leland Field is currently on hold.

The summer swim program was, once again, very successful and quite popular with the support from Multi-Sport. One Water Safety Instructor, one Water Safety Instructor/lifeguard, two aides, and two lifeguards were employed. With the restructuring of the swimming staff, we were able to increase the quality of swimming lessons and still provide for adequate protection of the swimming area. Due to budget constraints, the hours in which the beach was opened were altered; yet, it was still opened seven days a week.

Many children were registered for swim instruction. Red Cross courses being offered were: Beginners, Advanced Beginners, Intermediates, Swimmers and Basic Water Safety. It is still a goal of the Commission to offer lifesaving courses if enough interest is generated.

Valley Tech has been most helpful in the repairing and maintenance of the raft in the swim area. A U-shaped dock is still desirable for safety concerns, but is too costly at this time.

The Commission also worked with the Conservation Commission to develop a solution to the weed control problem at Pratt Pond which was getting to the point of endangering the swimmers. The water was treated in the summer.

We would like to express our thanks to the Board of Selectmen, various Town Boards we work with, Multi-Sport, and the community for their continued support so the town's recreational areas can be enjoyed by all!

Lt. Rodney Marchand retired after twenty-five years of dedicated service to the Town of Upton and the Law Enforcement Community in general.

Bruce Rivard and Erik Mager were appointed full time police officers and filled the two vacancies within the department.

Again our goal is to reduce the number of property crimes & with the assistance and support of the community we can reach that goal. If you see or hear something suspicious, please report it as soon as possible. A real problem at times is locating property; please have your house number visible from the street so the patrolling police officers can identify your property.

During the upcoming year the police department will be conducting another Bicycle Safety Program with inspections, driving courses and registrations, The Second Annual Fishing Derby will be taking place during the summer. The police department is working with

school officials in putting together a Drug Awareness Program directed toward a positive educational aspect of drug misuse and abuse. Our vacation checks, security evaluations and Operations Identification will be continued programs.

The police department assigned 2,828 case numbers to services rendered thru-out the past year. Case numbers are also assigned to crimes and/or possible crimes and not minor motor vehicle violations. These average out to approx. 236 assigned cases per month. Enclosed you will find a breakdown of the services rendered for the past year.



REPORT OF THE PUBLIC WORKS STUDY COMMITTEE

1989 was a year of great accomplishment for this Committee and the Town of Upton. Approval of a By-Law establishing a Department of Public Works was a most important event and the Board of Selectmen were proceeding to implement the By-Law by filling the position of Director and to have a public works facility.

Early in 1990 the Board of Selectmen requested the Committee to elect two of its members to serve with the Selectmen as a committee of five for the recruitment of a Director of Public Works. Henry J. Poirier and Rufin VanBossuyt were so elected.

The Committee, having been granted permission by the Board of Selectmen, proceeded with a site investigation of the Warren Street property. The Committee continued to visit existing DPW facilities in several municipalities and reviewed plans and specifications of typical facilities. In addition, meetings were held with officials and pertinent personnel of municipalities having a Department of Public Works, designers, and constructors and manufacturers of pre-engineered buildings.

Early in March the Board of Selectmen notified the Committee of the availability of a building on Walker Drive. Inspections of the site and building were made by the Committee as requested by the Board of Selectmen.

The Committee determined, in mid-March, to hold the continuation of the Warren Street site investigation in abeyance until the Walker Drive property acquisition was resolved.

In late March the Committee reviewed a proposal for an environmental assessment of the Walker Drive property and a request by the Board of Selectmen for a recommendation as to the acquisition of the property.

Although the Walker Drive building does not meet the criteria established by the Committee, because of the uncertain financial condition of the Town and the Commonwealth of Massachusetts, the investigation of sixteen sites (the majority of which were not viable), and the need for a Department of Public Works facility with time being of the essence the Committee voted the following recommendation:

"The DPW Study Committee recommends that the Board of Selectmen continue to pursue the acquisition of the land and buildings thereon and that the purchase and sale agreement be conditioned as follows: (1) the receipt by the Board of a favorable environmental assessment report; (2) quality and yield (minimum of 20 gpm) of the private on-site water supply; (3) that the on-site water disposal system be of adequate size and functioning properly for the proposed use; (4) an independent inspection to assure the weathertightness of the building, especially the roof, and the absence of asbestos and radon gas; (5) and the

determination of responsibility for unfound hazardous materials."

The recruitment committee after many meetings selected Mr. Hamid Hashemi to be the Town's first Director of Public Works. He assumed the position on December 10, 1990. The Committee, individually and collectively, offered congratulations and best wishes to Hamid and volunteered full support and assistance to him.

Negotiations for the Walker Drive property were continuing at the end of the year. Hopefully the matter will be resolved and a facility here or elsewhere in the Town will become a reality in 1991.

REPORT OF THE TREE WARDEN

In 1990, twenty-four (24) shade or flowering trees were planted along the town's roadsides. If anyone would like to donate a shade tree we will be happy to include it in our ongoing tree planting program.

The Tree Department had forty-one (41) emergency calls during the past year. We also had an ice storm on February 16th and high winds on November 12th that kept the Tree Department and Highway Department busy for thirteen (13) hours.

In 1990, one hundred four (104) trees were taken down in the Town of Upton, sixty (60) of these trees were dead, thirty-four (34) were dangerous to the public way and ten (10) were removed to help improve drainage.

During the year, thirty-four (34) stumps were removed along the town's roadsides.

The program of removing low branches and dead ones was carried out the past year.

I would like to thank Deputy Tree Warden Edward Wadsworth, public officials and Massachusetts Electric Company and the townspeople for their assistance during 1990.

During 1990 the Registrars of Voters held six special sessions to register new voters and certify nomination papers. A Total of 324 new voters were registered.

UPTON WATER AND SEWER DEPARTMENT 1990 REPORT

The state-imposed sewer connection moratorium remained in effect during the 1990 year, as improvements at the wastewater treatment facility are in progress. The town water distribution system continues to grow with the addition of thirty-one new water connections added during 1990.

Under the complete approval of the Department of Environmental Protection, the short-term improvements at the wastewater treatment facility are near completion. The installation of two supplemental aeration units will insure an adequate supply of oxygen for the sludge treatment process. Completed modifications to the baffle system within the clarifier tanks have improved the effluent flow through the system. The removal of the gaseous chlorine system and replacement with a liquid sodium hypochlorite system, along with construction of the new laboratory will provide state of the art treatment methods and eliminate potential safety hazards at the facility.

An inflow/infiltration study will begin in the spring of 1990. This study will identify extraneous flows into the wastewater system. The results will be used to develop a cost-effective sewer rehabilitation program.

During the past year the Federal Environmental Protection Agency instituted quarterly toxicity testing which is required by all wastewater treatment facilities within the United States. We are pleased to announce the Upton wastewater facility has complied with this new law and successfully passed these tests.

Our water distribution system continues to provide pristine drinking water which requires no chemical treatment. The system currently supports eight hundred and twenty-five service connections (households, schools, and businesses) and is pumping an average of three hundred and ten thousand gallons of water per day. While the current water supply is adequate for today's requirements, the board believes the time has come for a complete water distribution system study. This study will identify additional water sources and the requirements for the necessary system updating to continue our current operations and meet the future needs of the Town of Upton.

The commission thanks the people of Upton for their continued support and water conservation efforts. We welcome our new Department of Public Works Director Hamid Hashemi, and appreciate the help given by the Board of Selectmen, our clerk Sue Bonina, our superintendent and chief operator Leo Morin, and our plant staff, Larry Bovaird and Tom Wasilewski.

Regular School Committee meetings are held at the Blackstone Valley Regional Vocational Technical High School, Pleasant Street, Upton, MA on the third Thursday of each month in the School Committee Conference Room at 7:30 p.m.

The Blackstone Valley Vocational Regional School District, formed in 1963, has provided vocational-technical education for citizens throughout the thirteen (13) member towns since the unique vocational-technical institution opened its doors in 1966-67. Estimates ranging between 9,000 to 10,000 high school and adult students have availed themselves of the specialized programs offered at the vocational-technical school located on Pleasant Street, Upton, Massachusetts.

School year 1989-90 started August 23, 1989 and concluded June 8, 1990. The fully accredited vocational-technical high school (New England Association of Schools and Colleges) provided 180 days of dual instruction (Academic and Vocational Technical) for 745 young men and women in grades 9 through 12. The educational delivery system consisted of a structured academic curriculum and specialized vocational-technical prepara-

tion delivered in a two-week alternating format organized to provide 90 days of traditional high school subjects and 90 days of specialized vocational-technical instruction.

Specialized vocational-technical programs offered included: Air Conditioning, Auto Body, Auto Technology, Computer Information Processing, Culinary Arts, Drafting, Electrical, Electronics, Graphic Arts, Health Services, Machine Technology, Metal Fabrication, Painting & Decorating, and Plumbing.

Traditional academic curriculum provided sequenced instruction at each of the four (4) grade levels with appropriate course offerings in English, mathematics, science, social studies, business, computer literacy and physical education.

Special education services were provided for 175 students in accordance with their individual needs as determined by team evaluation.

The class of 1990 (grade 12 - Seniors) culminated its four years of vocational-technical preparation on Saturday, May 19, 1990. One hundred and ninety-two (192) seniors, adorned in their royal purple (144 males) and golden yellow (46 females) caps and gowns, surrounded by eight hundred (800) parents, friends, faculty and dignitaries presented themselves to the school committee as candidates to receive diplomas and certificates of vocational-technical competency.

The class was led by President Kierstin Lavoie (Grafton), Vice President Bradley Kibbe (Sutton), Secretary Laurie Mazzuchelli (Blackstone) and Treasurer Melissa Benoit (Douglas).

Chairman Kelton Johnson (Sutton) presided over the ceremonies and presented diplomas to the graduates. Mr. Kenneth Custy, retired Superintendent-Director of Tri-County Vocational School, delivered a stirring and very well-received address to the graduates. He complimented them for their achievements and reminded the young men and women that graduation signified they were prepared superbly to pursue their aspirations as they entered "the world beyond high school."

Significantly, 89% of the graduates were committed to a confirmed endeavor-six (6) entered military, sixty-five (65) were employed in a field directly related to their training, fifty-four (54) were employed in other areas, forty-five (45) were headed to some post high school educational program. Less than 10% were uncommitted to either employment or further education.

As has been customary, one hundred and two (102) seniors acquired first hand experience in the workplace during the school year through the school's highly successful Cooperative Education program. Cooperative Education allowed eligible seniors to acquire "hands-on" experience in their chosen field of vocational-technical preparation. In spite of a general business down-turn, employers throughout the area employed students who demonstrated they were vocationally-technically competent, were passing all their studies, attended school regularly and whose personal conduct was exemplary. Cooperative Education students were paid for their services while on-the-job trainees. They were rated by the employers for the quality and quantity of their performance. In turn, the students received course grades and credit toward graduation requirements. Most were offered full-time employment upon completion of their apprenticeship.

Scholarships and grants-in-aid were awarded in the amount of \$21,000. The Blackstone Valley Teachers Association distributed \$4,900. The Ohio Deisel Institute awarded a \$12,000 scholarship to John C. Pignartaro from the town of Sutton. Other awards were presented by the Upton Women's Club (\$1,000), the Northbridge Women's Club (\$500), the George L. Wood VFW Post (\$400), the Upton Police Department (\$200), and the Ella Risteen Foundation (\$200). Several memorial foundations provided thirteen hundred dollars (\$1,300) in scholarships to seven (7) deserving graduates.

An extensive extra-curricular program of activities was available for students during 1989-90. "Valley Tech", a charter member of the Dual Valley Conference, competed with teams in cross country, boys and girls soccer, boys and girls basketball, softball and baseball. The baseball team qualified for district competition for the third successive year. The Valley Tech track and field team completed another very successful year of competition.

Each of the classes (grd. 10,11,12) elected class officers and engaged in several class activities. The highlight of the year, the Junior-Senior Prom, was attended by well over one hundred and fifty couples. The gala event was held April 17, 1990 at the Royal Plaza Ballroom, Marlboro, MA.

Two annual blood drives (October 11, 1989 and March 14, 1990) managed by the Junior class, generated over two hundred (200) pints of blood for the American Red Cross.

Students involved in Vocational Industrial Clubs of America competed with other vocational-technical students at regional, state and national levels. Nine (9) "Valley Tech" students distinguished themselves in state competition by winning medals in Machine Technology, Metal Fabrication, Automotive Technology and Graphic Arts. Two qualified to compete in the national competition at Tulsa, Oklahoma in June. John Pignataro (Sutton), winner of a state gold medal in Automotive Technology, and Alicia Renaghan (Bellingham), elected as a VICA state officer, journeyed to the far west as members of the Massachusetts contingent of VICA competitors. "Friends of Valley Tech" and VICA activities raised the funds to sponsor the two students.

In another major state-wide competition sponsored by the Chrysler Corporation, "The Annual Trouble-Shooting Contest", a team composed of John Pignataro (Sutton) and Keith Talbot (Sutton) earned second place honors. The team scored highest of all teams in the written exam, one of the two segments of the competition.

Other services provided by the vocational regional school district included an Adult Evening Program. Two semesters, fall and spring, were organized to offer sixteen (16) vocational-technical courses and fourteen (14) avocation courses. Over two hundred and fifteen (215) men and women, each semester, paid fees ranging from \$55 to \$135 to take self-improvement courses taught on Tuesday and Wednesday evenings from 6:30 to 9:30 PM.

In conjunction with American Education Week (November 13-17, 1989), the school opened its doors for public viewing. The Annual Open House held on November 15, welcomed over 1200 visitors who were treated to specialized exhibits and programs. The broad spectrum of vocational-technical education, organized to prepare young men and women for the future, was fully displayed.

The school's Three Seasons Restaurant, a training component of the Culinary Arts Program, served daily luncheons to the public throughout the school year. The restaurant is noted for its excellent cuisine and service as evidenced by its broad mixture of patrons who hail from throughout Worcester County.

Among its distinctions, the school district once again was recognized for its efforts in energy conservation. New England Electric and the Commonwealth provided grants in the amount of \$32,480 to reduce power consumption. Students from the Electrical Program, as part of their training, were engaged in replacing less efficient electrical devices and motors with more efficient components throughout the facility. The effort proved to be very successful. Energy consumption was reduced by 20%, both in kilowatt hours and fuel oil used.

The overall effectiveness of the Blackstone Valley Vocational Regional School District was directly related to those who contributed countless hours of time and effort throughout the year. Foremost among the contributors were the thirteen (13) elected school committee members, the fifteen (15) general advisory committee members and the eighty (80) craft committee members, the parent advisory committees and involved industrial partners. Of particular note were industrialists in the Metalworking fields (Machine Technology and Metal Fabrication). Through their diligence, the Metalworking Partners developed a unique program called "Mentoring." Individual students in Machine Technology and Metal Fabrication were matched with regional companies for the purpose of expanding interest and encouraging students to learn and excel in their pursuit of satisfying careers.

The nationally recognized ASSET Program graduated twenty-one (21) post-secondary students in May 1989. Sponsored by the Ford Motor Co. in conjunction with Quinsigamond Community College and the Blackstone Valley Vocational Regional School District, graduates earned an Associate Degree in Applied Technology. The two year program of study included apprenticeship training at cooperating Ford-Mercury dealerships within the Commonwealth. Each graduate was employed as a sophisticated automotive diagnostician by the dealers. A fourth class was enrolled in August 1989.

On June 26, 1990, following an intense evaluation of Automotive Technician Program standards, the National Automotive Technicians Education Foundation, Inc. awarded its highest level of achievement to Valley Tech. In its letter of congratulations, the National Institute for Automotive Service Excellence stated that, "only a small percentage of educational institutions qualify for the distinction which certifies commitment to qualify automobile training."

Whatever success or positive development students experienced during 1989-90, it was attributable to the school's dedicated service providers-teachers, instructors and support staff. A highly competent and skilled group of people-professional and non-teaching personnel-combined their many talents with personal devotion to provide an educational system second to none. Below are numbers of employees who served the district.

Due to declining high school enrollments throughout the Blackstone Valley Region, the School Committee initiated a reduction plan designed to hold appropriations at this year's level for 1990-91. Everyone is cognizant of the dilemma caused by the state's fiscal crisis. Maintaining quality education in the face of less state aid presents an extraordinary problem for those held responsible to direct and manage institutional affairs. It especially will be difficult to lower costs in light of the fact that in expenditures per pupil, when compared to similar vocational regional schools, Blackstone Valley Regional Vocational Technical High School ranked 27th out of 30 schools.

The School Committee and school administration are pleased to submit this report. Each genuinely believes the vocational regional school district's performance has met every expectation, has continued to be vital resource for the thirteen (13) member towns and has provided excellent vocational-technical education at minimum assessed costs for services rendered. This educational enterprise, measured objectively, has delivered on its commitment to the citizens of the Blackstone Valley Region as was envisaged twenty-four (24) years ago. Continued operation is dependent on the cooperation and support of all who value comprehensive and measurable education.

TO THE CITIZENS OF MENDON AND UPTON

Our goal of education excellence is being challenged because of the decreasing commitment from State and community budgets to provide the necessary funds for school and town agencies. The right to educate our students has become a more difficult task. It is becoming more evident that the regional school funding process is in serious jeopardy. The responsibility and costs associated with educating our children falls heavily on each community. As citizens, we cannot stress the importance of the need to educate our youth. Education should represent one of our highest priorities and reflect the commitment of all citizens. Our shortsightedness now, could lead to catastrophic consequences in the future.

The 1990-1991 budget was developed to provide minimum support to the district's educational standards and to continue to provide students with the best possible educational opportunities. The effects of these actions have resulted in a negative growth budget. The negative growth budget was further diminished by a State reduction in August of 1990 of \$112,438. Therefore, the previous 1989-1990 budget of \$5,884,928.09 has been decreased from the 1990-1991 budget of \$5,658,106.09 by (\$226,822). The effects of these cuts are as follows:

1. Jeopardizing the quality of education being provided to our students.
2. Increased class size.
3. Elimination of programs effecting certain test score areas.
4. Limiting our ability to provide a full instructional program at all levels.

The following cuts represent drastic measures taken by the Mendon-Upton Regional School District Committee over the last two years.

SCHOOL RENOVATION PROJECTS UPDATE

After approval last spring, the school district began the process of \$1,056,000.00 repair improvement projects at Nipmuc Regional High School, Miscoe Hill Middle School, H.P. Clough Elementary School and Memorial Elementary School. I am happy to report that the projects as follows have been completed.

1. Roof renovations: Nipmuc, Clough and Memorial.
2. Replacement of boilers and outside fuel tanks at Nipmuc, Clough and Memorial.
3. Asbestos removal and re insulation at Nipmuc, Clough and Memorial.
4. Entrance doorways at Nipmuc and Clough.
5. Gym floor repair at Miscoe Hill Middle School.

Immediate savings have been noticed in the consumption of oil at each school site. I would like to thank all the citizens for their support in the completion of these projects. The cost of the projects will have lasting benefits which will provide the communities of Mendon and Upton with improved and efficient facilities for the next 20 years.

INSTRUCTIONAL

Improving student instruction is always a constant and important goal of the school district. The State Assessment testing which was taken in the Spring of 1990 indicated that

our students fell within the designated KOC band at all levels. Testing occurred in grades 4, 8, and 12. Some sub tests such as library skills indicated a downward trend. This score is reflective of budget reductions and curtailment of student services in the library area. There is a direct proportional relationship between service program scores and student outcomes. At Miscoe Hill Middle School, heterogeneous grouping practices are an important goal. In early Fall, the middle school schedule was revised to accommodate student grouping and teacher planning for the implementation of a heterogeneous instructional structure. This recommendation for alternative grouping practices had been suggested by the NESDEC middle school evaluation team that visited Miscoe Hill.

Other instructional options are currently being explored such as cooperative learning, sharing instruction and student based research projects. We are proud of our schools and the challenge to grow and improve all of our educational services is an important and constant goal. In these difficult times, bonding staff and creating an environment that is conducive to learning is being strained by economic and societal factors. We trust that all the citizens feel the same sense of responsibility as the members of the school community who believe sound education is not an alternative but an obligation.
