

BOARD OF Health MEETING MINUTES

March 8, 2022

1 The meeting was called to order at 4:45 p.m., by Chairman, Ted Briggs. Also in attendance were;
2 Member, Al Holman; Member, Richard Desjardins; Asst. Public Health Supervisor, Diane Tiernan, and
3 Title 5 agent, Paul McKeon.

5 The agenda was reviewed and accepted.

7 Minutes the previous meeting dated 2/4/22 were reviewed.

8 **Motion one** – Al made a motion to accept the minutes from the 2/4/22 meeting and Ted seconded the
9 motion. Minutes were approved by majority.

11 Vouchers were reviewed and signed.

13 4:48 p.m., Engineer, Mike Dean arrived to review septic designs for Westboro Road – 4 lots owned by
14 MacDonald. Mike wanted to discuss the request by the BOH Agent, Paul McKeon to perform additional
15 deepholes on the lots. Mike does not feel it is warranted.

16 Paul stated the plans even say that more test holes will be completed while digging the well and
17 foundation. Paul wants them done before anything is actually started. He is concerned that the testing that
18 was done was not conclusive. He'd rather see the holes dug before its too late to make any changes. Paul
19 stated that Lot 2 is ok, but he wants to see more soil logs for Lots 1, 3 and 5. If the new tests show that
20 there are no changes, than the proposed plans will be approved as submitted.

22 **Motion two** – Al made a motion to approve Lot # 2, Westboro Road for McDonald, and approve lots 1, 3
23 and 5 pending further test results. Richard seconded the motion and Ted made the motion unanimous.

26 Septic permit was reviewed for Cobblers Creek Senior Housing project – North Street – Lobisser
27 Builders. Board stated that the engineer has addressed each issue that DEP was concerned with.

28 **Motion three** - Richard made a motion to approve of the permit and Al seconded the motion. Ted made
29 the motion unanimous.

31 Food permits were reviewed for: The Caribbean Press – Millbury, Big T’s – Worcester, Juniper Farms –
32 Hudson, Birds Nest Italian Street Food – Millbury, Petal and Crumb – Upton , and Gasco – Upton.

33 **Motion four** - Richard made a motion to approve of the above permits and Al seconded the motion. Ted
34 made the motion unanimous.

86 Installers permits were reviewed for Scott Butler – Upton and Paul Kuczinski – Upton.

Motion five – Al made a motion to approve of the above permits and Richard seconded the motion. Ted made the motion unanimous.

40 Board discussed the new MA tobacco regulations and agree that they appear to be very restrictive.

42 Board discussed appointing Chloe Mawn as Title 5 Agent for the Board, who will assist Paul McKeon
43 and Lenny Izzo when needed.

Motion six - Al made a motion to approve of Chloe Mawn as agent and Richard seconded the motion. Ted made the motion unanimous.
